# Every good idea needs marketing strategy

Caine Monroy, a 9-year-old from East Los Angeles, made the news a couple of weeks ago with the cardboard arcade he built out of boxes in his father's shop last summer.

He used his own toys as prizes. Caine's arcade even had ticket dispensers to be redeemed for prizes.

After finishing his arcade, Caine had one problem — no customers. At least, he had no customers until an aspiring filmmaker showed to purchase a door handle from Caine's father and became interested in the arcade. The filmmaker used

on YouTube, Caine's arcade became a sensation and the subject of more news stories than I am sure he could have ever imagined.

What is the significance of Caine's story to us? Caine had a plan. He had a plan to build an arcade out of cardboard boxes.

The problem was it was an incomplete plan. He knew he wanted to build an arcade. He knew what he wanted the arcade to do. He didn't have a plan to properly market and promote his arcade (or business). What I think he learned — and what we can learn from Caine — is that it isn't enough to have a great idea. It isn't enough to take that idea and turn it into reality. We have to have a marketing plan.

The movie "Field of Dreams" with Kevin Costner had the sound bite that stated, "Build it and they will come." That unfortunately, as Caine found out, doesn't usually work. A good marketing plan will use a number of resources to let your target market know you are open and ready to serve them.

Seventy to 80 percent of new businesses fail within the first year. Some of this is because of the lack of a good marketing plan, or because of poor execu-

tion of that plan. We see businesses all over town that spring up almost overnight. As we observe these businesses, we can sometimes guess which ones will survive over a year based on the marketing we observe. As quickly as they spring up, many disappear because they did not have a plan for attracting their target market.

The entrepreneur needs to have a plan for promoting his or her business. They need a plan for attracting their target market and enticing them into the business.

Caine didn't have a market-

ing plan, but he got lucky when someone that could market his business happened by and helped him out. For most of us, no one is going to stop and help us with marketing our business because they took a liking to us. The staff of the SBDC can help you with your marketing plan. # The Death of Superstition

I've never been very superstitious. I've never used the services of a fortune teller, shaman or palm reader and I think the predictions offered up by a star gazer are as reliable as the defroster in my old 1964 Chevy pickup was. And Chinese food advice is as hollow as the inside of the fortune cookie it comes in.

I don't eat black-eyed peas on New Year's, or any other day for that matter, and other than having a fear of heights, I'd have no trouble staying on the 13th floor of a hotel, if they had them. I even wore jersey number 13 when my basketball coach in high school assigned it to me. I don't carry on my person a lucky penny, four leaf clover or rabbit's foot and black cats and ladders don't scare me.

Knock on wood, of course.

I don't know why these superstitions have been handed down from one generation to the next or why farmers and ranchers in the old days thought they were so important for their economic and physical well being. I can't for the life of me understand why otherwise smart people would plant their crop only when oak leaves were the size of a squirrel's ear, or that planting a cow's horn on your property would make your land any more fertile than a good load of cow manure would.

Fortunately, I don't believe that kid's today have a working knowledge of all this balderdash and they are much too smart anyway to believe in such witch-

craft. We're all getting better at understanding that sometimes positive results are not the result of silly superstitions, but of simple science. Take, for example, the case of what I call "The Curse of the Dead Champions."

Many years ago there was a bull sale in the west that many ranchers thought was jinxed. This was because the Ideal Range Bull, the bull determined to be the best of all the entrants, seemed to always die shortly after

some rancher had paid a lot of money for him. Every year when I'd arrive at the sale to work ring a rancher friend who everyone called "Speedy" was eager tell me of the latest misfortune to befall last year's champion. According to Speedy, past champions had died of strange diseases, been run over by a train, shot by deer hunters, stolen by a drug ring and one was drug to death, if you can imagine that horror. Every year's death seemed to be more horrific than the last and word of the of the dead champion's jinx spread like wildfire.

It got so bad that ranchers didn't want to buy the Ideal Range Bull because they knew he'd die soon. So the best bull often brought half of what lesser bulls brought later in the sale. Livestock insurance salesmen who usually competed to write policies on valuable bovines stayed away in droves, not wanting to write a policy on a bull everyone knew would die of some freak accident or disease before the year was out.

Normally purebred breeders would consign their best beast to this prestigious sale but when they saw the winner bringing way less money, they took their best bulls elsewhere. Naturally, this disturbed the sale manager. He became so distraught he was ready to hire a voodoo High Priestess to get rid of The Curse of the Dead Champions.

I never thought the curse was real and I tried to use my investigative journalistic talents in tracking down all the rumors. The trail always went cold on me when I found that the buyer of the Ideal Range Bull for the past six years had been an order buyer, and he wouldn't say who he was buying the bulls for.

Then one day I was on my way to a sale when I saw a ripping set of calves in a friend's field by the side of the road. Then as I passed his bull pasture I thought I noticed a few brands I recognized, and a few bulls looked faintly familiar to me. That's when I put two and two together and used science to conquer superstition. Every one of those jinxed deceased champions that died such terrible deaths had come back to life and were resting comfortably in Speedy's bull pasture.

# Texas, Amazon.com come to terms

Texas last week resolved a multi-year dispute over uncollected revenue with Seattlebased Internet sales giant Amazon.com, a company with a physical presence in the Dallas-Fort Worth area.

Comptroller Susan Combs, in an April 27 announcement carrying an Austin and Seattle dateline, said Amazon.com Inc. will:

- Begin collecting a state sales tax on July 1;

- Begin creating at least 2,500 jobs in Texas over the next four years; and

- Make at least \$200 million in capital investments in Texas.

The three-pronged agreement, according to Combs' statement, "resolves all sales tax issues between Texas and Amazon." Officially, Combs is "chief steward of the state's finances, acting as tax collector, chief accountant, chief revenue estimator and chief treasurer for all of state government."

In the announcement, Combs also suggested that "Congress should enact federal legislation that will give states access to revenues that are already due, which would resolve this issue fairly for

all retailers and all states." Amazon.com presently collects state sales taxes in only a few states.

Drought declaration extended Continuing exceptional

drought conditions in Texas prompted Gov. Perry on April 20 to once again extend the state emergency disaster declaration of July 2011. The three-month extension applies to 180 or more than 70 percent of Texas' 254 counties.

Roads program funds OK'd The Texas Transportation Commission on April 26 approved \$40 million "for repair and rehabilitation of roadways used frequently by the energy industry."

According to the agency that oversees the Texas Department of Transportation, "The energy industry has helped Texas remain an economic strength among states, but subsequent impacts on roadways and bridges, traffic, safety, and the environment have brought about a need for collaboration to lessen the impacts." Work projects to are scheduled to begin this summer.

#### GEAR UP GRANT AWARDED

The Texas Education Agency on April 27 reported it is one of seven states to be awarded a \$33 million federal grant to improve the postsecondary awareness, readiness and success of middle and high school students.

A seven-year grant for Gaining Awareness and Readiness for Undergraduate Programs, or GEAR UP, will support some 6,000 students in the Class of 2018, from seventh grade through graduation from high school. The new grant also includes a seventh year designed to help support students in their first year of college, the agency reported.

Take Mom to state park Mother's Day 2012 is Sunday, May 13, and looking forward to it, Texas Parks and Wildlife Department floated this novel idea on April 23.

"Why not do something special this Mother's Day by treating Mom to an outdoor adventure and a picnic lunch amid appetite-stimulating scenery at a one of more than 90 Texas State Parks? Not only will mom and the family enjoy a healthier and happier day, but they also will be helping state parks close a budget gap."

Parks and Wildlife, which suffered along with other state agencies in budget cutbacks dealt by the Texas Legislature in 2011, is working toward recovery from a \$4.6 million funding gap. PLEASE SEE STATE, PAGE 10





# **Ozona Bands end year on a high note**

In May 2010, I was approached by a colleague who had connections to the Ozona band program. He told me about the history and expressed that he felt it was a monumental challenge to return the band program to a successful level, but one he knew would be worth it for the students, the school, and the city of Ozona.

At first I was reluctant, but as he told me more I began to be intrigued by the challenge. Sometimes no one in particular does anything wrong, but constant revolving change in directors or administration and lack of consistency can weaken a once successful program and slide it into decline. Having rebuild several programs, I understood the gravity of the situation. At that time I believe I may have been one of the few in the music business who felt the program could change in a positive direction or was even worth the effort at all.

When I arrived, I saw first hand the effects the decline had taken on the band program. As we started the school year, I was able to see the picture more clearly to give me the direction we needed to take the program to get back on track for success. Just as when you hit the restore button on your computer it blanks out the memory and starts over, that is what the band program went through in the fall of 2010. What is important here in this picture are the feelings of the students who had to face these challenges. Some of these students had already experienced the changes of 3 different head directors and 3 assistant directors over their band career, and here we were changing it once again. They could have easily given up and said no, but as I talked with many of them that first summer, they agreed to come back and give band just one more try.

Over the last two years, the program has undergone a complete renovation. Just as school members went back through as many fundamentals as we could give them. I say this as a compliment to our wonderful students who had to endure this "unlearn -relearn" process from the back side and then perform publicly with skills they were working to acquire at the same time. We are proud of their efforts and look forward to the accomplishments they strive for daily. The students have created something they can take pride in. While the program may appear to be going well, there is actually a frantic level of teaching still going on as these students are still mastering basic skills and also beginning the process of learning the advance skills needed to really excel. They are beginning to understand that success requires a very high level of commitment. Our students are meeting every step of this challenge with lion pride and are determined to reach their goals for the Ozona Band!

As I took on the challenge of renovating the band program here, I also had to deal with the challenge of finding good help. In 2010, the applicant pool for assistant directors interested in Ozona was almost zero. It was difficult to find a candidate who wanted to reside in rural area and deal with rebuilding a band program from the ground up. I was so fortunate to find Elizabeth Bouquin, a fresh and energetic West Texas A&M music graduate and 2006 All-State ATSSB flautist. She has been a blessing to the students of Ozona and the band program. Besides being a willing learner as I threw her twenty books on how to deal with real world problems that you don't learn about in college, I also had to prepare her for how a new director takes a derailed program and gets it back on track. She has exceeded my expectations as a young director dealing with the stress of the first years of teaching let alone reviving a struggling band program. I am impressed with her innovative and student-engaging teaching style. Just look at the young bands this year and you will see what I mean. The seventh grade band successfully completed books 1 & 2 in their first two years and is playing level 2A high school music. The other OMS bands are doing very well also. Justina Saunders at elementary has been a god send as she helped us be aware of what the young students needed as they transitioned to the middle school. Her excellence in teaching has been the best I have seen. We have demanded a high standard of excellence in the band program because we care about our students and want them to believe in themselves and take pride in what they do. The support of the community and the band parents has been outstanding, and

I appreciate the comments made every time I am shopping and eating out around town. Your encouragement and great concert attendance is appreciated by the students who work so hard to perform at their best for you. As the saying goes, behind every successful man is the support of a good woman. My wife, Cathey, is really the one who keeps me going and organized. Her commitment at her own sacrifice to my career is why I still enjoy working. I love teaching music, but I also am here for the students of Ozona. Without her undying support I would probably not be here at all.

I have been humbled at the support of many directors around the state as they have noticed what is going on here in the Ozona band program. When the Texas state UIL office uses our program as a "textbook example" of how to rebuild a band, people notice. When several dozen of the state's top directors talk about how great it is that this program is finally coming back, I am proud to show off the work of our students. Several top award winning directors from this part of the state have come and visited us to see what is happening here because they are seeing the results of our hard work in the performances. It is great to hear them say we are doing it the right way, and we see many common denominators in our styles of teaching. I do not say this for our benefit as directors, but for vou to know that the progress of the band program here in Ozona is a result of your kids working so hard to bring pride back to the Lion band. It is the positive collaboration of this professional learning community of students and school personnel that will ensure this program stays on track toward success.

We are proud of what has been accomplished these last two years. We hope you have seen a positive difference, not only in the performance quality, but in the attitude of our students. The fact that the high school band has grown from 26 to 80 members, and is now performing at the 2A level in spite of the big leap they took in the level of difficulty I handed them this year, is a sign of their interest, growing musicianship, and commitment to the band program. We could have played easy music again, but it is not about the ratings. It is so much more about them increasing their abilities and attaining skills. However, success

does come from good knowledge and skills. The fact that the OHS Band sight-reading scores have improved dramatically over several years is a sign of the progress they are making. The fact that the middle school bands are show great progress is the result of good management and a testament of the commitment of the staff to do it in a right way that grows the program musically. The program is showing signs of stepping to the next level and that is something we can all be excited about! We believe that what the band students have accomplished is only a drop in the bucket compared to what we hope you will see in the next few years as the students meet their potential and reach for their goals, but we know this can only happen with consistency and your support! We hope you will come and enjoy an evening of music that will let you hear how hard these ladies and gentlemen of the band work! We look forward to seeing you on Tuesday, May 8, at 7 p.m. at the Crockett County Convention Center!

Her first boss, Selena Newby, of Ozona, said she will never forget how kind the Richardsons were.

"Some of the best people you'll ever meet," she said.

Former employee Roylan Sullivan, of Ozona, said Wade was a good business man with a soft heart.

"I always knew where I stood with him. He always treated me with respect. He always did what he said he would do, and, you could always count on him to do the proper thing," she said. "I learned so much from him. He also expected the best of everyone around him, which was sometimes difficult, but it made me always try my hardest to meet his expectations. He made you want to do your best, because he always did his best."

It was Wade's love of family and friends and faith that Crockett County Rancher Jack Baggett said he will remember most.

"When it came to matters of the heart, Wade was in a class by himself," Baggett said. "He was a mentor of young men. He did lead by example. He was unequal as a husband and father. Wade and Jane worked well as a team. They complimented each other."

Baggett also spoke of Wade's love of fishing and travel.

"He also made perhaps the best pancakes I've ever had," Baggett said. "He taught us so much about life and how it should be."

Melissa Harvick Masters was a third cousin to Wade. Masters grew up in Ozona and now lives in Ohio. She said her favorite memories of Wade were at family reunions.

"We always had such a fabulous time. It seems we were able to spend more time together, as third cousins, than most first cousins

Oueen treats.

"I was asked for dipped cones and it was always my pleasure to put smiles on those kids' faces," she said. Kyle was a year older then Fenton's son Koby. Throughout middle and high school, Kyle and Koby did lots of activities together.

"Koby thought the world of him and was delighted when he took the time to attend his wedding in October. That was the last time we saw him. He always had a smile on his face and that's the way we will always remember him," Fenton said.

Kyle followed in the family business, opening up his own Dairy Queen in Marlin, Texas. He also found success in Midland working for several oil and gas companies, most recently J Cleo Thompson and Lewis Energy.

"His biggest goal was to drill his own well before he turned 30. Last month, his first well was a success," Campbell said.

Kyle recently became engaged to Nicole Lewis, of San Antonio. The couple was planning to wed in September.

"He was transparent happiness. He had a pure heart and genuine intentions with nothing to hide," Campbell said. "He treated everyone with respect and believed the best you."

Wilson Classmates Stokes and Chase Clark remembered spending time at the ranch with Kyle, going on school trips and the love Kyle had for his family.

"Kyle was with me during some of the most crucial stages of my life. I will miss him dearly," Stokes said.

"He was one of my most faithful friends. He loved a challenge and achieved everything he set his mind to. I will cherish all the memories we had together," Clark added.

News of the plane accident on April 26 spread quickly throughout Ozona and Texas.

"It has been years since I have been in Ozona but my memories of being on their

ranch and enjoying the West Texas atmosphere and their hospitality will always rate highly. I was accepted to be part of a hunting party that leased their property many years ago and will always remember what a wonderful family they are and the business strength of Wade. My thoughts and prayers are with them," said Rick Cruz, of Fort Worth, Texas.

County Judge Fred Deaton said the accident is a tragedy and a loss for all of Ozona.

"Kyle sure had a promising future. His charisma was contagious," Deaton said. "I always respected Wade's insight and opinions on business and community issues. Wade invested his time, effort and energy into Ozona and Ozona prospered for it."

A report from the San Juan County Sheriff's Office in Utah stated that it appeared that the plane had just lifted off from a small back country air field just outside of the Dark Canyon Wilderness area. After liftoff, the plan flew east but soon crashed for unknown reasons around one mile from the airstrip.

The plane was registered to Kyle Richardson.

According to an article in the Midland Reporter-Telegram, the Richardsons flew into Price, Utah, on Wednesday and hired Newby at Redtail Aviation to serve as a guide for the back country tour, said Mark Francis, the pilot's brother-in-law and owner of Redtail Aviation.

It was Newby's portable GPS beacon that transmitted the plane's last known coordinates, said Francis, who visited the remote crash site more than 200 miles south of Salt Lake City.

It wasn't clear who was flying the plane because Newby and Kyle Richardson both were pilots, Francis said.

San Juan County Sheriff's Officials stated that the plane went missing around 1:30 p.m. April 25 leaving only the GPS coordinates col-

lected from a spot beacon. The release states the plane was recovered at 4 a.m. April 26.

Redtail Aviation, out of Price, Utah, contacted the San Juan County Sheriff's Office and reported that they had not heard from the plane for several hours. San Juan County Sheriff's Deputies, along with Utah Highway Patrol Aero Bureau, flew to the last known coordinates that were received by the spot beacon to discover the plane had crashed and that there were no survivors, the release stated.

The victims had to be airlifted from the crash scene by the UHP helicopter to the nearest highway, State Road 95, where San Juan County Deputies and Search and Rescue personnel transported the victim's remains to Blanding, Utah and then to the Office of the Utah Medical Examiner in Salt Lake City, officials stated.

'To try and access it by foot would be painstaking and very lengthy," said San Juan County Sheriff Rick Eldredge, in an article by KSL Utah. "The only way to access this is by horseback or by foot, and it's just very rugged, steep canyons."

Newby, 55, the pilot that was also killed with Wade and Kyle, is survived by his wife and two grown children. Francis said, in a Salt Lake Tribune article, that Newby has been flying since he was in his 20s and had been a flight instructor for years.

"He's a guy who lights up the room — always joking and pulling pranks – keeps us all on our toes," Francis said. "He was a big, shining part of this operation, and we'll miss him.'

The FAA and National Transportation Safety Board are investigating the crash. A preliminary report may be released in a few weeks, but the final report usually takes several months.

do now," Masters said. "Although no particular memory stands out more than others, I remember Wade's smile. He was so cute and so happy and always running, always laughing. Because I moved away and didn't get back to Ozona often, my memories of an older Wade are few, but his smile remained and his compassion and kindness shone. To me he became the epitome of a Texas gentleman."

In his short life, Kyle achieved many great things, just like his father.

Both Kyle and Wade were valedictorians of their high school classes, excelled on the football field and graduated from Texas A&M University with honors.

Along with Kyle, the Richardsons have two other children, a son Clay and a daughter Codi. Clay is keeping up the family tradition by running the ranch in Crockett County. Clay and his wife Andie have a newborn son West. Codi is a doctor in Temple, Texas and married to Taylor Kingman.

"The strongest influence in Kyle's life was family. I've never met one closer," said friend Charles Campbell. "He was so proud to be an uncle and he had the pictures to prove it."

Growing up, Kyle's closest friends were his brother and sister.

"One of my fondest memories was looking out the window of my office, which was at the back of the building, and seeing the three Richardson kids walking arm in arm across the back lot just laughing and chatting amongst themselves like close friends. Most siblings their age would have been arguing, aggravating or ignoring each other," Fenton said. "I remember being awed how obvious it was that they loved each other and truly enjoyed being together."

Newby said the trio was always asking for Dairy

Enforcement from Tarrant County College. I have thousands of training hours in law enforcement and public safety management. Training agencies include the Texas Department of Public Safety, Texas A&M (TEEX), the Federal Emergency Management Institute, the Federal Law Enforcement Training Center, Bureau of Alcohol, Tobacco and Firearms, and many other law enforcement agencies.

Political Experience – In 1974 when I was promoted to a supervisory position and I began working with elected officials. Although elected to positions in professional organizations I have never been a candidate for a political office.

Current Civic Involvement – I am a member of the Ozona Volunteer Fire Department. In the past I have worked as a local coordinator for the United Way and I have directed a law enforcement explorer group and instructed in citizen police and fire academies.

#### WHAT ARE YOUR TOP THREE PRIORITIES?

1. To establish a community service program. A community service program will provide an avenue for citizens to interact with the sheriff's office. The implementation of a community service program will include personal contacts, case follow-ups, public service programs, interaction with civic organizations and public relations. A community service program can help develop programs with our businesses, work with the chamber of commerce, help with community events and community organizations. The sheriff's office belongs to the people and everyone needs to feel they can approach any employee of the sheriff's office and receive friendly, respectful and cooperative service. The community service program will also be used to develop cooperative programs with our public schools to assist them whenev-

er possible. 2. To obtain maximum efficiency within the sheriff's office through duty assignments. The sheriff is responsible for the management of the sheriff's office, the review of all reports, filing case reports and overseeing the budget. The sheriff must be the administrator and the person running the day to day operations of the sheriff's office. My goal is to manage resources and provide maximum personnel on patrol. It is too easy for a deputy who is working alone to become involved in a dangerous situation with no expectation of immediate help.

3. To return the office of sheriff to one that is respected

by other public safety agencies and the citizens of Crockett County. I will work to foster an organization that has a cooperative spirit with fire, EMS, DPS and surrounding law enforcement agencies. The sheriff's office does not have the manpower or resources to handle a major disaster or emergency event without assistance from other agencies. Professional cooperation will be a priority so agencies can work together to protect our citizens. The sheriff's office cannot operate like it is an island, separated from other agencies.

### WHAT DISTINGUISHES YOU FROM YOUR OPPONENTS?

I worked uninterrupted in local public safety agencies from June 1966 until December 2008. My police certification has been uninterrupted and I currently hold a Master Peace Officer certification. I was employed by the City of Bedford in 1969 and worked through the ranks from patrolman to a deputy chief's position. I left Bedford in 2004 to become a deputy for the Crockett County Sheriff's Office. I have direct experience in all areas of emergency service and that provides insight into cooperating with our first responders. I understand that when the sheriff's office takes an action and someone is charged or arrested other people are affected.

The task of the sheriff is to be accessible to those who have concerns or question.

When a crime is reported the complaining party expects quick and appropriate action and to that end, reports will be prepared and filed with the proper agencies as quickly as possible. When I worked at the sheriff's office it was my direct responsibility to prepare and submit case documents to the county or district attorney. As sheriff, I will personally review all cases and confirm the proper charges are filed and reports are forwarded in a responsible manner.

#### NAME ONE AREA IN THE SHERIFF'S DEPARTMENT YOU WOULD LIKE TO IMPROVE?

Accessibility and Cooperation - The current cooperative spirit within the sheriff's office appears to be an issue. Improved communication, involvement with the public and employee training will improve this problem as the sheriff's office becomes more "user friendly." There are excellent people working at the sheriff's office who are capable of doing a good job. I would also like to work with the Commissioners Court to explore options for an office facility where people will not have to walk through slamming jail doors just to talk to the sheriff or a deputy. A visit to the current office facility is not a pleasant experience due

to the outdated office area.

#### WHAT ARE THE SPECIFIC NEEDS FOR LAW ENFORCE-MENT IN CROCKETT COUN-TY AND HOW DO YOU PLAN ON ADDRESSING THEM?

Cooperation with the commissioners' court is a priority. The sheriff is obligated to operate within budget limits and to maintain open communication with the court. Without the support of the commissioners' court the development of new programs and the continuation of existing programs cannot move forward.

The sheriff must place an emphasis on providing service and patrol duties in the community and county. Everyone in the county deserves law enforcement services from the sheriff's office. Dispatching procedures and radio systems can be used more efficiently, especially during large fires and EMS responses.

Professional leadership is essential in the sheriff's office. The implementation of professional standards for all employees through departmental meetings, training and Standard Operating Guidelines must occur. Every employee must understand the mission of the sheriff's office, their responsibilities in accomplishing the mission and understand there will be performance standards on and off duty.

#### WHAT MADE YOU DECIDE TO WANT TO RUN FOR CROCK-ETT COUNTY SHERIFF?

### WHAT ARE YOUR TOP THREE PRIORITIES?

1. Obtain a new communications console for the sheriff's office. The one we have now is a hand-me-down which came from the Ozona DPS office some years back. For some time now we have had problems with this system, and it has usually been when we needed it the most. When this communications system malfunctions, it is without any sort of warning and basically leaves our deputies on patrol in the blind. This is untenable in any environment, but especially so for a county law enforcement agency with the miles we have to cover in Crockett County. In an emergency situation, it could very well be fatal for one of my people or one of our citizens. 2. Continue with more

2. Continue with more schools and training for our officers. In Crockett County, we have no other law enforcement agency other than the DPS, our game warden, and our local constable's office. The DPS troopers are often not available to assist and much like the game warden are often completely out of our area on special assignments by their respective departments. Our constable is only one man.

As my fellow citizens already know, Crockett County is unique in many different ways.

We have over 3,000 square miles and are actually larger than some states, plus we have nearly sixty miles of an interstate highway which is a major coast to coast thoroughfare. Finally, we are only some 35 air miles from an international border, a border which is seeing historic levels of corruption, smuggling and violence. That leaves my deputies with a lot of ground to cover and with the real possibility of facing varying situations which call for a broad background of skills and knowledge. The way you obtain and keep an officer with such a background is by hiring the best the county can afford, and then seeing they are being trained as well as they can be by the county. That only happens by offering competitive wages and sending them to as many schools as possible.

3. The sheriff's office is currently occupying a 50 year old

two bedroom apartment that once housed a sheriff and his family. There are sixteen employees including myself trying to share this limited space. Crockett County CCSD has a vacant elementary school that could house all law enforcement, fire department, justice court, county court and some state offices. Shortly after taking office the Texas Jail Commission closed the use of the old jail that was built in 1892. It was unable to meet the standards required by the jail commission and being an historical building no alterations or repairs were permitted. The jail cells that were built 52 years ago can only be used to hold inmates for 72 hours and then they must be transferred to Upton County. There will come a time when those cells will also fail to meet the jail standards. Sometime in the near future Crockett County will have to

make a decision whether to build a new jail or continue to pay another county to house our prisoners. I ask that you the citizens of Crockett County contact your commissioner and voice your opinion. Five years from now the jail will cost twice as much to build.

### WHAT DISTINGUISHES YOU FROM YOUR OPPONENTS?

These differences come to mind: 1. I am the only candidate that has actually held the office of sheriff at present. 2. I am the only candidate who has extensive military background. 3. I am the only candidate who has been a peace officer at not only a local level, but also at state and federal levels. 4. I am the only candidate who has a bachelor's degree. 5. federal employment. 6. I am the only candidate who has ever worked internationally in a law enforcement position. In addition, I am the candidate who has: 7. I am the candidate who by far has the most training and experience in anti-smuggling and anti-drug operations. This experience also includes supervisory level 11. #### **VETERANS MAY BORROW** MORE

The Texas Veterans Land Board on April 26 voted unanimously to increase home and land loan limits.

Texas veterans may now borrow up to \$417,000 for a home and up to \$100,000 for a parcel of land as small as one acre, "making it easier for veterans to buy lots closer to urban areas," according to information published by the Texas General Land Office.

A Texas military veteran can simultaneously have a land loan, a home loan and a home improvement loan through the Texas Veterans Land Board, the agency said.

use of available grants and resources. The citizens of Crockett County pay a lot of tax money which ends up in Austin and Washington, and just about all of it we never see again. I am trying to change a bit of that by making myself aware of available grants and resources which our tax money helps fund. Often enough this is a long and involved process which can be even secretive at times. This includes having to negotiate an involved maze of paperwork and application process, as well as being able to provide the right information and criteria on our end to show our need for such assistance. Again, this is where my prior experience, knowledge, and education at all levels of government come into play. Many of these new patrol units and related equipment the average citizen sees us utilizing was not paid for out of the county coffers, but rather were purchased as a successful result of applying for these same grants and resources.

#### WHAT ARE THE SPECIFIC **NEEDS FOR LAW ENFORCE-**MENT IN CROCKETT COUN-TY AND HOW DO YOU PLAN **ON ADDRESSING THEM?**

1. Our needs are unique due to the uniqueness of Crockett County and the challenges associated with it. 2. We have over 3,000 square miles to patrol which includes nearly sixty miles of a major east-west interstate corridor. Our total area in physical size is larger than some states. 3. We have numerous secondary roads, including those which run on a south-north axis which brings the attending problems with narcotics and human smuggling. If we do not make a dent in this activity now and force these criminals to reconsider their routes, we will be overrun shortly in the same manner as many of the counties have been in South Texas. But to do that we need enough personnel, training and equipment to get the job done. Of course, leadership will figure into that also. In fact, leadership is the causative factor which brings it all together and makes for an effective deterrent But along with my Chief Deputy, Emilio Tambunga, I will bring that needed leadership to the table. 4. We have no police department for Ozona itself, which means we pull a double duty by being responsible for both the county and the town. We need to expand the number of our pe nel and their capabilities. The number of deputies we have at present are barely adequate to patrol Ozona and the immediate area surrounding the town. A lot of folks don't realize it, but you can be nearly 80 miles from Ozona by highway and still be in Crockett County. 5. We are currently experiencing a major economic boom due to oil exploration and production. That means more new people in our community, more traffic in our county and more the attending law enforcement problems entailed in this. 6. We are also experiencing a demographic phenomenon with our older, established ranch owners dividing up and selling off their property into so-called "ranchitas." This has brought a large influx of people from

larger urban areas who become land owners who are only here part of the time. These new citizens expect our department to respond to them as quickly as they do in metropolitan areas, or inside Ozona itself for that matter. These new needs should be addressed. 7. Geographically speaking, Crockett County is some 35 air miles from a country which has devolved into an open war, and three hundred air miles from a city which has the highest murder rate in the world. Already this historically high level of violence is spilling across the Rio Grande and into Texas. Take a look at Southern Arizona, and you can get an idea of just how bad it can get as well as how quickly. The damage done in the past couple of years will take decades to overcome, and there is no way to replace the innocent lives lost there. Just about every analyst and investigator involved in the subject of border violence opine that it will get a lot worse before it gets any better. That is a widely accepted fact, and there is no way of getting around it other than sticking one's head in the sand and wishing otherwise. The beginning signs here are already being noticed; one only has to talk to some of our area ranchers and land owners along the Pecos River to realize this. As of present, our department simply does not have the manpower needed to patrol that area on a daily basis. That is something else I would like to change. 8. In the 21st Century American criminal justice system, if a peace officer is not educated and articulate enough to write an offense report, that officer will lose that case in court of law. It is a shame and an abject failure for this to occur, and I will focus on finding the proper personnel to fill our ranks that have such skills, and then give them ample opportunity to enhance them.

#### WHAT MADE YOU DECIDE TO WANT TO RUN FOR CROCK-**ETT COUNTY SHERIFF?**

I want to continue making a positive difference in the sheriff's office. I knew three years ago that being a sheriff would be a challenge that I am still willing to take.

#### **ADDITIONAL COMMENTS:**

I want to try new ideas, new techniques and institute new programs. The old adage of 'that is the way we have always done it" is not good enough anymore in light of the multiple challenges we now face. Dur-






