## New season, new turf, new district

### Lions 'excited' for football

It's the start of a new football season.

The Ozona Lions took to their new turf field Monday morning on the first day of workouts.

Coach Ray Brown said the players and coaches are "excited" to get the season started.

"There's a different feeling this year. The kids and coaches were excited to get out on the new field and get back to work," Brown said.

Carter Construction has worked all summer installing the new field that will allow the players to practice on a full-sized field every day.

"We got it and we are going to use it," Brown said. "This will give us a bit of an advantage having the field with the markings."

Ozona will be playing on turf in seven out of their 10 games and in both their scrimmages.

Another change this year is how pre-season workouts are handled.

New University Interscholastic League regulations may make two-a-day workouts a thing of the past as the threat of heat exhaustion and dehydration have prompted UIL officials to limit the use of the

summer workout program.

Under new UIL summer workout rules, which were passed last October but take effect this year, teams are banned from using the double-session workouts for the first four days of summer camps.

Teams also will be banned from having two-a-days on consecutive days. On

the days teams are allowed to hold double workouts, players must be given at least a two-hour break between sessions.

During the initial four days of summer practices — which is now referred to as the "acclimatization period" — teams will be allowed to return for a second practice; but the second session can

only be a walkthrough with no equipment, conditioning or contact.

Weightlifting does not count as workout time.

Brown said the Lions have changed their workouts from four hours with an hour-long break to three hours with a shorter break.

The Ozona coaching staff is looking at maybe having

two evening workouts next week, which will be a walkthrough.

"This year we have shorter workouts. It's a solid three hours," Brown said.

Along with a new field, the Lions will be competing in a new district and classification this year.

## Anthrax case confirmed in Irion County

AUSTIN — A yearling female sheep in West Texas has been diagnosed with anthrax.

This is the second confirmed case of anthrax in a Texas animal for 2012 and the first in livestock this year.

The infected sheep was located near Mertzon in Irion County.

The first confirmed case of anthrax in a Texas animal for 2012 was detected on June 14 in an adult white-tailed male deer near Uvalde in Uvalde County.

The Texas Animal Health Commission (TAHC) has quarantined the premises. TAHC regulations require vaccinations of exposed livestock and proper disposal of carcasses before a quarantine can be released.

Anthrax is a bacterial disease caused by *Bacillus anthracis*, which is a naturally occurring organism with worldwide distribution, including Texas.

It is not uncommon for anthrax to be diagnosed in livestock or wildlife in the southwestern part of the state.

Basic sanitation precautions such as hand washing, wearing long sleeves and gloves can prevent accidental spread of the bacteria to people if handling affected livestock or carcasses.

Acute fever followed by rapid death with bleeding from body openings are all common signs of anthrax in

## Reagan County Deputy killed, shooter arrested after 17-hour standoff

A neighboring town is in mourning and shock after losing one of their own in the line of duty.

Reagan County Deputy Josh Mitchell, 26, was allegedly shot to death by Marcus "Mark" Wade Madison on Aug. 1. The event would lead to a 17-hour standoff.

Madison, 42, is facing attempted capital murder charges. As of Monday, he was in the ICU at Shannon Medical Center guarded by DPS Troopers and other law enforcement. Madison had a wound to his head when he surrendered himself to law enforcement.

Funeral services for Mitchell have been set for 10 a.m. today, Aug. 8, at the First Baptist Church in Big Lake.

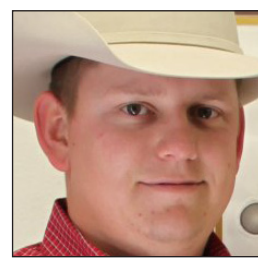
"Josh Mitchell was a fine young man. He was an excellent officer," said Reagan County Sheriff Jeff Garner.

## Licensing can help businesses expand into new markets

Entrepreneurs who are developing a product for commercialization basically have two choices to get their product to the marketplace; manufacture it themselves or license the right to make and distribute to someone else. The process is called licensing out. A license, through a licensing agreement, is a formal granting of the rights to make and sell to another party, who is called a licensing partner. The entrepreneur, or licensor, is usually paid in up front fees and ongoing royalty payments. Licensing offers a way of get-

ting products to existing or new markets more quickly and with less expense. Licensing offers a way to reduce capital investment by selling the rights to those who are in the business of manufacturing, selling and distributing. Licensing provides a way to

develop the product and have experts in these areas do the rest. The chances of success and gaining wealth from the development of a product are greater if you allow experts with manufacturing plants, sales forces, and well developed distribution systems handle taking the product to market. Licensing can also be used to expand into markets where one has little knowledge or experience. For example I know of a firm developing a device. They will manufacture, sell and distribute the device themselves here in the U.S. However to ex-

pand to other countries, the firm will license the rights to licensing partners to make and distribute the product in a certain country, and gain revenue without having to invest a large amount of money. In the future, when the licensing agreement runs out, the firm may decide to develop the capabilities themselves if they then have the capital and expertise to do so. Elements of a licensing strategy include research on the industry and market for the product, research on a group of possible licensing partners, and get-

ting resource partners who can help you through the process. Visiting with an attorney experienced in licensing is your first step. They can help develop a licensing strategy, negotiate a licensing agreement, and help research and select a licensing partner. In addition they can help secure your intellectual property through patents. Secure other resource experts to help with the market and industry analysis. This is where the SBDC can come in to assist. We have the resources to help entrepreneurs with market and industry anal-

ysis for any purpose. So if you have developed a product, and have a working prototype, you should explore licensing as a way of getting the product to market in a less expensive way. If you find the right licensing partner, you can reap the rewards through royalties. The process is not easy, but you may find it easier than trying to manufacture and distribute it yourself. ### Voter ID does not suppress votes

Even the star witness hired to testify against Texas' voter ID law agrees that photo ID laws prevent "almost no one" from voting and has stated that the voting rights concerns raised by partisans who oppose voter ID laws are "overblown." That star witness also agrees that comparing voter ID laws to Jim Crow and poll tax laws is unjustified. Just four years ago, the U.S. Supreme Court agreed that voter ID laws are non-discriminatory and perfectly constitutional. The high court held that even in states unable to prove voter impersonation, voter ID laws are justified by the need to protect the integrity of the election process. The court emphasized that the inconvenience of gathering all the required documents, going to the department of motor vehicles, and posing for a photo is simply not an infringement on the right to vote.

Voter ID laws do not prevent legal votes. Instead, they ensure legal votes are not diluted by illegal ones. Fraudulent voting must be stopped, and voter ID laws will help us stop it.

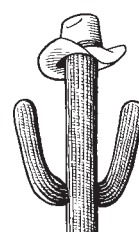
State Reps. Jose Aliseida and Aaron Peña testified that South Texas is plagued with voter fraud. Rep. Aliseida also testified that non-citizens voted in Bee County elections. In the past year, hundreds of people who claimed they were non-citizens had to be removed from the voter rolls.

## Roundup Dos and Don'ts

Ranchers are inviting city folks to their brandings to educate them about our business. I applaud this move but realize that there's never been any direction given as to how the townies are to conduct themselves. Until now, that is. Here is a list of dos and don'ts on how to win friends and influence cowboys at the next branding.

DON'T buy a brand new pair of boots and a brand new cowboy hat and then wear them to a branding. Your feet will hurt and some jovial cowboy will fill your new hat to the brim with cow manure as a practical joke. DON'T wear spurs with your Bermuda shorts either. DO wear a sensible pair of athletic shoes because you are going to be doing a lot of running away from mad cows who have had their babies temporarily kidnapped from them. You are also going to be dodging red hot branding irons, sharp needles and ropes that will feel like barbed wire running through your bare hands. But DON'T wear gloves; the cowboys will think you're a big sissy and the doctors in the emergency room will have a hard time finding your severed fingers amidst all the coagulated blood concentrated in the finger tips of your gloves. DON'T ask for a Band-Aid or pain medication either. Suck it up. Make sure your medical insurance is paid up and that you are within two hours of a good hospital. And you might want to consider having a Medivac chopper standing by.

DON'T ask if you can brand, give shots or use the knife to turn the bull calves into steers. This is serious business and a rancher could lose money and respect if some dude in low shoes put a brand on upside down, gave a shot that caused a bulbous growth, or only removed half of a bulls' manhood. Your job is to work the ground crew which means you get to tackle huge calves all day. DO try to lift with your back. DON'T complain or expect thanks. This isn't a party or a place to network. There are no invitations, you don't have to RSVP and there isn't a reception where canapés and cocktails are served. Everyone works for free, plain and simple. After all... this is the cow business. This isn't about you. DO come expecting to be exploited and abused. DO leave home your attitude, boom box, cell phone, dogs, girlfriend or mistress, unless she makes great desserts, or is built like a fullback and can flip calves on their right side. Especially DON'T bring a knucklehead horse. You aren't going to get to ride and rope anyway as there's barely enough calves to rope as it is for the real cowboys to get their fair share. DO bring donuts, preferably

chocolate with sprinkles on them. This isn't the Civil War where you can pay someone to take your place. If you aren't going to work by all means DO feel free to stay home. DON'T get all queasy and faint if you're forced to eat your share of mountain oysters as part of your initiation, or if you happen to see severed body parts, blood and other body fluids. They probably belonged to a cowboy anyway. It's called a branding because we brand our cattle. This is a branding, not Show and Tell so DON'T take hidden videos and then put them on You Tube. At the barbecue afterwards DON'T ask if they have chicken, sushi or a vegetarian entree. DON'T be an idiot or sue anyone at the conclusion of the day's activities. ## Cruz beats Dewhurst in primary runoff

**STATE CAPITAL HIGHLIGHTS** By Ed Sterling | Texas Press Association

AUSTIN — Voting in party primaries May 29 and runoff elections July 31 set the Nov. 6 general election ballot for Texas voters.

Texas had 13,065,425 residents who qualified to vote in the primaries and runoffs. Republican turnout statewide was 8.5 percent of the total while the Democratic turnout was 1.8 percent, according to tabulations posted by the Secretary of State's Elections Division last week.

Republican Ted Cruz of Houston and Democrat Paul Sadler of Henderson will face off for the U.S. Senate seat to be vacated at the end of the year by Kay Bailey Hutchison of Dallas. Hutchison, who has held the Senate seat for more than 19 years, was state treasurer when she won the election to fill the unexpired term of Sen. Lloyd Bentsen, who resigned the Senate seat after he was appointed U.S. treasurer by then-President Bill Clinton. Hutchison went on

to win three consecutive six-year Senate terms.

Three broadcast debates and waves of televised campaign advertising raised the profile of Cruz's primary bout with Lt. Gov. David Dewhurst. On May 29 Dewhurst got nearly 45 percent of the vote and Cruz, 34 percent, in a field of nine candidates. Had either candidate garnered 50 percent or more, a runoff would have been unnecessary. Both the primary and the runoff were watched nationally and made headlines. Much was made over Cruz's never having been elected to a public office and running successfully against the widely known Dewhurst, who was cast as the "establishment candidate."

In the Democratic runoff, Sadler, with 63 percent of the vote, topped his opponent Grady Yarbrough's 37 percent.

Picking here from the list of runoff winners was state Rep. Randy Weber, R-Pearland, who will face former U.S. Rep. Nick Lampson, D-Beaumont, in the race for retiring Congressman Ron Paul's Congressional Dist. 14 that includes Brazoria, Galveston and Jefferson counties.

State Rep. Pete Gallego, D-Alpine, won the runoff against former U.S. Rep. Ciro Rodriguez, and will face Republican incumbent U.S. Rep. Francisco Canseco whose enormous Cong. Dist. 23 runs from San Antonio to El Paso and includes Crockett County.

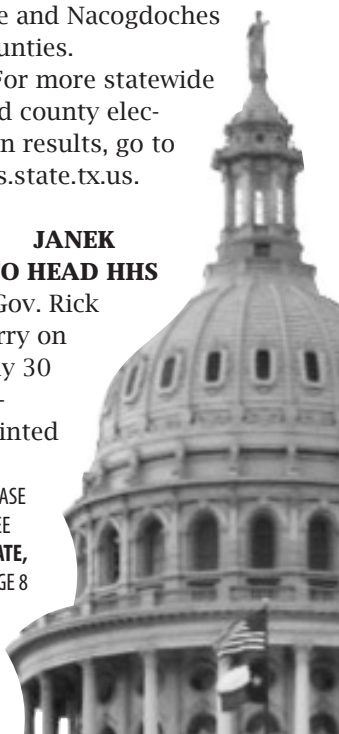
Also notably, incumbent state Sen. Jeff Wentworth, R-San Antonio, lost his runoff with Donna Campbell for Sen. Dist. 25, which includes part of Bexar and Travis counties and Comal, Guadalupe, Hays and Kendall counties. And, incumbent state

Rep. Chuck Hopson, R-Jacksonville, lost his runoff with Travis Clardy for Rep. Dist. 11, which includes Rusk, Cherokee and Nacogdoches counties.

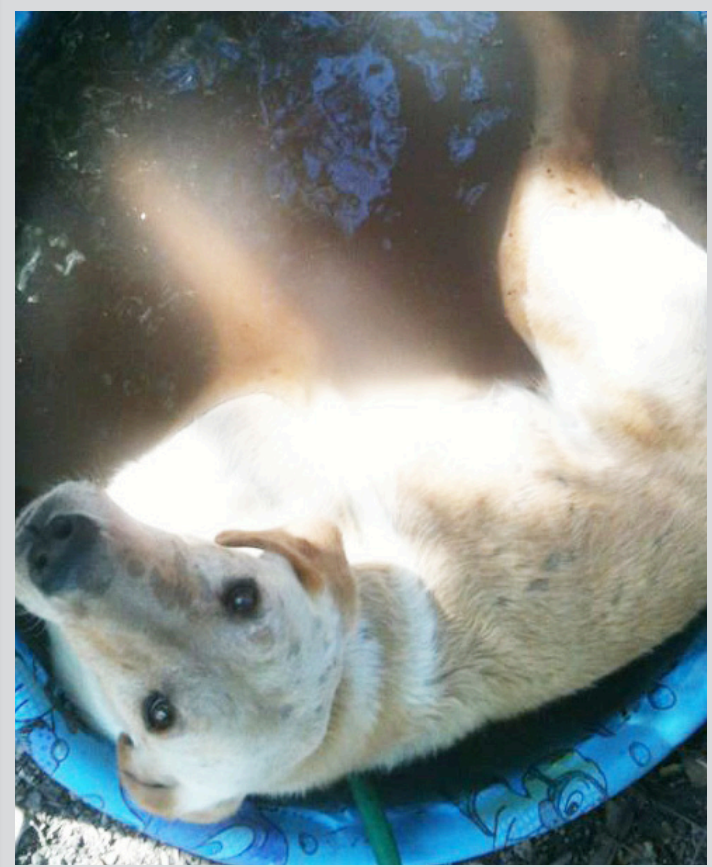

"He would do anything in the world for anyone. He was not the kind you can just replace."

Around noon on Aug. 2, a SWAT team entered the house through the back and searched room by room, Garner said.

Madison was found hiding in a closet. The standoff ended with Madison turning himself over to authorities after shooting himself with a rifle.

"Every effort was made to get him to come out on his own," Garner said, "which eventually he did."

His injuries were initially reported as extensive and that Madison shot himself with a "high-powered rifle or shotgun."

Madison had blood on his face and clothes when officers arrested him. He was taken to the Reagan County Hospital before Shannon AirMed helicopter transported him to San Angelo.

Mitchell went to the house around on 11th and Main around 6 p.m. on Aug. 1 to talk to Madison about an incident that had occurred earlier in the day, when Madison allegedly shot Mitchell, Garner said. Madison did not have warrants, and Mitchell did not intend to take him into custody.

DPS spokesman Trooper Sparky Dean said when the arrest warrant for Madison was issued, the officers who filed it thought Mitchell still was alive. He said during the investigation the charge of attempted murder will be changed to one of capital murder — either at the officers' discretion or when the case goes before a grand jury.

The two charges have to prove elements that are almost identical, Dean said.

Garner said the 112th District Attorney's Office will handle the case. The 112th District takes in Reagan, Upton, Crockett, Sutton and Pecos counties.

Immediately after Madison was taken into custody, police found several long rifles at the residence, including, Garner said, a .30-06-caliber, a .243-caliber and a

.30-30-caliber.

Madison also was recently arrested in Brownwood on charges of assault with injury — family violence, resisting arrest and retaliation or obstruction.

Brown County Sheriff Bobby Grubbs confirmed that Madison was living in the Shamrock Shores area of Lake Brownwood when deputies arrested him on July 7. Madison posted three bonds and was released on July 14.

Madison was convicted of evading with a vehicle by a Tom Green County jury and sentenced by the court to five years probation. In connection with that incident, the same jury acquitted Madison on a charge of assaulting a police officer. The trial took place in June 2003.

Mitchell's killing is "a reminder that there's no such thing as a routine call, and every call they go on has the chance of turning into a bad situation," Brown County Sheriff's Capt. Tony Aaron said.

Throughout the standoff, personnel and equipment from about a dozen different agencies arrived at various times, bringing fire trucks, armored transportation vehicles and a mobile tactical center.

Crockett County Sheriff's Office, DPS Troopers from Ozona and Crockett County EMS and Ozona Firefighters all assisted.

Officers took turns sleep-

ing behind the wheels of their patrol cars. American Red Cross volunteers were at the scene to feed first responders who couldn't leave the area.

Madison's father was in the house at the time Mitchell was shot, but he left the house shortly after Madison went in, Garner said. Madison's father helped officers with questions about the layout of the house. Madison apparently lived in the house with his father, acquaintances said.

"It's unknown to me why Mr. Madison shot my officer," Garner said.

Mitchell worked at the Reagan County Sheriff's Office since he was attending high school in Big Lake.

After graduation, Mitchell worked as a night jailer. He graduated from Howard College in 2007 and then the Concho Valley Regional Law Enforcement Academy in 2008. Mitchell then began his duties as a deputy.

Mitchell served as the department's D.A.R.E. officer and K-9 officer with his sidekick "K-9 Officer Sherlock."

He was also a member of the Big Lake Volunteer Fire Department and the North Reagan County Volunteer Fire Department.

"We knew Josh as a man, a great lawman and family man. He was so nice to us and our children," said Big Lake resident Brandi Lemons.

Reagan County High School students held a car wash over the weekend that raised more than \$2,300 for the Mitchell family. Subway of Big Lake also donated a percentage of their sales on Aug. 4.

Mitchell married his high school sweetheart and the love of his life, Jill Matthews Mitchell on June 21, 2008. They made their home in the Stiles area.

He was a member of Community Baptist Church in Stiles where he took time out of his busy schedule to care for the lawn.

Mitchell is also survived by his grandparents Marvin and Betty Mitchell, mother Cindy Mitchell, sister Jacy Mankin and her husband JL and their daughter Kenna, sister Bethany Hardison, all of Big Lake; father and mother-in-law Jimmy and Linda Matthews of Stiles; brother and sister-in-law Michael and Natalie Matthews of Mertzon, sister-in-law Julie Matthews of Stiles; many uncles, aunts, nieces, nephews and cousins; and the entire staff of the RCSO, which he considered family.

The family requests memorials be sent to the Reagan County Sheriff's Office D.A.R.E. program.

livestock. Carcasses may also appear bloated and appear to decompose quickly.

Livestock or animals displaying symptoms consistent with anthrax should be reported to a private practitioner or TAHC official.

"The TAHC will continue to closely monitor the sit-

uation for possible new cases across the state. Producers are encouraged to consult with their veterinary practitioner or local TAHC office about the disease and about preventative measures such as vaccination of livestock," said Dr. Dee Ellis, state veterinarian.

# CRP Highly Erodible Land Initiative continuous sign-up announced

Jed Hruska, Executive Director for the Reagan-Upton-Irion-Crockett County USDA Farm Service Agency (FSA), announced that continuous sign-up for the Highly Erodible Land Initiative under the Conservation Reserve Program (CRP) started on July 23, 2012.

Texas received a total allocation of 50,000 acres.

Offers will be accepted until either the state acreage allocation limit is reached or Sept. 30, 2012, whichever occurs first.

"CRP is a voluntary program that has protected environmentally sensitive land for more than 25 years," said Hruska. "This initiative will accept offers with an erosion rate of at least 20 tons per acre per year for new cropland or CRP acres that expire on September 30, 2012; however, existing grass stands that are not considered expiring CRP will not be considered eligible," he said.

Producers can stop by the Reagan-Upton-Irion-Crockett County FSA office to determine if their land qualifies for the Highly Erodible Land Initiative and to receive additional location-specific details.

Landowners enrolled in CRP receive annual rental payments and cost-share assistance to establish long-term, resource conserving covers on eligible farmland.

Incentive payments are not authorized under this initiative.

New land contracts approved during this continuous sign-up initiative will become effective the first day of the month following the month of approval and are valid for 10 years.

CRP contracts set to expire on Sept. 30, 2012, may be offered for consideration and approved contracts will become effective Oct. 1, 2012, and are also valid for 10 years.

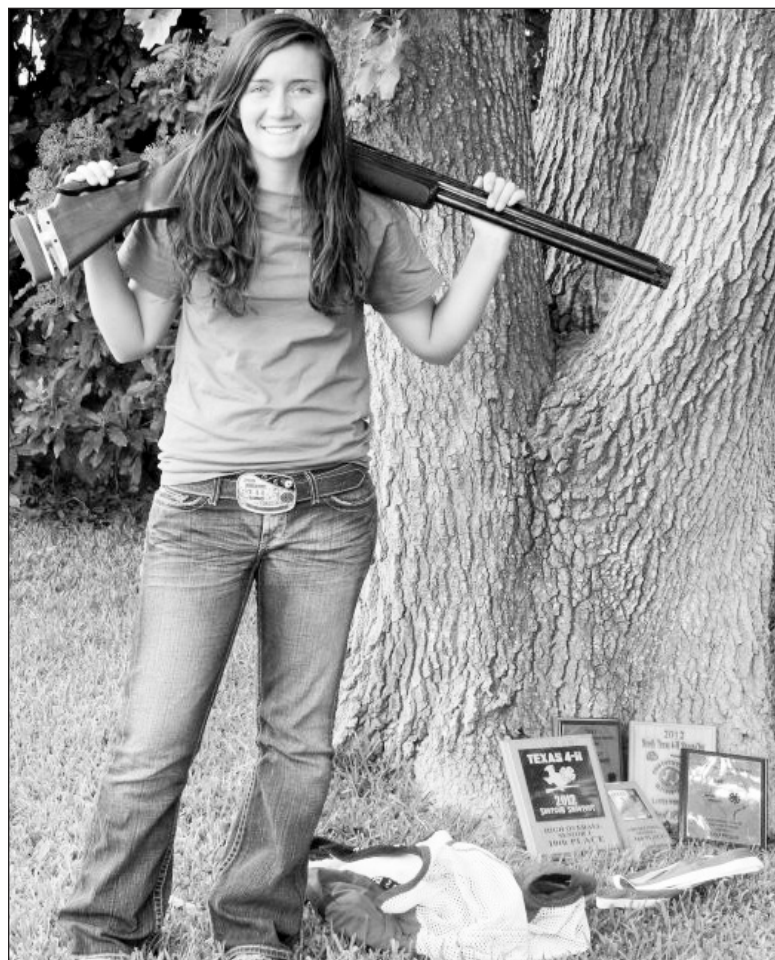

Dr. Kyle Janek as executive commissioner of the Texas Health and Human Services Commission, effective Sept. 1, and announced Chris Traylor will serve as the agency's chief deputy commissioner.

Texas Health and Human Services Commission oversees the state Medicaid program and the operations of five state agencies that employ more than 55,000 employees and have a combined annual budgets of more than \$30 billion.

Janek a medical doctor and an anesthesiologist replaces retiring Tom Suehs at the post. Janek was a member of the Texas Legislature, serving in the House of Representatives from 1995 to 2002 and 2003 to 2008. Traylor has served as commissioner of the Texas Department of Aging and Disability Services since 2010.

Controlled substance prescription dispensing history is made available under the program to authorized health care and law enforcement professionals, the DPS said.

When the program was officially launched in June, the database was available only to a select group of practitioners, pharmacists and law enforcement professionals, but last week, access was extended "to additional physicians and law enforcement, mid-level practitioners, medical board and nursing board investigators," the DPS said.

In 1982, the Texas Legislature created the original prescription drug-monitoring program, the Texas Prescription Program, but access was through a manual paper process.

**VETS' LOAN RATE LOWERED**  
Texas Veterans Land Board, a division of the General Land Office created in 1946 to help returning World War II veterans, voted Jul 26 to drop interest rates on land loans to 6.75 percent.

The previous rate was 7.25 percent. Under the loan program, veterans may borrow as much as \$100,000 to buy land and up to \$417,000 to buy a home.





The Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning; and NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Crockett County, Texas, that outdoor burning is restricted in Crockett County for 30 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 352.081, and other applicable statutes. This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on hand. This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times. In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.
