Two Ozona Lions were named to the San Angelo Standard-Times Class 1A All-West Texas Football Team.


At defensive lineman, Jerrod duBois was a menace to opposing offenses, registering 46 tackles, six sacks and five caused fumbles for the Lions.

OHS teacher defends position on concealed handgun issue

Dear Editor,

I have read the citizen commentary under the Ozona Stockman status update about my speaking in favor of authorizing and training teachers to be able to carry a firearm on a school campus for the protection of our students and faculty. I want to respond to some of the things that I've seen posted by citizens in CCCCSD and in doing so, I would also like to remind you that I do not represent the district with this opinion. The thoughts and remarks below are solely representation

of my personal beliefs, as a citizen of this county.

One citizen stated that he'd rather have "well trained guards" in the school. Another stated that "The idea of having armed guards sound better than armed teachers." Numerous other citizens made similar comments

If CCCCSD opted to go the route of a school resource officer I believe that they would pay a minimum of \$30,000 for the services of that individual. For that price, you could train and certify approximately 30-35 teachers to be prepared to handle any threats that appear on a campus.

So let's analyze that. Thirtyfive trained teachers throughout the district that are spread out, or one school resource of ficer? I'm inclined to believe in the old saying "strength in numbers.

Jessica Phelps stated that: "[steps on soapbox] Personally, I don't think this is the answer. Teacher's aren't and won't be trained like police officers. The only clear option I see is to put law enforcement in schools.


The lessons I was taught at home, at school and at church were all the same. Be good stewards of what God gave you, whether it's your land, your home or your finances.



The tax package stopped incredibly high tax increases for most Americans.

It also included new permanent amounts for the death tax. Estates worth \$5 million or less per person (\$10 million per couple) will be exempt from the death tax. Estates worth more than that will pay a 40 percent tax on anything over the exemption level. As an added benefit, these levels are indexed for inflation and also include a stepped-up basis.

This isn't perfect. We would have liked to see the death tax go away forever. But it is better than the alternative, which would have been a 55 percent tax on anything over a \$1 million per person (\$2 million per couple) exemption level. These levels would have crushed small ranching families.

The package also extends the 2008 Farm Bill until September 2013. Again, this isn't perfect. This shortterm fix gives extreme animal activist groups more opportunities to target the livestock industry, and while we have been successful holding them off in the past; we will have to continue to work hard to keep them from harming the cattle industry in the next farm bill.

Ranchers would have much rather seen a fiscally responsible 5-year farm bill signed into law. A 5-year

ting spending cuts. Many reports suggest that federal spending was decreased by only \$1 for every \$40 of new revenue generated.

As a rancher and a banker this just doesn't add up. Unless, of course, you're charging the additional \$4 trillion to a national credit card that's debt limit is already maxed out at \$16 trillion.

Even though Congress did address some of the tax issues, they missed a golden opportunity to take a responsible approach to start getting our country out of debt.

Congress has said they will address spending cuts soon when they face yet another fiscal debate. this time over whether they should raise the debt limit and what to do about the automatic spending cuts scheduled to take effect.

Republicans have said they will cut spending. Democrats, including the President, have pledged to raise the debt limit and continue "investing" in government programs. Clearly the two have different ideas.

If they want my advice, I'd invite them out to the ranch, cook them a steak, and show them some simple ranch arithmetic.

Texas Legislature enters 83rd session

STATE CAPITAL HIGHLIGHTS By Ed Sterling | Texas Press Association

AUSTIN — After passage of the American Taxpayer Relief Act of 2012 by Congress on Jan. 1, "98 percent of Americans and 97 percent of small businesses will not see their income taxes go up," President Obama said. The act, signed by the

president on Jan. 2, extends unemployment benefits for 2 million Americans who are looking for work, makes no cuts to Social Security and Medicare and expands Medicaid benefits. But the Act postpones Congressional action on budget "sequestration" for two months, leaving question marks over the accounting and social intricacies of how much to cut or tweak entitlements and how much revenue to raise. So, the shortand long-term impacts on states remain unclear.

Dynamics of decisions made at the federal level add to the complexity of deliberations state lawmakers enter Jan. 8, when the 83rd session of the Texas Legislature convenes. Systemic state budget deficits in recent years have left Texas unable to avoid shortfalls. In 2011, Texas resorted to using federal "stimulus" dollars to overcome a \$6 billion deficit. In 2012, sales tax revenues flowed in at healthier rates, and the state comptroller soon will release her biennial revenue estimate, giving lawmakers some idea of how much cash they will have to meet the needs of Texas.


Thirsty constituents, cattle, crops, industry are sure to be addressed this session. Widespread and chronic lack of water pose problems looking for legislative solutions. And yes, Gov. Rick Perry on Dec. 28 extended his drought emergency proclamation of

July 5, 2011, to a majority of Texas' 254 counties.

Those multi-billion dollar cutbacks on education in the 82nd session of the Legislature will be addressed, and so will Medicaid. If Texas refuses to meet the required match to receive federal Medicaid funds by rejecting the Medicaid expansion, the Lone Star State could lose billions of federal dollars.

To that, Gov. Perry stated in a newspaper editorial published in July: "We have no interest in following the federal directive to expand our Medicaid ranks by over a million (people), and we are also rejecting calls to establish a so-called 'state' insurance exchange designed and ruled by federal guidelines, many of which have yet to be written. Neither of these is the proper role of the federal government and both represent brazen intrusions into the affairs of states."

Even if the Texas Legislature passes health care reform to cover more of its lower-income and older residents, the governor wields the veto pen. It takes a two-thirds vote in each house of the Legislature to override a veto. PLEASE SEE STATE, PAGE 6



Officers go through extensive background checks. mental health checks and training. I doubt teachers and staff will have much more than a CHL to qualify to carry these handguns. However, I understand that is also lose-lose situation. There is already such a storage of cops and a budget cut in schools so no one is going to create extra salaries. Maybe someday we'll have a country (and state) that figures out its finances and the importance of not cutting education. [steps off].

Teachers also go through extensive background checks. We are also mandated by the State of Texas to be fingerprinted. Not many jobs have a requirement as strict as that. Again, even she is able to realize the lack of financial feasibility that exists within the suggestion of placing police officers in the school.

Sandra Santiago Reyes said: "What's going to happen when a very angry student over powers a teacher carrying a gun then what, come on people don't be stupid! This is not what I pay taxes for."

The students in our classrooms would not allow that to happen, nor do I believe any would attempt this. I don't believe that the threat is our current students, but rather a rogue shooter that enters along I-10. Further, it has

staff and held drills for various threats (like CCCCSD). Did any of that work? Not completely.

Sara Mayfield Grannis said: "Not sure I like this one. We already have a local officer that walks through our elementary school every morning, which is cool since her kiddos are there too, an ex cop at middle school, and our sheriff is always at the high school. With all the new security features of our elementary, I think they are pretty well protected. Parents have to teach at home as well. Keep it locked up. Just my opinion. I really wouldn't be surprised if a number of our school staff is already licensed to carry a concealed weapon."

The only time I regularly see the sheriff at the high school is in the morning and afternoon, when the school zones are in effect. Other than that, he has an entire county that he has to look after and can't spend his whole day at the schools. Again, reference the above information regarding the security that Sandy Hook had, exactly the same as OES. To your other point, even if our staff is licensed to carry it is still illegal to have that weapon on the campus, according to current laws and policies, which is why I'm asking the board to make a policy change

That should address the majority of negative opinions towards this suggested policy change.

Why do shooters pick schools? Because it is the easiest way to do the most damage, as the shooters pass the 'gun free zone' signs on the way in.

I hope this isn't too longwinded, but I feel as though it is very important for the people that say "no" to this to understand that an emergency binder and a locked door will not stop a shooter.

You have to have windows in school in the event of a threat of fire... so before people suggest that we get rid of windows... keep that in mind.

The only thing that I seek in pushing this issue is a better way of keeping your children safe. Whether the board and administration pursue this policy and later choose me as a "guardian" is not important. I just hope that by pushing for this it will allow for a few trusted, trained, and prepared employees, help defend our school in the event of a tragedy.

the second part of the first sentence, or prohibiting the free exercise thereof. This means if you are a Christian you can pray wherever you chose. 

BENEFITS EXTENSION GRANTED

Pursuant to the passage of the federal Taxpayer Relief Act, the deadline for jobless Texans to qualify for emergency unemployment insurance benefits was extended to Jan. 1, 2014, the Texas Workforce Commission announced.

Those benefits extend to some 120,000 Texans who would have exhausted their unemployment benefits on Dec. 31, but not for those who already exhausted their regular state unemployment benefits, federal Emergency Unemployment Compensation, and Extended Benefits, the agency said.

Emergency unemployment benefits provide temporary income for those who have lost their jobs through no fault of their own. Benefits are federally funded, and Texas employers will not be charged for any claims paid on this extension.

SPILL SETTLEMENT **IS REACHED**

Transocean Deepwater Inc. defendants have agreed to pay \$1 billion in civil penalties and \$400 million in criminal fines for April 20, 2010, Gulf Coast oil spill originating from BP's Macondo well, widely known as the Deepwater Horizon oil spill.

But recovery efforts have just begun and "there remains a long road ahead to restore the Gulf," Texas Commission on Environmental Quality Commissioner Toby Baker said on Ian. 3.

Transocean is based in Zug, Switzerland. The fines are to be paid over a period of three years, per agreement with the U.S. Department of Justice.

CAPPED WELLS AMONG PLUSES

Texas Railroad Commission, looking back on its accomplishments in 2012, noted that its agents "investigated, assessed or cleaned up 253 abandoned oilfield sites and plugged 764 orphaned wells using fees paid by the industry into the Oil & Gas Regulation & Cleanup Fund."

WATER- USE FIGURES ARE IN

A study by the Texas Water Development Board concludes "31 percent of annual singlefamily residential water use in Texas is dedicated to outdoor purposes, such as lawn and garden maintenance, pools, and car washing, with the rest used indoors."

In a Dec. 17 release, the agency stated the findings are based on an analysis of monthly water use data for 259 cities, and that average outdoor water use ranged from 20 to 53 percent of total household water use, with dryer areas of the state tending to use more than wetter areas.





The Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning; and NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Crockett County, Texas, that outdoor burning is restricted in Crockett County for 30 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 352.081, and other applicable statues. This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on hand. This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times. In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.
