## Lawsuit over road funding program leaves funds in limbo

A dispute over how to distribute \$225 million earmarked for road repairs in Texas oil field counties could force officials to let the money sit idle for months.

LaSalle County, a South Texas community in the heart of the Eagle Ford Shale, recently filed a lawsuit against the Texas Department of Transportation over the County Transportation Infrastructure Fund Grant Program. The suit, filed in Travis County court, accuses the agency of ignoring state law in distributing the funding.

"There are a number of counties that have been funded that aren't in shale plays," LaSalle County Judge Joel Rodriguez Jr. said. "All the rules state that the intention is to

## EPA air pollution plan sparks reactions

increasing energy efficiency and reducing demand in the electricity system, while creating tens of thousands of jobs across the country."

But Perry said the air Texans breathe today "is cleaner than it was in 2000, even as our population has grown by nearly 5.2 million people" and "statewide, from 2000 to 2012, nitrogen oxide levels from industrial sources were reduced by 62.5 percent and from 2000 to 2012 ozone levels were reduced by 23 percent, a 12 percent greater reduction than the national average."

However, the Obama administration pointed out that governors would have "flexibility to meet the proposed standards using the energy sources that work best for each state" and, "there's no one-size-fits-all approach here."

Along with its plan to reduce carbon pollution from power plants, the White House posted a fact sheet for Texas and one for each of the other states. The Texas fact sheet includes details under such headings as: A Cleaner More Efficient Power Sector in Texas, Improving the Health of Texas Residents, and Cutting Carbon Pollution in Texas.

State Sen. Rodney Ellis, D-Houston, praised the Obama administration's proposed EPA rules, saying, "There is an urgent need to act, and the President has answered the country's call. My preference is that Congress would act, but we all know that's not going to happen."

"Climate change is already here: the country's 12 hottest years on record have come in the last 15 years and Texas

is in the midst of one of the worst droughts in recorded history," Ellis continued. "If we want to leave our children and grandchildren a safe and healthy environment, we've got to limit carbon emissions - just like we've done with arsenic, mercury, and other pollutants," Ellis added.





The freshman class of Ozona High School took a trip to Junction on May 14 for the 4th annual Anti-Drug Rally. The Ozona Freshmen were joined by other freshmen from Junction, Menard, Paintrock, Brady, Sonora, Lohn and Mason.

Students welcomed four amazing speakers. The speakers were Jessica Gonzales from New Beginnings of San Angelo, Brian Ogle, Sean Carter and the Rev. Jim Barker. Around 400 students listened as these speakers spoke of making good choices in life, how drugs have affected their life and how one night can change your life.

Jessica Gonzales spoke on sexting and domestic violence in dating. Her presentation introduced information about the reasons for violence in dating. Gonzales stated that 1.5 million teens stated they were in a violent dating relationship this year. The average age of these teenagers was the age of 15. Feb. 11 is the national day for violence in dating relationships and the color for this is orange. Her informative speech gave the students many facts and useful tips in learning how to spot types of violence in dating relationships.

Brian Ogle's story started in Florida where his father was a preacher of a small church. He was offered his first joint (marijuana) when he was 11 years-old. Ogle stated that this was the start of his 17year addiction to drugs.

He was asked to join a gang at the age of 13 which was done by having 13 people beat of you for one minute. This new life in a gang was very demanding. He was ordered to do his first shooting at the age of 15 which did not end in any casualties. He was then asked to do a second shooting later that year which also did not end in any deaths but did hurt the person.

He never knew how badly that person was hurt as he ran off after he shot. Ogle started selling crack and marijuana at

### Farm Service Agency County Committee nomination period begins June 15

Agriculture Secretary Tom Vilsack announced today that the nomination period for local Farm Service Agency (FSA) county committees begins Sunday, June 15.

"County committees are a vital link between the farm community and the U.S. Department of Agriculture," said Vilsack. "I hope that every eligible farmer and rancher will participate in this year's county committee elections. Through the county committees, farmers and ranchers have a voice; their opinions and ideas get to be heard on federal farm programs."

Vilsack added, "We've seen an increase in the number of nominations of women and minority candidates, and I hope that trend continues."

To be eligible to serve on an FSA county committee, a person must participate or cooperate in a program administered by FSA, be eligible to vote in a county committee an eligible individual must sign the nomination form, FSA-669A. The form and other in-

formation about FSA county committee elections are available at www.fsa.usda. gov/elections.

Nomination forms for the 2014 election must be postmarked or received in the local USDA Service Center by close of business on Aug. 1, 2014. Elections will take place this fall.

While FSA county committees do not approve or deny farm ownership or operating loans, they make decisions on disaster and conservation programs, emergency programs, commodity price support loan programs and other agricultural issues.

Members serve threeyear terms. Nationwide, there are about 7,800 farmers and ranchers serving on FSA county committees.

Committees consist of three to 11 members that are elected by eligible producers. FSA will mail ballots to eligible voters beginning Nov. 3, 2014. Ballots are due back to the local county office ei-



the age of 16. He then moved to Kansas with his father. It did not take long for him to find drugs and get back into selling them in Kansas.

He graduated and lived with his parents all while still doing drugs and selling them for a little bit of spending money. He tried joining the military until one night the opportunity to drink some vodka arose and he took it not thinking it had any consequences. He was kicked out of the military shortly after. He lived with addiction for 17 years until he did time in jail and turned his life over to Jesus. His main focus of this speech was that a person makes an average of 1,500 choices in one day and any one of those decisions can affect your life.

The third speaker is a man who started his life as a normal twin brother who went to college and was striving to become a real estate lawyer. He lived his life as any other college student would. He worked hard and played even harder. He started drinking in high school but never realized how much alcohol could affect his life until one Saturday night. He allowed his friend to drive whom had also been drinking in excess. One minute they are in truck and the next minute he was in a hospital bed waking up from a 39-day coma.

He had suffered Traumatic Brain Injury, known as TBI. He lost all movement and speech. Sean Carter has lived with TBI for 9 years and his only way of communication is now through an IPad which translates his typed words in to a computerized voice. He talked about how his life has drastically changed and how his mother has given up her life to care for him 24 hours a day.

He has recently been funded by Texas A&M and can now go from town to town and give speeches to educate others about the dangers of driving while under the influence and how TBI has changed his life.

### **Commissioners approve fireworks**

During Monday's regular meeting, the commissioners agreed to keep the countywide burn ban lifted. They would evaluate again at their next regular commissioners' court meeting.

The commissioners also approved restricting sales of aerial fireworks, such as bottle rock-"skyrockets with sticks" ets. and "missile's with fins."

The State of Texas order states that no person may sell, detonate, ignite or in any way use these types of fireworks. Violation of the order is a Class C Misdemeanor.

Firework sales will be allowed for the Fourth of July with the restrictions. It does not prohibit common fireworks, small in size.

In the past, the commissioners have approved the sale of fireworks with these restrictions.

#### WELLNESS CENTER

Shirely Kirby with the Crockett County Health and Wellness Center organization asked the commissioners if they are planning on extending the agreement on the property where the north pool was formerly located.

In November 2009, the commissioners approved a resolution to establish a Crockett County Health and Wellness Center in setting aside the land where the original north swimming pool located. The land will be reserved for five years to give members of the Health and Wellness Center Board time to raise money for the center.

The five years will be up in November. During the fiveyear period, the organization has raised around \$60,000.

give money to counties with increased energy production."

Crockett County is set to

receive nearly \$2 million in funding for county roads. During Monday's commissioners' court meeting, County

lines, which has led to ineligible counties being awarded grants. Specifically, the lawsuit contends that the agency ignored language that requires that grants be awarded to "areas of the state affected by increased oil and gas production." The lawsuit also alleges that most of the counties that applied for the grants did not submit "road condition reports" that were required under the statute. "The Legislature's award, once chopped into 191 unequal pieces, will be of only blunted impact in those regions, such as La Salle County, whose roads have borne the heaviest load of the Texas energy boom," the lawsuit states. Kaufman said TxDOT was limited in how it could comment on the issue because of the ongoing lawsuit. "We can confirm TxDOT followed the letter of the law, and the Legislature's intent, by providing a formulaic distribution to counties impacted by increased energy sector traffic," Kaufman said. State Sen. Carlos Uresti, D-San Antonio, who authored SB 1747, said he believes TxDOT was following the law correctly. While his bill as originally proposed would have targeted the funding on counties most impacted by energy development, the version that passed was changed to make more counties eligible for the

funding. The changes were needed to persuade legislators to break from long-standing tradition and allocate funds for county road projects, he said. Uresti's district includes Crockett County.

"In order to pass the bill, I had to get the votes, and that involved me in broadening the language of the bill," Uresti said. "Since this is the first time this has ever been done in at least 50 years, I thought it was a pretty good start."

OHS VALEDICTORIAN VIVIAN MEDINA received a certificate from Texas Attorney General Greg Abbott and a Texas flag that was flown over the State Capitol on May 30, in honor of OHS Graduation Day.

Judge Fred Deaton said the Texas Department of Transportation is not going to disperse any of the funds until they have figured out the lawsuit.

The Legislature approved the program last year to address county roads affected by energy development, particularly those counties in South and West Texas seeing the most drilling activity.

Senate Bill 1747 directed TxDOT to distribute \$225 million to counties through a grant program. Of the state's 254 counties, 191 applied for a portion of the funding, identifying more than \$1 billion in road improvements.

In April, TxDOT announced plans to distribute the money to all 191 counties. While shale counties in South and West Texas are receiving among the largest grants, some officials have questioned why millions in funding are being distributed to counties in other parts of the state.

"We certainly feel comfortable with what we've been allocated. We know other counties in the state of Texas need money to repair their roads," Deaton said.

TxDOT spokesman Bob Kaufman said none of the \$225 million in funding has been distributed yet.

"The lawsuit filed by La-Salle County could slow down, or stop, all usage of these funds, depending on how the court rules," Kaufman said.

The lawsuit argues that TxDOT is refusing to fol-





Uresti said he hoped to address the energy sector infrastructure problems more forcefully in the 2015 legislative session.

In the meantime, he hopes the lawsuit is resolved quickly so that the \$225 million, which he described as a "Band-Aid," can begin improving roads around the state.

"If TxDOT is not able to distribute these funds, it's almost as if LaSalle is pulling that Band-Aid and that doesn't help anyone," Uresti said.

Rodriguez said the final version of Uresti's bill was "a beautiful bill" that was not being properly administered.

"We've been open to Tx-DOT, and they just don't shoot straight," Rodriguez said. "They've made rules they haven't followed or won't show you how they're coming up to their own logic.'





Attorney General Greg Abbott on June 4 announced Texas and 43 other state attorneys general secured a \$105 million agreement with drug maker GlaxoSmithKline LLC.

The agreement resolves a multistate investigation against the company for unlawfully promoting its asthma drug Advair and its antidepressant drugs Paxil and Wellbutrin.

Under the settlement agreement, GlaxoSmithKline must pay the State of Texas a total of \$6.2 million, Abbott said, pointing out that the drug maker violated state consumer protection law by misrepresenting the uses and qualities of the three named
