Sheriff makes statement about deputy investigation

Crockett County Sheriff Robert Rodriguez issued a statement last week pertaining to an investigation of one of his deputies.

Rodriguez said that there is an ongoing investigation being conducted with an outside agency, and that the sheriff's office is cooperating fully with the outside agency.

Rodriguez said the officer has been suspended pending the outcome of the investigation.

"I believe you are innocent until proven guilty. Where this investigation leads, I don't know," Rodriguez said. "The officer is not a bad officer, he just made a mistake."

The Ozona Stockman made numerous attempts to contact the Texas Rangers, the agency doing the investigation, as well as submitting a public information request to obtain court documents

BOND ELECTION

The \$3 million school bond election also passed in the Nov. 4 election. The bond passed 574-264, or 69 percent in favor and 31 percent against.

The next step is the sale of the bonds, which will be discussed at the Dec. 10 board meeting.

Market research is important for new businesses

Market research is one of the most important activities that someone wanting to open a small business can do. A lot can be learned about a given market and when analysis of the research is properly done, the prospective business owner can make that go or no-go decision.

There are two overall types of a market: the total market and the target market. The total market is everyone in the market area that has a dollar to spend. Not everyone with a dollar to spend is a potential customer though. The tar-

get market is that portion of the total market that had a need or a desire for your product or service.

For example, if you own a car or truck, then you belong to the target market of a tire store. To own or operate a car or

truck, you have to be of a certain age. So we could begin to define a tire store's target market as people over 16 years of age that own or operate motor vehicles. This is still a broad description of our market. Depending on the type and cost of tires we want to sell, it would be important to know how many potential customers make up the target market and what percentage of them are likely to buy the kind of tires we want to sell.

All of this is important because it can help us determine

if there will be enough demand for our business. If the target market is too small, the tire store may need to adjust its offering to include a broader range of products or services.

Often times, businesses open and assume that market will not change and their product or service will be available forever. They fail to consider that their target market might change or shift. Or, they fail to keep up with technology and are no longer in demand.

At one point in time, you bought music on vinyl discs or

cassette tapes. There were record stores everywhere. Today, you can still buy music in a store, but only on a compact disc. However, it isn't the most popular way to buy it anymore. With the Internet and digitalization of music, you can download it to an electronic player and never leave home. The record and cassette store of the past is out of business if they didn't adjust with technology.

The business owner needs to keep up with new innovations in the industry within which they operate and with the de-

mands of their target market. Because of that, market research is not just a one-time activity. It needs to be completed on a recurring basis to insure the product or service offered by a business is relevant and in demand.

When did you last complete a market analysis? Maybe it's time for another one if you are experiencing stagnant sales.

Seeing the news - from every angle - is necessary to report it

Things are not "looking up" when it comes to our ability to "look down" or just around to keep an eye on what our police and other authorities are doing.

In several high-profile incidents and elsewhere, police have moved to block the public from effectively seeing what they are doing at scenes. Those actions put First Amendment freedoms - speech, assembly, petition and free press - literally on the line.

Police stifled coverage by reporters and photographers in Ferguson Mo., and in New York City by blocking access on the ground, and by creating "no-fly zones" banning news helicopters from reporting on public demonstrations and altercations.

In some cases, authorities have cited safety concerns, but a report by The Associated Press recently cast doubt on the real reason for the no-coverage zone around Ferguson, Mo., last summer.

Make no mistake: While the issue is framed in terms of police and "news media," the view being blocked is yours and mine and that of our fellow citizens.

According to the AP, federal aviation officials agreed to a local police request for a "no media" zone of 37 square miles around Ferguson, Mo. for 12 days last August. AP uncovered audio tapes showing that the so-called "safety" zone was really intended to keep news helicopters away during a time of street protests.

While police denied that intent, AP's report included audio segments that would appear to leave little doubt: "They finally admitted it really was to keep the media out," said one FAA manager about the St. Louis County Police. "But they were a little concerned of, obviously, anything else that could be going on." At another point, a manager at the FAA's Kansas City center said that police "did not care if you ran commercial traffic through this TFR (temporary flight restriction) all day long. They didn't want media in there."

There's history here: In 2011, New York City police banned news helicopters - as well as reporters on the ground - from the vicinity of a small park where the national "Occupy" move-

ment had set up its headquarters.

The few reporters on scene, as quickly as they could be identified, were escorted to locations blocks away.

Lest we think attempts to restrict news coverage are rare, one need only scan for the all-too regular incidents in which journalists and others are accosted and often taken into custody for simply taking photos of regular police activity happening out in the open. Go to the other end of the spectrum and consider the ongoing flap over the White House's persistent attempts to exclude press photographers from events, with "official" photos offered as replacement.

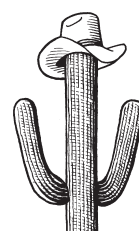
The nation's founders provided constitutional protection for a free press in large degree to provide an independent entity to observe and report on our public officials and the work that they do. You cannot be an effective "watchdog on government" if you're kept penned in the official doghouse, or shut out of the public yard.

Disturbingly, the efforts at censorship occur even in the most benign circumstances. Reports say that two Lindenwood University student reporters were questioned for more than 90 minutes by more than a dozen St. Louis Metropolitan Police Department officers and detectives who saw the students filming department patrol cars from a public sidewalk. The department is investigating the incident, according to St. Louis Police Chief Sam Dotson, responding to a Nov. 1 letter from the university.

Perhaps that investigation should expand to include at least the Ferguson police officials behind the "no-fly" zone, and start with this question: When did the "Show Me" state motto get edited to include the words "... except for this or that!"?

The much-dreaded morning arrived and I was in a funk. Even though I'm prone to being that way, this day was especially depressing for it was the day of the last sale ever to be held at the Templeton Livestock Market. The owners, friends of mine, had sold the property and the land will soon be planted in houses. I don't blame them, I'd have probably taken the cash too.

We had been expecting this day for a long time but the sale of the property was held up by a lawsuit. It seems the neighbors went to court to stop the sale of the land because they'd grown to love "their" sale yard. These were the same people who years ago moved into the new neighborhood and then complained about the noise and the dust of the auction barn which had been there for 70 years. Now they were especially upset because it was being torn down to make way for houses. It seems they preferred cows to people after all.

In the past, whenever you said, "I'm going to Templeton," everyone knew you were referring to the auction market, not the town of the same name. Although the town always has been a very agreeable place where people are real people, if you know what I mean. And while it's true that I've only been to two of the seven continents, I'd have to say that Templeton is truly one of the greatest places on earth.

Templeton was the unofficial cow capital of my county, home to three cows per person, and the only sale yard left within

200 miles. At one end of town was the sale yard and at the other was the feed and grain mill. Templeton has one way of entering and one way of leaving and I've never altered that routine in 41 years of going there.

I think I've worked every bull sale they ever had and bought cattle, been a consignor and fed cattle out back in a small grow yard they had. Next to the sale yard was a roping arena where I worked horse sales and went to "play days". Hoover's restaurant was also on the grounds, a staple of simple food and a popular destination for the town folk. They used to sell 100,000 head of cattle a year at TLM and it was the home of the World Livestock Auctioneer Championship in its heyday. Dean Schow of Paxton, Nebraska, was named the winner that year and I'm so glad he became a good friend of mine. Like TLM, he was real easy to like. I'm sad to say Dean died a few months ago... there seems to be a lot of that going around. And now the auction market has breathed its last breath too.

At the last auction ever held at TLM I worked ring for the bull sale and when I looked up into the crowd it hit me that this was the last time I'd ever see many

of these fine folks who had become my friends. It felt like a funeral. Old timers greeted me with a lump in their throats and Randy Baxley, who grew up at TLM and ran the sale yard, but did not own it, almost broke down as he fine-tuned his going away speech. He and his wife Beth lease another yard at Visalia and are wonderful people.

It was such a large crowd there wasn't room for everyone inside the sale barn. We had all come to say our final goodbyes and to make the day a special one. No one wanted to leave, or for the day to ever end. The top three bulls that day were the three highest selling bulls ever sold at TLM. We all did her proud on her final day.

I suppose it had to come to this. The sale yard was standing in the path of an onslaught of people. Now Templeton town is growing up and I suppose before long it will either have a prison or a casino. Signs of what passes for progress these days.

The last animal ever sold at the Templeton sale barn brought more than seven dollars per pound, as if it was for a county fair junior livestock exhibitor battling cancer. On the morning after the last day I couldn't help thinking that the consignor who owned that last animal sure was lucky. As were we all to have known this wonderful grand dame who took her town's personality and identity with her when she left.

Spigot is open: Flow of legislative bills, resolutions begins

AUSTIN — On Nov. 10, dozens among Texas' 31 state senators and 150 state representatives, including a few members-elect who won't be sworn for nearly two months, jumped right in and filed legislative bills in advance of the 84th regular session of the Texas Legislature, which convenes on Tuesday, Jan. 13.

In all last week, 316 House and 170 Senate bills, proposed constitutional amendments and commemorative resolutions were filed. These are samples of the subject matter in those early-filed bills: acceptable forms of voter identification, use of a portable wireless communication device while operating a motor vehicle, repeal of the franchise tax, property tax reform, minimum wage increase, changes regarding the offense of student hazing, and free pre-kindergarten in public schools. The bill-filing deadline is the 60th day of the session, March 13. By

then, lawmakers likely will have filed more than 10,000 bills and resolutions.

In other news, Sen. Glenn Hegar, R-Katy, who was elected state comptroller on Nov. 4, announced he will resign from the Senate effective Dec. 5. Gov. Rick Perry set Dec. 6 as the date for a special election to fill the seat opened by Hegar's departure. State Rep. Lois Kolkhorst, R-Brenham, is in the race for the seat. Kolkhorst is chair of the House Committee on Public Health and a member of the House Committee on County Affairs. Others candidates for the seat are expected to file declarations soon.

NEW EFFORT TO HELP VETERANS

A pilot project, the Texas Veterans Initiative, will allow a \$1 million investment by

the state to match local and private funds to expand and evaluate community-based mental health programs serving veterans and their families.

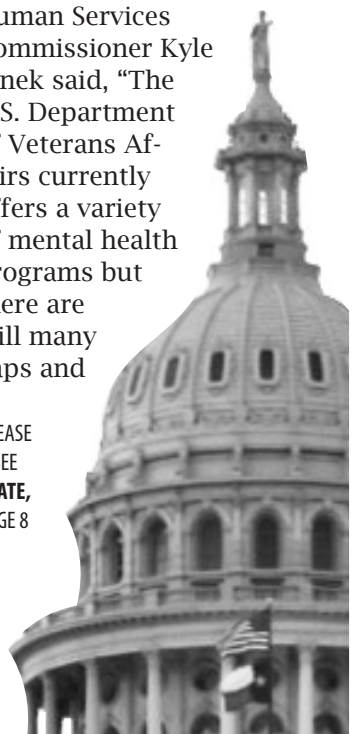
In a Nov. 10 announcement, Gov. Rick Perry, Lt. Gov. David Dewhurst and House Speaker Joe Straus said that if the pilot phase generates widespread interest from communities around the state, the Legislature could act in 2015 to expand it. The project will be funded through the budget of the Texas Health and Human Services Commission.

"This project brings communities together to provide better outcomes for Texans who served our country in uniform," Straus said. "It's a smart, effective way to address an issue that affects veterans across this state. This pilot program is a very

good starting point as we head into the legislative session."

Texas Health and Human Services Commissioner Kyle Janek said, "The U.S. Department of Veterans Affairs currently offers a variety of mental health programs but there are still many gaps and

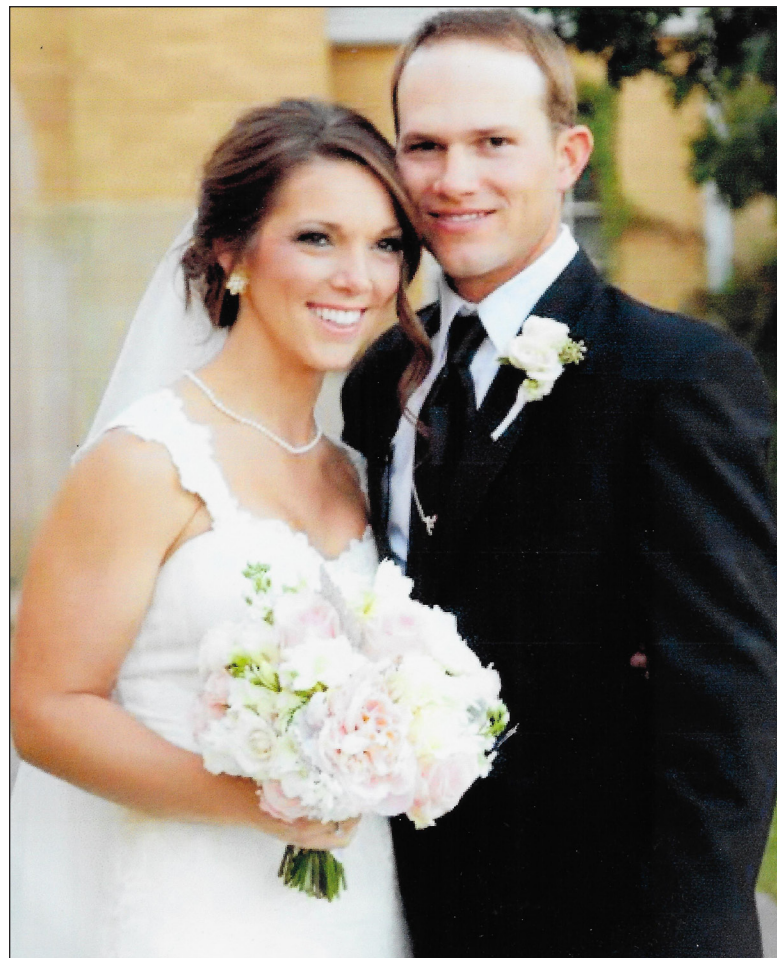

Tuesday at 7 p.m. we play Bunco. Wednesday at 1:30 p.m. there is a hot game of Mexican Train going.

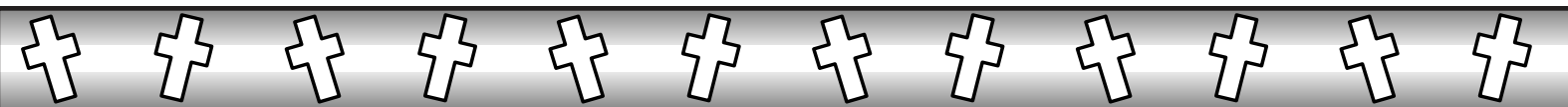
The Prayer Groups meet in the prayer room and another room at 3 p.m. and 5 p.m.

GOAL-SETTING

Chavarria said he is planning a special called meeting in January that will be a CCCCSD Goal Setting Workshop.

In the workshop, the board will formulate a five-year plan that will include campus success rates expectations, teacher and staff retention and salaries, facilities and infrastructure, community involvement and budget.

ENROLLMENT AND ATTENDANCE

Enrollment is 854 students in the district, which is up 48 students at this time last year.

Attendance average is 96.9 percent. The district's goal is 97.5 percent. State average is 94 percent.

Last spring, the group made recommendations on outside lunches at the elementary school.

"The group we have this year are interested in the health and well being of our students. We are looking at the nutrition for our kids," Huffman said. "As a nurse I don't directly contribute to our kids education, but the more I read about our nutritional needs that does play a big role in our education."

Huffman said the council is looking at starting a breakfast in the classroom pro-

gram next fall.

The program would involve all elementary students eating breakfast in their classrooms first thing in the school day.

The breakfast meals could be delivered to each room prior to school starting, perhaps using fifth grade students, Huffman said.

"Elementary kids don't have control when they get to school. This way students who are late will have something to eat," Huffman said.

Huffman said she has talked to other school dis-

tricts who have implemented the program. Breakfast will still be free to all OES students.

"We're just a society of convenience and drive-thru. We want them to be eating well at school," Huffman said. "A lot of our kids don't even have supper at night, so breakfast is even more important."

Game Warden Field Notes

COMPILED FROM TEXAS PARKS AND WILDLIFE DEPARTMENT LAW ENFORCEMENT REPORTS.

PREPARED FOR THE ZOMBIE APOCALYPSE
The U.S. Marshall's Fugitive Task Force contacted a Howard County game warden to assist with locating a suspect named in a felony arrest warrant. Once the arrest had been made, a search warrant was issued and the suspect's residence searched. Law enforcement officers found one deer rifle, two AK-47s and about 4,000 rounds of ammunition in the house. Other items found in the house included a gas mask, ammunition cans full of red beans and rice, knives, medical supplies, marijuana and a stack of \$100 bills. The suspect was charged with drug possession, possession of a dangerous drug and felon in possession of a firearm.

several vehicles, an ATV, the boat and several go karts. Using the confidential hull identification number, the wardens confirmed the boat was stolen. After some investigation, they found that one vehicle and the ATV were also reported stolen. The stolen vehicle was also reported to have been used in a recent burglary. The wardens worked with the Arlington Police Department Auto Theft Division to arrest the man and recover the stolen vehicles and boat.

SHOTS FIRED IN THE END ZONE
Last year, a Longview game warden received information about illegal dove hunting over a baited field near a football field in the Pine Tree ISD. The information included reports of shotgun pellets hitting bleachers during a junior varsity football game. This year, the game warden returned to the field on opening morning of dove season and found a group of hunters hunting over a baited field behind the stadium end zone. Because opening day fell on a holiday this year, students and players were nowhere near the field.

WEAPON OF CHOICE: SNAPCHAT
Polk County game wardens assisted the Diboll Police Department in locating an individual who sent threatening messages to school children via Snapchat, an instant messaging service. The subject was arrested for terroristic threats, a third-degree felony.

INTO THE WOODS
Five hours after his disappearance, Shelby County game wardens received a call that a man had left his house with a shotgun and entered a heavily wooded area. The wardens and other county law enforcement officers used a helicopter and tracking dogs in their search. Almost nine hours after the man went missing, the search party heard a single gunshot. With night vision capabilities, the wardens headed toward the direction of the shot, located and disarmed the man and took him into custody.

BURIED BUCK
A Rannels County game warden received a call from a landowner who had found a buck that had been shot and dragged into the brush behind a deer feeder. The warden questioned the only hunter left on the ranch and was able to exclude all but two of the hunters who had hunted that blind within the last few days. After some phone calls, a teenaged boy from Bastrop admitted that he killed the buck and hid it because it didn't meet the ranch harvest rules, and he was not supposed to shoot bucks in the first place. A Bastrop County game warden assisted in getting statements.

SANDBOX LOVE STORY
In the Red Sands/Montana Desert area in eastern El Paso County, a man lost his car and his girlfriend. The couple had gone joyriding when the car got stuck in the sand. The boyfriend then left on foot to get to the main road and call for help, since cell service was unavailable in the desert area. He headed back to the desert with two friends who had come to help, but he could not remember where his girlfriend and vehicle were. He and his friends asked two El Paso game wardens for help. After two hours of searching,

STOLEN BOAT? STOLEN EVERYTHING.
A Dallas County game warden received information from a Tarrant County game warden about a stolen boat inquiry at the Fort Worth regional Law Enforcement Office, where a man was asking about getting a title for a boat the office clerk confirmed as stolen. After several unsuccessful attempts to reach the man by phone or email, game wardens went to the man's residence, which was surrounded by a privacy fence. The wardens met the man at his fence and asked if he had a boat for sale and if they could see it. The man allowed the wardens to enter his yard, where they noticed

FACEBOOK FISH MARKET
After receiving information that a man was selling fish on Facebook, Cameron County game wardens contacted the man to set up a buy. The wardens arrived at the man's residence where he was selling the fish, including red drum, spotted sea trout, flounder and sheepshead. After the man sold the fish to the wardens, the wardens issued the man citations that included not having a retail fish dealer license, sale and purchase of commercially protected fish and possession of undersize red drum.

geographic barriers. The Texas Veterans Initiative will create an opportunity for Texas communities to come together to fill those gaps and improve the delivery of mental health services to veterans and their families for years to come.

EBOLA MONITORING REACHES END
Texas Department of State Health Services Commissioner David Lakey announced that the last person being monitored in connection with the state's three diagnosed Ebola patients would be cleared from twice-daily monitoring by the end of the day on Nov. 6. According to Lakey's announcement, some 177 people were monitored because

they had contact with at least one of the three Texas Ebola patients, specimens or medical waste. The last person being monitored Friday is a hospital worker who handled medical waste Oct. 17.

ABBOTT NAMES SECRETARY OF STATE
Governor-elect Greg Abbott on Nov. 11 announced his choice of Cameron County Judge Carlos Cascos as the next Texas secretary of state, to succeed Secretary of State Nandita Berry, who was appointed by Gov. Perry and was sworn into office on Jan. 7. Berry congratulated Cascos, expressed pride in the work she has done over the past year, said she is looking forward to serving out the remainder of her term and then returning to the private

sector.

SALES TAX REVENUE INCREASES
State sales tax revenue in October was \$2.41 billion, up 12.9 percent compared to October 2013, Texas Comptroller Susan Combs said in a Nov. 5 news release. Growth in sales tax receipts can be seen across all major economic sectors, Combs said, with notable increases from retail trade and the oil and natural gas-related sectors, plus increased spending by both consumers and businesses. The comptroller's office will send cities, counties, transit systems and special purpose taxing districts their November local sales tax allocations totaling \$723.1 million, up 10.5 percent compared to November 2013.


