A drop in oil and gas revenues means CCCCSD will be sending less money to the state.

At a June 30 budget workshop, Superintendent Raul Chavarria presented the 2016-2017 preliminary budget to the CCCC-SD School Board.

Preliminary numbers show the district is facing a \$1 billion drop in tax valuations due to decline in oil and gas.

In situations like this, the state kicks in more revenue for the district and lowers the amount that the district has to send to the state, Chavarria said.

CCCCSD is a Chapter 41 "property wealth" school district and is required to send part of its budget to the state each year.

For 2016-2017, CCCSD is looking to only have to send \$6.6 million. That is the lowest amount in the past two years. In 2014-2015 the district had to send \$14.5 million. In 2015-2016 it was \$12.6 million.

"It works in our favor. When valuations go down by so much, we don't have to send that much to the state," Chavarria said. "That is encouraging, but we do have less

#### revenue to work with.

Chavarria said by the next budget workshop the district should have harder numbers.

The board then met in executive/closed session for an hour and a half to discuss personnel and real property. No action was taken when the board reconvened in open session.

The next budget workshop is scheduled for 6:30 p.m. Monday, July 11, at the Administration Building. The meeting is open to the public.

Board members Ryan Bean, Dwight Childress and Grizz Medina were absent from the meeting.

In the May 30 edition of the Auction Exchange there was an ad celebrating the Midwest Auctioneer Roundup contest in Shipshewana, Indiana. There were pictures of the winners, contestants and one precious little three or four year old girl with her hands covering her ears. My sentiments exactly!

I've spent my adult life around auctions and I loved every minute, but I'm paying the price now. As a youngster I could hear a bug walking across the kitchen floor but I'm losing my hearing now and I know why. It was having my head right next to speakers for 43 years. I knew it would happen but what could I do? Auctions put food on our table.

My wife noticed it before I did. She'd say something and I'd reply, "Not today, maybe next week.

And then she'd yell, "I asked you if you fed the dog."

So now my standard reply to everything she says is, Huh?'

I suppose I need a hearing aid but I hear good ones can cost a couple grand and I'd rather be deaf than to spend that much money on something I can easily do without. Every time my wife says I need a hearing aid I reply, "When someone says something to me that's worth two thousand dollars then I'll get one. Until then I'll just use this antique ear trumpet I inherited from my great-grandna " (For you youngsters, an ear trumpet is a device

with a big round end that people talk into and at the other end is a narrow tube the hard-of-hearing person puts in his ear. I find mine works quite well.)

Maxine, of Hallmark Card fame, spoke for me when she said, "Never wear a hearing aid because if you do people expect you to listen to them.

I've worked with a lot of different auction-

He was going to stay in the same hotel so I invited him to drop by for a free lunch and to watch the auction. Much to my surprise he did. I took a rare break to welcome him and explain how it all worked. After one lot I explained that we had just sold four loads of cattle to a buyer participating in the auction all the way back in Nebraska.

He replied, "And I bet he heard every word."

## Supreme Court strikes down major changes to abortion law

**STATE CAPITAL HIGHLIGHTS** By Ed Sterling Texas Press Association

AUSTIN — The U.S. Supreme Court on June 27 struck down parts of the state abortion law that Texas lawmakers revised and passed in 2013.

The law's provision that physicians providing abortions must have admitting privileges to a nearby hospital and the provision that abortion facilities must meet minimum standards for ambulatory surgical centers are in violation of the Constitution, the court said in a 5-3 ruling.

Justice Stephen Breyer, author of the court's majority opinion, wrote, "We conclude that neither of these provisions offers medical benefits sufficient to justify the burdens upon access that each imposes."

Furthermore, wrote Breyer, the admitting-privileges requirement imposes an "undue burden" on a woman's right to choose, and evidence provided by the State of Texas did not show how the new law

advanced the state's legitimate interest in protecting women's health.

In her concurring opinion, Justice Ruth Bader Ginsburg wrote that the Texas law inevitably would reduce the number of clinics and doctors allowed to provide abortion services.

"Texas argues that HB 2's restrictions are constitutional because they protect the health of women who experience complications from abortions. In truth, complications from an abortion are both rare and rarely dangerous," Ginsburg wrote.

Justice Clarence Thomas, in his dissenting opinion, wrote: "This suit is possible only because the Court has allowed abortion clinics and physicians to invoke a putative constitutional right that does not belong to them -a woman's right to abortion." Soon after the high court's ruling was published, Gov. Greg Abbott said, "The decision erodes states' lawmaking authority to safeguard the health and safety of women and subjects more innocent life to being lost. Texas' goal is to protect innocent life, while ensuring the highest health and safety standards for women."

Texas Attorney General Ken Paxton said, "It's exceedingly unfortunate that the court has taken the ability to protect women's health out of the hands of Texas citizens and their duly elected representatives."


State Sen. Kirk Watson, D-Austin, however, said: "For too long, the women of this state have been collateral damage in a political battle. I'm hopeful we can now get to work on policies that truly do protect women's health, such as improved access to birth control and breast and cervical cancer screenings, as well as medically ac-

A major change in the revision now requires all food employees to complete an accredited food handlers training program within 60 days of employment, effective Sept. 16, 2016.

A food handlers course accredited by the Texas Department of State Health clude good personal hygiene, cross contamination, and time and temperature abuse.

The cost is \$20 per person and must be paid in full before the course begins.

The Devil's Sinkhole cave is a National Natural Landmark and home to Texas's fourth biggest bat colony. Every evening during bat season, a mass swarm of bats arises from the huge cave in a tornadic spiral, one of the most amazing animal swarms anywhere on Earth.

Tours are given Wednesdays through Sundays and are available by reservation. All Devil's Sinkhole tours, including the bat tours, begin at the Rocksprings Visitors Center on the Rocksprings town square. Start times for the evening bat tour vary according to bat behavior throughout the season, which runs from now until Oct. 31. During August, September, and October, morning bat return tours are also held, also by reservation.

The Devil's Sinkhole Society, the nonprofit Texas Parks friends group that operates the Devil's Sinkhole tours, also provides day tours, nature walks, and birding tours. Volunteers at the Rockpsrings Visitors Center can connect guests to the numerous nearby attractions such as Kickapoo Cavern State Park, too.



A ketogenic diet is a high fat, moderate protein, low carbohydrate way of eating that compels the body to burn ketones (beta hydroxybuterate) rather than glucose, which is converted from carbohydrate. According to Wikipedia, the free encyclopedia, "... if there is very little carbohydrate in the diet, the liver converts fat into fatty acids and ketone bodies. The ketone bodies pass into the brain and replace glucose as an energy source. An elevated level of ketone bodies in the blood, a state known as ketosis..."

In the therapeutic ketogenic diet for pediatric epilepsy during the 1920's, just enough protein was provided to maintain age and size appropriate muscle mass, along with very minimal carbohydrate and a dietary fat-toprotein ratio of 4:1. pass into glucose as source. An

a state known as ketosis, leads to a reduction in the frequency of epileptic seizures," says Wikipedia.

Despite incredible advances in our health care system today, chronic diseases such as heart disease, cancer, type-2 diabetes and obesity grow at an accelerated rate throughout the world. The growth of these and more mix-matched diseases have not been slowed by pharmacology, genetic therapy, or surgery.

Healthy Treatment News claims. "It should be obvious that the real solution for treating cancer and disease is not found in a man-made pill but rather is found in regulating the metabolic functions within our bodies.

"Western cultures today enjoy a diet rich in the delicacies that our ancestors did not consume on a regular basis such as grain, sugar, and starch. Research continues to show that sugar is the main source of fuel which feeds cancer and contributes to an inflammatory environment. Sugar essentially increases the risk for cancer and disease."

Cancer cells damage the energy producing mitochondria and lack the ability to create energy from the ketones produced by fatty acids. It is for this reason; cancer cells thrive in an oxygen-depleted environment

and feed on glucose and amino acids. Therefore, limiting glucose and the amino acid glutamine is crucial to retard the growth of, and may even destroy cancer.

Some markers of Cardio Vascular Disease (CVD) have been debated, like overall cholesterol numbers. but some are firmly established by hard scientific evidence, like triglyceride levels and HDL cholesterol.

Yes, high triglyceride and low HDL levels contribute to CVD. Triglycerides are fat molecules but eating dietary fat, as in a keto diet, actually lowers your triglycerides and raises your HDL. Eating excessive carbohydrates happens to lead to high triglycerides.

A ketogenic way of eating has many beneficial effects on hormone control, especially those relating to blood glucose, like insulin, and those relating to appetite, like ghrelin. This is especially important for overweight people, who typically lack hormone control.

Also, the lower appetite associated with the ketogenic diet leads to less consumption, in most cases, and straightforward weight loss. If you are seeking weight loss, Keto may be a great option.

# FSA County Committee nomination period

Reagan-Upton-Irion-Crockett County USDA Farm Service Agency (FSA) Executive Director Jed Hruska, has announced that the nomination period for local FSA county committees began June 15.

"County Committees are unique to FSA and allow producers to have a voice on federal farm program implementation at the local level," said Hruska.

To be eligible to serve on a FSA county committee, a person must participate or cooperate in an FSA administered program, be eligible to vote in a county committee election and reside in the local administrative area (LAA) where they are nominated.

This year, nominations and elections will be held in LAA 1, which includes all of Irion County and LAA #3, which includes the southern portion of Reagan County and southern and western por-

norities and women also may nominate candidates. To become a candidate, an eligible individual must sign an FSA-669A nomination form. The form and other information about FSA county committee elections are available at www.fsa.usda.gov/elections. The 2016 nomination forms must be postmarked or received in the Reagan-Upton-Irion-Crockett County FSA Office by close of business on

Aug. 1. Elected county committee members serve a threeyear term and are responsible for making decisions on FSA disaster, conservation, commodity and price support programs, as well as other important federal farm program issues. County committees consist of three to 11 members.

"It is important that county committees are comprised of members who fairly represent the diverse demographics of production agriculture for their community," said






