## Parents speak out about Ozona Middle School incidents

Parents addressed the CCCCS School Board about recent incidents at Ozona Middle School during a special called meeting on Jan. 27.

Crystal Ortiz spoke to the board about an incident earlier that week where the seventh grade girls were made to clean the girls' and boys' bathrooms as punishment due to the girls' bathrooms being trashed.

Ortiz said the punishment was done without the campus administrator's knowledge and without the girls being supervised.

"I am not a mom to complain about my child being punished. I have had to go through a chain of command to give my complaint. Why didn't they have to go through chain of command to issue out punishment of my child? My daughter was held accountable for something most likely she had nothing to do with. Now they need to be held accountable for their actions. This was cruel and unusual punishment and child neglect. All this has caused emotional distress and mental anguish and taunting," Ortiz told the board.

A meeting was held with parents, staff and students on Jan. 25 with OMS officials after the incident occurred. An apology letter from OMS Principal Tammy McWilliams was also mailed out to all parents of the students involved.

According to the letter, a teacher and the custodians issued the punishment.

The letter, sent by McWilliams, also stated that an apology was issued to all the girls involved and that the punishment was inappropriate.

It also stated that the restroom will be monitored by adults throughout the day, and that school staff will be reminded about appropriate punishments, which includes no blanket discipline.

"I will work with staff, students and parents to repair the trust lost through this incident and repair the working relationship we have with students and parents," McWilliams stated in the letter.

Parent Mimi Perez spoke to the board about an incident where a teacher struck a student at the OMS Gym.

Perez said the comments "man up" and "it was just a slap dude" were used toward the student after the incident, which has made the student feel embarrassed and sad.

"I know we all make mistakes, but it's learn-

ing from that mistake is what is the most important thing here. With that being said, I just want for everyone to know that I'm not here speaking out of vengeance, or spite, or even evil. That I'm here just out of love, concern and protection not just for one kid but for all the Ozona kids and the teacher. We've got to have better sportsmanship than we do and we've got to have more self-control. Considering the individual that it occurred with it needs to be handled seriously and appropriately," Perez said.

Parent Ana Knaack asked the board to consider hiring a full-time principal at each campus.

Currently, McWilliams oversees the elementary and middle school campuses. Edward Perez is the assistant principal at OMS and Vicky Munoz is the assistant principal at OES.

"I believe they are stretched thin and they need more help. I don't have an issue with that person. I think they do a great job, but I think they have too much on their plate," Knaack said. "I really believe, strongly, that you need to choose a principal for each campus. It's only fair to the students, the staff and us the parents to know where our principal is, so if we do have concerns it's easier to locate them."

The board then met in executive/closed session for 2 hours and 19 minutes to discuss personnel matters.

When the board convened back into open session, Board President Dwight Childress issued the following statement: "We would like to thank all of you for coming, and for you being interested in what your children are up to and helping us to make them better people. We would like to assure our parents that appropriate action is being taken in both those matters that you brought to us today. We will provide our students with a safe and supportive environment to go on with their education. That's the action we're taking. That's all we have to say."

Superintendent Raul Chavarria said his door is always open to those who want to discuss any school matters with him.

"Our kids are important to us and we're going to take care of them," Chavarria said.

The next regular CCCCS School Board meeting will be 6:30 p.m. Feb. 22 at the Administration Building. The meeting is open to the public.

## Hurd disagrees with Trump's wall, immigration ban

U.S. Rep. Will Hurd, R-San Antonio, has spoken out against President Donald Trump's plan to build a wall along the Mexican border and the immigration ban implemented over the weekend.

In a statement issued last week, the Republican Congressman said "The facts have not changed. Building a wall is the most expensive and least effective way to secure the border. Each section of the border faces unique geographical, cultural, and technological challenges that would be best addressed with a flexible, sector-by-sector approach that empowers the agents on the ground with the resources they need."

Last week, Trump signed the executive order to create the border wall.

In a speech to federal agents in Washington after signing the order, Trump said the measures would help restore peace and stability in the U.S. but would also benefit Mexico.

"This will also help Mexico by deterring illegal

immigration from Central America and by disrupting violent cartel networks," he said. "As I have said repeatedly to the country, we are going to get the bad ones out - the criminals and the drug dealers and gang and gang members and cartel leaders."

The executive order also calls for the hiring of another 5,000 Border Patrol officers and tripling the number of U.S. Immigration and Customs Enforcement officers currently employed by the federal government, he said.

"Building this barrier is more than just a campaign promise, it's a common-sense first step to really securing our porous border," White House press secretary Sean Spicer told reporters during a briefing. "And yes, one way or another - as the president has said before - Mexico will pay for it."

Hurd's district, which includes Crockett County, has over 800 miles of the border,

more than any member of Congress.

"It is impossible to build a physical wall in much of its terrain. Big Bend National Park and many areas in my district are perfect examples of where a wall is unnecessary and would negatively impact the environment, private property rights, and economy. There is no question that we must secure our border, but we need an intelligence-led approach in order to effectively combat the 19 criminal organizations currently operating in Mexico," Hurd said.

Over the weekend, Trump issued an executive order banning travel from seven predominantly Muslim countries.

Travelers from Syria, Iran, Iraq, Yemen, Sudan, Somalia and Libya are barred from entering the United States for the next 90 days, per Trump's Friday executive order. The ban set off chaos in major airports across the country on Saturday, where refugees in transit were detained.

"A one-size-fits-all solution is not the way to solve one of the most complex national security challenges we face, Islamic Terrorism. The execu-

tive order banning visa adjudication from seven countries does not make us safer; rather it decreases the security of our homeland and endangers the lives of thousands of American men and women in our military, diplomatic corps and intelligence services. There are almost 10,000 Americans serving in Iraq, Syria, Iran, Libya, Somalia, Sudan and Yemen. A target has been placed on their backs by increasing tensions in an already volatile region. These men and women are fighting alongside citizens of those countries in order to keep Islamic Extremists on the run and off our shores," Hurd said.

Hurd, a lone Republican, joined a handful of the Texas delegation's Democrats in challenging Trump's executive order over the weekend.

Hurd was recently selected for the U.S. House Permanent Select Committee on Intelligence by Speaker of the House Paul Ryan, R-Wisconsin.

Hurd also sits on the committees of Homeland Security and Oversight and Government Reform and has

## Session watch: legislature begins and budgets arrive

The 85th Legislative Session kicked off earlier this month with much less fan-fare than in years following a gubernatorial election. Being the mid-term for our Governor and Lt. Governor means there are no inaugural festivities at the state level. Of course, at the Federal level, there was a plethora of celebrations, and protests, surrounding our new President Donald Trump.

For the Uresti Family, there was however much celebration. Not only was I sworn in for another four year term

representing Senate District 19, my (older) brother Tomas was sworn in as the State Representative from House District 118. We are the first brothers to serve in each chamber of the legislature at the same time since 1940.

Each member of the legislature is assigned to a number of subject matter committees, responsible for reviewing legislation that pertains to their issue of interest early in the process, before the bills are sent to the Senate floor. Committee assignments for the 85th Legislature were released, and I am happy to report the following assignments: I will continue to serve on the Senate Finance Committee, and I received a promotion to Vice-Chair on the Health and Human Services Committee. In tune with the needs of Senate

District 19, I will serve on the Education, and Veteran Affairs & Border Security Committees. The Chairs that head the committees remained the same, with the exception of the Senate Administration Committee, which will now be chaired by my colleague Senator Lois Kolkhorst from Brenham.

Constitutionally, the only bill the legislature is required to pass is our state budget - we have the 10th largest budget in the world! The other 500-600 bills we will pass this session, while necessary to varying

degrees, are not necessarily required. The House and the Senate have each filed our respective budgets as House Bill 1 (HB 1), and Senate Bill 1 (SB 1). I consider the top budget items to be student enrollment growth in our public schools, Child Protective Services, foster care, and one of our largest budget drivers, Medicaid.

As the bills stand now, they reflect the tighter economy Texas is currently experiencing due to the downturn in the oil and gas industry and sales taxes, which is a major source

of Texas' revenue.

HB 1 and SB 1 will be worked on in each respective chamber as the session progresses, and I look forward to advocating for District 19 as a member of the Finance Committee, and of course, keeping you up to date on our progress in the weeks ahead. Please look for my bi-monthly "Session Watch", keeping you up to date on the issues facing District 19, and our state. Semper Fi.

## The mechanics of the Texas Legislature

The 85th meeting of the Texas Legislature began on Jan. 10th.

Unlike the U.S. Congress which meets practically year round, our state legislature meets for just 140 days every two years, so we have to get down to business and focus on our primary task - passing another fiscally conservative, balanced budget.

The first two to three weeks of the session are largely ceremonial, however.

This is because the rules of the House of Representatives prohibit the debate of legislation on the House floor prior to the 60th day of the session unless it is deemed an emergency by the governor.

This lull at the beginning of the session allows members and their staffs to work with the lawyers and drafters who turn ideas into actual bills ready for consideration.

As of this morning, there were 1,989 bills already filed this session.

Proposed bills also cannot proceed through the legislative process until the Speaker of the House appoints members to fill the 38 standing committees.

Thus far, those assignments have not been made, and while there is no mandated deadline, historically the committees are filled around the first week of February.

In 2015, I was assigned to the Transportation Committee, the Culture, Recreation and Tourism Committee, the Rules and Resolutions Committee, and (following session, in the interim) the Select Committee on Mental Health.

I do not know if I will be

returning to those committees at this time, or be named to one or more different committees, but once assignments are announced, I will be sure to update you further.

In addition to committee assignments, this week we are receiving two speeches from our state's leaders.

On Jan. 31, Governor Abbott will address a joint session of the Texas House and Senate for his state-of-the-state address. During that time, he will likely inform us of any issues or legislation that he has decided rises to the level of an emergency item.

The next day, on Feb. 1, the Chief Justice of the Texas Supreme Court, Nathan Hecht, will also address a joint session of the legislature to deliver his state-of-the-judiciary address.

I am excited to get down to business and begin this important work, and I would like to ask all of you to keep me in your thoughts and prayers, and to contact me with your comments and opinions.

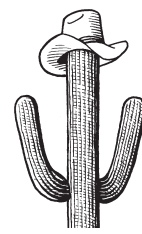

## Dying From Complications

I'm sure you've read about the VFD. It's kinda like BVD, bovine viral diarrhea, only VFD is a disease of the bureaucracy. In my opinion, it's just another in a long line of regulations to fix something that wasn't broke. VFD stands for Veterinary Feed Directive and it's an attempt to turn your vet into a paper pushing pharmacist. To learn about VFD you've been urged to develop a closer relationship with your vet. Hah!

Every large animal vet I know is so busy meeting himself coming and going that he or she doesn't have time for writing prescriptions, or for strengthening personal relationships. Most large animal vets I know aren't what you'd call "touchy feely" kind of people anyway. Some are downright grouchy, probably because they're already 45 minutes late for their next appointment. But ranchers and their animals should be extremely grateful for our vets and some day we're going to look back and realize that ranchers and their stock never had it so good as right now. You call them up with a problem and they came out to your place and fix it. Or not.

There's already a large animal veterinarian shortage and it's only going to get worse because 80% of students in American vet schools are female, and most of them want to be equine or small animal vets. So overburdened cow docs are now going to be even more overworked writing prescriptions, pushing pills and giving consults. We're gonna miss the days when your vet

have.

This is just the first of many regulations the government will use to turn your vet into a pill pusher and your sick cows into DOA's. They'll die from complications. It may come as a big shock to younger people reading this column to learn that medical doctors used to come to your house when you were sick to fix what was wrong. Or not!

The day is not too far off when vets will no longer make ranch calls. To treat a sick cow you'll have to haul it into town where you'll sit in a waiting room reading three year old cow magazines for 45 minutes. You'll have to pay first and be asked to fill out a four page questionnaire every time you come in that asks you all sorts of embarrassing questions. If it's a sick cow

came out to the ranch for a difficult calving cow and even though he may have just held the calf in a little longer to make you think you were getting your money's worth, at least you did everything you could and felt good about it. Even if all the vet did was give a sick cow a vitamin shot to make you think he was doing something, at least you felt better. Even though the cow may not

you'll be asked when it was born and if its father ever had lump or a venereal disease. You are given this questionnaire to give you something to do while you're waiting. (No one actually ever refers to these pieces of paper, they are just stored away in banker's boxes somewhere.)

You may note that you're the only one in the waiting room and while you can't get in to see the vet, a parade of drug salesmen are getting to see the Doc to give him free pens and pads of paper with the name of a new drug on them. After the requisite length of waiting you'll be taken into a stark room where you'll wait another 30 minutes until a nurse comes and takes your temperature and blood pressure, even though it's your animal that's sick, not you. Then you'll wait another 30 minutes until your vet finally enters. He'll then tell you that your blood pressure is high, no doubt because you've just wasted two hours.

Your vet may, or may not, go see the sick animal in your trailer. Then he'll look in his cupboard for some old free samples of a drug that's about to expire and you'll be told to come back in two weeks. After that time if your cow is still alive your vet will then refer you to a specialist. Probably his brother-in-law.

At this point you'll give up and illegally buy some black market antibiotics off the Internet from Canada.

## Abbott tells sheriff to reverse sanctuary policy or lose funding

AUSTIN — Gov. Greg Abbott has stepped up the pressure on Travis County Sheriff Sally Hernandez to participate in immigration enforcement, warning that she could lose state funding if she refuses.

In a Jan. 23 letter, Abbott urged the sheriff to reverse her policy directive "forbidding Travis County Sheriff's Office employees from cooperating with U.S. Immigration and Customs Enforcement detainer requests."

Failure to reverse her directive would put in jeopardy millions of dollars in funding from the governor's office to Travis County, Abbott warned. Abbott mentioned that last year, he conditioned all Criminal Justice Grant funds from his office to counties on their enforcement of federal immigration law. Furthermore, Abbott said, he is committed to signing legislation that bans sanctuary cities throughout

the state of Texas.

Sheriff Hernandez posted a news release in reaction to the governor's letter, saying: "I respect the job of our state leaders, but I will not allow fear and misinformation to be my guiding principles as a leader sworn to protect this community. I am following all state and federal laws, and upholding constitutional rights to due process for all in our criminal justice system. Our community is safer when people can report crimes without fear of deportation. I trust the court system and our judges to assess the risks and set appropriate bonds and conditions for all who are incarcerated. The voters, who elected state leaders and me, expect and deserve a collaborative effort to come up with solutions to this very complex issue. That is precisely what

I'm committed to."

### COURT RULES AGAINST REGENT

Outgoing University of Texas regent Wallas L. Hall Jr. has lost the latest round in his legal battle to obtain admissions records from the university.

The Court of Appeals for the Third District on Jan. 27 ruled unanimously in favor of the defendant, UT System Chancellor William H. Raven, in a lawsuit brought by Hall.

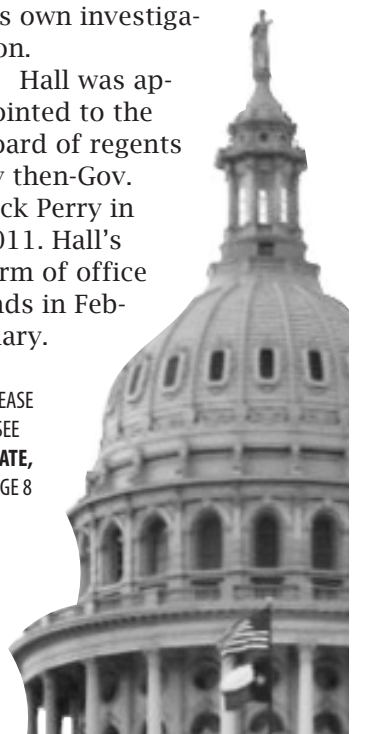
Hall sued over McRaven's refusal to grant Hall complete access to records containing student-admissions information. McRaven had the legal standing to deny Hall's requests for certain information, the court ruled.

The underlying dispute began in 2013, when Hall raised concerns about po-

tential improprieties in the admissions process of UT Austin and requested information to conduct his own investigation.

Hall was appointed to the board of regents by then-Gov. Rick Perry in 2011. Hall's term of office ends in February.

# Diabetes is worse than we thought

The world's public health authorities are at a loss to discover solutions that will affect a reversal of Diabetes Mellitus Type Two's debilitating conditions.

"Mortality estimates usually suggest 3.5 percent of deaths were caused by diabetes. A new study finds the number may be closer to 12 percent." - Julia Belluz of Vox Media.

This "new study" came to a shocking conclusion: "Middle-age white Americans are dying at younger ages for the first time in decades, despite our advances in medical technology and the positive trends in other wealthy countries." The research was conducted by Princeton University's, Dr. Anne Case, and her husband, Nobel Memorial Prize winner in Economic Science, Dr. Angus Deaton.

Some 30 million US citizens are diabetic and that seems almost normal to some... until one realizes it is triple the number of confirmed diabetes cases in the early 1990s.

The ambiguity in reporting diabetes and heart disease on a death certificate is because listing diabetes as the principal cause of death is "highly variable," said Andrew Stokes, assistant professor of global health at Boston University's School of Public Health. "Often times, the certifier will code the death as being caused by heart disease rather than a death from diabetes," he added. "So to some extent, deaths that should be attributed to diabetes go to other causes."

People with diabetes experience greater reductions

can be reduced as much as 65 percent in those with diabetes and causes greater levels of inflammation.

Carolyn Gregoire, senior writer for the Huffington Post writes, "With a growing body of research showing an association between insulin resistance and neurodegeneration, some scientists are even referring to Alzheimer's Disease as "Type 3 diabetes"... Hopefully, these findings will one day be used to devise better treatments for the degeneration of thinking and memory skills co-occurring with diabetes."

New trials and studies are planned and in process that will determine if the injection of insulin directly into the brain will potentially slow cognitive loss. For now, improved detection and monitoring of blood flow regulation may help foresee and address cognitive challenges in those with diabetes.

"Worse performance on daily activities, worse memory or slower gait speed in older diabetic adults may

in brain tissues and cognitive impairments because their body's decreasing ability to regulate blood flow in the brain and throughout the body. Blood flow

hallmark a decline in ability to regulate blood flow in the brain," Dr. Vera Novak of the Harvard Medical School, told The Huffington Post. "For older diabetic people it is important to maintain healthy lifestyle and minimize fluctuations of blood sugar levels, in addition to their medication regimen."

The significance of the above is to illustrate the fact that Diabetes Mellitus Type Two is far more entrenched in the world community than previously thought or communicated. The world's public health authorities are yet at a loss in the discovery of solutions that will affect a reversal of its debilitating conditions. Until they do, we can only be cognizant of our health and wellbeing, and seek our answers in our own lives, habits and conditions.

One thing each of us can do is understand the conditions caused or influenced by diet and restrict the elements that are indicated as a causation of almost all metabolic diseases, those being refined, simple and starchy carbohydrates. Each of us has a need to better understand how our individual diets and ways of eating impacts our physical, biochemical and mental/emotional health... and to become more proactive in our own preventive care.

land conservation programs by the USDA/ASCS.

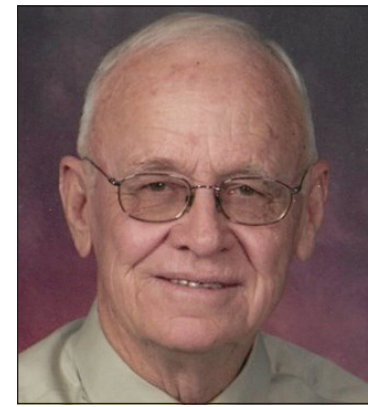
Sam's family was very important to him and he and Polly were happiest together at the ranch.

## UPDATED PROPERTY TAX INFORMATION NOW AVAILABLE FOR TEXAS TAXPAYERS

New and updated property tax information has just been compiled by the Crockett County Appraisal District and is available now to assist taxpayers. This property tax information is current and covers a wide range of topics, such as taxpayer remedies, exemptions and appraisals, and has information for select groups, such as disabled veterans and persons age 65 or older.

"Whether you are a homeowner, business owner, disabled veteran or taxpayer, it's important you know your rights concerning the property tax laws," said Janet M. Thompson, Chief Appraiser of the Crockett County Appraisal District. "You can contact us about any property tax issues with full confidence that we will provide you the most complete, accurate and up-to-date available information to assist you."

This includes information about the following programs.

**Property Tax Exemptions for Disabled Veterans** – The law provides partial exemptions for any property owned by veterans who are disabled, surviving spouses and surviving children of deceased disabled veterans. This includes homesteads donated to disabled veterans by charitable organizations at no cost to the disabled veterans and their surviving spouses. The exemption amount is determined according to percentage of service-connected disability. The law also provides a 100% homestead exemption for 100% disabled veterans and their surviving spouses and for surviving spouses of U.S. armed service members killed in action.

**Property Tax Exemptions** – Non-profit organizations that meet statutory requirements may seek property tax exemptions and must apply to their county appraisal district by a specific date. Businesses that receive tax abatements granted by taxing units; ship inventory out of Texas that may be eligible for the Freeport exemption; store certain goods in transit in warehouses that are moved within 175 days; construct, install or acquire pollution control property; own and operate energy storage systems; convert landfill-generated gas; or store offshore drilling equipment while not in use may also be eligible for statutory exemptions.

**Rendering Taxable Property** – If a business owns tangible personal property that is used to produce income, the business must file a rendition with its local county appraisal district by a specified date. Personal property includes inventory and equipment used by a business. Owners do not have to render exempt property such as church property or an agriculture producer's equipment used for farming or ranching.

**Appraisal Notices** – Normally, taxpayers receive a notice of appraised value from the appropriate local county appraisal district. The city, county, school districts and other local taxing units will use the appraisal district's value to set property taxes for the coming year.

**Property Taxpayer Remedies** – This Comptroller publication explains in detail how to protest a property appraisal, what issues the county appraisal review board (ARB) can consider and what to expect during a protest hearing. The publication also discusses the option of taking a taxpayer's case to district court, the State Office of Administrative Hearings or binding arbitration if the taxpayer is dissatisfied with the outcome of the ARB hearing.

**Homestead Exemptions** – A homestead is generally defined as the home and land used as the owner's principal residence of January 1 of the tax year. A homestead exemption reduces the appraised value of the home and, as a result, lowers property taxes. Applications are submitted to the appropriate local county appraisal district.

**Productivity Appraisal** – Property owners who use land for timber land production, agricultural purposes, and wildlife management can be granted property tax relief on their land. They may apply to their local county appraisal district for an agricultural appraisal which may result in a lower appraisal of the land based on how much the taxpayer produces, versus what the land would sell for in the open market.

**Residence Homestead Tax Deferral** – Texas homeowners may postpone paying the currently delinquent property taxes due on the appreciating value of their homes by filing a tax deferral affidavit at their local county appraisal district. This tax relief allows homeowners to pay the property taxes on 105 percent of the preceding year's appraised value of their homestead, plus the taxes on any new improvements to the homestead. The remaining taxes are postponed, but not cancelled, with interest accruing at 8 percent per year.

**Property Tax Deferral for Persons Age 65 or Older and Disabled Homeowners** – Texans who are 65 years of age or older or disabled, as defined by law, may postpone paying current and delinquent property taxes on their homes by signing a tax deferral affidavit. Once the affidavit is on file, taxes are deferred, but not cancelled, as long as the owner continues to own and live in the home. Interest continues to accrue on unpaid taxes. You may obtain a deferral affidavit at the appraisal district.

**Notice of Availability of Electronic Communication** – n appraisal districts located in counties with a population of more than 200,000 or that have authorized electronic communications, and that have implemented a system that allows such communications, chief appraisers and ARBs may communicate electronically through email or other media with property owners or their designated representatives. Written agreements are required for notices and other documents to be delivered electronically instead of mailing.

**Protesting Property Appraisal Values** – Property owners who disagree with the appraisal district's appraisal of their property for local taxes, or for any other action that adversely affects them, may protest their property value to the appraisal district's appraisal review board.

## Four people injured in explosion near Sonora

Four people were injured during an explosion at an Enervest pump Station near Sonora Friday, January 27, 2017. Ron Whitmire, Senior Vice President and Chief Administrative Officer for EnerVest, Ltd confirmed that two Enervest employees and two contractors were injured as a result of the explosion. All four people were transported by ambulance to a local hospital where they were treated and released the same day.

A chemical treatment was being completed at the compressor station when the explosion occurred.

The event was contained with no off-site impact or threat to the community, according to Whitmire.

Compressor stations such as this one operate in the transportation process of natural gas requiring constant pressurization every 40-100 miles.

Enervest, Ltd. has opened a full investigation into the incident, according to Whitmire.

More information will be made available following review.

Sutton County law enforcement and emergency responders assisted. A helicopter was on standby but was not employed.

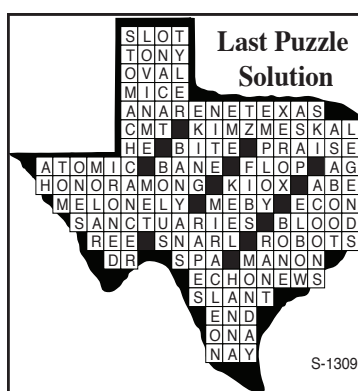

The U.S. Department of Transportation has picked Texas as one of 10 testing locations for autonomous vehicle technology.

In a Jan. 24 news release, the Texas Department of Transportation suggested the designation establishes Texas as a leader in the research and development of new transportation technologies that could make roads safer and less congested.

TxDOT will be involved in a "Texas Autonomous Vehicle Proving Grounds Partnership" with the Texas A&M Transportation Institute, The University of Texas at Austin's Center for Transportation Research, Southwest Research Institute and 32 municipal and regional entities.

"This partnership puts Texas at the forefront of automated vehicle technologies that likely will shape the future of transportation around the world," said Marc Williams, deputy executive director of TxDOT.

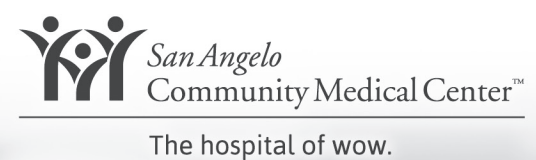
