## Javelinas disturbing the peace

Texas Game Warden Dan Waddell and Crockett County Animal Control Officer Joe Jurado talked to the Crockett County Commissioners' Court during their regular meeting

Monday about javelinas in precinct 3 around Live Oak Street. Javelinas are considered game animals, like deer, which means a person must have a permit to trap or dispose of the animal.

Waddell presented the commissioners about the two

permits through Texas Parks and Wildlife.

The TTT or Trap, Transport, Transplant permit costs \$750 per release site, and the animals can be trapped but not shot or destroyed. Instead, the animal must be relocated to an approved release

site through Texas Parks and Wildlife Department Wildlife Management Plan approved by a TPWD Wildlife Biologist, according to the Texas Parks and Wildlife website.

The Family Health Center of Ozona has reported that they have seen up to 20 positive flu cases as of Tuesday morning.

The first flu case was seen on Dec. 6, said Susan Bilano, clinic manager.

Bilano said that if anyone suspects they have the flu, it is important they come to the clinic during regular hours, 8 a.m.-5 p.m., while the doctor and lab are available, as well as the local pharmacy being open so pa-

- Cover coughs and sneezes with a tissue.
- Wash hands with soap and water or use hand sanitizer.
- Cover your nose and mouth with a tissue when you cough or sneeze.
- Try to avoid close contact with sick people.

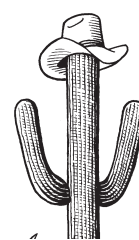
I'd also like a waist, since I lost mine somewhere in the seventh month of my last pregnancy.

## You Be The Judge

I have mixed emotions about the showing and where it fits in with today's data-driven cattle business. I grew up showing cattle and being on judging teams and I think I learned more in those activities than I ever did in school. Participating in cattle shows builds character and a good work ethic in kids and many use the proceeds from their animals to help finance a college education. Big cattle shows like Denver, Houston, Fort Worth, Kansas City, Louisville and San Antonio, help educate the general public and they are a great place for cattlemen to meet and exchange ideas. A lot of business gets done and they bring in lots of tourist dollars. And there still isn't a better way to evaluate an animal's structural correctness than to look at it. I sat on the auction block as an announcer for a major video company for 20 years and got to see a lot of cattle and I'll tell you this, the buyers wouldn't start bidding until they saw the pictures. And I don't care what you say, a rancher still likes to look at good cattle. I believe it was the Greek scholar Anonymous who said, "The eye of the master still fattens his or her cattle."

On the other hand, I am reminded of another old saying also credited to Anonymous: "They stopped judging chickens when they learned how to count eggs." There are so many other tools we have to evaluate cattle today that are much more accurate and consistent and I worry that EPD's and DNA data have almost turned

cattle shows into their dog show equivalent. I also know from having been a judge that judges who pass down their decisions with God-like superiority and impartiality would admit that when it comes to appraising cattle by their phenotype, your guess is often as good as theirs. I also wonder if judges can't be influenced in subliminal ways. I love the old Jerry Palen cartoon of Elmo with a baseball bat in his back pocket and when the judge passes within ear shot he says, "I sure hope the judge likes my kid's project."

I have a friend who is one of the best showmen in the business and he told me that one year he had two heifers that showed in the same class. Usually the herdsman will show the best one and the judges know this, but in this case the inferior heifer was a little hard to handle so my friend showed it. "And you wouldn't believe," he said, "how many times the judges picked the inferior heifer just because I was showing it."

My judging team coach, Bill Jacobs, was a popular and proficient judge 30 years ago and I always playfully accused him of reading all the breed journals to see which

animals had been winning before he judged a major show. He insisted that he never looked at them and I'll admit in all the years of our friendship I never caught him reading one. There was one time though I think he was tempted.

Bill was asked to judge the Brangus at a major show but unbeknownst to those who hired him, he'd never judged eared cattle on a big stage before. Naturally Bill was a little nervous and it didn't help that we ate dinner together the night before the show. I told him that the next day he was going to judge the winningest Brangus bull in history and he'd better name him Grand Champion or he'd never judge another show.

The next day after every bull class Bill looked at me for a response and I always just shook my head in disgust as if he'd really blown it. At this point he was sweating bullets. In the final class, the two year old bulls, much to my surprise the best bull I think I'd ever seen in my life, WSR Rocky Joe 650, walked into the ring and Jacobs got a huge smile on his face. A blind man who knew nothing about cattle could have found him.

Bill died a few years back and I've always regretted that I never got the chance to tell him that I'd made my whole story up just to make sure he didn't sleep a wink before the big show.

## Abbott picks TCEQ to manage Clean Air settlement funds

AUSTIN — Gov. Greg Abbott on Dec. 4 announced his selection of the Texas Commission on Environmental Quality as the lead agency for Texas' participation in the Environmental Mitigation Trust.

The trust was established in 2016 and early 2017 by the settlement of certain federal Clean Air Act claims against Volkswagen, Audi and Porsche related to the car companies' use of "defeat devices" to pass emission standard tests. As a participating state, Texas must develop a draft mitigation plan outlining how it would spend its \$209 million share of the settlement funds in efforts to reduce emissions of nitrogen oxides.

"Our agency looks forward to developing a plan to efficiently administer these funds to help address issues associated with the emission of nitrogen oxides, which leads to ozone formation," said TCEQ Commissioner Jon Niermann.

"We look forward to working with all stakeholders to develop a plan that effectively mitigates the emissions from vehicles that did not meet the emission standards."

HURRICANE HELP IS OFFERED

Many citizens who live in "Presidentially Declared Major Disaster Areas" — like the nearly 50,000 square miles of Texas hit by Hurricane Harvey — have home loans insured by the Federal Housing Administration.

And of them, those who are having trouble making mortgage payments were encouraged, in a Dec. 4 announcement by Department of Housing and Urban Development Secretary Ben Carson

and Texas Land Commissioner George P. Bush, to contact their service providers to learn about available resources or call the FHA Resource Center at (800) CALL-FHA.

"While we rebuild, many Texas homeowners are facing a second struggle of returning to work and making mortgage payments. To help these Texans, the General Land Office is proud to team with our disaster recovery partners at HUD to help those who need help avoiding foreclosure or assistance in financing repairs to damaged homes," Bush said.

The Federal Housing Administration, an agency within the Department of Housing and Urban Development, insures more than one quarter of home loans in Texas.

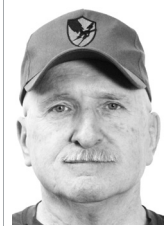

**Fasting triggers cellular level repair processes**



**HERE'S TO YOUR HEALTH**

In the pursuit of optimal health and wellbeing, fasting is one of human nature's best-kept secrets. While fasting and starvation are often confused with one another, starvation begins after the body has depleted stored nutrient reserves, or they become hazardedly low. Until then, the body is said to be in a state of "fasting", which occurs 10 to 12 hours after its last meal.

Our hunter/gatherer ancestors didn't have the accoutrements of modern food storage, procurement and availability (no grocery stores), refrigerators or year-around food availability. Theirs was a life of intermittent and extended periods of fasting for weeks-on-end from one meal to the next. Their offspring, our ancestors, evolved with this pattern of eating for some 2.5 million years.

Fasting may have began as a result of the lack of food, but was then practiced for medical reasons like cleansing and healing and, as our ancestors grew more sophisticated, for religious protocols. When a mammal is ill or sick with a toxin or disease, it loses its appetite and naturally refuses food. Then, upon surviving the issue; the appetite returns, it feeds, the healing begins... and life goes on.

As the liver, kidneys and other organs evolved, they perfected their ways to continually cleanse and heal the body. Fasting allows for a rapid and more profound cleanse and when followed by a healthy feasting, the body can repair and heal itself more effectively... and many claim with greater mental clarity.

In a fasted state, the body relies on endogenous sources of energy (like glycogen, fat and protein stored in the body) rather than the recently consumed food being processed in the digestive tract, or exogenous sources of energy.

The actual duration of a fast will vary individually from hours to days and weeks. A person of average

weight will have enough body fat to nourish themselves for 40 or more days.

Our body expends copious amounts of time and energy on its many and varied processes during our waking hours. While our exocrine system digests food and eliminates waste, the endocrine system converts macro and micro nutrients into essential molecular elements and distributes them among the fluids, tissues and organs required for the body to function at optimal levels.

Changes occur in your body when it's fasting. Human Growth Hormone (HGH) levels increase as much as five times. Enhanced cleansing, healing, and fat loss are but a few of the scientifically backed benefits. Insulin sensitivity recovers, and the body's insulin levels decrease dramatically which make body fat more accessible to be converted to energy.

When in the fasted state, cellular level repair processes like autophagy are triggered, where cells consume and eliminate old and malfunctioning proteins that collect within the cells. Genes relating to longevity and disease prevention are also changed and bolstered.

Chris Gunnars says, "These changes in hormone levels, cell function and gene expression are responsible for the health benefits of intermittent fasting. When you fast, human growth hormone levels go up and insulin levels go down. Your body's cells also change the expression of genes and initiate important cellular repair processes. Intermittent fasting may boost metabolism slightly, while helping you eat fewer calories. It is a very effective way to lose weight and belly fat."

Hippocrates advised us, "Everyone has a physician inside him or her; we must help it in its work. The natural healing force within each one of us is the greatest force in getting well. Our food should be our medicine. Our medicine should be our food. But to eat when you are sick is to feed your sickness."

Like the clean-up after a storm, a fast rids the body of impurities and microscopic debris because of neglect and abuses heaped upon it during the "storm" ... the numerous daily insults in our modern living conditions. The period of rebuilding with proper nutrients afterward is 'the rest of the story' that puts recovery in motion and sets up the 'happy ending' we all seek.

I have always nutritionally prepared myself for fasting and, thus have experienced neither hunger nor anxiety during my fasts. My only problem is what to do with my extra time. There's no food to buy, no meals to prepare and no dishes to wash.

Just Eat Real Food (JERF), be moderately active, and get plenty of sleep. If fasting is right for you... give your body a break from time-consuming task of constantly processing micronutrients and storing fat in your body.

Fasting is not a big deal, as many people believe, but should be done responsibly. It is another path we may take in our personal journey toward optimum health. The "fast well, feast well" pathway is made more profound when the fast is followed by feeding that provides all the healthy nutrients our body needs to repair, rebuild and heal itself. This is just another way we become a-tuned to our body and follow its lead in conducting our safe and rewarding journey toward good health and wellbeing.

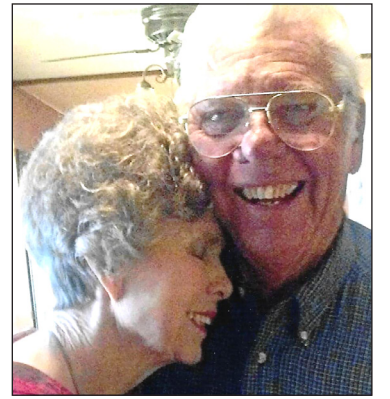
**Jettie Proctor Adcock**

new commissioner for Precinct 2.

G.L. Bunger and Dwight Childress are facing each other on the Democratic Primary Ballot. The winner of that race will face Slate Williams, who filed in the Republican Primary, in the Nov. 6 General Election. Slate Williams was the local candidate to file in the Republican Primary.

For the Commissioner, Precinct 4 position, incumbent Eligio Martinez is facing Michael Medina Jr. and Patricia Hernandez on the Democratic Primary Ballot.

Other local candidates that filed, but did not draw opponents in either Democrat or Republican Primaries, were: District Judge, 112th

Judicial District Pedro (Pete) Gomez Jr. (incumbent), District and County Clerk Ninfy Preddy (incumbent), County Treasurer Karen D. Webb (incumbent) and Justice of Peace Evelyn C. Kerbow (incumbent).

On the state level, incumbent State Rep. Andrew Murr, R-Junction, filed for re-election in the Republican Primary.

Murr will face either Joe P. Herrera or Stephanie Lochte Ertel who both filed in the Democratic Primary.

On the federal level, incumbent U.S. Rep. Will Hurd, R-San Antonio, will face Alma Arredondo-Lynch in the Republican Primary.

In the Democratic Primary, Angela "Angie" Villescaz, Gina Ortiz Jones, Jay Hulings,

Control states on their website that seasonal flu activity has increased slightly this week in the United States.

Texas is listed as having moderate flu activity, according to the site.

Between Oct. 1 and Nov. 25, according to the CDC, more than 7,000 cases of influenza were confirmed.

CDC states that peak influenza activity in the United States most commonly occurs during December-February.

Dr. Marcus Sims said in the past the flu virus has hit as in October and November.

"It's just a cycle and one never really knows when it will start," Sims said.

The CDC states that the

flu vaccine is the best available way to protect against influenza. The CDC recommends that everyone 6 months and older get an injectable flu vaccine as soon as possible.

Bilano said flu vaccines are still available at the Family Health Center in Ozona. It takes about two weeks for the vaccine to become effective.

In households with babies under 6 months, all family members should get flu shots, said the Texas Department of State Health Services.

Besides getting vaccinated, experts recommend that people wash their hands frequently, cover coughs and sneezes, and stay home when they're sick to avoid infecting others.

Likewise, anyone experiencing flu symptoms is en-

couraged to seek treatment promptly. Antiviral drugs can help shorten the duration or ease the severity of the flu if begun within 48 hours of the onset of symptoms.

Bilano also said patients seeking refills or needing to fill out paperwork, need to call the clinic to let the staff post messages back for the doctor to review instead of coming and sitting in the lobby.

"If you are immuno suppressed, but really need to see the doctor, please advise the receptionist when you call in and a special location will be set up for you to wait instead of being in the lobby," Bilano said.

family to live in Kerr County, Ertel has a deep appreciation of the Texas Hill Country and surrounding rural areas that she seeks to represent.

Voters who are concerned about preserving and funding public education, protecting rivers and groundwater supplies, improving health insurance coverage and creating better economic opportunities for residents of District 53 will find a champion in Ertel.

Ertel's campaign in 2016 is described in a memoir, Running on Trust and Rainwater, that Ertel wrote in the summer of 2017.

"You can't win if you're not on the ballot," is the proposition that Ertel adopted in 2016. She had no footsteps to follow, since no Democrat had run to represent District 53 in the prior nine elections. Ertel was encouraged by her ability to attract independent and Republican votes, and the active support of Democrats in her 2016 campaign.

In Kerr County, where Ertel resides, and most other counties in District 53, local races for salaried county positions fail to attract Democratic candidates, so voters are drawn to the Republican primary contests where down ballot races are decided.

In 2018, multi-candidate contests for Congressional nominations in District 53 counties may attract voters to the Democratic Party primary.

Ertel anticipates that the wave of support for Democratic Party candidates in some 2017 elections will continue through 2018.

Ertel is a Tivy High School graduate who left home for careers in teaching and corporate law.

She is a graduate of Texas Lutheran University, holds an M.S. in political science from the University of North Texas and graduated from SMU Dedman School of Law. She began her legal career as a corporate lawyer at Akin, Gump, Strauss, Hauer and

Feld in Dallas, then became the Senior Vice President and General Counsel of The Coca-Cola Bottling Group (Southwest), Inc., which became the fifth largest Coca-Cola bottler in the U.S. She worked at the bottler from 1985 until the company was sold to Coca-Cola Enterprises in 1998.

Pro bono clients ranged from Central American refugees to church and other nonprofit organizations.

With her husband, Richard R. Ertel, a corporate attorney, Ertel moved to Kerr County in 2006 to establish an off-grid home near the small community of Mountain Home, 17 miles west of Kerrville.

Their home place demonstrates commitment to conservation through wildlife habitat restoration, rainwater harvesting, and solar power.

Ertel anticipates having many opportunities to share ideas with constituents about sustainable off-grid living as she campaigns in District 53.

Ertel's roots in Kerr County are deep. Her great-grandparents, Paul and Frieda Raaz, built their home on the Guadalupe River in 1908.

Holdsworth Memorial Library.

Ertel's parents were both veterans of World War II.

Today, Ertel is a volunteer advocate with Hill Country CASA, a member of the Hill Country Chorale and past president of its corporate board, Secretary/Treasurer of the Ladies Auxiliary of the Mountain Home VFD, a volunteer mediator with Hill Country Dispute Resolution Center and a team leader for American Cancer Society Relay for Life. She has been a leader in Democratic Party activities in the Hill Country since 2007.

The Ertels are members of St. James Lutheran Church in Harper.

They have two grown, married daughters who live in Austin, and two young grandsons

# Lions getting new district opponents

The Ozona Lions will have new district opponents next season.

The University Interscholastic League released the 2018-2019 and 2019-2020 Reclassification and Realignment Conference Cutoff Numbers last week.

Ozona submitted an enrollment of 190 students keeping them in Class 2A Division 1. An enrollment snapshot was taken Oct. 27 at high schools across the state.

All of the other schools in District 3-2A either moved up or down based on enrollment numbers.

Anthony moves up to Class 3A Division 2 with an enrollment of 239. Cutoff was 225 for that classification division.

Christoval, Eldorado and McCamey all moved down to Class 2A Division 2. Christoval turned in 161 students, Eldorado 151 and McCamey 143. The divisional cutoff in 2A is 161.4 students.

Ozona will now wait to see where it will fall with the other 94 schools in Class 2A Division 1.

The UIL realigns high school classifications and districts every two years. The districts each school will play in will be announced in February.

"I think Forsan, and Winters will be moved our way in addition to Junction. I believe there is a possibility of Mason in our district. But any guess is as good as that," said Athletic Director and Head Football Coach Kyle Freeman.

Forsan turned in an enrollment of 193 students

Mason (214), who lost to Refugio (200) Saturday in the Class 2A Division 1 state quarterfinal, won their dis-

## Game Warden Field Notes

COMPILED FROM TEXAS PARKS AND WILDLIFE DEPARTMENTAL LAW ENFORCEMENT REPORTS.

### CROSSING THE LINE

On opening weekend of mule deer season, game wardens were patrolling an isolated stretch of backroad near the Texas/New Mexico border in Cochran County when they observed suspicious activity in the distance; a red pickup truck had suddenly turned around on the two-lane highway to go southbound, and then came to a stop in the bar ditch.

The wardens quickly turned into the nearest county road to observe. Using binoculars, the wardens detected a rifle sticking out the window of the truck. They quickly moved in and made contact with the occupants in the red truck, which was still in the ditch. The occupants, from New Mexico, admitted to shooting at feral hogs, but claimed that because they were in New Mexico, the Texas wardens were out of their jurisdiction.

Asked how they had determined their location, the

individuals pointed to the yellow centerline in the highway, believing that was the state line separating Texas from New Mexico.

Charges for hunting on a public roadway, in Texas, and discharging a firearm on a Texas public roadway are pending.

### SHOULD'VE PASSED THE BUCK

Game wardens responded to a call about a possible case on a subject exceeding his annual bag limit on buck white-tailed deer. For the season in Brazos County, hunters are allowed only one buck with an inside antler spread of 13 inches or greater. The wardens went to the subject's residence and during the interview discovered he had harvested an 8-point buck earlier in the week, and a big 10-point buck that evening.

Citation was issued for exceeding the bag limit on white-tailed deer and multiple tagging warnings were given. Civil restitution is pending.

a school's characteristics and achievements, combining parts of other recently released accountability reports to provide campus-level information detailing student and campus performance.

The School Report Card includes the following information for each campus in Texas:

- 2017 state academic accountability rating;
- Campus distinction designations;
- Attendance rates;
- Enrollment figures;
- Dropout rates;
- Class size averages;
- State of Texas Assessments of Academic Readiness results;
- ACT/SAT results; and
- Per-student financial expenditures.

These campus reports, required by the Texas Legislature and prepared by the Texas Education Agency, will be sent to the parent or guardian of every child enrolled in a Texas public school by local

school districts.

### STATE REVENUE TOTAL IS UP

State Comptroller Glenn Hegar on Dec. 4 said state sales tax revenue totaled \$2.78 billion in November, 11.1 percent more than in November 2016.

"The double-digit growth in sales tax revenue compared to last year was fueled, in part, by increased collections from oil- and natural gas-related sectors. Recent higher oil prices have spurred increased well drilling and completion. Collections from retail trade and restaurants were also up, reflecting growth in consumer spending," Hegar said.

Total sales tax revenue for the three months ending in November 2017 was up 9.5 percent compared to the same period a year ago. Sales tax revenue is the largest source of state funding for the state budget, accounting for 58 percent of all tax collections. Motor vehicle sales and rental taxes, motor fuel taxes and oil and natural gas production taxes also are large revenue sources for the state.

### HEGAR DISTRIBUTES REVENUE

Comptroller Hegar on Dec. 6 announced he would send cities, counties, transit systems and special purpose taxing districts \$695.2 million in local sales tax allocations for December, an amount 10.8 percent more than in December 2016. Allocations were based on sales made in October by businesses that report tax monthly, according to the Office of the Comptroller.

permit, the animals can be shot using centerfire (rim fire under the permit is unlawful) and must be immediately field dressed and kept in edible condition, according to the Texas Administrative Code.

The animal must then be donated to be used as food. Jurado said the Concho Valley Regional Food Bank in San Angelo would accept donations.

Cost for the Depredation permit is \$250. Hunting license and hunter education certification required to obtain the permit. Trapping and humane dispatch is not allowed under this permit, and season and lawful hunting hours and bag limits do not apply.

"Both permits have their pluses or minuses, but we feel the Depredation permit is the way to go," Jurado said.

Jurado said he could apply for the permit, but that educating the public is also necessary.

Jurado said it was around 10-12 javelina in the area.

Waddell and Jurado said they would get information out in The Ozona Stockman, on KYXX 94.3 FM Radio Station and on the Crockett County Animal Control Facebook Page.

"You always have the right to defend yourself against wild or domestic animals, if they are attacking you," Waddell said. "The first step is education."

### WELLNESS CENTER

The commissioners reviewed the proposed J. Cleo Thompson Wellness Center Bylaws, Membership Handbook and Job Description: Center Director, General Employee and Assistants.

County Attorney Jody Upham reviewed the documents and made suggestions as to changes that need to be made.

Commissioner Eligio Martinez said on the job descriptions there is no qualifications, such as lifeguard, CPR and other safety certifications.

"If we turn this over to somebody without any background and any certifications, we could be sued," Martinez said. "I want somebody to run the facility that is qualified in some general health knowledge."

County Judge Fred Deaton agreed that adding requirements, such as lifeguard certification, CPR and basic safety and first aid training is needed.

Also, Upham said there needs to be separate job descriptions for the director position and the two part-time employees, instead of just one job description as presented.

Upham also said that the Texas Association of Counties needs to be contacted about the medical questions and the medical release forms in the proposed membership handbook, since the facility is not tied to a hospital.

The wellness center

board used McCamey's forms as an example. However, McCamey's wellness center is tied to their hospital.

"We're not a hospital-based facility. That throws us to a totally different side. It would be totally different if we were hospital base. We would have other guidelines," said Commissioner Wesley Bean.

"It's a community exercise facility," added Commissioner Pleas Childress.

The commissioners will submit the changes to the wellness center board to be reviewed and brought back to the commissioners at their Jan. 8 regular meeting.

### 2018 COMMISSIONERS' MEETINGS

The commissioners' will have to start meeting once a week to pay bills and payroll starting next month.

Along with their regular meetings every second Monday of the month, the commissioners' court will meet at 7:30 a.m. Tuesdays to approve bills and payroll due to an opinion from Texas Attorney General Ken Paxton.

The opinion states that under Local Government Code, the commissioners' court must approve claims and the treasurer and auditor do not have the authority to pay claims without the commissioners' court approval.

A commissioners court cannot delegate to the county treasurer the commissioners court's duty and authority to approve payment of county claims.

Provided it complies with any statute applicable to the particular subject matter, a commissioners court may review and direct payment of payroll and claims at a meeting called for a day other than the commissioners court's regular meeting day, the opinion states.

County Treasurer Karen Webb said due to this change she will have to send letters to the sheriff's office, civic, library and any other departments that are paid biweekly that the payroll dates will have to change.

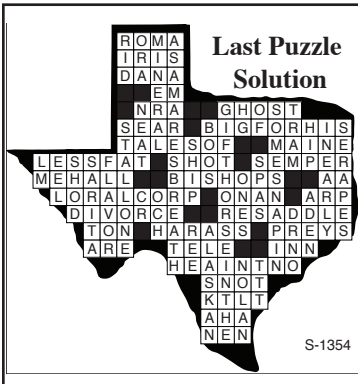
