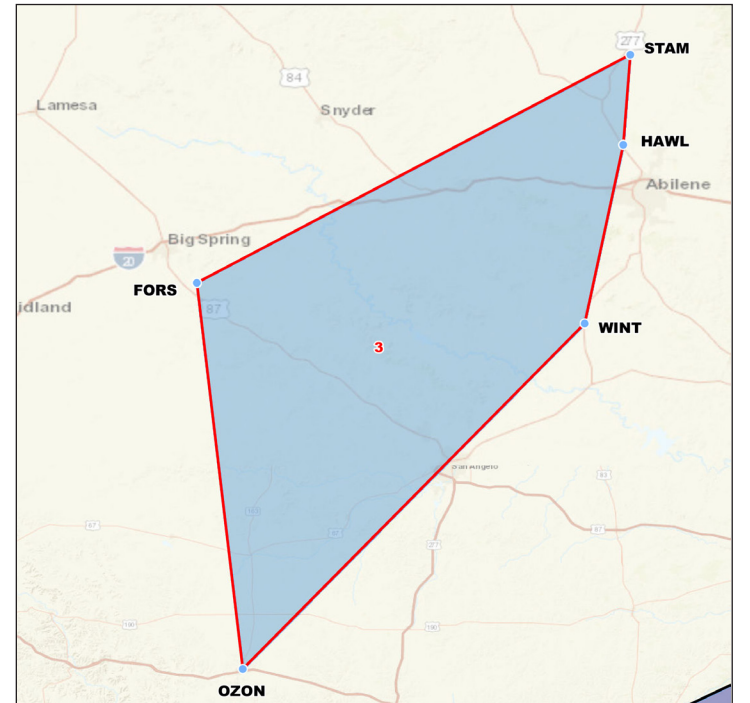

## UIL Realignment: Lions heading north

## As Uresti's fraud trial drags on, one testimony could be key

SAN ANTONIO — It was a young, grieving mother, prosecutors hoped, who would make the difference in the federal government's case against state Sen. Carlos Uresti, sending the long-time Democratic legislator to serve prison time instead of continuing to serve the people of Senate District 19. And as the third week of the criminal trial against the San Antonio lawmaker started Monday, the testimony of that key witness, 38-year-old Denise Cantu, slogged on. She first took the stand Thursday, and remained there until the end of the day Monday describing how she invested \$900,000 in a now-defunct frac-sand company called FourWinds Logistics at Uresti's suggestion — and then lost nearly all of it.

Uresti, who defended Cantu in a wrongful death suit after a 2010 car accident killed her son and

daughter, has been accused of defrauding investors — including Cantu — in a Ponzi scheme perpetrated by the company.

He faces 11 felony charges, and has claimed that he wasn't aware of FourWinds' illegal dealings. Cantu said she only invested because she trusted his guidance and because she believed he was personally invested as well.

Jurors had already heard from FBI personnel, who investigated FourWinds; former company officials, several of whom entered into plea deals with the government; and other company investors, who have painted a picture of a chaotic organization run by an erratic and irresponsible CEO in Stan Bates.

## Why I voted to release the Nunes memo

In 1885, Woodrow Wilson wrote in his treatise "Congressional Government: A Study in American Politics" that "the informing function of Congress should be preferred even to its legislative function."

I voted to release the Nunes memo because, like Wilson, I believe that the duty to inform the American public is one of my biggest responsibilities as an elected representative in our democratic republic.

This is in accordance with the Legislative Reorganization Act of 1946, which directed House and Senate committees to "exercise continuous watchfulness" over executive-branch programs.

Furthermore, according to rules of the House, the House Permanent Select Committee on Intelligence, on which I serve, may disclose publicly any information in its possession after a determination by the committee that the public interest would be served by such disclosure.

I spent close to a decade as an undercover officer in the CIA and have spent most of my adult life collecting intelligence and protecting sources and methods.

As a result, I've been asked by some how I could vote to make classified information public. My response is simple: Not all classified information has national security implications. If it does, it should be withheld.

Classified information includes much more than the actual "secrets." It includes how they were acquired and the process by which related analyses were made.

In matters addressed by the Nunes memo, I am not confident that proper vetting occurred, and I believe that the American people should have the ability to decide for themselves.

As the nation's premier law enforcement agency, the FBI is expected to maintain the highest levels of professionalism and excellence.

There is little doubt we have been free of another attack on the scale of the one that occurred Sept. 11, 2001, because of the men and women in our intelligence services, armed forces, diplomatic corps and federal law enforcement agencies — especially the FBI.

However, if the FBI requests a warrant from a federal court to conduct surveillance on an American citizen, it has a duty to ev-

ery citizen not to use information that the then-FBI director himself considered "salacious and unverified," or information drawn from circular reporting and rumors.

My vote to release the memo was not about discrediting the special counsel's investigation into Russian interference in the 2016 election.

It was not about debasing the hard-working men and women serving in the FBI.

Rather, I supported the release because I do not agree that an American citizen's civil liberties should be violated on the basis of unverified information masquerading as intelligence.

The Intelligence Committee also voted this week on whether to release the minority response.

This secondary memo included many references that would affect existing intelligence activity.

I voted against releasing the minority response until revisions are made to ensure that it would not jeopardize national security.

Let me be clear, special counsel Robert S. Mueller III's investigation must continue to ensure that our democracy was not compromised by Russian interference.

However, regardless of Mueller's investigation, all Americans should understand the implications of the actions taken by the leaders of our federal law enforcement agencies and their impact on our citizenry.

I understand the FBI and Justice Department's unprecedented public denunciation of the potential publication of the memo, because they don't want to see a precedent set by which Congress firmly exercises its informing function.

But it is the right of our citizens to demand that they are kept informed by the men and women they send to Washington, especially during troubling and contentious times. My vote to release this memo did exactly that.

You know Milwaukee for their tools, not their beer. Although I'm told it is equally good.

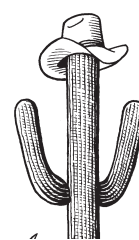
While in the bank your wife discovers, horror of horrors, there's still a red rag hanging out of your back pocket.

## Straus: Audit reveals need for stronger oversight at state agency

AUSTIN — House Speaker Joe Straus on Jan. 31 said a new state audit raises questions about the management of the state Health and Human Services Commission and illustrates the need for legislative hearings.

A report released last week by the State Auditor's Office found that HHSC allowed Superior Health Plan Inc. to report approximately \$29.6 million in bonus and incentive payments paid to affiliates' employees, even though those payments were not allowed under the state's contract with Superior. The state agency also approved Superior's request to report affiliate profits as costs without following the approval process contained in the state's contract with Superior.

"This audit highlights serious weaknesses in HHSC's oversight of its own contracts. Taxpayers have a right to expect that the Commission will hold providers to contract re-

quirements. Unfortunately, this isn't the first example of HHSC failing to properly enforce requirements in taxpayer-funded contracts. This audit shows that there is a lot of room for improvement at HHSC," Straus said.

Some \$80 billion of the state's \$217 billion budget for the 2018-2019 fiscal biennium is funding the Health and Human Services Commission and the agencies it oversees.

### REVENUE TOTAL INCREASES

Texas Comptroller Glenn Hegar on Feb. 2 announced that state sales tax revenue totaled \$2.67 billion in January, an amount 9.1 percent more than the total recorded for January 2017.

Sales tax revenue is the largest source of funding for the state budget, accounting for 58 percent of all tax collections. Growth in sales tax

revenue occurred across all major economic sectors in January, led by collections from the mining, construction and wholesale trade sectors.

Manufacturing, retail trade and restaurant sectors also saw strong gains. Hegar reported total sales tax revenue for the three months ending in January was up 10.8 percent compared to the same period in 2017.

Revenue from other major taxes on motor vehicle sales and rentals, motor fuels and oil and natural gas production also rose in January. Notably, oil and natural gas production taxes, which totaled an estimated \$407 million for the month, were up 63.9 percent from January 2017.

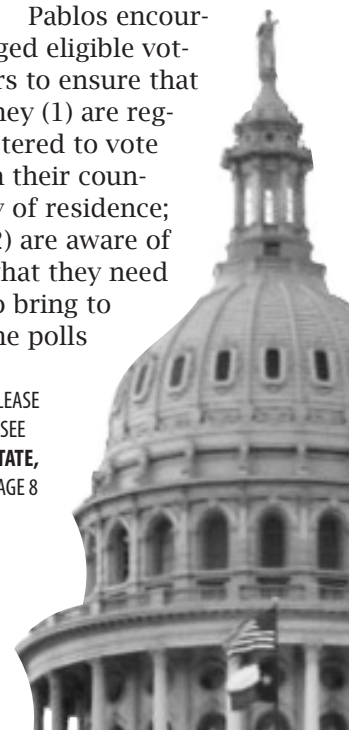
### GET READY TO VOTE, TEXANS

# Being heart healthy

Becoming more heart healthy was discussed during "Heart Health Lunch & Learn" on Friday at Crockett Room.

Crockett County Extension Agent Kailey Roberts and Ozona United Methodist Church Wesley Nurse Niki Bishop gave a presentation that included heart healthy tips and information, as well as a cooking demonstration and recipes.

"Women have unusual signs compared to men," Bishop said during her presentation.

According to The Heart Truth, heart disease is the number one killer of women. The Heart Truth is sponsored by the National Heart, Lung and Blood Institute part of the National Institutes of Health.

It is a national education program for women that raises awareness about heart disease and its factors.

Friday was National Wear Red Day, which serves as a reminder to every woman to care for their hearts.

Heart disease develops gradually and can start a young age. The risk rises in women ages 40-60.

Heart disease can be controlled or prevented through lifestyle changes and medication, Bishop said.

While both men and women can experience chest pain or discomfort, women are more likely to experience other symptoms like shortness of breath, nausea and vomiting, unusual fatigue, pain in the back, shoulders and jaw.

Some of the major risk factors for heart disease include: smoking, high blood pressure, high blood cholesterol, overweight/obesity, physical inactivity, unhealthy eating, diabetes and prediabetes, metabolic syndrome, preeclampsia, sleep apnea, stress and heavy use of alcohol.

Having one of the risk factors can double a person's risk of heart disease. Two can quadruple and three or more can increase a person's risk more than ten-fold, according to The Heart Truth research.

By eating right, being physically active, not smoking and maintaining a healthy weight, a person can lower their risk of heart disease by 82 percent.

"It's an eye-opener," Bishop said. "Talk to your doctor. As women we should be going to our doctor annually and they should be checking for heart disease."

Bishop said many wom-

en don't think about heart disease because they think it mainly affects men, they put other priorities first or they are too busy or too stressed and tired.

"It's a wakeup call. You need to make it a top priority," she said. "With lifestyle changes, I tell people to start out small and build up."

Bishop also showed participants how much fat, sugar and salt are in some of their favorite foods and offered handouts emphasizing that water is the best beverage to drink when it comes to being heart healthy.

Roberts gave a cooking demonstration showing how to prepare a Southwestern Quinoa Salad, a recipe from the Dinner Tonight, a program through Texas Agrilife Extension Service.

Participants also got to make Take-a-Break Snack Mixes and taste Avocado Blueberry Muffins, both recipes from the American Heart Association.

Door prizes were also given.

## DPS ramping up Move Over/Slow Down

AUSTIN - The Texas Department of Public Safety (DPS) is beginning enforcement efforts across the state focusing specifically on violations of the state's Move Over/Slow Down law. These periodic enforcement operations by DPS Troopers are planned throughout the year at various locations in Texas, with several operations planned in February.

The law, originally passed in 2003, requires motorists to move over or slow down when certain vehicles - including police, fire, EMS, Texas Department of Transportation vehicles and tow trucks - are stopped on the side of the road with emergency lights activated.

Specifically, Texas law states that a driver must either:

- Vacate the lane closest to the applicable vehicles

stopped on the side of the road (if the road has multiple lanes traveling in the same direction), or

- Slow down 20 mph below the speed limit. (If the speed limit is below 25 mph, the driver must slow down to 5 mph.)

Drivers should only move over if they can do so safely and legally; otherwise, they should slow down.

Violations of the law can result in a fine of up to \$200; the fine increases to \$500 if there is property damage. If violators cause bodily injury, they can be charged with a Class B misdemeanor, resulting in possible jail time and a maximum fine of \$2,000.

Preliminary data from 2017 shows that DPS issued more than 10,650 warnings and citations to motorists violating the Move Over/Slow Down law.

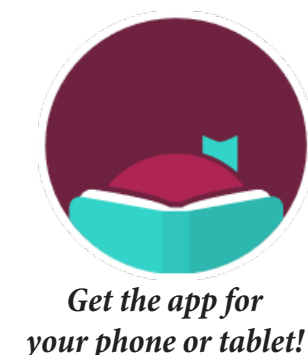

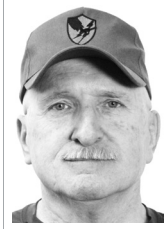

**Protein, the 'Holy Grail' of nutrients?**



**HERE'S TO YOUR HEALTH**

Protein is the essential nutrient, containing the building blocks for sustaining life. An 8-ounce piece of red meat will give most people what they need for normal daily activities, from 80 to 130 grams. Some claim protein to be the "holy grail" of nutrients and overestimate the amount the body requires for various activities. Others propagate all the protein myths and dogma that have circulated in the texts and journals of nutritional science for some 100 years, with no science to support them.

Protein is macronutrient present in food consisting of amino acids, the building blocks for many major parts of the human body. Imagine proteins are much like Tinker Toys or Legos, used in various ways to build many items.

The body makes most of its own amino acids but some, called essential amino acids, have to come from the food we eat. While our bodies can recycle up to 300 grams of protein per day, it cannot be stored, as in the case of glucose and triglycerides from consumed carbohydrates and dietary fat.

According to nutrition expert, Marty Kendall, who qualifies himself as "an engineer with an interest in nutrition who seeks things numerically" ... "There is a lot of confusion ... about 'excess protein'."

"Insulin and protein are used to build and repair your muscles, organs and the other important parts of your body. This is an important and beneficial use of protein and insulin."

"Foods that contain the harder to find nutrients (e.g. potassium, magnesium, choline, vitamin D) typically contain plenty of protein."

"Actively avoiding protein and can lead to a less nutritious diet."

"Unless you require therapeutic ketosis for the treatment of cancer, epilepsy,

Alzheimer's, Parkinson or dementia, you should be chasing vitality, health and nutrition along with stable blood sugar levels ...

"There are a range of different ways to quantify protein intake. [Measure your nutrients in grams or ounces per body weight.] Thinking in terms of percentages can be more confusing than helpful."

"It's hard to over-consume protein because it is highly satiating. However, if you avoid protein your body may drive you to consume more calories until you get the protein it needs."

"If you follow your appetite and focus on foods that contain the vitamins and minerals you need you will probably get enough protein."

Wikipedia, the free encyclopedia further explains, "Amino acids are necessary nutrients. Present in every cell, they are also precursors to nucleic acids, co-enzymes, hormones, immune response, repair and other molecules essential for life... Aside from water, proteins are the most abundant kind of molecules in the body. Protein can be found in all cells of the body and is the major structural component of all cells in the body, especially muscle."

A person can live and thrive without ever eating a single carbohydrate during their lifetime. This is facilitated by a process called "gluconeogenesis", an on-demand process where the liver converts protein into glucose and mandates it for use elsewhere in the body.

Presently, animal-derived foods contribute about 70 percent of protein sources in

North America. Meat, dairy, eggs, and fish are the best sources of complete protein. Plant based food sources of proteins such as grains, legumes, nuts, seeds and fruits must be combined to form complete proteins. Unfortunately, many of the phytochemicals in some plants cause various autoimmune diseases and trigger many illusive food sensitivities.

Three reasons to use protein, rather than carbohydrates, as an energy source:

1. Protein is more satiating and takes longer to digest than carbohydrates, which means that calories from protein tend to keep you full longer than calories from carbohydrates. This can be very helpful in controlling calorie intake and managing your weight.

2. Protein doesn't cause sharp spikes in blood sugar, which reduces your risk of diabetes.

3. Protein can modestly boost your metabolism, or the rate at which your body burns calories.

Our bodies react genetically to everything we ingest, whether it be nutrient or malnutrient. Protein is an essential nutrient and we must include and appropriate amount in our ways of eating for good health and wellbeing. We all are bio-individuals and there is no one-size-fits-all diet, way of eating, or quick fix that is going to cure everyone. Each of us owes it to ourselves to take responsibility and be proactive about our own wellbeing and help our caregivers save us from ourselves and the countless individuals, groups, institutions, and industries that seek to profit from our ignorance, ill-health and misfortune.

prepared me for this position. While being a business owner and board member, I have assisted in the management of budgets for both profit and nonprofit organizations. I have always used conservative judgement when making decisions for these organizations and if elected I will use this same judgement when evaluating the budget for Crockett County.

The school board and commissioners' court collaborate on matters concerning our schools and county. Much like the commissioners court, the CCCC-SD Board of Trustees works as a governing body that oversees the management of our local schools. Duties of a trustee include: working with the school attorney and within the guidelines of legal policy to build local board policy, setting goals that best serve needs of the Crockett County Consolidated Common School District and the community, and providing good governance to assure that policy is followed and promotes student and faculty success within the community in which we serve.

In my second year as CCCCSD Board President and 12th year as board trustee in general, I have listened to the concerns and suggestions of the citizens of the Ozona and tried to effect change that would best serve our students, faculty and community as a whole. I understand that keeping an open line of

communication and cooperation is important for the citizens we serve. I have experience with balancing budgets through windfalls and shortages while making tough decisions along the way. 

# CCCCSD District of Innovation Plan public meeting Feb. 15

The CCCCSD District of Innovation Committee will hold a public meeting at 4:30 p.m. Thursday, Feb. 15, at the CCCCSD Administration Office, 797 Avenue D.

Items on the agenda include a public meeting to review the District of Innovation Plan and accept the CCCCSD District of Innovation Plan.

Innovative districts can exempt themselves from certain laws, including hiring instructors for career and technical classes based on years of experience, but not teacher certification, and make changes to the school calendar like the start date. Those are the two main areas CCCCSD is considering.

The District of Innovation Committee is the school district's site-base committee, which is comprised of teachers, administrators, parents and local citizens.

The committee must come up with a five-year plan for the district, post it online for 30 days and hold a public meeting to consider the final plan. Once the plan receives a majority vote from the committee, it is presented to the board who may vote to approve it.

Prosecutors have also pointed to how Uresti was struggling financially at the time of the company's fraud scheme. And investors themselves have emphasized that without Uresti, they would not have trusted the unknown company with their money.

Meanwhile, defense attorneys have attempted to distance Uresti from the company, arguing that Uresti was unaware and uninvolved with the fraud that occurred at FourWinds. In cross examination of various witnesses for the prosecution, for example, defense attorney Michael McCrum has tried to show that Uresti did not know about the company's forged financial statements. The burden of proof falls on the government to demonstrate Uresti was complicit in criminal dealings.

At stake for the legislator are millions of dollars in fines, years in federal prison and a two-decade career in the Texas Legislature. If convicted, Uresti would lose his long-held seat in the Texas Legislature, though he could continue to serve during the appeals process.

Prosecutors spent much of Thursday afternoon airing explicit text messages between Cantu and Uresti, arguing that their intimate relationship had led her to invest in the company that would ultimately defraud her. The defense on Friday made much the same argument — but with their focus on a different sexual partner. It was Bates, the defense argued, who leveraged his intimate relationship with Cantu to convince her to invest more money in the scheme.

However, Cummings added that "a categorical denial of employment opportunities to all job applicants convicted of a prior felony paints too broad a brush and denies meaningful opportunities of employment to many who could benefit greatly from such employment in certain positions."

Cummings ordered the EEOC to promulgate an enforceable, substantive rule.

**ABBOTT COMMENTS ON ARRESTS**  
Gov. Greg Abbott released a statement following the announcement by the Texas Department of Public Safety that the Texas Rangers on Feb. 1 had arrested four suspects on charges of misconduct at the Texas Juvenile Justice Department.

"Misconduct on the part of employees entrusted with the responsibility of protecting our youth will not be tolerated," Abbott said.

The arrests come after Abbott directed the Texas Rangers to investigate reports of sexual misconduct and inappropriate relationships at state youth detention facilities.

Cantu testified Thursday that her relationship with Uresti, built as early as 2010, turned intimate. That romantic relationship made her trust him years later, when he suggested she invest in the frac-sand company, allegedly asking "Are you ready to make some money?"

"I knew he was married, but we would still be intimate at times," Cantu told the jury Thursday. "He was a good friend. We could talk about anything."

Uresti — whom Cantu called "Carlos" throughout her testimony — has denied that they had an affair.

Cantu said Uresti convinced her that the investment was "guaranteed" and "good as gold." She said she was under the impression that he had invested his own money in FourWinds as well, though he had not.

On cross-examination, Uresti's defense tried to highlight Cantu's affair with another FourWinds affiliate:

Bates, the former CEO, who pleaded guilty last month to eight felony charges related to his work at the company.

And McCrum attempted to downplay Cantu's relationship with Uresti, which she initially denied in an interview with FBI agents investigating FourWinds.

McCrum also made much of the fact that she could not recall many details or dates.

He asked, did you have sex with Uresti in 2012?

"Could be... I didn't write down the days we had sex," Cantu said softly from the stand. She was asked to speak up three times Friday morning alone.

"How about for 2013? Was it more than one time?"

"Could have been."

"Maybe more than once..." McCrum scribbled on an easel facing the jury. "What about in 2014?"

That line of questioning continued until they got to the year 2017, as McCrum looked to downplay Cantu's relationship with Uresti while emphasizing her ties to Bates.

McCrum also played for the jury a voicemail Uresti left for Cantu in August 2014, advising her not to agree to a FourWinds investment deal before discussing the terms with him. That message was left on the same day that Cantu signed an agreement and exchanged sexual messages with Bates, McCrum noted.

To testify in the trial, Cantu had to be released from police custody, where she has been held since November on charges of aggravated assault and aggravated robbery because she was unable to post bail. U.S. District Judge David Ezra ruled that attorneys could not mention those unrelated charges in court.

After the prosecution wraps up its case — likely early this week — the defense will have its chance to call witnesses. Uresti's attorneys told the San Antonio Express-News they have not yet decided whether they'll call the senator to testify. Even if he doesn't take the witness stand, jurors may hear audio recordings of interviews Uresti gave the Express-News in 2016, when the newspaper published a lengthy investigation of FourWinds.

Defense attorneys are expected to call more than a dozen witnesses from lists of more than 200, which enumerate several high-profile names, including state Sen. José Menéndez, D-San Antonio, Republican Lt. Gov. Dan Patrick and Republican Comptroller Glenn Hegar.

Monday marked the 11th day of a trial attorneys originally expected to last three weeks, but which has dragged slightly. The judge has already instructed lawyers to pick up the pace.

Uresti is also scheduled to go to trial in early May on separate bribery allegations. He was indicted on those counts, as well as the charges he's fighting this week, in May 2017 after a February FBI raid of his law offices.

The lawmaker has also been accused of sexual harassment at the Texas Capitol, charges he has denied. The judge ruled that those allegations will not be allowed in court.


