Primary Runoff early voting ends Friday, Election Tuesday

Early voting for the May 22 Primary Runoff Election ends Friday, May 18.

Crockett County Voters can cast their ballots from 8 a.m.- 5 p.m. at the courthouse annex. They are open during the noon hour.

Election Day voting on Tuesday, May 22, will be from 7 a.m.-7 p.m. with Precincts 1, 2 and 3 at the courthouse annex and Precinct 4 at the Ozona Chamber of Commerce Visitor Center.

Locally, there is only one race. In the Democratic Primary incumbent Eligio Martinez is facing Michael Medina Jr. for the Crockett County Commissioner, Precinct 4 position.

State and federal races that will also appear on the Democratic Primary ballot are:

- U.S. Rep. District 23 - Gina Ortiz Jones and Rick Trevino

- Governor - Lupe Valdez and Andrew White

If you voted in a party primary, you're eligible to vote in that primary's runoff. According to the Texas Election Code, if you haven't affiliated with a particular party

Recently, one such Texan received an award for serving 40,000 hours as a volunteer in the Big Springs VA facility, which provides service to many of my West Texas constituents.

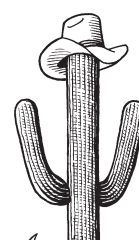

A Rare Bird

The closest town to mine is a well known bird sanctuary and once a year "birders" migrate to the big bird bash where they fill up the hotels, dine in local restaurants and put a smile on the face of the fine feathered folks at the local Chamber of Commerce. Believe it or not, 20% of Americans are proud to call themselves bird watchers and they annually spend in excess of 36 BILLION dollars to add to their "Life Lists" of birds they've seen.

There are thousands of rural towns in this country struggling right now and they could sure use the cash derived from such birdbrained activities. The problem is that most towns just don't have the birds for it. Oh sure, they might have their share of lemmings, pigeons and jail birds, but that's just the city council, and I really doubt rich people from the east would pay to see them. So I asked myself, what do rural towns have that are vanishing everywhere else that folks would flock to see?"

Cowboys, that's what! There are many advantages of "cowboying" over "birding". Cowboys are more colorful, interesting and they don't bomb you from above, if you know what I mean? You don't need expensive binoculars, spotting scopes or cameras and unlike bird watching, you can watch for cowboys in the air conditioned comfort of a mall, bar or airport. Like birds, the cowboy species you'll see will vary by where they're from, and are identifiable by the shape of their hats, their saddle rigging and the sounds they produce. In Nevada you'll see the

black booted buckaroo, in Texas it's the red-necked cow puncher, and in California you might catch a fleeting glance of a silver-saddled vaquero.

To watch cowboys all you do is find a bench on Main Street and start watching. You can do it anywhere, although cowboy watching might be a little slow in Santa Monica or New York City. Even if you did spot one wearing colorful plumage in their hat and silver tips on their boots, it's probably just a hair dresser.

Species of cowboys include dudes, rodeo and drugstore cowboys, along with the much rarer working varieties. Subspecies include team ropers stove-up old cowboys who had to resort to shepherding, corn farmers who would run from a uterine prolapse, Harley riders who look like they could bulldog a steer from their bike and politicians who wear boots in states like New Mexico, Texas and Wyoming where the cowboy vote can swing an election.

Spotting the genuine article is not as easy as spotting someone in a hat and boots and walking like their legs were wrapped around a barrel. It could be a Sheriff, lawyer, or line dancer. The drugstore species wears the right clothes and can be spotted watching rodeos but

wouldn't know the difference between a Hereford and a heifer. They are not to be confused with the multimillionaire absentee owner who flies in once a year like a migrating goose, honking and generally making a mess of things.

Rodeo cowboys are easy to spot because they sleep in the same trailer they haul their horse in. If you see a cowboy walking into a jewelry store, bank or a Mercedes dealership, it's a cow buyer, not a buckaroo. Speaking of bankers and cow buyers, the dead giveaway they aren't cowboys is that real cowboys wouldn't be caught dead roosting in a vegetarian restaurant.

You'll know right away if you spot a working cowboy because he'll be driving a broken down pickup and have silver on his spurs. But his kids are barefoot. The working cowboy has small feet, is missing at least one digit, has a white forehead but the rest of his face is sunburnt and is as rough as rawhide. Skin cancer is a common blemish and there is usually a ring on the back pocket left by a can of Copenhagen. Speaking of rings... cowboys are usually monogamous mates but can often be seen alone and without a band around their ring finger. All because their last wife wanted to live in a house with indoor plumbing and heat she didn't have to chop first. Imagine that.

So good luck. If you see one, congratulations! A real cowboy these days is a rare bird indeed.

Paxton requests federal funding for women's health program

AUSTIN — Texas Attorney General Ken Paxton last week asked two federal agencies to move quickly to fund the state's Healthy Texas Women program.

The program was cut off from Medicaid funding by the Obama administration in 2012 after the Texas Legislature enacted a law preventing taxpayer money from going to abortion providers.

In a May 7 letter to the U.S. Department of Health and Human Services and the Centers for Medicare & Medicaid Services, Paxton said the addition of some \$30 million a year in federal dollars would increase access to family planning and preventative health services for low-income women across the state who are not covered by traditional Medicaid in Texas.

Paxton sent the letter at the request of Gov. Greg Abbott and on behalf of the Texas Health and Human Services Commission. He wrote that al-

lowing states to exclude providers who perform or promote abortion is consistent with federal policy.

Texas spends \$29 billion a year on Medicaid — more than one-fourth of the state's annual budget — to serve some 4.3 million people. The state allocates another \$95 million annually to fund the Healthy Texas Women program, which has a current enrollment of 240,798 women, Paxton noted.

"States have discretion in implementing the Medicaid Act, including in setting qualifications for providers," Paxton wrote. "Texas and the Healthy Texas Women program should not be penalized through the continued withholding of federal funds merely because Texas has exercised the authority that federal law has granted to it — namely, the authority to re-

fuse to be a conduit for channeling taxpayer funds to abortion providers pursuant to state law."

FORUM HONORS WOMEN

Texas Comptroller Glenn Hegar on May 7 highlighted Texas women in the workforce by hosting a roundtable discussion with a dozen women leaders who comprise the Texas Governor's Commission for Women.

The panel was part of a briefing with the Governor's Commission for Women to review Gov. Abbott's priorities for the commission and to develop strategies to make Texas "the best state for women-owned businesses."

The discussion addressed topics such as hardships women face in the workplace, women with families who pursue careers, ways to move more women into higher-pay-

ing jobs and women as entrepreneurs. The discussion is part of Hegar's multi-stop "Good for Texas Tour: Women in the Workforce."

More than 6 million women held jobs in Texas in 2017 and 938,000 women-owned businesses generated about \$134.2 million in sales, but further efforts are needed

Visitors can talk with soldiers, see early settlers and wander through the ruins imagining the once-impressive fort buildings including the barracks, stables, blacksmith shop, and hospital. As part of Western Frontier Days, the site will recog-

nize the History of Fort Lancaster and celebrate Armed Forces Day during a special ceremony at 1 p.m. on Saturday, May 19. Following the ceremony, the Sahawe Dancers will provide a Native American cultural dance performance. Come out to Fort Lancaster to experience the rich history and culture of West Texas. Spanning 82 acres in the Pecos River valley, Fort Lancaster State Historic Site commemorates Fort Lancaster, established in 1855. Exploring the relationship between fructose and your liver

"What the liver does with fructose, especially when there is too much in the diet, has potentially dangerous consequences for the liver, the arteries, and the heart." ...reports the Harvard Medical School.

Yep, that's three more reasons to omit or limit foods that generate a lot of sugar. Human organisms process glucose and fructose, the prevalent sugars in our diet, in different ways. Just about every cell in our body can break down glucose for energy but the only cells that can deal with fructose are in the liver.

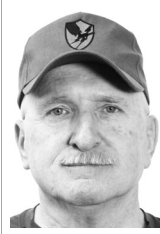
Ever wonder how Non-Alcoholic Fatty Liver Disease (NAFLD) or Alcoholic Fatty Liver Disease (AFLD) occurs? Well, look no further.

Harvard Medical School adds, "Fructose, also called fruit sugar, was once a minor part of our diet. In the early 1900s, the average American took in about 15 grams of fructose a day (about half an ounce), most of it from eating fruits and vegetables."

Well, that was a hundred years ago, we're eating four or five times that these days. Just about all our fructose comes from the refined sugars used to make processed foods like breakfast cereals, pastries, sodas, fruit drinks, and other sugary foods and beverages.

Amanda MacMillan wrote in the May 1, 2017 edition of Time Magazine; "About 30 percent to 40 percent of American adults have a condition that has no visible signs and rarely causes symptoms, but can raise the risk of heart disease, diabetes, cirrhosis and liver cancer. It's called nonalcoholic fatty liver disease ...an umbrella term for several stages of disease. Most people with NAFLD have what's known as simple fatty liver, which means that more than 5 percent of the liver is made up of fat cells."

When fructose enters the liver for processing it initiates a sequence of complex chemical changes.

One of those changes is that the liver uses fructose, a carbohydrate, to create fat in a process called lipogenesis. Given enough fructose, fat molecules start to amass in our liver cells. NAFLD is diagnosed when fat molecules reach a threshold of 5 percent of normal liver cells.

"People with simple fatty liver don't have inflammation or scarring in their liver and don't appear to be at high risk for liver complications. But the condition affects insulin sensitivity and puts people at higher risk for diabetes and cardiovascular disease. Increased liver fat is never normal," says Dr. Jaideep Behari, associate professor and founder of the University of Pittsburgh Medical Center's Fatty Liver Clinic.

NAFLD was virtually unknown before 1980, but it now affects up to 30 percent of adults in the United States and other developed countries, and between 70 percent and 90 percent of those who are obese or who have diabetes.

The Harvard Medical School advises, "Early on, nonalcoholic fatty liver disease is reversible. At some point, though, the liver can become inflamed. This can cause the low-grade damage known as nonalcoholic steatohepatitis ("steato" meaning fat and "hepatitis" meaning liver inflammation). If the inflammation becomes severe, it can lead to cirrhosis — an accumulation of scar tissue and the subsequent degeneration of liver function."

Excess fructose in the liver does more than just cause the buildup of fat, it also elevates triglycerides, promotes the buildup of fat around or-

gans (visceral fat), increases blood pressure, makes tissues insulin-resistant (a precursor to diabetes), and increases the production of free radicals, which are energetic compounds that can damage DNA and cells... and all these changes are bad for the arteries and heart. In fact, people with NAFLD are far more likely to die of cardiovascular disease than liver disease.

Also referred to as "High Fructose Corn Syrup (HFCS)", fructose is a very questionable sweetener. Just because it comes from fruit and vegetables does not mean that it is categorically "healthy" for your fitness and wellbeing. It is much cheaper than regular sugar and extends the shelf life of processed products. Aside from the liver, the arteries, and the heart; fructose has been linked to many health problems such as obesity, dementia, diabetes, and cancer. For this reason, many consumers have begun to check food labels and steer away from foods containing HFCS and other forms of fructose.

"For the majority of patients, lifestyle modification is way more effective than any drug," says Dr. Jaideep Behari.

"Here's to Your Health," is only one source seeking to educate and enable you to be your own health, wellness and fitness advocate. The information is "out there," you must take the initiative to pursue what is beneficial to you. There is no "one size fits all" way of eating. You must develop a "seek and tweak philosophy" in the management of your lifestyle, way of eating, and wellness.

Here's to your health.

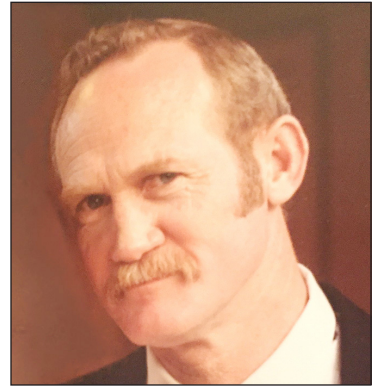

Wellness center aiming for July opening

The J. Cleo Thompson Wellness Center is aiming to open July 2.

During Monday's regular meeting, the Crockett County Commissioners' Court approved to allow Wellness Center Director Stormi Oglesby to purchase furniture, fixtures and equipment up to \$40,000 for the new center.

Oglesby also presented the packet of information, including membership application, membership fees, physical fitness readiness questionnaire, physical activity release form, membership agreement, and consent form for children's classes and bylaws for approval.

Oglesby said the center plans on offering swimming classes and fitness classes for children. Classes will be a separate charge and the money will go toward the center, not the teacher.

Regular membership will be for adults 18 and over. She also said you do not have to have a physician's release to be a member. Crockett County Attorney Jody Upham also reviewed the information.

Commissioner Frank Tambunga said he wanted to review the information before approval. The commissioners tabled the item until a May 22 special meeting.

Oglesby also said all center employees, including herself, have completed Texas Association of Counties Harassment Training, Lifeguard and CPR and First Aid Certification.

She said fitness equipment should arrive this week and equipment training will be May 22. Final cleaning will be this week and walk through with the architect and making of punch list will be the last two weeks of May.

The pool has been filled. It still has to be labeled, but Oglesby has received training on the pool and equipment.

Employees and myself gone through TAC Harassment Training and Lifeguard Certification.

Final construction cleaning scheduled this week, equipment delivered this week and this equipment training on May 22 and architect walk through. Pool is full. Still have to get it labeled.

The center also has a website at ozonawellness.com, Facebook page and phone app.

Oglesby said an open house is being planned for the middle of June for people to walk through the facility and sign up for memberships, with opening day aiming for July 2.

ACTIVE SHOOTER TRAINING

The commissioners approved Active Shooter Training for county employees given by Texas Parks & Wildlife Game Wardens Dan Waddell and Chris Amthor.

Tambunga said he attended the recent Active Shooter presentation and luncheon at the Ozona Chamber of Commerce Visitor Center and felt

the training would be good for county employees.

He said the game wardens are willing to talk to all county departments.

FIRE SIRENS

Georgia Morrow, with the Ozona Volunteer Fire Department, spoke with the commissioners about the fire sirens around town.

Morrow said the sirens are not blown on Sunday mornings and evenings, Tuesday and Wednesday evenings due to church services. They are also not blown from 8 p.m.-8 a.m., unless it is a weather emergency like a tornado.

Morrow said the department does blow the sirens when there is a fire, and on second call-outs to get firefighters to show up. She also said having the sirens lets ranchers and townspeople know that something is happening, and that firefighters will be coming through town.

She said sirens are generally not sounded on traffic accidents, unless firefighters are not responding.

Firefighters from other towns, like Big Lake, Sonora and Irion County, who are working in Ozona sometimes respond when they hear the sirens as well.

Many people in the community have told Morrow they don't want the sirens silenced. Morrow said there are two sirens that do need repairs.

"We now have people who say they can't hear the sirens. The sirens are for the townspeople's protection," she said. "I think it's for the betterment of the community."

Along with the sirens, Morrow said firefighters also have radios and are connected to the e-dispatch.

"We have technology to do away with it (sirens), but we don't want to do away with it," Morrow said.

Commissioner Wesley Bean said he thinks there are some people that are tired of hearing them blow a lot.

Morrow said the department has been busy lately, especially with drought conditions and grass fires.

Deaton said the county has invested "significant money" on the siren system.

"If we're going to have them then all of them should be on," Tambunga added.

The commissioners did agree to continue the county-wide burn ban until next month.

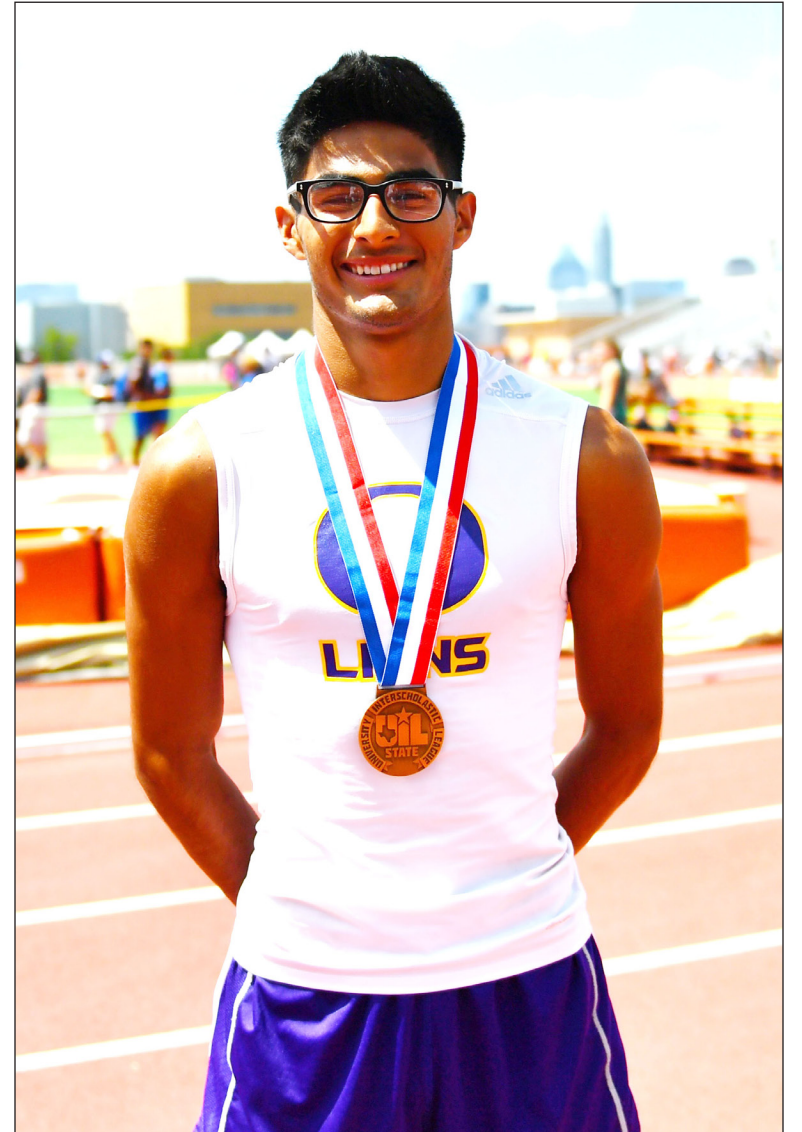
Luke Williams, of Wellington, won the Class 2A Boys Division with a vault of 15-0. Quentin Schulze, of Junction, was second at 14-9.

during the same voting year — by either participating in a party's primary or convention — you can vote in any party's primary runoff election as long as you're registered to vote for that race, according to the Texas Election Code.

"So if, for example, a voter who participated in the Democratic primary wants to vote in a Republican primary runoff, he or she will not be accepted to vote in that Republican primary runoff race," said Sam Taylor, a spokesman for the Texas Secretary of State's Office.

If you voted in your party's primary and choose to vote in the runoff elections, you don't need to re-register to vote, Taylor said.

The same form of ID that's required to vote in a primary is needed for a runoff.

The forms of approved photo ID are:

- Texas Driver License
- Texas Personal Identification Card
- Texas Concealed Handgun License
- United States Military Identification card containing the person's photograph
- United States Citizenship Certificate containing the person's photograph
- United States Passport
- Election Identification Certificate - issued free by Texas DPS

With the exception of the U.S. citizenship certificate, the approved photo ID must be current or have expired no more than four years before being presented for voter qualification at the polling place. As provided by court order, if a voter does not possess and is not reasonably able to obtain one of the seven forms of approved photo ID, the voter may vote by (1) signing a declaration at the polls explaining why the voter is reasonably unable to obtain one of the seven forms of approved photo ID, and (2) providing one of various forms of supporting documentation: certified birth certificate (must be an original), a valid voter registration certificate, a copy or original of one of the following: current utility bill, bank statement, government check, or paycheck, or other government document that shows the voter's name and an address, although government documents which include a photo must be original and cannot be copies.

the Texas Association of Counties 2017 Short Answers to Common Question document, protocol for the appointment is explained as follows:

Question: Is there a statutorily mandated process for making an appointment?

Answer: "No. The commissioners' court, county judge, or district judge as appropriate, may devise the appointment process. Some counties, for example, publish a notice of the vacancy in the newspaper with a time period for interested persons to apply. Other counties ask potential appointees to fill out an application to establish their eligibility for the office. NEITHER IS A REQUIRED PRACTICE."

And according to Texas Local Government Code Section 87.041

A. The commissioners' court of a county may fill a vacancy in the office of Treasurer.

B. The commissioners' court shall fill a vacancy by a majority vote of the members of the court who are present and voting.

C. The person appointed by the commissioners' court shall hold office until the next General Election.

The appointment procedure to this position is not a hiring process. An application is not mandatory. However, an application provides a good list of the applicant's qualifications, their availability, and the applicant's expectations. I sincerely appreciate the good people who have confidently applied to serve Crockett County in this public position.

"After a lot of deliberation, we've gone through, it's our position to appoint the most qualified person," added Commissioner Pleas Childress.

Conner was interviewed during a special meeting on May 10. Her application was submitted after the April 25 deadline the commissioners set at their April 9 meeting and that was advertised in The Ozona Stockman for two weeks.

Prior to their vote, the

commissioners interviewed Roylan Sullivan Monday morning. Sullivan also turned in her application on May 10 but was unavailable for interview on that day.

Candidates that were interviewed on April 28 that turned in applications by the April 25 deadline were: Amy Cowley, Annette DeHoyos, Elsa Fierro, Cynthia Hokit, Molly Martin and Pete Morado.

At the May 10 meeting, Tambunga disagreed with accepting Conner's and Sullivan's applications after the April 25 deadline.

"We received their applications after we advertised it two weeks in the paper. I don't think we should accept them," said Commissioner Frank Tambunga.

Commissioner Eligio Martinez said he agreed with Tambunga.

Conner will be finishing the term of Karen Webb, who died in March of a brief illness. The term expires at the end of December.

Conner previously worked for San Felipe Del Rio CISD as the school district's comptroller for five years.

She is a graduate of Del Rio High School and has bachelors and master's degrees in accounting from Texas A&M-Corpus Christi.

As for the November election, it will be up to Crockett County Democratic Party to decide whose name is on the ballot. Webb won the Democratic Primary in the March 6 Primary Election. She did not have an opponent in the Republican Primary, so her name would have been placed on the November ballot for the General Election running unopposed.

When there is a death, and the primary elections have already been held, it's up to the county party chair to decide who is put on the November ballot. Crockett County Democratic Party Chair is Margaret Riquelmy. The party chair can consider the person the commissioners appoint.

The only other way a person could run as county treasurer in November General Election would be as a write-in candidate.

to eliminate barriers to women's entrepreneurship and improve access to top-level positions, Hegar said.

MAY ALLOCATIONS ARE SENT

Comptroller Hegar on May 9 announced his office would send cities, counties, transit systems and special purpose taxing districts \$861.8 million in local sales tax allocations for the month of May.

The amount is 9.4 percent more than was distributed for the month of May 2017. Allocations are based on sales made in March by businesses that report tax monthly and sales made in January, February and March by quarterly filers.

HURRICANE SEASON COMING

With the hurricane season less than one month away, Gov. Abbott and the Texas Department of Public Safety on May 7 urged Texans to use Hurricane Preparedness Week to learn how to protect themselves and their families from hurricanes and tropical storms. Hurricane season starts June 1 and continues through Nov. 30.

The DPS posted of list of actions to take, such as:

- Assemble an emergency kit that includes essential documents, supplies and provisions;
- Review hurricane evacuation maps and select a route;
- Plan how family members and pets will evacuate safely;
- Consider special needs for individuals with disabilities and the elderly; and
- Stay informed about changing weather conditions.

ABBOTT HONORS THE FALLEN

Gov. Greg Abbott on May 7 joined law enforcement officers from across the state for the 2018 Texas Peace Officers Memorial Ceremony to honor fallen Texas peace officers and their families.

During the ceremony, Abbott met with and presented medals to the families of officers who died in the line of duty. The ceremony included the laying of a memorial wreath and a 21-gun salute.

Last year, during the 85th session of the Texas Legislature, Abbott signed House Bill 3647, legislation that established the Texas Peace Officers' Memorial Ceremony as an annual event. This year's ceremony was the first to be conducted since the law was passed.

CROCKETT COUNTY PUBLIC NOTICE

ORDER RESTRICTING OUTDOOR BURNING

The Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning; and NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Crockett County, Texas, that outdoor burning is restricted in Crockett County for 30 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 352.081, and other applicable statutes. This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on hand. This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times. In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.


