
HOME "A Tribute to Billie Loving"

The Coleman County Water County Supply Saturday, May 15th for the purpose of converting from a water supply corporation to a special utility district and addi- 15th. The polling place will be tionally, to elect temporary direc- located at the Corporation's oftors for the newly formed district. fice and will be open from 7:00 CCWSC manager Davey Thweatt said that persons qualified to vote in this election are registered voters who reside within the proposed district boundaries. "The cites of Coleman and Santa Anna are not included in the proposed district," said Thweatt. "The district will include all of Coleman County (except the Trickham and Buffalo communities which are currently in the Brookesmith Special Utility District), northeast and southeast Runnels County (Content area and Lake Ivie area, southern Taylor County (Lawn area), southern Callahan County (Cross Plains area), and northern Brown County (Cross Cut area)." A map of the district and a sample ballot will be published in next week's issue of the Cross Plains Review.

"There are several advantages for the corporation in converting to a Special Utility District," said Thweat. "The main one being that this conversion will enable the corporation to seek tax-exempt financing for future project. I must emphasize that the district will not have a taxing authority." Early voting will begin on April 28th and extend through May 11th, 2004. The early voting box will be located at the Coleman

#### Plains Cross I.S.D. **Credit by Exam Available**

Cross Plains I.S.D. students may receive credit for an academic subject in which the students has had no prior instruction if the student scores 90 percent or above on a criterion-referenced examination for acceleration in the course. Credit by Exam is offered for all elementary grades K-6 as well as for all courses 7-12. If such credit is given, the examination score will be entered on the student's permanent record and transcript; and the score will be used to compute class rank.

State law requires that three days between January 1 and June 30 and three days between July 1 and December 31 will be scheduled annually for the admiration of the examination for acceleration. The Cross Plains I.S.D. school board has examination for acceleration in the summer of 2004:

> June 28, 29, and 30 July 6, 7 and 8.

There is no fee for the credit for examination used for acceleration. The student interested in taking credit for examination must submit a request to Jimmie Cearley, High School Principal, Margie Sowell, Elementary Principal, or Ed Brady, Counselor by April 20, 2004 for either testing session. Request forms can be obtained at either principal's office or the counselor's office.



Through her words I was alienated, but through her eyes I felt her yearning. She needed support in her search for strength and a new start. She needed my friendship now more than ever. So I took her hand and told her that I was there and that it was okay to cry - so she did.


## Former Resident Recently Recognized as **Outstanding in the Field of Agriculture**




