The second large ranch in th's county was the Dixle ranch. Its headquarters house was built near the present Tahoka-Lubbock road on the Wilson County School Land by Major Johnson about 1887. "He didn't have much luck," and finally sold out to W. D. Nevels, W. R Clifton, and S. A. King.

Another early ranch in this section was the Deuce O' Hearts ranch. Its first headquarters house was built in 1889. Its owners wire J. K. Milwee and Van Sanders. New Home school was first called Deuce O' Hearts school after this ranch.

In 1900 there were only 17 prople in Lynn county. They were the people at the T-Bar. Dixie and Deuce O' Hearts ranches. After 1900 a few more people began coming in.




