



Concert And Auction Sponsored By Making Progress On Highway No. 9 Caliche; Open Highway No. 84 To East

DELAY SHORT

RELIEF WORK'S

Work on highawy No. 9 north of Tahoka, which was greatly reduced Friday, March 1, was resumed last Saturday, but not with the full force enjoyed by almost a capacity crowd of men until Monday of this week. The project is now about 70 per cent completed, according to information from the Relief office. From 325 to 400 men are being employed, but the daily average is about 125 to 140 men. About eight but trucks are now being used.

Laying of the first course of caliche is almost completed, lacking less than a mile." Laying of the second course is proceeding satisfactorily, several miles having been completed.

.Detour has been shifted back over No. 84 to a point two miles west of Tahoka and thence north.

The recent rains have settled the roadbed south to O'Donnell, wh.ch was completed several weeks ago. and it should be ready for the laying of caliche by the time the sec.or north of Tahoka is completed.

The dump across the lake on highway No. 84 two miles east of Tahoka has been completed and traffic is now open over it. The dump is 2,000 feet long and is four feet higher than the old roadbed.




