And probably he, is a devout Christian. Personally we have never called that in question. We do believe however, that there are better ones





Assign Coast Guard For Friendly Tour To Visit Central American


Ports This Winter.

NEW ORLEANS. - The coast uard—America's police force on the high seas-has been assigned to make a "friendship tour" of the Central American republics.

Late this winter one of the service's large, new cruisers and a 175foot patrol boat will leave New Orleans for various ports of the southern republics. The larger cutter is equipped with an amphibian plane and the newest equipment for navi-gation, communication and life-sav-

The coast guard is seeking to give a wider understanding of its activities, both at home and abroad. It hopes to acquaint the southern countries of its peace-time mission and at the same time promote friendlier relations between the United States and its neighbors. The trip also is expected to result in the selection of appointees to the coast guard academy from the countries visited. Demonstrations of how the guard works, shooting of life lines and rigging breeches buoys and the life of the crew on board the ships will be made at every port visited. Moving pictures will be used to supplement the actual demonstrations.

Plans for the voyage are being worked out by Commander Ellis Reed-Hill of the coast guard, who visited the capitals of the countries to be visited and made arrangements with government officials and United States attaches.
