Aggie Building Is Provided For At Local School

In order to make provision for the ministatement of vocational ogriculture work in the Tahoka high school, which was suspended two wears ego, the bus sheds on the school campus are being converted into a vocational agriculbuilding this week.

The structure is 30 by 60 feet in size. It is boing cut into two rooms ne about 24 by 30 feet in size to he used as a class room, and the other about 36 by 30 feet to be used as a workshop. The windows are all in the south wall for light and ventilation.

The walls are being plastered and will be neatly finished, and the agriculture students will really have commodicus and comfortable lace in which to do their work. The high school building became greatly crowded last year. This addition will afford little relief for that situation, however, for agriculture classes were not taught ast year. It is beginning to look as f substantial additions will have o be added to our excellent school plant as soon as building material becomes available.

Virgil Carter, who taught in this ounty a number of years and who more recently has been superintendent at Meadow, is the new voational agriculture instructor.
