

**Stenholm Cites Needs For New Farm Bill** 

#### **BY DALTON WOOD**

Farmers cannot continue to. produce more than the market will bear, and the 1985 farm bill needs to address ways to take some acreage out of production as well as put some emphasis on selling the product, U.S. Rep. Charles Stenholm told a group of farmers and other citizens at a meeting of Tahoka Rotary Club last Thursday.

The popular congressman for the 17th district, which includes Lynn County, received a standing ovation from the crowd of about 75 club members, wives and other guests at the meeting held at noon in Fellowship Hall of First United Methodist Church.

Many farmers were in the audience as Stenholm, who lives in Stamford when he's not in Washington, said the 1985 farm bill which Congress is about to tackle must meet three criteria: "It must be budget responsible, it must improve net farm income; and it must be passable."

On the budget angle, the Democratic member of the House of Agriculture Committee emphasized that "we must do something about our national deficit. You can live beyond your means only so long; there comes a time when the chickens come home to roost." He added that spending "absolutely must be cut straight across the board, except for those programs helping the elderly poor." He pointed out that this means spending on farm programs also must be cut.

He said the farm program must in some way rescue as many of the family farmers in the nation as possible, but warned that "we're not going to be able to save everybody."

Expanding his comment that the farm bill must be passable, he gress and the President refuse to members and guests.

Stenholm, who also is a member of the House Small Business Committee, discussed briefly some suggested alternatives to the farm program which have been mentioned often in recent weeks, and why he does not believe most of them would work.

Noting that one suggested option is to fine-tune the existing farm program, Stenholm said he didn't think farmers wanted more of the same thing they've had in a farm program. Suggestions of free markets and mandatory controls also were labled as "dreaming" by the congressman, who said neither of these ideas would work.

He observed that mandatory controls on production coupled with high loans would not work because it didn't work with OPEC in the oil industry. He also said the free market concept is idealistic, because "the American farmer cannot survive without government programs." He mentioned that he recently was in Europe to study farm programs and quickly learned that food costs in the United States are

cheaper than anywhere else in the world, "but we don't appreciate it."

"market-oriented supply management" approach to solving the farmers' problems, which means some kind of plan to cut production back and get a good price for what is grown. He suggested a lower loan guarantee, but support for domestic consumption of cotton at a fair price, mentioning a figure of 81 cents per pound. "Let's admit

we cannot farm every acre of

every farm and expect a good

market will bear,"Stenholm asserted. "We must target a farm program to help those growers grossing from \$40,000 to \$200,000 a year," rather than the very largest farmers, he said, meaning a limit on how much government aid one farmer can receive. "I think the 1985 program will

contain some kind of conservation feature -- a second cousin to the soil bank," Stenholm predicted.

He also said the U.S. tax code should not be structured so as to encourage outsiders to get into farming for tax write-off purposes rather than for the profitmotive.

In a question-answer session, the congressman commented on the uproar caused by the new rule requiring auto mileage records on vehicles used for business.

"We saw some abuses in this area and instead of taking a rifle and aiming it at the offenders, we took a shotgun and fired it at everybody in sight," he said. He added that a meeting is scheduled Feb. 3 to consider some easing of the requirements of a daily log onvehicles.



#### **SCS** News **OMB Says - Scrap SCS in 1966**

We are living in a time when our world seems to be upside down. We have grain with no market in this country. Yet, on the T-V news, we have been seeing images of thousands of people in Africa who are starv- ... ing to death.

What the 6 o'clock news doesn't tell you is that much of the starvation in northern Ethiopia is the direct result of soil erosion along with drought and government policy. Lands devastated by years of soil erosion cannot sustain a crop in times of drought.

This year, if we can muster the dollars to buy and send American grain overseas we can help the starving--temporarily. But what of the future--not just next year, but in the next hundred years? IF we do not care for our soils as a national resource, will we be able to continue providing food to others in times of need? It is those questions which our

nation's leaders should be asking as they look at the federal budgets. Instead, what do we find? A nation, temporarily secure in its resources, deciding to eliminate the federal conservation program.

That proposal by the federal Office of Management and Budget should get the response it deserves from the American public: ridicule ... and oppositions.

As a nation, we treasure our national resources. Our soils and water are the sound basis of the most economically agricultural system the world has ever known. But that does not mean we can begin to take them for granted--or worse yet, adopt a national policy of ignoring their value.

The federal soil conservation program has made us the envy the world for our

### **Cotton Harvest** Winds Down

Most of the High Plains 1984 cotton crop was off the stalk by the week ending Jan. 25, according to Mack Bennett, Area Director for USDA's Marketing Services Office at Lubbock. Many modules of field stored cotton remain to be ginned. Much of the remaining harvesting and ginning is in southern and western counties, Bennett said.

Many gins in northern and central counties have finished the season or will finish soon.

The Lubbock office classed 148,000 samples during the week. ended Thursday, Jan. 24. This brought the season's total to 1,570,000 and compares with 963,000 classed by the same date last year.

The week's premdominant grades were grade 52 at 28 percent followed by grade 42 at 23 per cent and grade 51 at 21 percent. About 54 per cent was reduced one grade because of bark.

Predominant staples were staple 30 at 22 percent, staple 31 was 25 percent and staple 32 was 17 percent. The average was 31.2 thirty seconds of an inch.

Micronaire 35-49 amounted to percent, 33-34 was 10 percent, 30-32 was 31 percent, 27-29 accounted for 34 percent and 26 or below was 18 percent. The

High Volume Instrument breaking strength averaged 25.3 grams per tex at Lubbock during the week ended Jan. 24. Cotton prices continued to slide lower on the Texas High Plains. Growers sold mixed lots of mostly grades 42 and 52, staples 30-32, mike 30 -32 at around 400 to 500 points over 1984 Commodity Credit loan rates. This was about one cent per pound lower than a week earlier. Gins paid High Plains growers \$88 to \$105 per ton for cot-
