



# Santa Coming To Town During Moonlight Sale

6:00 - 9:00 p.m. Friday

Santa Claus advised the Tahoka Chamber of Commerce Friday night that he would arrive in Tahoka about the time that Friday night's Moonlight Madness Sale begins, at 6 p.m. A fire truck from the Tahoka Volunteer Fire Dept. will take Santa on his rounds of 15 businesses which are taking part in the third annual Moonlight

Madness Sale from 6 to 9 p.m. He will visit each business briefly, then will be at Heritage Furniture store from 8:15 p.m. to 9 p.m. to talk with all the youngsters who may have missed him at one of the other locations. Warned by chamber officials who spoke to Santa on the phone that the weather has been cold in

Tahoka, Santa replied that it would seem warm after working at the frigid north pole.

Businesses make a special effort to offer exceptional bargains to shoppers for just those three hours, and in the first two years of the event, sponsored by the Tahoka Chamber of Commerce, sales have been good. Traffic in the stores has been good, too, as area residents also are enticed by turkeys and other gifts offered by most of the participants. Each store which gives away something at a drawing Friday requires only that the signups for the drawing be made only during the 6-9 p.m. period, and that those signing up be at least 18, with no requirement made for anyone to be present to win. Winners usually are notified the next day by the individual stores.

"The chamber sponsors this event every year so that the local businesses can get a boost and at the same time show people that you really can get bargains at home," said Chamber President Dalton Wood. Most of the bargains offered during the three-hour sale are detailed in advertisements inside this issue of the Lynn County News.

## Bid Approved For Elevator In Courthouse

Wardrop Construction Co. of Lubbock has been awarded the contract for building an incline entrance for wheelchairs, new restrooms in the basement of the courthouse and installation of an elevator at the Lynn County courthouse.

Wardrop's bid of \$174,344 for the project was one of five received. The project has been authorized to comply with federal standards regarding easy accessibility to public facilities for handicapped persons.

The elevator shaft will start at the Dept. of Public Safety office in the basement, go through the tax assessor's office on the main floor, and up to the present jury deliberation room next to the district courtroom on the third floor. The shaft will be constructed so that the elevator later may be extended to the now unused fourth floor if it ever becomes necessary.

## Lower Speed Limits On Lockwood Pondered

At the request of Tahoka city officials, the state is taking a new look at speed limits along Lockwood St., where there have been two major traffic accidents recently.

Since Lockwood is also U.S. Hwy. 380, speed limits must be set by the state; the city cannot arbitrarily set any limit it chooses, Mayor Jim Solomon explained to city councilmen in the group's monthly meeting Monday night.

Solomon said the state has sent out workers to survey the speed limits and state officials have indicated that the speed limits will be lowered soon, but that it does take a few weeks "for the wheels of progress to turn."

The city would like to see speed limits of 30 mph from the traffic light west to about Ave. P, then 35 on out to the city limits. At present the speed limits are different on different sides of the street in many places. For example, the speed limit is now 30 going west from the traffic light until the city hall, where it goes up to 35, then to 45 at Ave. N. (Summitt's), to 50 at Ave. P (just two blocks south of the high school) and to 55 at Ave. R and beyond.

Coming into town from the west, the speed limit drops to 45 at the city limits (Ave. S) and stays at 45 until it drops to 30 at Ave. N (Summitt's).

This means that between Ave. K and Ave. N, the speed limit is 35 going west and 30 going east. It's 45 on both sides from Ave. N to Ave. P, where it becomes 50

going west. City officials would like to have the speed limits the same on both sides of the street.

City council Monday also approved the recommendation of a steering committee which has negotiated with Southwestern Public Service on an SPS request for rate increases. The committee, representing most area cities served by SPS, has asked cities to approve a rate increase totaling \$28 million across the system, compromise figure reached after SPS first requested a \$41 million increase.

What this means to the residential user in Tahoka was not spelled out, but SPS has stated that despite the increase, the average monthly bill of consumers should reflect a decrease.

Harold Roberts, manager of SPS in Tahoka, said the lower average monthly bills which both commercial and residential users would see if power consumption is about the same as ever are a result of lower fuel costs.

Applications for housing assistance under a federal program at six locations in the city were approved by the council.

The group also voted to accept the bid of Walker and Solomon Agency for liability insurance covering police officers. All agencies in the city were advised that they might submit bids, but the Walker and Solomon Agency's bid, with a premium of \$2328, was the only one received.

Police Chief Gary Morrison reported that during the last month the department had in-

DURING THE recent Thanksgiving holiday, a lot of airlines out of Lubbock were flying only half full or less, with few standbys and plenty of empty seats. But if you had called any of them a week or so before the holiday, you'd have been told there were no available flights to anywhere worth going to.

What happens is that people book flights and then they don't show up, nor do they bother to cancel the reservations when they finally decide they won't need them. This causes airlines to overbook on many occasions, guessing that some with reservations won't claim them. And when everybody does, they have to bump someone, which makes everybody involved unhappy.

I know a man who makes reservations with several different airlines every time he is considering taking a trip. For example, if he thinks he may go to Las Vegas on a certain weekend, he books flights for his entire group of two to four on Friday night, Saturday morning, Saturday around noon, and maybe even other times.

He also books his return flights at various times. Then he decides later which one he wants to use, but he never bothers to cancel the others.

He is a nice guy otherwise, but this practice is selfish. People who really need to get someplace can't get the flights, and most of us don't like to run the risk of going

standby, especially on the return trip home.

Texas Tech students book a lot of flights during holidays and often don't show up, we are told.

What this may mean someday soon is that the airlines will start doing like the motels do: When you reserve a flight, you give a credit card number, and if you don't cancel by a certain time, you'll be billed for the flight whether you show up or not.

Then, unless you have lots of money to throw away, you'd free some of those reservations.

Of course, some folks may not need reservations. There was this rich Texas promoter who dashed into the travel agency and told them he wanted an airline ticket immediately. "Where to, sir?" the girl asked. "Anyplace," he replied. "I got business all over!"

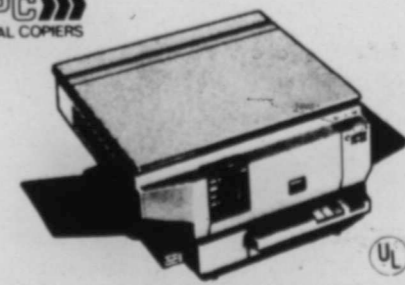

## 4-H Food Show Winners

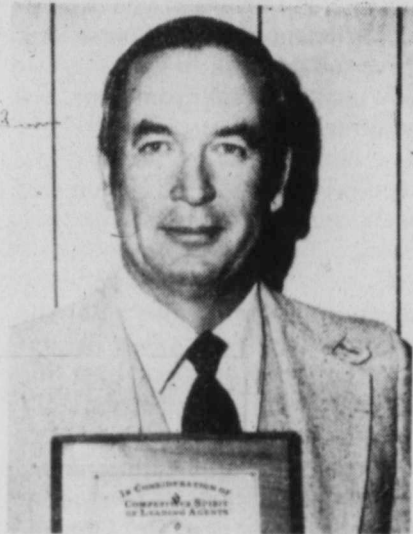

## Social Security ... Out West

**New and better service offered by Lubbock Social Security Office — Appointment now necessary to apply for retirement, survivor, and disability benefits.**

In an effort to reduce waiting room time for those making application for retirement, survivor or disability benefits, the Lubbock Social Security office is now offering the convenience of taking applications by appointment only.

We have been taking disability applications by appointment since last April. The appointment process for taking disability claims is working so well that we have decided to make this service available to all those applying for any type of Social Security benefit.

There are two ways to apply for Social Security benefits. You may "do it all," by telephone or you may apply in person at our office at 1611-10th Street, Suite 100 in Lubbock.

Remember that you may now call to make a telephone or in-office appointment.

Even if you live as far as Guthrie, Muleshoe, Morton, Denver City, Earth or Spur or anywhere in between, you can apply by telephone and save a long drive to Lubbock.

When you call for your appointment we'll set up a date and time between 9 a.m. and 3 p.m., Monday through Friday that will be convenient for you to file your claim.

If you decide to apply by telephone we will call you at the appointed hour, complete the application for you right over the telephone and mail it to you for your review and signature. You then return the application, along with the documents requested, in an envelope we provide. Our appointment clerk will tell you what documents you will need to submit with your claim. We will usually need proof of your age, W-2 Forms or tax returns for the last two years and sometimes other proofs, such as a marriage certificate, military service DD 214, divorce judgment, medical reports or doctors names and addresses.

The number to call for your appointment is (806) 743-7381 in Lubbock.

### Social Security For Divorced Persons

If you are divorced, financial matters can be a major concern. This is especially true if you have dependent children or you are older and have counted on getting benefits on your former spouse's social security record.

As a divorced person, you should be aware of what protection Social Security can provide. In this way, you will know what to expect should you or your former spouse have a loss of income due to death, disability, or retirement.

Unmarried children can get monthly benefits when either parent insured under social security dies or receives disability or retirement checks. Their payments continue to age 18 (19 if in high school) or to any age if disabled before 22.

If you are caring for a child under 16 or disabled who is getting benefits on your deceased former spouse's record, you may be eligible for checks also if your earnings are limited.

### HOLIDAY CLOTHING QUALITY

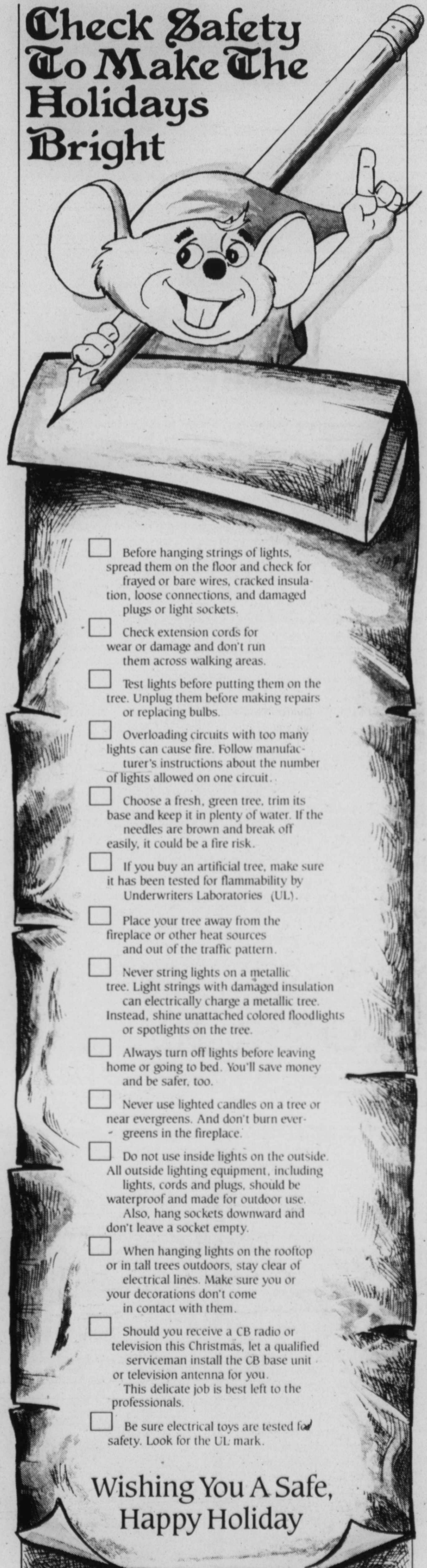
Those beautiful clothes on display for Christmas party wear may not be of the highest quality. "At this time of the year, clothes are often bought for their festive appearance," says clothing specialist Becky Saunders. "But consumers may be disappointed if they expect these garments to last much beyond the holidays." For special occasion outfits that are worn only a few hours and get very little wear and tear, quality may not be a consideration. Less expensive dress clothes that give a good appearance may be a better buy for this type of use, she says. But shoppers who want a more permanent addition to the wardrobe, should consider the fabric, workmanship and care required for special Christmas clothes, just as they would for everyday wear, Saunders advises.

your marriage lasted at least 10 years. If he or she is alive, you can receive payments as a divorced spouse at 62 or older; you can get checks even if your former spouse has not yet retired provided you have been divorced at least two years.

As a divorced widow or widower, payments generally can start at age 60. However, they can begin as early as 50 if you become disabled no later than 7 years after you received survivors benefits because you had children in your care.

## Check Safety To Make The Holidays Bright



- Before hanging strings of lights, spread them on the floor and check for frayed or bare wires, cracked insulation, loose connections, and damaged plugs or light sockets.
- Check extension cords for wear or damage and don't run them across walking areas.
- Test lights before putting them on the tree. Unplug them before making repairs or replacing bulbs.
- Overloading circuits with too many lights can cause fire. Follow manufacturer's instructions about the number of lights allowed on one circuit.
- Choose a fresh, green tree, trim its base and keep it in plenty of water. If the needles are brown and break off easily, it could be a fire risk.
- If you buy an artificial tree, make sure it has been tested for flammability by Underwriters Laboratories (UL).
- Place your tree away from the fireplace or other heat sources and out of the traffic pattern.
- Never string lights on a metallic tree. Light strings with damaged insulation can electrically charge a metallic tree. Instead, shine unattached colored floodlights or spotlights on the tree.
- Always turn off lights before leaving home or going to bed. You'll save money and be safer, too.
- Never use lighted candles on a tree or near evergreens. And don't burn evergreens in the fireplace.
- Do not use inside lights on the outside. All outside lighting equipment, including lights, cords and plugs, should be waterproof and made for outdoor use. Also, hang sockets downward and don't leave a socket empty.
- When hanging lights on the rooftop or in tall trees outdoors, stay clear of electrical lines. Make sure you or your decorations don't come in contact with them.
- Should you receive a CB radio or television this Christmas, let a qualified serviceman install the CB base unit or television antenna for you. This delicate job is best left to the professionals.
- Be sure electrical toys are tested for safety. Look for the UL mark.

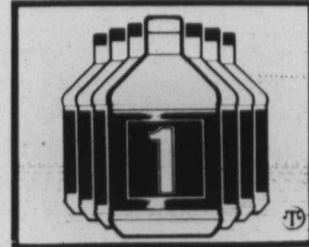

Tips from the Mobil Auto Tech Group

### TAKING THE HEAT

Running faster and hotter, car engines pack more punch per pound than ever before. So there's increasing attention to the heat-resisting stability of tough "man-made" synthetic oils.

For example, Mobil 1 synthetic engine oil was used by three champions in the four categories in Sports Car Club of America's 1985 U.S. Endurance Cup series. These are races as long as 24 hours, for show-room stock cars—the kind you buy from car-dealers.



And more and more cars have turbochargers. They kick in when extra power's needed, cramming more air into your fuel mix with impellers that crank up to a staggering 2,000 times a second. When you shut down your engine, the heat in turbo parts can zoom to 600 degrees F.

When conventional oils were used, turbochargers on disassembly after testing showed heavy coke deposits and bearing wear, often leading to bearing failure. Such deposits and bearing failure didn't occur when the synthetic was used, said reports to the Society of Automotive Engineers.

### Office Efficiency

Warning to all office workers: Beware of phony telephone salesmen. "Paper pirates" are hitting the phone lines these days, pretending to offer first-rate office supplies at supposedly bargain prices. All too often the supplies are grossly inferior, orders paid for are not shipped and the bargain price is really a rip-off. Some customers have paid \$300 for a "case" of toner, thinking the case contained ten bottles. Upon delivery, it was discovered the "case" contained only two bottles.



These pirates often call office managers and others saying they are a "source" for a major office supply company such as Toshiba brand products or a representative of Toshiba America, Inc. He or she can't be—Toshiba America Inc. sells no copy supplies directly to a copy machine user either by phone or any other method. All the company's fine quality copier products are sold only through authorized dealers.

Swindlers have even offered expensive gifts to employees to order large volumes of overpriced products. Later, they call and threaten to tell the "boss" about the gift unless the employee continues to buy at the inflated price. Knowing the tricks of the "Paper Pirates" can keep your business from suffering at the hands of unethical people.

**CRIME VICTIMS ASSISTANCE PROGRAM**—Texas Attorney General Jim Mattox called on county tax assessors collectors meeting in College Station Nov. 19-21 to help inform people about the Crime Victims Compensation Fund. The fund, which now has some \$9 million in escrow, is aimed at helping victims of violent crime. A victim can receive up to \$25,000 under the program to cover unpaid medical and burial expenses and therapy and up to \$150 a week for lost wages. Parents of children who have been abused can apply for funds to cover counseling. The meeting was conducted by the V.G. Young Institute of County Government, a part of the Texas Agricultural Extension Service, The Texas A&M University System.

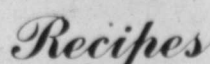

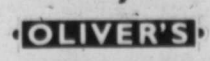

## Social Security ... Out West

### New and better service offered by Lubbock Social Security Office — Appointment now necessary to apply for retirement, survivor, and disability benefits.

In an effort to reduce waiting room time for those making application for retirement, survivor or disability benefits, the Lubbock Social Security office is now offering the convenience of taking applications by appointment only.

We have been taking disability applications by appointment since last April. The appointment process for taking disability claims is working so well that we have decided to make this service available to all those applying for any type of Social Security benefit.

There are two ways to apply for Social Security benefits. You may "do it all," by telephone or you may apply in person at our office at 1611-10th Street, Suite 100 in Lubbock.

Remember that you may now call to make a telephone or in-office appointment.

Even if you live as far as Guthrie, Muleshoe, Morton, Denver City, Earth or Spur or anywhere in between, you can apply by telephone and save a long drive to Lubbock.

When you call for your appointment we'll set up a date and time between 9 a.m. and 3 p.m., Monday through Friday that will be convenient for you to file your claim.

If you decide to apply by telephone we will call you at the appointed hour, complete the application for you right over the telephone and mail it to you for your review and signature. You then return the application, along with the documents requested, in an envelope we provide. Our appointment clerk will tell you what documents you will need to submit with your claim. We will usually need proof of your age, W-2 Forms or tax returns for the last two years and sometimes other proofs, such as a marriage certificate, military service DD 214, divorce judgment, medical reports or doctors names and addresses.

The number to call for your appointment is (806) 743-7381 in Lubbock.

### Social Security For Divorced Persons

If you are divorced, financial matters can be a major concern. This is especially true if you have dependent children or you are older and have counted on getting benefits on your former spouse's social security record.

As a divorced person, you should be aware of what protection Social Security can provide. In this way, you will know what to expect should you or your former spouse have a loss of income due to death, disability, or retirement.

Unmarried children can get monthly benefits when either parent insured under social security dies or receives disability or retirement checks. Their payments continue to age 18 (19 if in high school) or to any age if disabled before 22.

If you are caring for a child under 16 or disabled who is getting benefits on your deceased former spouse's record, you may be eligible for checks also if your earnings are limited.

### HOLIDAY CLOTHING QUALITY

Those beautiful clothes on display for Christmas party wear may not be of the highest quality. "At this time of the year, clothes are often bought for their festive appearance," says clothing specialist Becky Saunders. "But consumers may be disappointed if they expect these garments to last much beyond the holidays." For special occasion outfits that are worn only a few hours and get very little wear and tear, quality may not be a consideration. Less expensive dress clothes that give a good appearance may be a better buy for this type of use, she says. But shoppers who want a more permanent addition to the wardrobe, should consider the fabric, workmanship and care required for special Christmas clothes, just as they would for everyday wear, Saunders advises.

your marriage lasted at least 10 years. If he or she is alive, you can receive payments as a divorced spouse at 62 or older; you can get checks even if your former spouse has not yet retired provided you have been divorced at least two years.

As a divorced widow or widower, payments generally can start at age 60. However, they can begin as early as 50 if you become disabled no later than 7 years after you received survivors benefits because you had children in your care.

## Check Safety To Make The Holidays Bright

- Before hanging strings of lights, spread them on the floor and check for frayed or bare wires, cracked insulation, loose connections, and damaged plugs or light sockets.
- Check extension cords for wear or damage and don't run them across walking areas.
- Test lights before putting them on the tree. Unplug them before making repairs or replacing bulbs.
- Overloading circuits with too many lights can cause fire. Follow manufacturer's instructions about the number of lights allowed on one circuit.
- Choose a fresh, green tree, trim its base and keep it in plenty of water. If the needles are brown and break off easily, it could be a fire risk.
- If you buy an artificial tree, make sure it has been tested for flammability by Underwriters Laboratories (UL).
- Place your tree away from the fireplace or other heat sources and out of the traffic pattern.
- Never string lights on a metallic tree. Light strings with damaged insulation can electrically charge a metallic tree. Instead, shine unattached colored floodlights or spotlights on the tree.
- Always turn off lights before leaving home or going to bed. You'll save money and be safer, too.
- Never use lighted candles on a tree or near evergreens. And don't burn evergreens in the fireplace.
- Do not use inside lights on the outside. All outside lighting equipment, including lights, cords and plugs, should be waterproof and made for outdoor use. Also, hang sockets downward and don't leave a socket empty.
- When hanging lights on the rooftop or in tall trees outdoors, stay clear of electrical lines. Make sure you or your decorations don't come in contact with them.
- Should you receive a CB radio or television this Christmas, let a qualified serviceman install the CB base unit or television antenna for you. This delicate job is best left to the professionals.
- Be sure electrical toys are tested for safety. Look for the UL mark.

## Office Efficiency

Warning to all office workers: Beware of phony telephone salesmen. "Paper pirates" are hitting the phone lines these days, pretending to offer first-rate office supplies at supposedly bargain prices. All too often the supplies are grossly inferior, orders paid for are not shipped and the bargain price is really a rip-off. Some customers have paid \$300 for a "case" of toner, thinking the case contained ten bottles. Upon delivery, it was discovered the "case" contained only two bottles.



These pirates often call office managers and others saying they are a "source" for a major office supply company such as Toshiba brand products or a representative of Toshiba America, Inc. He or she can't be—Toshiba America Inc. sells no copier supplies directly to a copy machine user either by phone or any other method. All the company's fine quality copier products are sold only through authorized dealers.

Swindlers have even offered expensive gifts to employees to order large volumes of overpriced products. Later, they call and threaten to tell the "boss" about the gift unless the employee continues to buy at the inflated price. Knowing the tricks of the "Paper Pirates" can keep your business from suffering at the hands of unethical people.

**CRIME VICTIMS ASSISTANCE PROGRAM**  
Texas Attorney General Jim Tomox called on county tax assessors meeting in College Station Nov. 19-21 to help inform people about the Crime Victims Compensation Fund. The fund, which now has some \$9 million escrow, is aimed at helping victims of violent crime. A victim can receive up to \$25,000 under the program to cover unpaid medical and burial expenses, therapy and up to \$150 a month for lost wages. Parents of children who have been abused can apply for funds to cover counseling. The meeting was conducted by the V.G. Young Institute of County Government, part of the Texas Agricultural Extension Service, The Texas A&M University System.

## Harvesting Expands Rapidly In Area

Cotton harvesting moved into high gear following the recent killing freeze, despite cloudy weather and some early morning fog. Modules appeared abundantly as harvesting quickly exceeded ginning capacity, said Mack Bennett, Area Director for USDA's Marketing Services Office at Lubbock.

This harvest was estimated at 50 to 60 percent complete at mid-week. A few northern county gins have almost finished the season, Bennett continued. Ginning was estimated at 35 to 45 percent. Peak harvesting momentum is near and with good weather, harvesting could be finished by mid-December. Fog halted harvest Thursday and Friday.

Many gins expect to be through their season by Christmas. USDA's Lubbock office classified 137,000 samples during the week ended Wednesday, Nov. 27. This brought the season's total to 375,000 and compares with 313,000 classed by the same date last year.

The week's predominant grades were grade 42 at 53 percent and grade 52 was 32 percent. About 19 percent was reduced one grade because of bark.

Predominant staples were staple 31 at 33 percent followed by staple 32 at 30 percent and staple 33 was 19 percent. The average was 31.8 thirty-seconds

of an inch.

Micronaire 35-49 was 67 percent, 33-34 accounted for 15 percent, 30-32 was 13 percent and 27-29 amounted to 4 percent. The average was 36.

HVI breaking strength averaged 24.2 grams per tex at Lubbock during the week ended Wednesday.

Growers sold some 1984 crop loan equities at \$3 to \$10 per bale, mostly \$3 to \$5. Mixed lots of mostly grades 42 and 52, staples 31 and 32, mike 35-49 brought growers 150 to 200 points over loan.

Gins paid growers \$55 to \$80 per ton for cottonseed, mostly \$55 to \$65. The average was \$61.

The "Cotton and Wool Outlook and Situation Summary" predicted that textile imports in 1985 will be about the same as in 1984. Consequently, continued increased retail sales are benefiting U.S. mills.

## Crop Insurance Deadline Nears

Dec. 10 ends the 1985 crop year insurance period for grain sorghum and Dec. 20 ends the 1985 crop year insurance period for soybeans grown in Lynn County and insured by the Federal Crop Insurance Corporation (FCIC) or by a private company reinsured by FCIC, according to E. Ross Smith, a representative for the Federal Crop Insurance Corp.

"Any notice of loss must be given no later than 30 days after total destruction of the unit, completion of harvest, or the deadline for the crop, whichever occurs earlier," according to Smith.

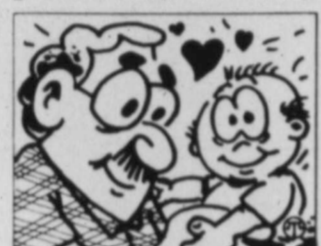
The producer who anticipates a claim should notify his or her crop insurance agent immediately.

"Under terms of the policy, any acreage on which harvest will not be completed must be left intact until an inspection is made. Any claim for indemnity may be rejected if these loss reporting requirements are not met," Smith stated.

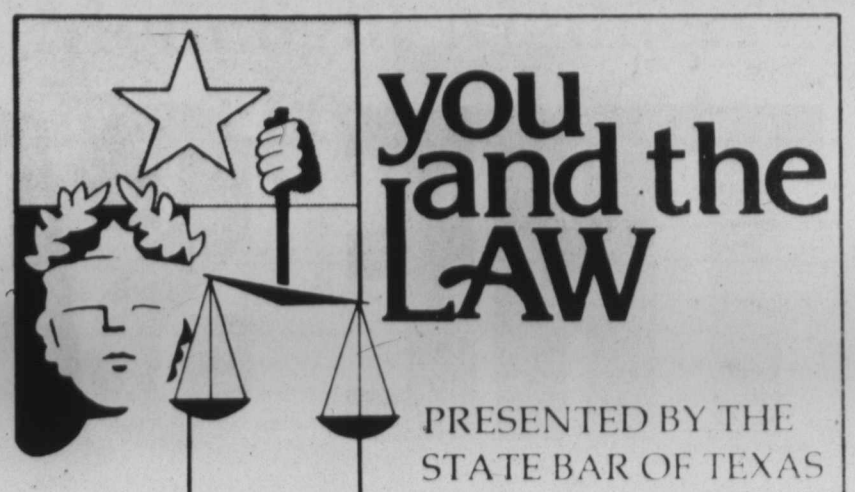

LONG DISTANCE CARING--Do you live quite a distance from an older parent whose health is failing? If there is no family member or neighbor to maintain daily contact with your parent, consider inquiring about a telephone reassurance program in the community, says Dr. Judith Warren, a gerontologist. She explains that volunteers in these programs make regular telephone calls to help provide social contact for the older person and obtain special assistance if it's needed. For information about such a service, she suggests contacting the Area Agency on Aging which serves the county where your relative lives. You can get the number through the telephone information or county government offices.

HANK'S HANKERINGS--Drivers license examiners have a unique job. They deal with every type of person imaginable. As a result, they have some great "war stories". Here's one of them: An examiner is giving an oral examination to an applicant who can't read. Examiner: What is meant by the term, over-driving your headlights? Applicant: It's when you're driving so fast that the wind blows your headlight beam back into your face and you become blind. An elderly female asked the officer why he had stopped her. "You're traveling 55 MPH in a 35 MPH zone" he replied. "Why, officer," she said, "in the papers and on radio and TV they keep asking us to drive 55 MPH to conserve energy - I was only trying to comply."



**Q. My ex-wife got custody of our son, remarried and moved 1,000 miles away. I used to go get him and keep him for several months at a time. Now he is in school and she won't let me see him again until summer. This isn't fair. Is there anything I can do? I pay my support without fail.**

**A.** Your visitation rights are spelled out in your divorce decree. If your schedule is specific, and you are being denied what the Court ordered, you may ask the Court to help you enforce the decree.

If visitation is not spelled out to your advantage, or if it is a schedule you cannot manage across 1,000 miles, you can ask the Court to enter new orders modifying the decree. You are correct to keep paying child support, even during this controversy over visitation.

**Q. This change in child support laws can't affect people like me, can they? I read that salary can be assigned directly to the parent who has custody, but I live partly on disability and partly on commissions for some telephone selling I do. Can my ex-wife get part of that money?**

**A.** The change in child support laws effective September 1, 1985, allows the Court to order any employer to pay directly to the custodial parent, if the paying parent is behind in support.

And, yes, disability income payments are subject to this assignment, and commissions paid for a job such as yours are also subject. Your employer will be liable to comply fourteen days after being served with a court order specifying the amount, and where payment should be sent.

**Q. Here in Personnel and Payroll we are trying to understand the new direct wage assignment law. If we do get served with several direct payment**

child support orders, say two on one parent, how do we decide what to pay? Or can we ignore the orders because they add up together to more than this guy's salary?

**A.** No, the employer must honor the Orders equally, until the full amount has been paid or until the maximum amount has been taken out of disposable earnings.

Please also note that from time to time you will receive an Order increasing or decreasing child support, so you will have to re-figure your calculations. Please also note that the law prohibits any employee from taking fewer exemptions than he is legally entitled to, to prevent reducing his disposable earnings and defeating child support.

**Q. I recently completed and mailed back a sweepstakes ticket for a large prize. I was wondering whether I would have to pay taxes on any money I won in this sweepstakes.**

**A.** The Internal Revenue Service considers income from sweepstakes, like gambling income, to be taxable. It must be reported on your annual federal tax return, and will be added to other income, such as wages and interest for the year.

All prizes and awards are also treated as taxable income except those certain fellowships and scholarships excluded by IRS regulations. All other awards must be reported in the year received.

**Living with your pacemaker**

You may be one of the hundreds of thousands of Americans who have an artificial pacemaker. Your pacemaker is medical science's answer to the electrical problems of your heartbeat.

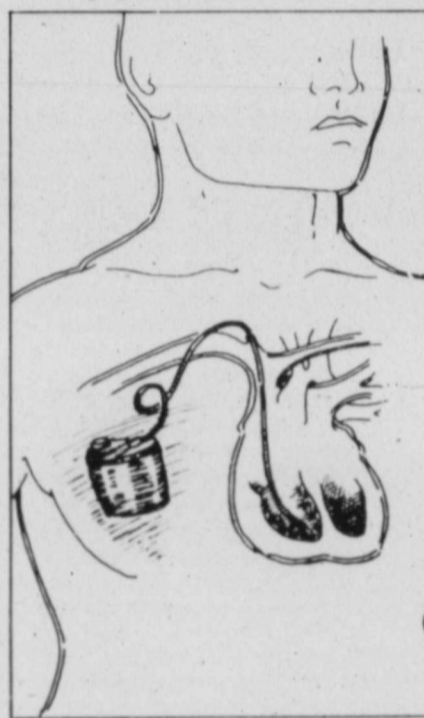
When something interferes with the electrical impulses of your heart's natural pacemaker, the heart may pump blood too quickly, slowly or irregularly. The artificial pacemaker is a small unit that uses batteries to produce the impulses needed to make your heart pump efficiently. The impulses flow through tiny wires to your heart. They are timed to flow at a certain pace just as the impulses from your body's own pacemaker used to do. With the help of the artificial pacemaker, your heart should pump almost as well as it did before.

The batteries that supply the electrical impulses may wear out over a period of time and must be replaced. Replacement requires only a minor surgical procedure. As the batteries wear out, the pacemaker slows down, but it will not stop suddenly. Your first warning will be a change in your pulse rate.

Counting your pulse is a good way to see if your pacemaker is working properly. Your heartbeat, or pulse, can be felt by placing your fingertips on a point inside of your wrist, or over the neck vessels. The number of pulses per minute is the same as the number of times your heart pumps. Your doctor or nurse can tell you how many times your heart should beat per minute.

Help your heart! Count your pulse as often as your doctor advises, or at least once a day. Count it for one full minute. Then write down the number of beats, the date and the time. Show your doctor this information at your next visit. If your pulse rate drops suddenly to around 40 or 50 beats per minute,

usually within the first few months after the pacemaker was installed, you should call your doctor immediately. A wire may be broken or there may be some other malfunction of the pacemaker.



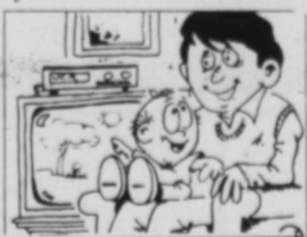
Your dentist needs to know you have a pacemaker. Tell him before you have any work done. You also should use caution around microwave ovens and similar devices since older devices may not be well shielded.

Thousands of people who have artificial pacemakers continue to lead full lives. Pacemakers are usually quite safe and reliable, but they do have to be checked regularly. In addition to checking yours by counting your pulse, you can help by taking your medicine as prescribed and by seeing your doctor regularly.

**Negotiating Committee Recommends SPS Electricity Rate Settlement**

Southwestern Public Service Company (SPS) and the Steering Committee representing SPS-served Texas communities have settled upon a rate-restructuring plan that leaves electricity prices for most retail customers stable.

The settlement recommends SPS-served communities in Texas allow the electric utility a base rate increase of \$28 million. However, utility spokesmen point out, the base rate increase will be more than offset by decreased fuel charges. SPS has decreased its boiler-fuel costs primarily by building coal-fueled power plants.

Sam Hunter, SPS vice president of Rates and Economic Research, said the utility now is "designing" rates to fit the settlement the Steering Committee is recommending to Southwestern's Texas retail customers.

Residential rates, he said, are not expected to change noticeably under the proposed settlement. Rates for most other customer classifications also will continue stable; or decrease somewhat, Hunter said.

SPS last sought, and was granted a retail rate increase in Texas in 1982.

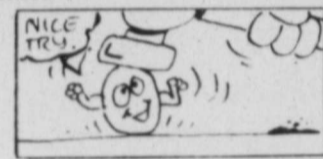
Each of the 65 Texas communities in which SPS has filed for rate restructuring must approve the proposed settlement before it can become effective in that community.

The PUCT already has agreed on an interim basis to let SPS lower its fuel charges to customers by \$40,933,368. Final PUCT action on decreasing fuel charges and on the proposed base rate settlement is expected this week.

The new rates, if approved by the SPS-served communities and the PUCT, are expected to become effective Jan. 1.

**DON'T LET YOUR CHILDREN BURN** (Part 2)—A child who has had the opportunity to practice what to do in a fire has a much better chance of surviving a real fire, says a safety engineer with the Texas Agricultural Extension Service.

Families can practice a number of drills aimed at surviving a fire. One is called "Don the gas masks" and teaches children about poisonous gasses which are the true killers in fires. Another drill is called "hot door, cold door". This drill teaches the dangers of opening a door in a fire. Tests have shown that behind a closed door a person's survival time is from 5 to 11 minutes; with the door open that survival time is reduced to only 2 minutes.
