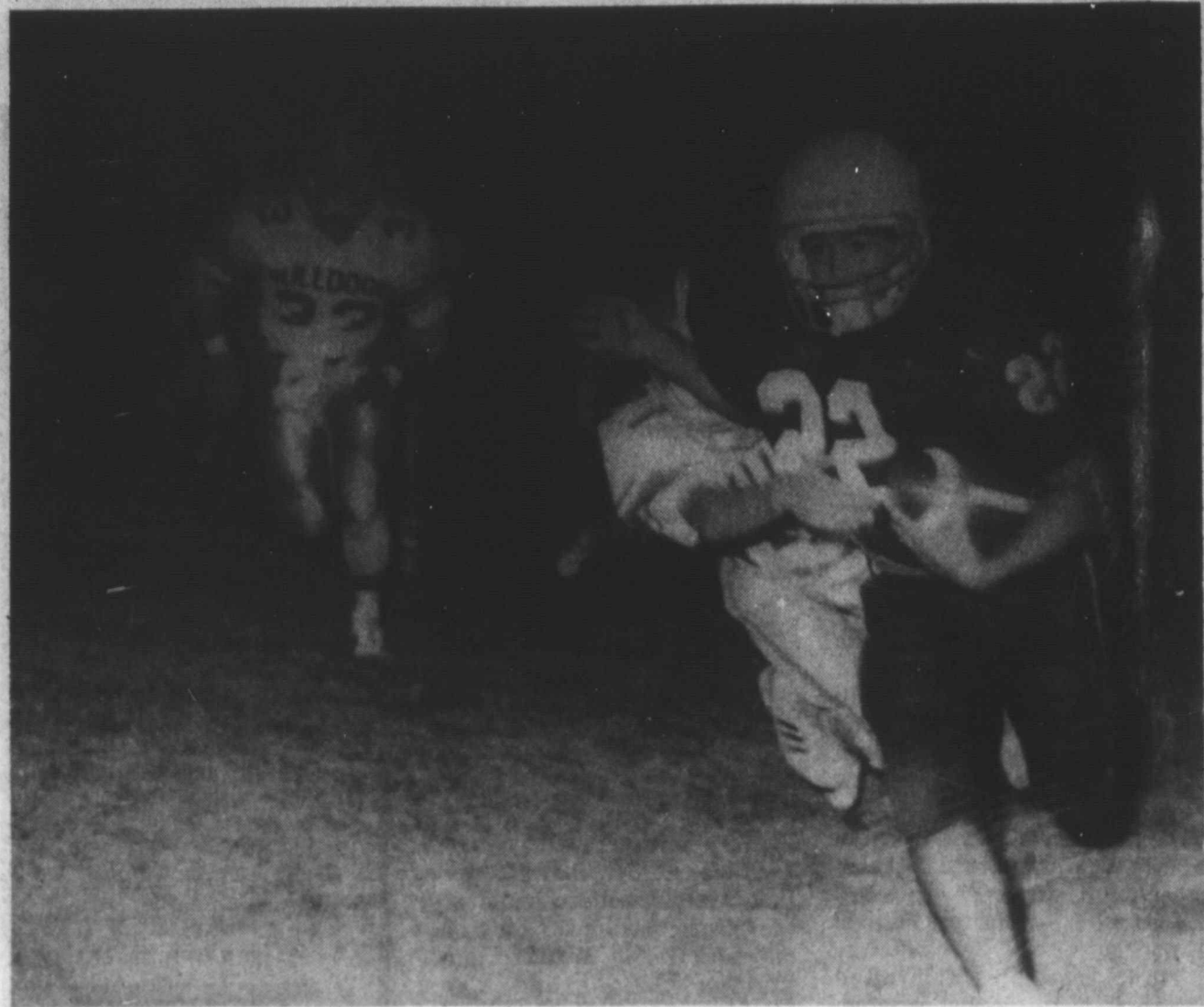

## Mustangs Kick Dogs; Spur Due Here Friday

The Shallowater Mustangs were too talented for the Tahoka Bulldogs last Friday night, and the home town team took advantage of early Bulldog mistakes and then coasted to a 41-0 win. Despite the score, Tahoka played well at times, especially on defense. Rusty Jennings blocked a punt, his second block in two games from his defensive end position, and corner back John Aldous played well in the secondary and also on the special teams.

This week Tahoka will host

another breed of Bulldog as Spur comes to town. Spur last week beat Crosbyton by four touchdowns.

Shallowater kicked a 37-yard field goal on the Mustang's first possession last Friday, and after Tahoka threw an interception, drove in again from the 25, with Ronnie Barron going in from the 2. Barron scored again in the second quarter and the score was 31-0 at halftime, with Shallowater adding 10 points in the third.

In the second period, Tahoka

drove to Mustang 12, but penalties set them back. In the fourth, Jennings blocked a punt which set up the Bulldogs at the Shallowater 25, but again the Blue and White could not score.

Shallowater had three players ejected by officials in the second half.

Todd Nance gained 56 yards in 14 carries and Mike McDonald had 33 yards in 8 trips.

## Rural Home Heavy Loser To Burglars

Wilson, where about 30 cartons of cigarettes were stolen after entry was gained by breaking a window.





## Leopards Burn Eagles With 53-6 Thrashing

The New Home Leopards came up with some big plays Friday night and kept their record intact with a big 53-6 win over Southland.

The Eagles were held to only 117 yards rushing and a negative 18 yards passing. New Home Coach George Deck summed it up saying, "Our boys did a super job both offensively and defensively and kept mistakes down to a minimum."

Jimmy Wyatt had 11 carries for 73 yards and two TDs and two receptions for eight yards and one TD for New Home including a three-yard run in the first period to get New Home on the board first. Lloyd Caballero threw a 55-yard touchdown pass to Leo Torres and a 12-yard TD pass to Chuck Smith in the opening period. Darrell Paul had six carries for 79 yards and one touchdown on a 46-yard run which came in the first quarter.

Southland's David Martinez scored the Eagles' only points on

a 12-yard pass interception in the second quarter. New Home followed with a 5-yard TD pass from Caballero to Brad Morrow.

Wyatt scored twice for the Leopards in the third period and Carey Rudd got in the end zone on a 47-yard touchdown run to give the Leopards their final points which now hold a 4-1 mark in district and are now 5-2 overall.

New Home goes to Cotton Center to take on the Elks at 7:30 p.m. this Friday night, who are winless in district.

**LOAN PRICE IS STANDARD FOR SOYBEANS**—The new marketing year for soybeans is at hand, and farmers can take their cue from the government's loan rate—\$4.77 a bushel—as to what market prices will be. The loan rate, which is down 5 percent from last year, has already made itself felt in the marketplace, with current cash prices around \$4.50 a bushel. Some 61.8 million acres were planted to soybeans in the U.S. this year, down about 8 percent from 1985. ## NOTICE OF APPLICATION FOR WASTE DISPOSAL PERMIT AMENDMENT

THE CITY OF WILSON, P.O. Box 22, Wilson, Texas 79381 has applied to the Texas Water Commission for an amendment to Permit No. 10624-01 to reflect the existing operation of the facility. The existing permit authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 58,000 gallons per day. The proposed amendment would authorize the treated effluent to be disposed of by evaporation at the oxidation/evaporation pond which consists of approximately 2.35 surface acres. No discharge of pollutants to surface water in the State is authorized by this permit.

The plant is located approximately 0.8 mile southwest of the intersection of Farm to Market Roads 400 and 211, approximately 600 feet west of Farm to Market Road 400 in Lynn County, Texas. The treatment plant and evaporation pond are located in the drainage area of the Double Mountain Fork of the Brazos River in Segment No. 1341 of the Brazos River Basin.

Legal Authority: Section 26.028 of the Texas Water Code, as amended, and 31 TAC Chapter 305 of the Rules of the Texas Water Commission.

No public hearing will be held on this application unless an affected person who has received notice of the application has requested a public hearing. Any such request for a public hearing shall be in writing and contain (1) the name, mailing address and phone number of the person making the request; and (2) a brief description of how the requester, or persons represented by the requester, would be adversely affected by the granting of the application. If the Commission determines that the request sets out an issue which is relevant to the permit decision, or that a public hearing would serve the public interest, the Commission shall conduct a public hearing, after the issuance of proper and timely notice of the hearing. If no sufficient request for hearing is received within 30 days of the date of publication of the notice concerning the application, the permit will be submitted to the Commission for final decision on the application.

## SPS Seeks To Lower Fuel-Cost Factor On Electric Bills

Southwestern Public Service Company (SPS) has filed with the Public Utility Commission of Texas (PUCT) to lower its fuel-cost factors on electric bills and to credit \$12 million in past fuel savings and interest to its Texas retail customers.

If approved, the fuel-cost factor on residential bills will be reduced from 2.7555 cents per kilowatt-hour (KWH) to 2.6096 cents, beginning with December bills. The change will reduce overall rates by 2.5 per cent.

The one-time credit will lower December's bill by \$13 for a "typical" residential customer who uses 600 kilowatt-hours of electricity monthly, said Sam Hunter, SPS vice president of rates and economic research. The lower fuel rate will result in an ongoing savings of 88 cents a

month for the same "typical" customer.

"This action is possible for two basic reasons," Hunter said. "First, the prices of the natural gas and the coal we use to generate electricity have declined because of the current energy situation. Second, SPS employees have continued to increase the fuel efficiency of SPS power plants."

Under PUCT regulations, electric utilities are mandated to file for a fuel-cost adjustment if lower fuel costs lead to an accumulation of at least a 4 per cent overcollection, and if the lower fuel costs are expected to continue. Interest, calculated at 11.7 percent annual rate, is added to the fuel cost overcollections and will be included in the credit to customers, Hunter said.

### Stocker Cattle Seminar Examines Keys To Profit

A one-day seminar for stocker cattle operators will be held by the Texas Agricultural Extension Service on Nov. 4 from 9 a.m. to 3:30 p.m. in Lamesa at the Dawson County Community Center. The program is tailored

for operators in Lynn, Dawson, Andrews, Borden, Garza, Howard, Martin, Scurry and Yoakum counties.

A catered lunch will be served and there is no fee for participating stocker operators.

Changes in farm programs and crops economy have increased the interest in stocker cattle.

Dr. John McNeill, Extension beef cattle specialist, will open each program with a look at cost-

effective management of stocker operations. This will include an update of research and result demonstrations, products and techniques that apply to stocker cattle production. It also will look at practices such as use of implants, wormers, vaccines and supplemental feeding programs.

Effective treatment of shipping fever will be addressed by Dr. Larry Hollis of Snytex Animal Health in Amarillo. Hollis will explain vaccination programs and preventive medicine techniques to reduce cattle sickness and death loss.

Marketing tips from a cattle buyer will be presented by Ed Wright, independent buyer from Amarillo. He will explain factors producers should consider when purchasing and selling their livestock, and which can have great impact on the financial outcome of their operation.

Following lunch, the program will feature a live animal demonstration dubbed, "Do It Right While They're In The Chute." Which will show how to properly administer vaccines, implants, wormers, feed additives, rumen inoculants and other products.

During the closing segment, Dr. Dee Griffin, staff veterinarian for Pioneer Hybrid International, Guymon, Okla. and Hollis will necropsy cattle

that have died from different causes. They will show what producers can learn from a necropsy report and its values in treating problems.

**Huge Highway Resurfacing Effort Completed**

The 17-county Lubbock District of the State Department of Highways and Public Transportation has completed what is believed to be its most successful resurfacing period ever--resurfacing 780 miles of highway in the last six months.

The resurfacing, called a seal coat, helps protect the roadway from water and ice damage, and improves skid resistance. Highway officials consider the work vital to protect taxpayer's investment in the highway system.

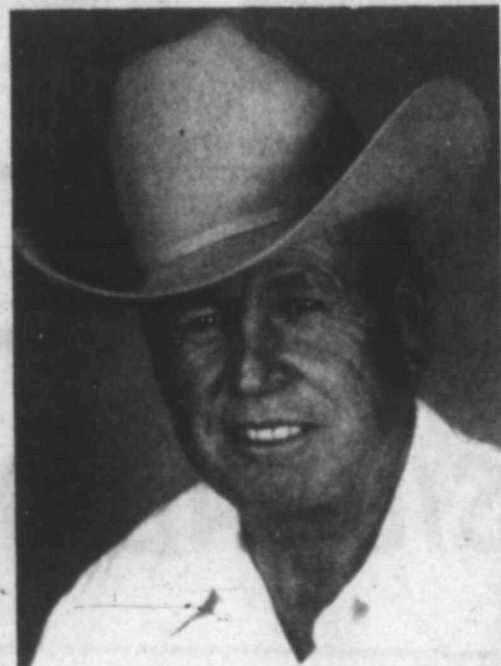

**WHAT DO I PLAN TO DO AS SHERIFF?**

Property protection will naturally benefit if the liquor and drug laws are enforced and if we can keep the pushers and bootleggers from operating in the county.

I plan to revise deputies work schedules so that we will have 24-hour coverage at all times, rather than having so many on duty at once and then having to pay overtime when they have to be called out at other times.

I plan regular meetings with law enforcement personnel in each of the cities in the county so we all will know what is going on and can therefore coordinate our activities.

I believe in strict, but common sense law enforcement.
