

Wilson Area Vandalism, **Arson Cases Reported**

Residents of Wilson and surnoticed some activity, possibly by young persons, late last Friday night were urged this week to contact the Lynn County Crime Line, 998-5145, in connection with cases of arson, criminal mischief and attempted burglary which occurred around midnight Friday and early Saturday.

A \$500 reward has been offered in the arson incident, where a house described as the "old Klattenhoff place" just over two miles north of Wilson on FM 400 was burned, along with a shed containing two antique autos, which were damaged.

The fire was discovered about 1 a.m. Saturday, and Wilson and Tahoka volunteer firemen answered the alarm. The property is owned by Mary Ann Bridges of Lubbock, and a fire investigator is studying the case.

Phebe K. Club To Celebrate 65th Anniversary April 14

On April 14, the Phebe K. Warner Club of Tahoka will celebrate its 65th anniversary. The club was named after Mrs. Phebe K. Warner of Claude, Texas, "Poet Laureate of the Panhandle" and the "Little Brown Wren of Texas". Mrs. Warner was born in May 1866, in Belle Plain, Illinois. She worked her way through Illinios Wesleyan University and became the first woman in Belle Plain ever to graduate from college. In February, 1898, she came to Claude, Texas to marry her college sweetheart, Dr. W.A. Warner. She fell in love with Texas, particularly the Panhandle. "No place ever seemed so gloriously beautiful to me as the Oceanic Plains of Texas," she wrote. She was a country doctor's wife, the mother of four children, a noted speaker and writer. Although she was an early advocate of women's rights, she had definite opinions to a woman's primary calling. "Motherhood...is the best investment of a woman's life," she wrote. She pioneered in adult education, and she urged women to organize and improve themselves. She originated the first women's club in the Texas Panhandle in 1903. She also organized the first County Federation of Women's Clubs in the world--a unit designed to bring the rural and city women together. Her obituary in the Fort Worth Star Telegram, to which she contributed many editorials as Rural Life Feature Writer, states, "by the sheer force of compelling personality she became one of the most influential prohets of contentment that farm women of Texas have ever known. Her influence spread from the community of

Claude to a sphere that became international when she addressed a World Congress on Dry Farming in Peoria, Illinois, in 1917. They still tell the story of the delegate from Hungary who came to her after the lecture and said, 'Mine Gott, Mrs. Warner, I wish somebody would go to my country and do something for my wimmins."

Mrs. Warner was known for her energy and enthusiasm and her love for Texas and its people. Only 4 foot 10 inches tall, she became affectionately known as the "Little Brown Wren of Texas".

She was an early advocate of the state park system and was one of the first to envision a state park in Palo Duro Canyon. In 1929, Governor William P. Hobby appointed her the Texas. representative to the National Congress of Farm Women. In 1929 President Hoover appointed her to the National Homebuilders' Committee.

She died in May 1935, only 10 months after Dr. Warner's death. Lucille Smith, a former resident of Claude, Texas, concludes the brief history she has compiled of Mrs. Warner's life with this thought, "I believe our lives are a little brighter and fuller for having known her, and I think our club should strive to be a little better after having been named for her."

There will be donations of prizes from businesses and individuals, McCord said. Each team may consist of a





- 1. Persons who have never made application for a homestead exemption.
- 2. Persons that changed homesteads. (Purchased a different residence.)
- 3. Persons who became 65 years old in 1986.

Do not make application if you received a homestead exemption in 1986 and did not make any change. You will receive the same exemption for 1987 automatically.

FARM AGRICULTURAL USE EXEMPTION

Persons who should file this application with Lynn County Appraisal District:

- 1. If you did not file in 1986.





"I would like to ask you for your vote for a position on the Tahoka School Board.



New Action To Keep Rail Spur Mapped

Lamesa Chamber of Commerce is spearheading a campaign to keep the rail service now provided by Santa Fe from Slaton to Lamesa through Tahoka in operation.

Santa Fe has indicated it would shut down the spur line sometime soon, and businesses in Wilson, Tahoka and Lamesa would be affected.

Lamesa chamber executive Luke Nichols said several industries would be lost if the rail service is discontinued.

Nichols said the group which met in Lamesa last week set as its first priority getting Santa Fe to continue operating the line.

Santa Fe trains on the spur line are restricted to traveling at 5 mph because, Santa Fe says, the line needs repairs which are too expensive to make in view of the revenue generated by the service. The Lamesa task force plans to hire a consultant on freight rail service and also to ask that an engineer from the Texas Railroad Commission inspect the safety of the line and determine the cost of repairs needed to allow faster travel, which would increase profit potential.

Another alternative mentioned was for Santa Fe to sell the spur line to another carrier specifically in the spur rail market.


Energas Office Will Close **On April 3**





Sen. Cyndi Krier of San Antonio and Rep. Richard Smith of Bryan have introduced bills in the Legislature to conduct th the Democratic and Republican primaries in a single location in each election precinct, a proposal which Secretary of State Jack Rains says will save the Texas taxpayers \$5 million.
