Road Needs Fixing, But Nobody Sure Who Owns It

A stretch of road less than a mile long which runs from U.S. 87 east to the Tahoka cemetery is badly in need of repair or repaving, but nobody seems to know for sure whether the road is owned by the city, county or state. And whoever owns it needs to fix it, so nobody is eager to claim ownership.

The poor condition of cemetery road was one topic discussed at the meeting of Lynn County commissioners Monday, with Tahoka Mayor Jim Solomon on hand.

City Manager Barry Pittman said Tuesday that the road possibly may belong to the State of Texas, as some property in that area was deeded to the state in 1934, according to courthouse records. He said the state highway department has been contacted, and is researching the situation.

It was noted that the city limits of Tahoka run along that road, but whether the road is included in the city is uncertain. A similar problem of where the exact boundaries of the city are located exists in the area of the road going to the rodeo grounds at the south side of town.

The road going to the rodeo grounds has always been a dirt

Home Burglary, Another Pipe Theft Investigated

Another in a series of recent major burglaries of homes in Lynn County was reported during the last week as the mobile home of Bruce and Mary Angell, Rt. 2, Slaton, was burglarized April 20, between 7:30 a.m. and 4:30 p.m.

Stolen from home at FM 400 at the north Lynn County line were items valued at a total of \$3574. These included a Mossberg .22 rifle, a microwave oven, Magnavox VCR, a component stereo system, Canon 35mm camera, Kenmore sewing machine, Gruen watch, jewelry and men's clothing.

Crime Line, 998-5145, has offered a \$500 reward in the burglary and also is offering a \$300 reward for information clearing theft of six joints of aluminum pipe from a farm owned by J.R. Ash, located a half mile south and 1.5 miles west of Grassland. The theft occurred sometime during the last month, and the pipe was valued at \$540.

Cade Furlow reported he was driving his pickup just after midnight Saturday on FM 2053 east of O'Donnell when someone threw a rock through his pickup windshield. An 18-year-old suspect from Lamesa later admitted throwing the rock and agreed to pay restitution.

Tahoka EMS Featured In S.P. EMS Magazine

(Editor's Note: The following story was published in a recent edition of the South Plains Emergency Medical Services, Inc. magazine.)

Tahoka EMS had a countywide volleyball tournament, March 25-26 to raise funds for a new ambulance. Men's and women's teams from Wilson, New Home and Tahoka played a round-robin tournament with all proceeds going to Tahoka EMS.

Entry fee was \$35 per team, and the high school gym was

provided gratis due to EMS working school games at no charge.

Tahoka EMS is a volunteer service with 14 active people. The service was rejuvenated 4½ years ago when some citizens took an EMT course that was paid for by Texas Department of Highways grant money. The local hospital auxiliary also paid for some students to take the

The service now has two ECAs The service now has two ECAs, nine EMTs and three **EMT Special Skills.**

The hospital dispatches, and all EMS providers have pagers which were purchased with money contributed by the hospital and the hospital's auxiliary and with private donations.

When talking with Billy and Jolene Tomlinson and Susan Tipton of Tahoka, I could feel the concern, caring and dedication there is for Tahoka EMS.

Every person in town knows what that jacket stands for, Billy said, referring to the uniform the volunteers wear.

Billy continued, "We're guided by the hospital administration and board, but basically we are on our own. We've established some rules for the service. One of those rules is that once new people complete their training, they must go through a probationary period of approximately six ambulance calls. They are then voted on by the whole group to see if the other people are confident in the new person's skills," said Billy.

"However, we keep up with every volunteer-they are not just left on their own after six runs. Maybe two years later they go



Texas DPS Reports March **Statistics**

Capt. L.A. Reinhart, District Supervisor of the Lubbock Highway Patrol District comprising 21 counties said, "For the month of March, our troopers investigated two fatal accidents, 39 personal injury accidents, and 63 property damage accidents. There were two persons killed and 39 persons injured in these accidents."

Sgt. Lamar Beckworth of Brownfield stated, "In Lynn County, our troopers investigated one personal injury accident, two property damage accidents in the month of March. One person was injured in these accidents."

Sales Tax Checks Sent

State Comptroller Bob Bullock Friday sent checks totaling \$57.5 million to 980 cities that collect local option sales taxes at either one or one-half percent rates.

In Tahoka the sales tax total \$3.294.95, in Wilson \$557.22, O'Donnell was \$0.00, an overall total of \$3,852.17.

This month's allocation bring the year-to-date increase over 1987 to 6.5 percent.

"The state's economy is on the upswing and growing. Texans are becoming more confident about spending their money," Bullock said.

Bullock also sent checks totaling \$5 million to 81 counties that collect a half-percent county sales tax. Businesses in these counties and 55 cities that adopted the additional half-percent tax began collecting it on January 1-this year.

April's checks represent taxes collected by monthly filers in February and reported to the Comptroller's Office by March 21, Bullock said.

(continued from page 1) back on probation if needed. We always have three people on every ambulance run," stated Tomlinson.

Billy added, "The people who have just completed their training are a little 'green' at first, but when you need them, they come to. We fall in together."

There is a Lynn County Ambulance Fund set up at the Lynn County Bank for contributions and memorials. The ambulance Tahoka currently has is a 1982 model and the backup unit is 17 years old.

The service also has an EMS Fund to which each provider contributes \$5 a month. This fund is used for C.E. hours and minor equipment.

When discussing the ambulance, Tomlinson said; "The backup unit doesn't have med radios, and I feel naked without them. It feels good knowing no matter where we are, we can get medical control on the radio and not be on our own.'

Billy continued, "We're tickled to death with the SPEMS protocol. The (hospital) board accepted the protocol as is. It's great to have a basic protocol to go by."

When I asked Susan and Billy about the service's relationship with E.R. staff, Susan said, "We now have a good working relationship. For a good while, we had to prove ourselves step by step."

Tomlinson said they also have a good relationship with law enforcement and other authori-

"We work well with the sheriff's office and the city and highway patrol, and it's due to professionalism and quality of training," he added. "We've got a ways to go, but we're a lot further than we were.'

Almost 4600 Texas women-our mothe sisters and friends --died las ear from smoking-related dis es. Although most women know that smoking poses significant health risks, many fear they will gain weight once they stop.

Which is worse, smoking or gaining weight? According to Dr. Michael Crawford, President of the Texas Affiliate of the American Heart Association,

"pound for pack, you're better off giving up cigarettes. But putting on pounds doesn't have to be the result if you put down cigarettes. Here are some of the problems women who quit

may face, and some ideas for dealing with them. * Increased appetite. Once you quit smoking, food may taste better, as you want to eat more. Or since you no longer smoke after dinner, you may find yourself having extra helpings or desserts. Try slowing

down meals by cutting food into smaller pieces; eat slowly; and leave the table as soon as you are finished. Save dessert for later and substitute lower-calorie treats.

* Oral craving. If you're used to having a cigarette in your mouth, food may become a replacement. Instead, try sugarless gum or mints. Occupy your hands too, with needlework, puzzles, gardening or anything

* Social situations. You may find yourself overeating in social situations where you ordinarily would have smoked. Try substituting a walk for a donut at coffee break, and position yourself away from the food table at

A Visit With Your

County Agent By Brett Cypert, CEA-Ag.

Forget here and now, this a matter of here and then. If you were a farmer in the 1970s, you're entitled to a refund for some of your fuel expenses. But you have to act before June 30. reports Brett Cypert, county agent with the Texas Agricultural Extension Service, The Texas A&M University System.

The refund is a result of a settlement reached by the Dept. of Energy with oil companies that allegedly overcharged for crude oil during a period regulated by price ceilings.

Consequently, farmers can get back about \$80 or more for every 100,000 gallons of fuel used between August 19, 1973 and January 27, 1981, says Cypert. That equates to a little over \$14 for every 100 acres of cropland in production during the seven-and-a-half year period, according to economists with the Extension Service.

Cypert notes that this refund should not be confused with the income tax credit for federal excise taxes on fuel.

The Dept. of Energy will base refunds on actual gallons purchased, estimated gallons used or a USDA estimate of 23.8 gallons per acre of cropland per

Fertilizer Use Held Vital To Crop Yield

Soil tests indicate that soil fertility levels in the Southern High Plains of Texas will limit average crop yields to less than 300 pounds of lint per acre if producers do not apply fertili-

Cotton requires about 18 inches of water and from 50 to 60 pounds of nitrogen to yield 300 pounds of lint per acre. Five hundred eighty samples collected from 200 farm contained an average of 36 pounds of nitrate nitrogen in the top two feet of the soil. These soil samples were collected in the High Plains Underground Water Conservation District's service area by the **USDA-Soil Conservation Service** and Water District personnel in December 1987 and January 1988 while making the pre-plant soil moisture survey.

Plant nutrients levels measur-

ed in the soil samples were nitrate nitrogen, phosphorus, potassium, calcium, magnesium, zinc, iron, manganese, copper and sodium. In addition, soil pH and salinity were measured. Only nitrogen appeared to be low enough to limit crop

Cotton requires about 22 inches of water and 80 to 90 pounds of nitrogen to yield 500 pounds of lint per acre. If a higher yield goal of 750 pounds per acre of lint is desired, 30 inches of water and 110 to 120 pounds of nitrogen are needed. In addition to the nitrogen, 20 to 25 pounds of phosphorus are required for a yield goal of 500 pounds of lint per acre, while 35 to 40 pounds of phosphorus are required for a 750 pound yield. The sampled sites had an average of 122 pounds of phosphorus in the top two feet of the soil.

Research demonstration plots at Texas Tech University, on the Texas A&M University Research Station, and on producer's farms in 1987 did not show significant responses to the addition of phosphorus on cotton.

Nature provides about 20 pounds of nitrogen per acre each year from soil organism activities, soil chemistry interactions and from the atmosphere in this area where cotton generally follows cotton. It should be safe to assume that one-half of the nitrogen provided by nature will be available during the growing

The average amount of nitrate nitrogen found in the top two feet of soil in Lynn County was 8 pounds per acre.

The averages should not be used to determine fertilizer needs for individual farms in the counties represented. Producers are urged to collect soil samples from their own farms for fertility analysis to make these determinations.


