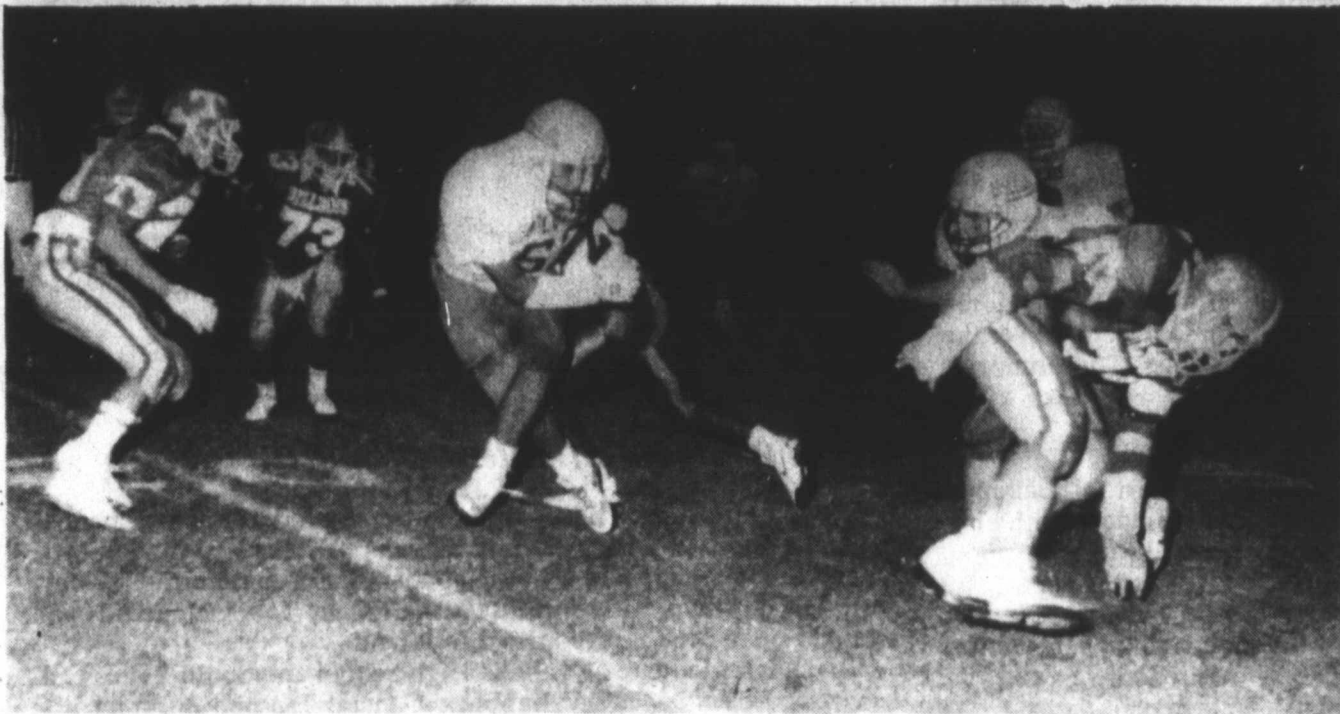

## Bulldogs Play Tough, Finally Lose To Cats

It was Tahoka's best game of the season so far, and yet it wound up as the team's worst loss so far as score was concerned, with the visiting Idalou Wildcats winning 26-7.

The game last Friday night was a lot closer than that, however, as the Bulldogs slugged it out with heavily-favored Idalou on even terms for more than three

quarters and came within an inch — literally — of tying the score early in the fourth period.

Tahoka's Underdogs carried the fight to Idalou from the very first possession and must have left the Idalou fans and coaches wondering who let this bunch of scrappy critters out of their cages. Tahoka drove more than 70 yards, all on the ground, to score with Shannon Clift diving a

yard across the goal line with 7:39 left in the quarter. Ramiro Rodriguez kicked the point and Tahoka led 7-0.

The drive featured a 23-yard run by Mike Ramirez and a 22-yard run by Cory McCleskey, but this was a costly gain as McCleskey was seriously hurt when he was tackled at the end of the run. The junior running back was to undergo major knee surgery this week.

Idalou took only a couple of plays after the kickoff to tie up the game. Fleet Ricky Westbrook ran 63 yards for a touchdown and Tracy Saul kicked the extra point to tie it at 6:52.

It was a hard-hitting game all the way through, and there were many turnovers, including seven by Tahoka and five by Idalou; yet it was an exciting contest as Tahoka refused to roll over and play dead.

After swapping fumbles in the second quarter, Idalou had the ball at the Tahoka 31 and then QB Chris Criswell, playing for the injured Saul, passed 28 yards to End Cliff Alexander to the 3, and then Criswell scored to make it 14-7 at halftime.

Tahoka put together a good drive in the third period, featuring a fake punt on fourth down and a pass from Rodriguez to Thomas Glisson 22 yards to the Wildcat 23. Then T.C. Spruiell wrestled a pass away from a couple of Idalou defensive backs and gave Tahoka a first at the 5. Charles Jurden ran to the 3 as the period ended.

On the second play of the fourth quarter, with fourth down for Tahoka at the Idalou 2, Clift dived in for an apparent touchdown, but the official ruled he did not go across the goal line with the ball in his possession.

From films of the game viewed later, it appeared that Clift scored, but the ball was placed down almost touching the goal line, about an inch away.

On the next play, Idalou FB Jeff Russell broke through the middle and ran 81 yards before

## Parents Urged To Warn Children Against Strangers

With rumors going around Tahoka and other cities in the county about someone in a blue pickup trying to pick up children around schools, and amid other

reports that this activity is somehow related to "devil worshippers," the Lynn County sheriff's office this week urged parents to caution their children about riding with strangers.

Sheriff Clifford Laws said several phone calls have been received from concerned parents who have heard the stories, but that no reports have been received from anyone who actually saw an alleged blue pickup with New Mexico plates with occupants attempting to pick up children.

He added that the department would like to hear from anyone having first-hand, eyewitness information about such activity around any of the county's schools, regardless of the vehicle involved.

He said officers have checked out the reports and so far have found no witness who actually saw anything.

Two more burglaries of homes were reported in the county during the last week, and Crime Line, 998-5145, has offered rewards of \$500 in each case.

The residence of Curtis Wilke, about four miles northeast of Wilson, was burglarized during the day last Thursday. Stolen were a Panasonic stereo system, RCA 19-inch TV and some items recently purchased in Austria, including six Sterling silver necklaces valued at \$50 each and nine handpainted Christmas tree ornaments.

Bruce Angell, whose trailer home is about 200 yards inside the north county line, reported his residence burglarized between 9 a.m. and 4:30 p.m. Saturday. A 20-inch Magnavox TV was stolen. With the loss, including damage to a front door, totaling \$600.

Two recirculating pumps and motors, valued at \$450 each, plus some steel T-posts valued at a total of \$80, were reported stolen sometime recently from tank batteries located about 17 miles northeast of Tahoka. The stolen items are owned by Crown Ex-

ploration of Abilene.

In jail during the week were 14 more persons on various offenses, including bad check charges, speeding and driving while license suspended, no drivers license, driving while intoxicated, reckless conduct and possession of marijuana under two ounces, theft by check, failure to appear, hindering secured creditors and application to revoke probation on DWI charges.

## School To Dismiss Early Thursday For Parent Conferences

Classes at Tahoka Elementary Schools will dismiss at 1:30 p.m. Thursday, Oct. 13, in order for teachers to meet with their students' parents for a Parent Conference. These conferences may be held from 1:30 until 3:45 p.m. on that day.

Teachers who wish to talk to parents will be sending home letters to set up these conferences, or parents may call the school to set a time.

According to Elementary Principal Gaylon Gassiot, these conferences must be held and parents are required to attend in order for the children of Tahoka Elementary to be given the best opportunity to learn.

If a parent has a question or concern, he or she should set a conference time with the teacher on Thursday or contact the teacher by telephone.

The purpose of these conferences on a six-weeks basis, says Gassiot, is to ensure that there is communication between parents and the school. He added, "As teachers and parents, through talking to one another about our common educational goals having to do with our children, great gains can be made for the betterment of the child."

## WOODWORK

WE RECENTLY returned from our second trip in four years to the Northeastern coastal states, and I don't care what they say, those leaves aren't turning. Vermont, Massachusetts and New Hampshire (and the few miles of Maine which we saw) all are beautiful country, however, although the native residents still try to con us flatlanders with claims that the foliage turns every year and is really pretty, "only you just missed it."

They told us this time we were two weeks or so early for most of the action. A guy with us on the trip pointed at a tree and said some of the leaves already were turning, but I sat down and stared at a particular leaf for 30 minutes and it never moved at all.

Here are some of my impressions from the trip:

There are a lot of Yankees up north, some of them pretty nice, some pretty weird, and all speaking some language which only vaguely resembles English as we know it down heah.

Plymouth Plantation and the Mayflower II (built in England exactly like the original and sailed to Plymouth, Mass. in 1957) are still well worth visiting, especially if one is interested in early American history.

New Hampshire has no sales tax or state income tax. There is a state lottery and the state operates liquor stores.

Vermont has no large cities, probably none over 40,000.

New York City (we flew into Kennedy and out again 9 days

later) is a great place not to visit. It is dirty and populated by maniacs hurtling down the roads and streets at 87 mph. It also is full of dope addicts and assorted other lowlife and nobody in his right mind would live there by choice. Prices are so high that clerks and waiters should wear masks.

We flew into JFK airport and as soon as we could we rented a car and made our Escape From New York (it would have been easier if we had taken some of the weapons Kurt Russell had in the movie). We escaped via the Long Island freeway, our hearts ceasing operations on several occasions.

We didn't even consider driving down into Manhattan, although we did want to see the usual tourist sights such as the World Trade Center, Broadway and 42nd Sts., the Statue of Liberty, etc. On the last day of our trip we finally did get a closeup view of most of these things by hiring a cab driver to take us downtown. We considered riding the subway, but we couldn't reach Bernard Goetz, and we weren't about to get on the subway without him.

Our cab driver was Melvin Stewart and he possibly is the only really nice guy in New York City. He is a retired black man (actually, he still is a black man, but he has driven a taxi several years after a career of driving big trucks all over New England, and he only drives however many hours a day he wants to). He wanted to know if people double-park in Texas.

## Commissioners Hear Report Of 'No Progress'

Lynn County commissioners were advised by County Judge J.F. Brandon Monday that the U.S. Justice Dept. still has taken no action on a request from the county that certain justice of the peace precincts in the county be combined.

Currently there are five JP precincts in the county, with only two JPs serving the entire county--adequately, according to commissioners. A third JP precinct is expected to have a judge after the November elections.

Commissioners voted to pay dues totaling \$401 to South Plains Assn. of Governments (SPAG); to Lubbock County Youth Center for 92 days, a total of \$1,610; and \$117 to South Plains Community Action Assn. for food commodities distribution.

Juvenile Probation officer Jerri Akard spoke to the group regarding some recommendations in that area.

Present were commissioners Bart Anderson, Eldon Gattis, Boyd Barnes and J.T. Miller, plus two Democratic nominees for commission, Jerry Gerner and Bobby Cox.

Still the Bulldogs never quit. Blocking an Idalou punt gave Tahoka the ball at the Cat 33 and then Jurden ran 5 and 13 yards to the 15. But another Tahoka fumble gave Idalou the ball at the 5. Idalou iced the game finally with a 60-yard return of an intercepted pass with just 2 minutes left.

Jurden gained 69 yards on 12 carries and Ramirez also averaged better than 5 yards a carry with 37 yards in 7 trips. Rodriguez completed 7 of 16 passes for 92 yards and Glisson caught three for 33 yards.

This week the Bulldogs, now 1-2 in district and 2-3-1 overall, will go to Crosbyton, which features one of the area's best running backs in Greg Williams.

With 37 seconds left in the fourth quarter, QB Nance hit Burleson with a forty yard pass for the go-ahead touchdown. Morton's JV Indians traveled to Tahoka on Sept. 29, and got their head feathers plucked 16-0 by the JV Bulldogs.

"Morton had a very strong team with a lot of speed," commented coach Jurden. "The Indians drove the ball the length of the field on their first possession. The Bulldogs finally stopped the drive

and from that point took control of the game, according to coach Jurden.

Jurden said the strong offensive line blocking of Arriaga, Williams, Holland, Tipton, Hatchet and Aleman, enabled Mendoza, Rogers, Burleson and Nance to race for big yardage.

Touchdowns were made by Burleson and Mendoza; extra points were run by Mendoza and Rogers.

Jurden said the outstanding defensive player of the Morton game was Jay Forsythe and outstanding offensive player was Mikey Burleson. The most improved JV player is Bryan Patterson and Juan Hernandez was the hardest hitter in the Morton game. "The Indians had a very good football team. The Bulldogs played a great game and deserved to win," said Jurden.

On Oct. 6 at Idalou, the JV faced their first district loss 6-28. At the end of the first half, the score was 6-12. Coach Jurden said the JV Bulldogs failed to play the tough aggressive defense they had played for the four weeks previous and they let the Wildcats manhandle them. Tahoka's TD was made by Mikey Burleson. Jurden cited George Cantu for outstanding player against Idalou.

JV will face district play against Crosbyton on Thursday, Oct. 13 (tonight) and they will meet Shallowater, New Deal and Seagraves to finish the season.

### Your HEALTH TIP

**CHOLESTEROL**  
We know that cholesterol is a fatty substance in the blood that tends to clog arteries, causing coronary heart attack or stroke. But what level of cholesterol is dangerous? To explain, cholesterol is a mixture of HDL (high density lipoprotein) that is beneficial, and LDL (low density lipoprotein) that is harmful in excess. Anyone with a cholesterol level above 230 needs a strict low-cholesterol diet; with a level above 260, a cholesterol-lowering drug may be advised. Adults with cholesterol levels above 200 (children above 170) should eat less animal fat: eggs, whole milk, butter, cream, cheese, meat fats.

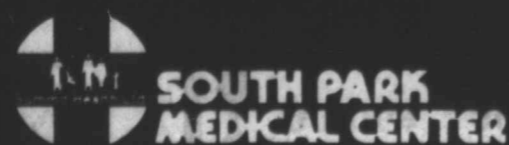

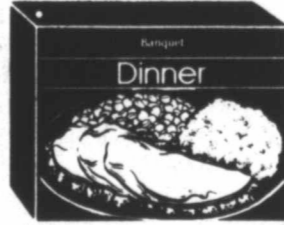

### FmHA Activates New Program

The Farmers Home Administration (FmHA) is preparing to activate a loan program designed to help members of socially disadvantaged groups, including minorities, acquire land for farming, J. Lynn Futch, FmHA State Director, said today.

Under the new program, FmHA will try to find persons in those categories who are interested in farming and can qualify for an FmHA ownership loan. The agency would also be prepared to sell or lease to them a farm held in its inventory if any are available in that county, Futch said.

FmHA can also provide other loan and technical assistance, if needed, to help the borrower get started.

The new program was included in the agricultural credit act signed earlier this year, Futch said, and funds have been reserved for farm purchases based on the population of socially disadvantaged persons.

The population of such persons range from as low as 1 percent in some New England and midwestern state to highs of 68 percent in Hawaii, 57 percent in New Mexico, and somewhat lower percentages in southwestern states. Population groups involved are Hispanics, Native Americans, Blacks, Asians Pacific Islanders.

Persons who think they might be eligible and who are farming or who would like to become farmers are urged to contact the Farmers Home Administration county office serving their area, Futch said.

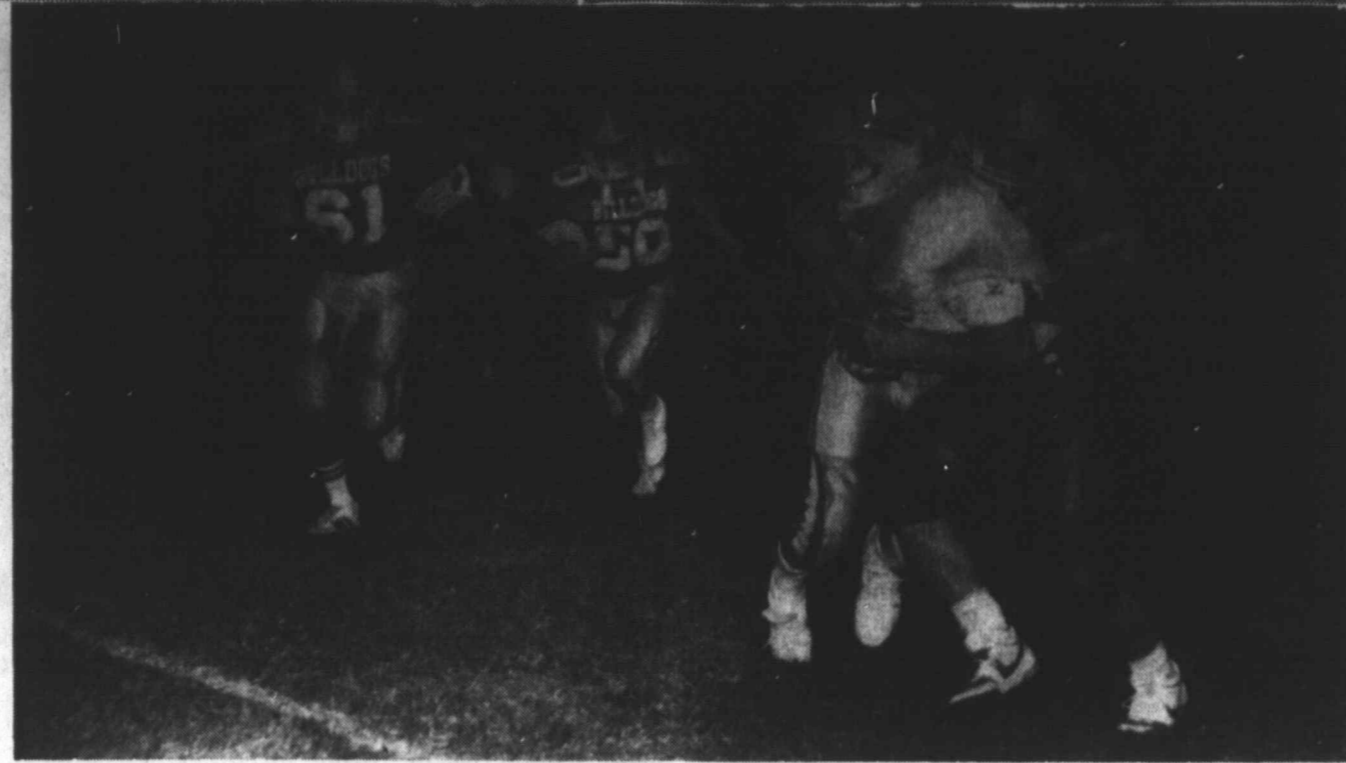

**A Visit With Your County Agent**

**Get Lawn In Shape For Spring**

Homeowners can take steps now to get their lawns in shape for next spring.

Weed and disease control along with fall fertilization can help get lawns off to a fast start next year, said Brett Cypert, county agent with the Texas Agricultural Extension Service.

Fall fertilization maintains the lawn's green color and promotes early spring green-up, Cypert said. Use a complete fertilizer with a 3-1-2, 4-1-2 or similar ratio of nitrogen, phosphorus and potash at a rate of 1 to 2 pounds of nitrogen per 1,000 square feet.

A dense, vigorous turf produced by proper fertilization also keeps winter weeds from invading lawns.

If winter weeds have been a problem in past years, apply a preemergence herbicide (chemical weed killer) for additional protection against weeds, said Cypert. Some preemergence herbicides are available in formulations with fertilizers, which simplifies application.

Homeowners should follow label instructions in regard to grass species and rates of application when using herbicides.

Materials containing atrazine should not be used around trees and shrubs.

For disease control, apply a fungicide on St. Augustine lawns to prevent damage from brown patch. Not only is brown patch unsightly, but weeds will invade the lawn in disease-weakened areas, said Cypert. Also, spring recovery is delayed in areas damaged by brown patch.

Fungicides containing PCNB (Terraclor, Ortho Lawn Fungicide), benomyl (Benlate, Tersan 1991) or chlorothalonil (Daconil) control brown patch when applied according to label instructions.

A good practice is to raise the mowing height in October to 2½ or 3 inches for St. Augustine and 1½ or 2 inches for bermuda lawns. Taller grass provides more cover and insulation for the growing points of grass and reduces the chance for winterkill.

Another fall task for homeowners is to remove excess accumulations of grass clippings or tree leaves from the lawn, said Cypert. Excess debris from these sources increases thatch accumulation and creates a favorable habitat for insects and disease organisms.

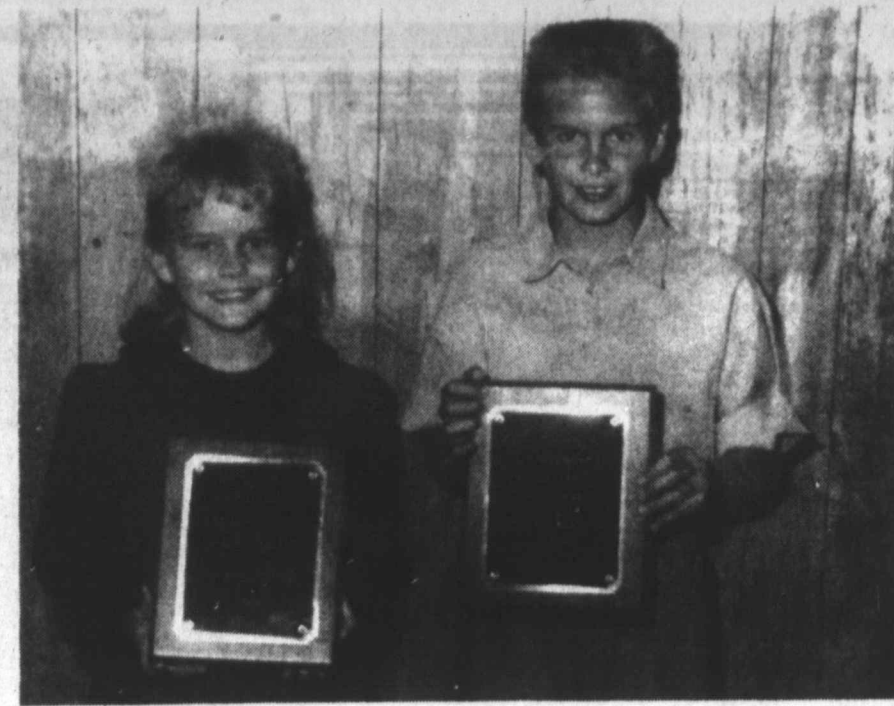

**Blue Angels To Fly At Reese Sunday**

Col. Mark H. Lillard III, commander of Reese AFB's 64th Flying Training Wing has designated Sunday, Oct. 16, as "Commanders Day" Open House.

The base will be open to the public from 10 a.m. to 5 p.m.

The featured flying attraction will be the U.S. Navy's Blue Angels Flight Demonstration team. They will be making their first visit to Reese in 20 years and will be flying their A/F-18 Hornet jet fighters.

More than 30, and possibly as many as 50 aircraft from all the military services will be on ground display on the flightline when the gates open. The display will include fighters, bombers, reconnaissance, transports, helicopters and training aircraft.

Some of the more interesting aircraft currently scheduled to be on display are a B-1B bomber

from Dyess AFB in Abilene, Texas and a C-5 Galaxie, the Air Force's largest transport aircraft. Visitors will be able to walk through the length of the C-5 as it will be displayed with the front nose open and the rear ramp down.

A number of the latest military aircraft are expected to fly-by and give a demonstration of their maneuver capability. Reese's T-37 and T-38 training jets will fly-by in formation prior to the Blue Angels show.

A number of exhibits and displays will be available for viewing. The Reese fire department will show the capacity of their crash-rescue trucks and demonstrate a simulated extraction from a disabled aircraft. The Reese Honor Guard Drill Team and Color Guard will perform throughout the day.

There will be plenty of food, drink and parking available.

**Sales Tax Payments Still Increasing**

State Comptroller Bob Bullock said Friday that a surge in sales tax rebates to several large metropolitan areas in Texas reflects increasing statewide economic growth and stability.

Checks totaling \$64.8 million were mailed to 914 Texas cities that collect an optional local sales tax at either one percent or 1½ percent, showing a growth of 17 percent in sales tax rebates this month over October 1987, Bullock said.

Net payment for O'Donnell was \$824.90, 1988 payment to date \$10,494.85 compare to last year, \$8,542.47; Wilson's 1988 payments to date was \$3,719.05 compare to 1987, \$3,570.26; In Tahoka net payment was \$3,269.08, 1988 payment to date \$52,181.39, and 1987 payments to date was \$46,861.92.
