

Three Traffic Mishaps Investigated In City

Tahoka Police Dept. investigated three traffic accidents in the city during the past week, and in one of them an 80-year-old Alpine man was seriously injured.

On Thursday at Lockwood and U.S. 87 access road a 1976 Kenwood truck driven by Charles J. Coplan of Lakeside, Ariz., and a 1971 Chevrolet driven by Charlie Rudd Bailey of Alpine were involved in a colli-

Bailey reportedly suffered a broken neck, broken ribs and facial cuts. He was taken by EMS ambulance to Lynn County Hospital and later transferred to Methodist Hospital in Lubbock. No subsequent report on his condition was available Wednes-

Police investigated another accident on Thursday involving a 1974 Triumph driven by Joe Francis Hays of Tahoka, whose vehicle reportedly struck a street barricade located at S. 3rd and Ave. J. No injuries were reported.

A third mishap in the city occurred Saturday at the intersection of Main and N. 5th, where a 1982 Mazda driven by Granvel Henry Ayers of Tahoka and 1988 Pontiac driven by Marie Garcia of Tahoka collided. No injuries were reported.



Postal Inspectors Warn of Phone 'Prize' Scams

The U.S. Postal Inspection Service has warned the public about the increasing number of "boiler room" scams that use the telephone to pitch a variety of products, usually attached to a "free gift" gimmick.

Chief Postal Inspector Charles R. Clauson said the bogus companies flood post offices with computerized mailings notifying people "they've won a prize," usually after offering for sale everything form vitamins to office supplies. "The operators then followup with high-pressure telemarketing," Clauson said, "usually asking for money or a credit card number to cover shipping charges."

Clauson suggested the best way to defend against the scams is to "check out the company and call them back-without giving out your credit card number or any money-and if still suspicious get in touch with a postal inspector through the nearest post office."

Last week a promoter and 12 telephone pitchmen were arrested in the New York City area for misrepresenting the sale of cleaning supplies.

Several weeks ago four operators from Seattle, Washington and Las Vegas were arrested for mail and

wire fraud for offering prizes as part of a nationwide promotion.

And in Houston, William E. Gardner, 35, operator of International Direct Mail Marketing, Ins., is awaiting sentencing after pleading guilty to mail fraud charge. He told those who responded to his mailings to call a Houston area phone number to claim a motorboat and outboard motor, he said was worth as much as \$500, as part of a marketing survey. The thousands who responded-by each paying more than \$120 for shipping-received and inflatable raft and motor worth \$40.





SPEMS Improves EMS Radio System

Emergency Medical Services on the South Plains have experienced inadequate radio reception/transmission on ambulance runs. As a result, South Plains EMS, Inc. (SPEMS) a non-profit EMS support organization, doubled the height of the regional radio antenna Feb. 26.

This antenna is part of the regional radio system used by all EMS services and providers across the South Plains. It was designed and put in place with federal grant money by SPEMS, Inc., so that South Plains ambulances can communicate with hospitals when treating and transporting patients.

The regional antenna is accessed for radio contact with critical care facilities in Lubbock from any location in the region. Additional repeaters and antennas are placed in strategic locations across the region. The regional antenna is the tallest at 620 feet and transmits to and receive from the rural repeaters to provide rural hospitals and ambulances radio contact with Lubbock hospitals.

SPEMS, Inc. is financially supported by the following hospitals and counties: Crosby, Dickens, Garza, Hale, Hockley, Lamb, Motley and Yoakum; Garza County Memorial. Lubbock General, Lynn County Hospital, Methodist-Lubbock, St. Mary of the Plains and South Plains Hospital-Amherst. New Home Basketball **Wins Stir Memories**

When former New Home resident Letta Cocanougher read about the New Home boys basketball team making its first trip ever to the state tournament, it stirred memories of March 9-12, 1949, when the Leopard girls team make its first trip to the state tournament at Hillsboro.

The former Letta Roland noted that the New Home boys team made its first trip to state almost exactly 40 years from the time the girls team went. In those days, the girls teams played three girls on each end of the court. Newspaper clippings showed that the New Home girls were favored to win the state championship, but were upset in the semifinals 33-31 by East Chambers in an overtime game. The team had been coached most of the year by Supt. A.L. Pace, who had a heart attack during the season, and Bill Fleming and Wilmer Smith took over as coaches for the rest of the season.

In the first game of the state tournament the New Home girls beat Cranfills Gap 63-33 as Colleen Savage Scored 30 points, Emadene Robinson scored 20 and Joy Dean McClintock had 13.

Other members of the team included Letta Roland, Katherine Roland, Martha Crabtree, all starters and Bernice Fillingim, June Huev. Joyce Jones, Nell Alice Davis, Jackie Jo Rogers and Norma Evans.

One story noted that Emadene Robinson had scored 667 points

Mrs. Cocanougher's letter to the Lynn County News concluded as

"I now live at Pottsville, AR. My parents (Inez and Eugene Roland) lived around Tahoka for several years. My mother's brothers were Borden and Vernon Davis. Average minimum temperatures

as follows: sorghum 55 degrees, cotton 65 degrees. "Minimum" rather than "average" temperatures should be used for rice and peanuts, with rice being 60 degrees and peanuts 70.

Hardy vegetables such as onions, cabbage and potatoes can be planted once soil temperatures range between 45 and 50 degrees. However, warm-season vegetables such as tomatoes, melons, beans and peppers need soil that has warmed into the

With early-season planting, particularly when soil temperatures are still marginal, farmers need to pay particular attention to using high quality seed, fungicides and other seed protectants, and adjusting seeding rates.

How do farmers keep abreast of changing soil temperatures? Daily readings are taken at various locations throughout Texas in cooperation with the Extension Service, the Texas Agricultural Experiment Station, the National Weather Service and individual cooperators. For example, the regional temperature reading for North Texas is based on temperatures at Lavon Dam northeast of Dallas, while readings at Lufkin and Longview make up the East Texas average. Regional readings also are made for the High Plains, Trans-Pecos area, Rolling Plains, Central Blacklands, Coastal Plains, South Texas and the Lower Rio Grande Valley.

As temperatures are collected, they are included in daily agricultural weather advisories issued for each of the regions by the National Weather Service's Southwest Agricultural Weather Service Center at Texas A&M University. The advisories are fed into the NOAA (National Oceanic and Atmospheric Administration) weather wire teletype system to be received by commercial radio and television stations. The advisories also are carried over the NOAA Weather Radio Network.

Specific temperature readings for about 40 locations also are distributed daily through regular weather service dissemination channels.

Keeping tabs on the weather and soil conditions can help farmers get off to a good start with spring pla ing. With the high cost of farm inputs, it's information that should be put to good use.

In many cases the early bird does get the worm. But when it comes to spring planting, farmers may want to use a little restraint and take a look at soil temperatures before cranking up their planters.

One of the keys to getting spring crops off to a good start is to heed soil temperatures, said Brett Cypert, county agent with the Texas Agricultural Extension Service.

Soil temperatures have been shown to have an important effect on how well seeds germinate. Planting in cool soils often leads to poor seed germination and poor crop stands. Plants that do come up often lack vigor for early growth. And this opens the door to early season dis-

ease and insect attacks. Farmers should begin planting only after the danger of a late frost is past and the soil has warmed to temperatures favorable to the intended

bia Grade: Cr uis .qora Farmers also need to keep tuned to weather forecasts prior to planting. A sudden change in weather conditions following planting can be detrimental to the crop, particularly a cool, wet spell that can lower soil temperatures


