Tahokan Designs Device To Aid Handicapped

A Tahoka man who is a teaching assistant in merchandising, consumer economics and environmental design at Texas Tech has developed a speed control device to help handicapped persons operate machinery even when they have no use of their legs and feet.

Zane D. Curry said he designed the device at the request of an instructor in the home economics department who specifically was concerned about one fashion design major who could not use the department sewing machines because she is a paraplegic unable to use the foot controls on the machines.

The student is scheduled to test the device within the next week or so and during the summer.

"She is anxious to try it out," said Curry. He explained that the portable device attaches to the sewing machine and does not interfere with traditional speed control.

"Basically, it works by the natural human motion of sewing, leaning forward slightly less than one inch, which activates the clutch of the

sewing machine," Curry said. Both handicapped and non-handicapped persons will test the device, which may be patented this summer.

Curry has completed work on a masters degree he is scheduled to receive this summer and also is working on a doctorate.

School Board Considers Practice Gym, Track

Tahoka School Board last Thursday night considered sketches of a steel barn-type structure which would serve as a practice gymnasium and also sketches of a track which would be constructed around the football field.

Neither project has been authorized, but the board had asked Coaches Joe Paradis and Steve Qualls to present documents after inquiring into the possible construction of a track and practice gym, and they brought the sketches and gave rough estimates of costs. The board asked that the practice gym be investigated further with the possibility of taking action on the project during the summer.

Tahoka has not had a track, and one of the reasons given in the past was that there was not enough room to build a track around the football field with the bleachers as near as they are to the field.

Bookkeeper Loretta Tekell reviewed the financial status of the district at the regular monthly meeting of the board, with all board members present. She reported 1988 tax collection at 91.5 per cent complete, or \$977,771, less discounts of \$9,291 as of March 31.

A contract with the regional Education Service Center was approved for the coming school year.

Dr. Duane Carter, superintendent, reported on the need to repair a bus, and the board instructed him to look further into costs of repair and also the cost of various sizes of new buses.

Mozell Smith is retiring after 28 years of service to the schools, and

the board voted its appreciation to her as lunchroom supervisor. Sheri Stone was offered the position of lunchroom manager on a one-year contract.

Employment of 18 non-certified school personnel, including secretaries and aides and others, was voted.

A bid of \$6,986 from Cecil's Draperies in Lubbock for curtains in the high school auditorium was accepted.

**Bureau Issues
Caution On
Mag Sales**

Last week the BBB/South Plains started receiving calls from the public about Union Circulation out of Las Vegas, Nev., selling magazine subscriptions door-to-door. The Lubbock Police Department became involved when a consumer complained about an over-zealous salesperson touching her. Company representatives are allegedly requesting payment by check made out to "cash". The Bureau advises consumers to never make a check out to cash or anyone but the company. Also, the salespeople are asking customers to sign a waiver of their rights to the 72-hour cooling off period law. The Federal Trade Commission has advised the BBB that such a waiver may not be legal. That law allows consumers to cancel contracts with peddlers for up to three days following the transaction. BBB/Las Vegas reports that the

home office is located in San Diego, CA., and numerous complaints have been filed regarding non-delivery of merchandise. This company does not meet the BBB/Las Vegas standards of business practice because of one or more unanswered complaints. The BBB/South Plains reminds consumers to be alert to peddlers selling magazines, home improvements, book, etc. door-to-door. "If they cannot identify themselves to your satisfaction, call the police department or sheriff's office immediately," said a BBB spokesman.

In Tahoka, persons selling magazines or other items door-to-door in residential areas must have a permit from the city. Homeowners should ask to see that permit.

Texas Should Develop Textile Industry, Says Study Group

Texas should process its own cotton, wool and mohair to enhance state jobs and revenue, according to a recent study by the Texas Agri-Business Electric Council (TABEC) and Texas A&M University. The study was done in consultation with Texas Tech University International Center for Textile Center for Textile Research and Development.

TABEC is composed of 10 Texas investor-owned electric utilities, including Southwestern Public Service Company, and works in conjunction with Texas A&M's Agricultural Engineering Department.

A third of U.S. cotton is produced in Texas, but 92 percent of the state's crop is processed elsewhere, the study said. Thirty-seven percent of Texas's crop is sent to North Carolina, South Carolina, Georgia, Alabama and Virginia for processing. The remaining 55 percent is exported to foreign markets.

Texas also produces almost all U.S. mohair, which is derived from Angora goats, and a fifth of all U.S. wool, according to the report.

"SPS will be using this study as an economic-development tool to provide information for those interested in developing the textile industry in our service area," said Greg Boggs, SPS agricultural consultant.

SPS serves a 52,000-square-mile area of the South Plains and Panhandle of Texas, eastern and south-

eastern New Mexico, the Panhandle of Oklahoma, and southwestern Kansas.

"In Texas, we have an abundance of cotton, and 92% is sent out of state," he said.

Boggs said several textile plants are operating in Texas, but the industry has not been developed to its potential. The TABEC-A&M study, as well as other reports, suggests there is room for expansion in the textile industry in Texas, he said.

Boggs pointed out that the market value of cotton leaving the state is about 55 cents per pound. By spinning the cotton into yarn, its market value increases about \$1 per pound and another \$1 per pound when it's woven or knitted into fabric.

"Fabric is purchased for roughly \$3.50 to \$4 per pound and sold as clothing for about \$5 per pound," he said.

"This all suggests there are millions of dollars of revenue being lost to the state, not to mention a large amount of jobs that are lost when we ship our fiber elsewhere," Boggs said.

**Oil Property
Tax Rate For
Lynn Disputed**

A report from the State Property Tax Board that Lynn County taxes oil and gas properties at 138 per cent of actual value was disputed by the county tax appraisal district this week as officials of the tax appraisal office said the state board has been asked to refigure the comparison, since the county office maintains the property is taxed at 100 per cent of value.

Lynn County members of the National Assn. of Royalty Owners, Inc., an organization of people who own oil wells or percentages of wells, were told at a recent meeting in Austin that Lynn taxed oil property at 148 per cent in 1987, and that this was the worst of any county in Texas, so far as the royalty owners are concerned. The information came from figures compiled by the State Property Tax Board, which later reported that the 1988 tax rate in Lynn was 138 per cent of value.

The county tax appraisal district disputes this claim, and has filed for a change, claiming that the taxes are assessed at 100 per cent of value on the relatively small amount of oil property in the county. It also was noted that anyone who thinks his taxes are out of line may appear before the review board when it meets.

"None of the oil companies, which pay more taxes than the royalty owners, has ever protested before the review board regarding the appraisals," said a spokesman for the appraisal district.

Trends In Laundry Practices Changed

Today a trip to the local supermarket to pick up a box or bottle of laundry detergent or some fabric softener isn't as simple as it used to be. In the last few years there has been an explosion of laundry products. Choices include liquid or granular detergent, phosphate or nonphosphate detergent, a single product with both detergent and fabric softener, dryer-added or rinse-added fabric softener, and products with an assortment of fragrances. A closer examination reveals some interesting trends. Not surprisingly, one of the hottest trends convenience. Because time is such a valuable commodity, many consumers want to spend as little of it as possible doing the laundry, but still want clean clothes.

Most choices and changes are in soaps, detergents and fabric softeners. A recent study reveals that detergents are used by 95 percent of consumers and soaps by 5 percent of the market.

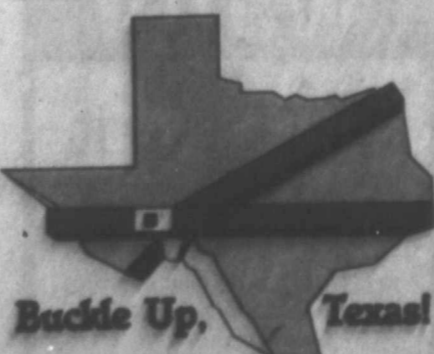
A recent development in detergents is the advent of the combination product. It's now possible to purchase one product that contains detergent and fabric softener or detergent, fabric softener and stain fighters. It's estimated that 15 to 20 percent of the detergents now on the market are of this type. These products are slightly more expensive than separate products but do offer the convenience of having only one product to use. Use of rinse-added and dryer-added softener is evenly split, each accounting for about half of the softeners sold.

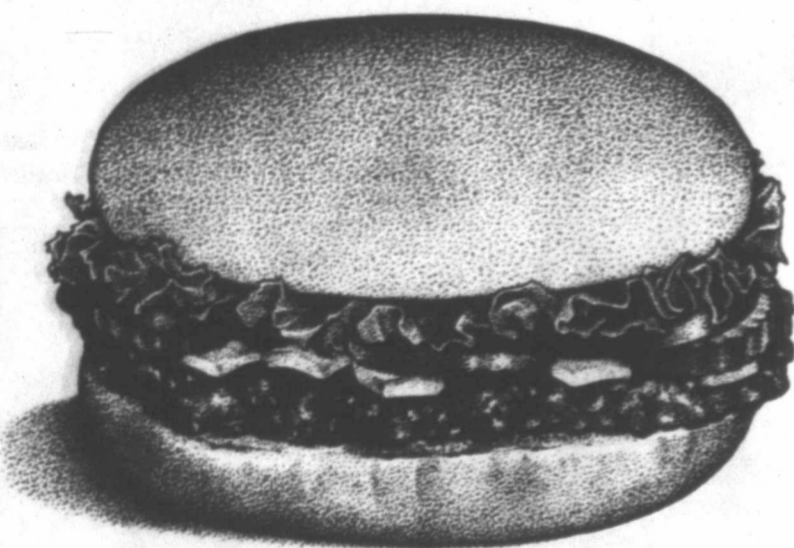
