## Annual Festival, Auction For Hospital Set Saturday

The annual Fun and Food Festival and auction to benefit Lynn County Hospital is scheduled this Saturday, May 19, from 4 p.m. to 9 p.m. in the county show barn on the south side of Tahoka.

Sponsored by the Lynn County Hospital Auxiliary, the festival will feature these booths: fish and fries—hospital board members and friends; nachos supreme—St. Jude's Ladies; ice cream—Phebe K. Warner Club; pie—Tahoka Chamberettes; drinks—Lynn County 4-H Club.

Nadine Dunlap, festival co-chairman with Thalia Burks, said "We are greatly indebted to these organizations for the funds their booths donate to the auxiliary; their efforts help our fundraiser to be a success each year."

There will be entertainment by a male quartet from O'Donnell and medical tests offered by the Ameri-

can Red Cross.

The main fund-raising activity of the event and the year, however, is the auction of donated items, art and crafts. Some of the donations will be given as door prizes which will be drawn for throughout the day. Each 50 cents admission will entitle the holder to one chance for the door prize drawings. tain.

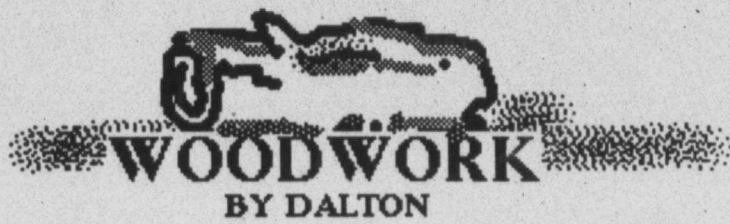
Tests to be offered by the American Red Cross will include triglycerides (for which a person must fast for 12 hours before the test), blood sugar, pulse rate with oxygen saturation, and pulmonary functions.

Funds raised by this year's festival and auction will be used to pay for a new nurse call system for all patient rooms at the hospital.

The auxiliary will be setting up for the festival about 6 p.m. Friday, and volunteers are needed to help with this task.

**NATIONAL DRINKING WATER Week** was the first week of this month, so most of us missed the entire celebration, but here at the newspaper office we received in conjunction with the observance some supposedly accurate facts of water trivia, some of which are a bit hard to swallow, so to speak.

For example, it poses the question "How much water is used to brush your teeth?" and gives the answer as 2 gallons. On two gallons of water I could brush the teeth of everybody in the 2100-block of N. 8th St., where I and about 17 others live. Even the electric toothbrush critter which I use occasionally only holds about 10-12 ounces. (An electric toothbrush or water pic, or whatever, is a device which shoots out a little stream of water strong enough to make a hole in your cheek, or to spray the south wall of the bathroom from 8 feet away).

The fact that this answer is so far off from reality makes the other answers on the water trivia sheet suspect, but if they are true, some interesting statistics are revealed.

The sheet says that it takes 39,090 gallons of water to manufacture a new car. It also says an acre of corn gives off 4,000 gallons of water per day in evaporation, it takes 2 to 7 gallons to flush a toilet, 25-30 gallons of water is used in the average 5-minute shower, that the average residence in the nation uses 107,000 gallons of water per year, and—get this—that the average individual uses 123 gallons per day.

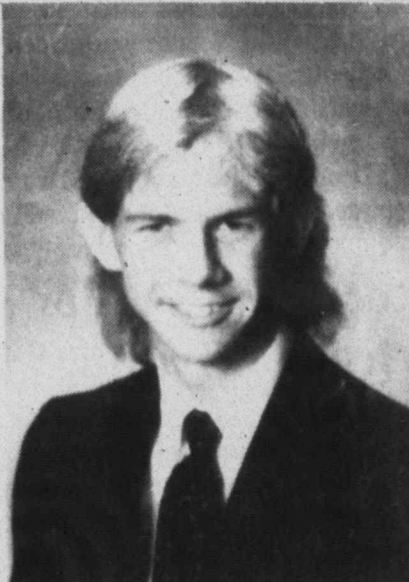
It also claims that the average person can live only about three days (seven days maximum) without water, while the average person can live up to a month without food. The latter is something I need to try.

The people who sent us all this water stuff operate the Brookesmith Special Utility District (a water supply company) near Lake Brownwood. I'm saying that so the women who read the rest of this will send them the poison pen letters instead of me. I wouldn't dare say what they said about men having more water in their bodies than women because men have more muscle and women have more fat. I would be afraid that some of those females would come by to demonstrate to me that they do, too, have plenty of muscle.

Anyway, the sheet says that there are about 40 quarts of water in the body of the average adult. And that water makes up about 60 to 65 per cent of men's bodies, and 50 to 60 per cent of women's bodies. It said "Women have a smaller percentage of water because they have more fat compared to body weight...muscle contains a large amount of water, fat contains virtually none."

## Tahoka Minister, Wife Die In Head-On Crash

A head-on collision between the car of a Tahoka minister and his wife and another car traveling on the wrong side of U.S. 87 killed the Tahoka couple last Friday night as they were returning home from Lubbock.

The Rev. James Scott, pastor of the Love Chapel of the Church of God in Christ in Tahoka, and his wife, Dorothy, both age 55, were pronounced dead at the scene of the accident near the 114th St. bridge on U.S. 87 south of Lubbock. The Scotts were headed south when their 1981 Honda Civic collided with a 1974

Chrysler driven by Shirley Hamlin, 54, of Lubbock, whose car was traveling north in the southbound lanes of traffic. Mrs. Hamlin remained in serious condition Wednesday at University Medical Center. According to investigating officers, she was wearing a seat belt. A blood sample was taken when she was admitted to the hospital; no charges had been filed in the accident early this week.

Scott was described by church officials as a well-liked man who had worked his way up from a job as janitor in a Tahoka automobile dealership to operating his own automobile repair service in Lubbock during the week. He also has been preaching at the Tahoka church for more than 10 years.

George Lewis, a business partner and friend of the Scotts, said the couple had just left their daughter's home in Lubbock when the tragedy occurred. Lewis said Mrs. Scott needed special care since several years ago when she suffered a stroke. Another church member said the preacher was dedicated to serving God and caring for his wife. "He would drop her off at his daughter's home in the morning and then pick

## Tahoka Schools To Offer Full Day Kindergarten

Tahoka schools, which have been offering half day kindergarten classes the last two years, will return to the full day program this fall after the board voted 5-1 for the change in a regular meeting of trustees last Thursday night.

Most parents of kindergarten age children apparently favor the full day program, it was reported.

The board voted to accept the bid of Hunter Construction Co. on certain school improvements, with changes which would lower the bid to \$402,323, plus \$32,186 for architect fees.

Christine Wuensche and Kristi Crooks were hired as elementary teachers, Alicia Garcia as a teacher's aide and Oscar Garza, now at Taft, TX, as teacher/assistant coach.

Transfers of eight students into the Tahoka ISD were approved, and Supt. Dr. Duane Carter advised the board of developments including the costs of repairing skylights which leak when it rains, TEAMS tests, that drivers education was to begin using a school car on Monday and gave an update on court rulings pending on the Career Ladder program.

The board reorganized after new member Brad Hammonds was sworn in, and Joe Hays was re-elected as

board president, with Delbert McCleskey as vice president and Richard Lopez as secretary. Other members present were Gary McCord and Clint Gardner, with Nedra Young absent.

Bookkeeper Loreta Tekell reported that tax collections on the 1989 tax roll were 92.4 per cent complete as of April 30.

Dr. Carter introduced Michelle Colon, THS student who recently placed sixth in national competition in computerized accounting. The board also had praise for retiring teacher Virginia Griffing, who is retiring after 28 years of teaching.

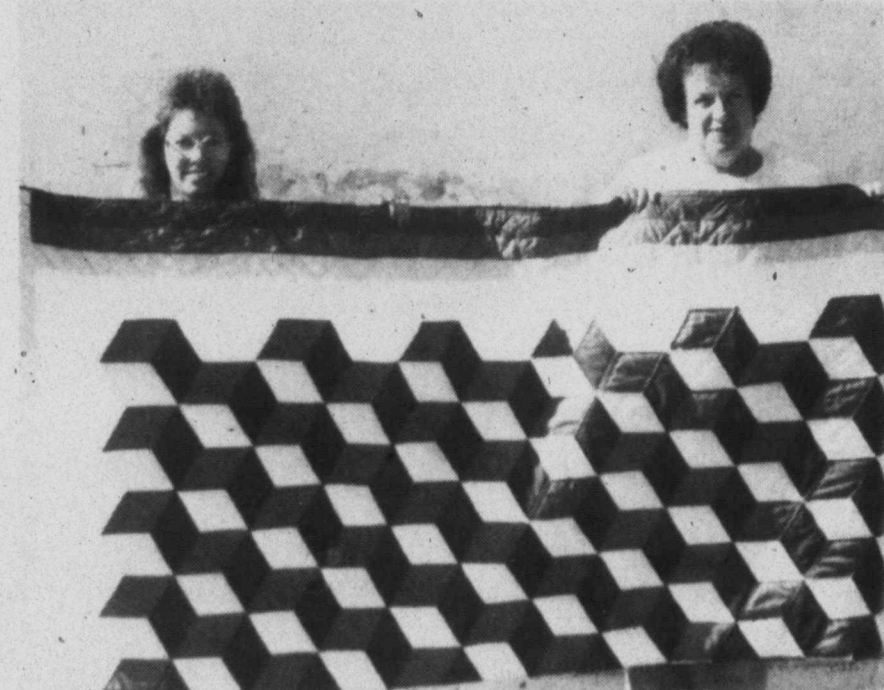

## Tahoka Schools To Provide Special Instruction For Gifted And Talented

Beginning this fall a gifted and talented program will be implemented in grades K-12. In grades K-6, students will be served both in their homeroom and with a pull-out program. Mrs. Suetta Martin has been employed to serve as the GT teacher and resource person. A minimum of 150 minutes of differentiated services will be provided weekly with excelleration, enrichment, and expansion of the student's time and efforts.

In grades 6-12 the gifted and talented population will be served through a self-study in English, Math, Science, or Social Studies. A teacher from each area will serve as mentor for students who do research and excellerated work in that field.

The identification process is comprehensive and detailed with three major steps. These are: (1) screening, (2) identification and (3) selection.

The students will be screened through testings and observations. However, nomination may be made by parents, teachers, or anyone who has worked with the student. In no way will the process discriminate against any person or group for reasons of sex, race, creed, handicapping condition, ethnic origin, or religious preference.

After the screening process and nomination, additional student information is obtained through special tests, teacher questionnaire, students product/performance, student interviews and observations. Those students who perform at or above the 95th percentile in the identification step will be recommended to the selection committee for possible entrance into the program. ## News From ... Extension Agent Brett Cypert Lynn County Extension Office

With spring already in full bloom, the time is ripe to spray newly budded pecan trees.

Spraying will combat scab, the most prevalent disease among pecan trees. The disease is hard to see, but if pecan growers have had the problem in the past, they probably can expect it in the future. Pecan scab usually produces lesions on the leaf and black or dead shucks.

Some varieties such as Burkett, Wichita, Belmas and Western are susceptible to pecan scab and should be treated with a fungicide. Varieties resistant to pecan scab are Choctaw, Desirable, Cheyenne, Pawnee and Sioux, but growers should still be alert for problems with the fungus.

Spray immediately after the buds break and then two or three more times until June.

While spraying a fungicide, also spray the pecan trees with zinc. Zinc sprayed on foliage helps produce larger leaves and promotes overall tree growth and nut production.

The prime time to fertilize pecan trees is immediately after the buds break. The old rule of thumb is to apply one pound of ammonium sulfate, 21-0-0, per inch of trunk diameter.

Fertilizer should be broadcast on the surface under the pecan tree and should extend out to the canopy. A common misconception for fertilizing is to dig a hole near the trunk and pour liquid fertilizer into the hole. Since most feeder roots are in the top 18 inches, there is no need for fertilizer to be placed beneath the depth of the soil.

Newly planted pecan trees should be cut back to one-half their height. When pecan trees are dug at nurseries, the roots are damaged. Cutting

### Census Work Won't Count Against AFDC Or Food Stamp Eligibility

Texas and other states have decided that people who receive Aid for Families with Dependent Children and people on food stamps will be able to do temporary work for the Bureau of the Census without losing their federal benefits.

According to Jim Wilson of the Lubbock office of the Census Bureau, short-term workers are badly needed in Lynn County. Applications will be taken and tests given for Census jobs on May 23, next Wednesday at 10 a.m. and 1:30 p.m. at the Tahoka City Hall.

The U.S. Dept. of Agriculture has announced that food stamps recipients may do this work and still maintain their food stamp allowance. Exemptions also have been announced for those on the AFDC program. Both exemptions will be in effect from March 1 to Aug. 31 of this year.

"All those on food stamps or getting aid to families with dependent children are encouraged to consider short-term employment as Census takers," said Wilson, adding that the Census count is continuing and will continue for a few months.

### Head Start For 4-Year-Olds Is Available

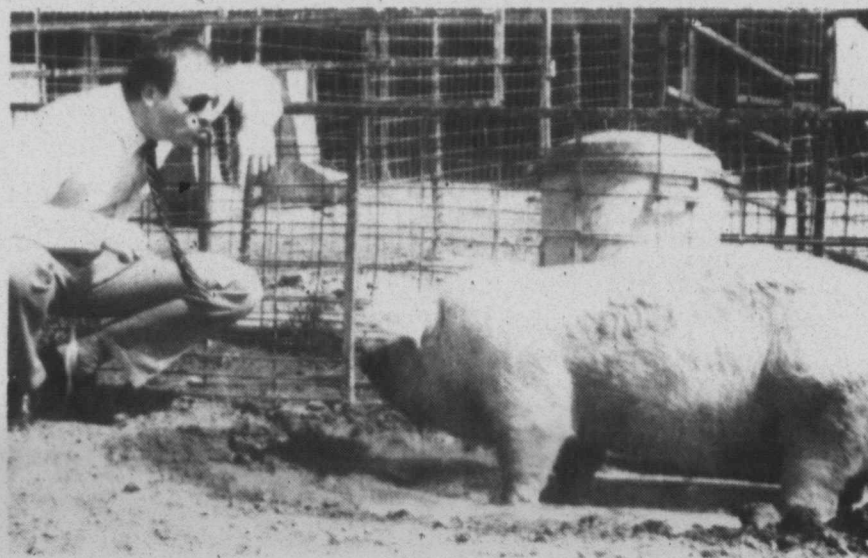
South Plains Head Start program officials in Tahoka this week announced that Head Start is available for income eligible children who are four years old on or before Dec. 31, 1990.

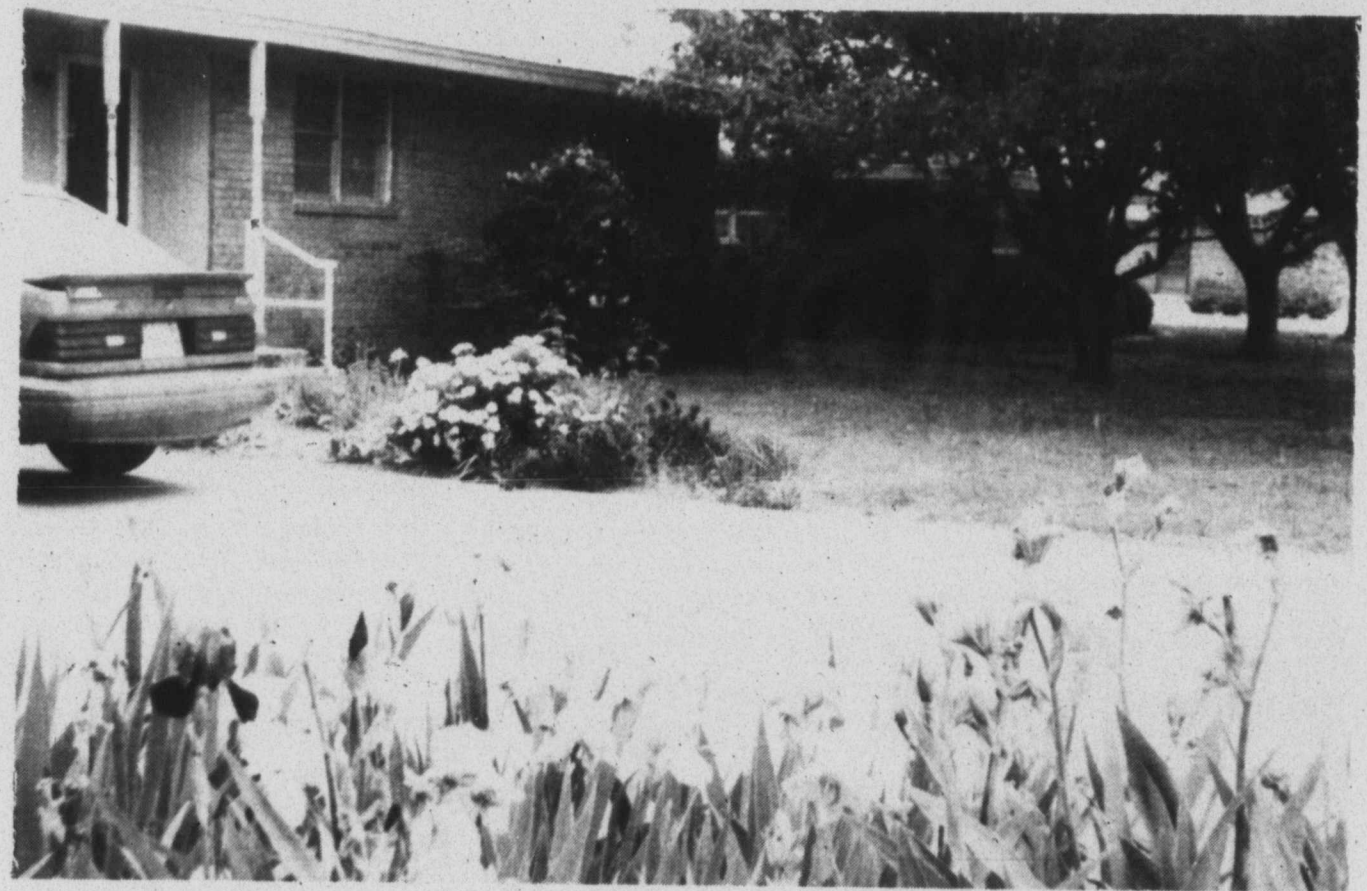

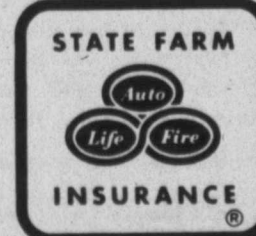
