### **More Diesel Fuel Thefts Reported In County**



A WRITER named Robert Ragaini has written an article (in The Rotarian magazine) about his adventures and experiences in growing vegetables and other sometimes edible things in his garden, and how high technology has come into play in gardening, as in all other endeavors.

I read this article with only a mild amount of interest, since I do no gardening at all. I do eat some of the things which come from gardens, and I appreciate fresh tomatoes and corn and radishes and onions, which my wife has grown from time to time in her garden.

I don't try to help her with the gardening, because whenever I lay hands on a plant of any kind (except weeds), it immediately dies, never to produce fruit, vegetables, pecans, peaches, blossoms or even leaves again.

Ragaini says his father never spent any money on his garden, but the biggest difference in gardening then and now is that you can spend tons of cash on gardening aids, and here are some he discussed:

Seed dispensers: "Resembling an oversize syringe, it deposits a single seed in exactly the targeted spot. Given the time it takes to replace unused seeds in the packet and to refill the dispenser with each different variety, it probably doesn't take much more time than the old method of sprinkling seeds from the palm of the hand directly in the row."

Ollie Owl: "A fearsome creature that frightens birds away from ripening fruit and berries. Farmer Fred is an inflatable scarecrow whose arms and legs flap in the breeze and frightens the crows in the corn, and a long Vinyl Snake scares the daylights out of almost everybody."

The writer also mentions that there is a collection of instant analyzers which one may buy, "hand-held minicomputers that, when stuck into the soil, indicate moisture content, or pH level, or concentrations of salt, or the need for fertilizer, so that at any time during the growing season it is possible to confirm your worst fears."

Anyway, he winds up by saying that all these fancy things are expensive and not really needed, and that "no matter how you slice it, a tomato is a tomato, and a garage full of sophisticated do-hickies isn't required to grow one."

I know nothing about growing tomatoes except what I hear from those who grow them. My county agent says there are about 99 different varieties, and a friend who thinks he knows everything about gardening once told me you had to "succor" tomatoes (or was it corn?). Anyway, at the time. I wrote an article advising my readers against that, explaining that I tried it in my wife's garden, and I kept getting dirt in my mouth.

Anyway, I hope my wife and others who know how to raise things continue to grow good fresh vegetables, because they taste so good, even if it does raise the water bill while leaving the grocery costs about the same.

## **Medical Waste Facility Land Contract Approved**

Plans for a \$4 million medical waste disposal plant to be built northeast of the City of Tahoka advanced this week as the city council unanimously approved a resolution authorizing Mayor Jim Solomon to sign a contract on the city land with the private firms planning the facility.

The mayor now has signed the contract with Southwest Enviro-Waste Services Ltd., and the next

#### **Moths Invade** Lynn County

A large number of moths are now congregating at night around lights in Lynn County. These moths are the adults of two or three species of mesquite cutworms. The number of these moths increased rapidly during the past few days. They will be present in large numbers for about a week then they will quickly disappear.

The mesquite cutworm larvae feed on mesquite leaves. They feed at night and remain hidden under the rough bark or at the base of the tree during the day. When full grown the larvae are about 1 1/4 inches in length. They are black with lightcolored to gray parallel lines running the length of the body.

Most of the foliage may be stripped from mesquite trees that are heavily infested by mesquite cutworms. When these cutworms are damaging mesquite trees in the home landscape carbaryl (Sevin) will provide effective control when sprayed on the foliage.

The moths which are almost black have a light colored line about 1/3 of the way back across the wings. When the moths are folded this line forms a v. There is a crescent shaped orange spot on the end of the underwings.

If the moths become a problem in the home, aerosol sprays containing pyrethrins or resmethrins will be helpful in controlling the moths. They will not cause any damage in the home but may be a nuisance. Use yellow lights that do not attract the moths if the presence of large numbers become a problem.

Now that school is out and vacation time is here, motorists are heading for the road in droves, this increasing their chances of experiencing unfamiliar driving conditions.


Major V. J. Cawthon, Department of Public Safety Commander of Region 5 said, "When driving in the rural areas, slow down before not after entering a curve. If you wait until it seems urgent to slow down, it is too late. Your engine should be pulling your vehicle through the curve. This pulling force aids in directional control, when you use a safe speed in a curve."

The major reminded Texas motorists to be alert to the fact that many people lose their lives within 25 miles of departure and/or destination. This fatal fact of the road is due, in great part, to abusing the speed





STORING FOODS SAFELY

Maintaining food quality starts with selecting high quality foods. It also involves storing foods properly and using them in a timely way. Tips for maintaining quality during storage include:

Rotate foods on hand with newly purchased foods so that older items are used first.

Reseal packages tightly after opening. Transfer foods such as flour, sugar, and cereal to airtight containers. Store whole wheat flour in the refrigerator or freezer.

Keep refrigerators below 40 degrees F. Store foods in airtight containers to prevent transfer of odors or flavors. Allow enough room between items for adequate circulation of air. Remove spoiled foods promptly to prevent cross-contamination.

Keep dry storage areas clean, cool, dark and dry. Store foods on shelves above the floor, away from water pipes and hot air ducts. Store foods in coolest areas of the kitchen. Keep cleaning supplies in a separate area, away from foods.

All foods have limits on now long they will stay at peak quality, even when stored properly. A guide for storing some common perishables can be obtained from your local county Extension office. You have visions of beach-combing on an exotic isle. But is this offer too good to be true? According to the Federal Trade Commission it proba-

When you call the toll-free number, you're likely to be told you must join a travel club to be eligible for the free trip. Sometimes, a credit card number is requested so that your account can be billed for the membership fee.

With these offers, it's likely you'll be sent the vacation information package only after you have joined the club. Usually your reservation request must be accompanied by yet another fee. New charges are added at every step.

The final catch is that you may never get your "free trip" because your reservations cannot be confirmed or you can't comply with the hard-to-meet hidden or expensive

Carpet Emissions And Indoor Air New carpet may prompt complaints of odors, irritation, and sometimes illness. These complaints can be caused by volatile organic compounds emitted by the carpet. However, all carpets are not the same, and research has not produced information on all situations. The major component and dominant odor emitted by carpet installations (carpet, backing, pads, etc.) is 4-Phenylcyclohexene (4-PC).

If residents have problems with new carpet odors, the only practical solution is to "air out' the carpet. Increased ventilation is the best answer. Open windows (about an inch) in the affected rooms for the first month. This may result in more energy use, but it is the cheapest and most effective method available.





#### **DEVELOP LAND TO** CONSERVE WATER

With hot, dry weather looming ahead, homeowners and others involved in landscape development should focus on water conservation.

Water conservation can be practiced in all areas of landscape development and maintenance, including plant selection, irrigation practices and equipment, and soil preparations. These practices can be aesthetic as well as practical, said Brent Cypert, county agent with the Texas Agricultural Extension Service.

Homeowners can lower their landscape water usage in several ways:

-Using native and adapted plants. Native plants often thrive on existing growth conditions and reduce the need for extra irrigation. Many plants have been introduced that show adaptability to soil, rainfall and temperature conditions.

-Taking advantage of innovations in irrigation practices and equipment. The landscape irrigation business is experiencing a revolution, with new timing devices, low pressure systems, drip irrigation and other highly specialized water devices focusing on more efficient water usage. Irrigation systems and small ponds and fountains also can effectively use water as an aesthetic addition to a landscape.

-Using mulches for insulation. By providing an insulating layer between the sun and soil, mulches prevent rapid drying and lower soil temperature in hot weather, which keeps the top soil from crusting or hardening. Low-cost materials such as hay, grass clippings, bark and pine needles are excellent for mulching and can add appeal with texture and

-Properly preparing the soil. When soil has been loosened and improved with plenty of organic material, such as peat, pine bark or compost, it will hold significantly more moisture and release it over a longer period of time. However, organic materials break down over time and need to be supplemented. A compost pile can be a good source of these materials, allowing the homeowner to recycle leaves, grass clippings and other waste to improve the






Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7,80% per annum.


