

A MAN I KNOW recently was ticketed for speeding and took a defensive driving course in order to pay less than the maximum fine and in order to keep the insurance company from getting what little money he has left. In effect, this amounted to a sentence of eight hours in a classroom (probably fastened to a chair with seatbelts).

He said there was one interesting comment made by the instructor/jailer about driving while intoxicated. The guy reported that in El Salvador the penalty for drunk driving, first offense, is death by firing squad. There are no second offenses. (He's not sure the guy said El Salvador, but it was one of those countries.)

This may be a little extreme, and I wouldn't want to live in any country other than the U.S., but there certainly is some merit to this kind of law enforcement. For example, it sounds like a reasonable punishment for the guy who drove his vehicle through a house and killed a woman (who happened to be active in Mothers Against Drunk Driving) who was sleeping on the divan in the front room.

Democracy is great, but sometimes I wish we had a dictatorship (with me as dictator, of course). If someone is sentenced to death for murder, for example, the sentence would then be carried out that day, instead of dragging it out for 15 years of court hearing and then finally turning the murderer loose, when the courts decided he wasn't such a bad guy even if he did chop up his neighbor's little girl with an ax, because his welfare check was late that month and he was under a lot of strain, and besides, there was a typographical error in the transcript of the first trial.

Our Criminal Injustice system protects the monsters and perverts and does little for the victims or their families.

Another example of legal wrongdoing was in the recent Supreme Court decision to allow flag-burning as "free speech." Sen. Phil Gramm of Texas, incidentally, is cosponsoring a constitutional amendment to prohibit flag burning—one way to get around the Supreme Court. "I reject the ridiculous notion that burning the American flag is somehow protected by the Constitution," Gramm said.

So when I am dictator, here are just a few of the changes that will be made in this nation:

First-time DWI offenders will be required to watch two hours of soap operas and wrestling every day for a year. Second offenders will be shot. Flag-burners will lose their citizenship and be deported to Libya, never to be allowed to return. Animal rights demonstrators will be imprisoned forever in Los Angeles coliseum with all the stray dogs and cats which can be rounded up in this hemisphere.

Income tax will be 10 per cent of what you make, regardless of expenses and regardless of whether you earn \$1 a year or \$47 zillion.

No one under 18 who plays baseball, football, tennis, basketball, or is in FFA, Little Dribblers, 4-H, band, Little Miss pageants, tumbling or any other organized activity will be allowed to have parents.

No one will be allowed to advertise phone numbers which spell out the name of their product, company or cause. A phone number should be a number, not a bunch of garbage.

Anyone guilty of telephone soliciting for insurance, stock sales or aluminum siding will have their tongues cut out.

All homosexuals and Gloria Steinem will be sent to the moon to start a new colony of strange beings in outer space.

# **Annual Old Settlers Reunion Set Saturday**

The annual reunion of Lynn County Old Settlers-persons who lived in the county 25 or more years ago-is scheduled for this Saturday at Tahoka High School cafeteria.

Something new is being tried this year, as the event has been opened to the general public, not just for the pioneers, although they are in the spotlight as honored participants. "We want everybody to come out to the celebration," said publicity chairman Cal Huffaker.

Registration for the old settlers will begin at 10 a.m., and the barbecue meal, for everyone, will be at

noon at a price of \$3 per plate.

Gerald Huffaker will be master of ceremonies for the program following the meal, when the person traveling the longest distance to the event, the oldest person not previously so honored, and others will be recognized.

Following the recognitions of special persons and other matters on the program will be informal visiting by those who each year take part, both from out of town and those who still live here.

# 10-Year-Member Of Tahoka School Board Resigns

Joe Hays, president of the Tahoka School Board, resigned from the school board at the beginning of the regular meeting of the board last Thursday, explaining that he was doing so because his wife had applied for a teaching job in Tahoka schools. Hays, who has been a school board member for 10 years, indicated in his letter of resignation that he is on the best of terms with the board and that being on the board has been a good experience.

Vice President Delbert McCleskey took over leadership of the board meetings. There was no indication as to whether the vacancy on the board would be filled before the next scheduled election.

Resignation of Mary Goldston as elementary special education teacher was also accepted by the board. Following an executive session, the board voted to hire Donna Carter to replace her, and to hire the following:

Mrs. Joe (Glo) Hays as DECA teacher, Vicki Steinhauser as elementary teacher, Frank Stone for high school mathematics, Kelli Cullen as high school English teacher and assistant coach for girls athletics, Esmeralda Longoria as Chapter I regular teaching assistant, and school secretaries and assistants.

Dr. Duane Carter, superintendent, advised the board that under the legislature-approved school funding plan, Tahoka Schools would receive more than \$300,000 above the current state funding level, but only if

school taxes were increased.

Business manager Loretta Tekell said that 94.8 per cent of the 1989 tax roll had been collected. She also noted that for those who have not paid their taxes, an additional 15 per cent penalty will be added effective July 1.

Officials at the Lynn County Appraisal District office in Tahoka pointed out that the additional 15 per cent penalty will be on all school, city and county taxes not paid by that time, and that when the new penalty is added to those already accruing since taxes were due by Jan. 1, the total penalty on unpaid taxes for 1989 will be 33 per cent in July.

All members of the school board were present Thursday night as the group also voted to participate in a Texas Tech Ford Foundation Project, which will involve the high school vocational agriculture teacher in a program to train young farmers in computer-assisted bookkeeping. The project also will involve teachers Patti Rambo and Barbara Jaquess in some computer work with young homemakers. The Ford Foundation project will pay all expenses involved.

Minnie Lou Ash, assistant to the superintendent, reviewed a Chapter I Regular improvement plan, which was approved by the board.

The board also appointed local representatives to various organizations, such as the Texas Assn. of School Boards.

### District Judge Sentences Three Here

Three persons were sentenced after appearing before 106th District Judge George Hansard in Tahoka this week.

Pedro Rodriguez Jr., 24, of O'Donnell, was fined \$650 and given a 60-day jail term on a hearing for revocation of his probation on a previous conviction.

Armandina Rodriquez, 40, of Tahoka, was sentenced to 60 days in state prison on a charge of delivering an alcoholic beverage to a penal institution. She was accused of bringing beer for a prisoner in Lynn County jail recently.

Juan Jose Vasquez, 39, of Wilson, was sentenced to 42 months in prison and fined \$1000 on a charge of felony driving while intoxicated.

Among new incidents investigated this week by law enforcement officers was a report from Bennie Middleton, 10 miles west of O'Donnellon FM 2053 that someone had stolen a 3 hp Homelite motor and a Homelite pump from a water trailer at that location last Wednesday. The stolen items were valued at a total of

Tahoka Police Dept. had a report from Santos B. Garza of Tahoka that someone had broken a window on a 1984 Oldsmobile Delta 88 which was parked on the west side of Thriftway Supermarket Sunday. Damage was estimated at \$250.

In jail during the week were two persons for public intoxication, two for DWI, one for judgement and sentencing on aggravated assault, one for application to revoke probation on a DWI charge, two more for judgement and sentencing on DWI, and one for application to revoke probation for delivering alcoholic beverage to a penal institution and tampering with government records.



TO ALL FORMER AND CURRENT INTRASTATE WIDE AREA TELECOMMUNICATIONS SERVICE (WATS/800) SUBSCRIBERS:

Southwestern Bell Telephone Company has instituted a Class Action Lawsuit seeking judicial approval of a settlement reached in: Docket No. 7297, an inquiry of General Counsel of the Public Utility Commission of Texas into possible overcharges which occurred between September, 1976, and February, 1987, due to rounding practices, onbills of intrastate WATS/800 customers sent by Southwestern Bell and other telephone companies which concur in Southwestern Bell's tariff. The suit is styled "Southwestern Bell Telephone Company, Plaintiff, vs. MCI Telecommunications Corporation, A Member of the Class of Texas Intrastate WATS and 800 Service Customers Who Paid Overtime Charges From September 1976 Through February 1987, Defendant," and identified as Cause No. 471,460 in the 126th Judicial District Court of Travis County, Texas.

Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7,80% per annum.

### Claim Forms And Additional Information

Those customers who think they may be entitled to a refund or who desire more information must call 1-800-782-3026, 8:30 a.m.-4:30 p.m., Monday through Friday, or write to WATS Refund Pool Administrator, One Bell Plaza, Room 670, P. O. Box 650376, Dallas, Texas 75265-0376, to request a WATS Refund Information Package. The WATS Refund Information Package will contain further information regarding the lawsuit and eligibility for a refund, a description of documentation required to support a customer's claim for refund, and a refund claim form to be filled out and submitted requesting a refund. REQUESTING A WATS REFUND INFORMATION PACKAGE DOES NOT OBLIGATE YOU IN ANY WAY.

All claims for a refund must be received by the Refund Pool Administrator by Friday, October 5, 1990, and all rejections of the settlement (that is, requests for exclusion from the class action lawsuit) must be received by the Court by Wednesday, September 5, 1990. Only those who respond by filing a claim or by filing a rejection of the settlement, as explained in the WATS Refund Information Package, will receive notice of future developments in this proceeding
