Three Planter **Units Stolen**



Commercial **Drivers License**

The Department of Public Safety is making preparations to license approximately one million commercial drivers in Texas. On Sept. 17, DPS began uniform testing for all currently licensed commercial and

All commercial motorists who drive vehicles in excess of 26,000 pounds or transport hazardous materials that require the vehicle to be placarded are required to have a commercial drivers license (CDL) by April 1, 1992. Bus drivers, including school bus and church bus drivers, who drive buses designed to carry 16 or more passengers, including the driver, will also be required to obtain a CDL by the same date.

Exempt from the CDL requirements are farmers, when they are driving within 150 miles of their farm, military personnel, recreational vehicle operators, and fire fighters when operating fire fighting vehicles or equipment.

Commercial drivers who must carry the new CDL's cannot renew their current licenses due to expire between Sept. 17, 1990 and April 1, 1992. They should plan to visit the DPS Driver License offices for CDL testing at least one month before the expiration date.

To ensure that all commercial drivers in Texas who must have the CDLs obtain them in time to avoid penalties, the DPS troopers are urging them to visit the Driver License offices as soon as they have studied the CDL handbook. CDL license fee is \$40, less \$4 for each year of validity remaining on current Texas driver license. Free CDL handbooks are available at all of the offices.


The meeting, which will start at 7:00 p.m. with the election held immediately after the meal and program, will be at the Wilson School Cafeteria.

Legal qualifications state that a candidate for the office of a soil and water conservation district must own land in the zone he represents, be 18 years of age, and be actively engaged in farming or ranching. He must also live in a county all or part of which is in the district. Soil & Water Conservation District Directors serve four year terms of office.

The sketch below shows the zones or subdivisions within Lynn County. A director will be elected from Zone 1 and Zone 2. Presently serving for Zone 1 is W.R. Steen of Wilson and T.B. Mason of Tahoka for Zone 2.
