Family Histories Are Still Being Accepted

Lynn County families wishing to or extremely large pictures. write their histories while together during the Thanksgiving holidays may submit them to County History Book Committees, Box 296, Tahoka, TX 79373. Although the deadline has passed, the committee realizes that families will be together during the holidays and this will give them an excellent opportunity to compose a family story. Photos are also welcome. Several hundred stories have been received to date.

Stories should be typed on 8 1/2 x 11 paper, if possible. The title of the story should be at the top of the first page and author's name at the end of the story. There is no charge for 500 words in a story, but additional words cost \$15 per 100. The number of words in the story should be given under the author's name. A, an, I, to, of, me, at, and other two letter words do not count.

Each family unit or person should write his own story. Each adult child should write his story about his family unit.

500 word stories written about deceased parents or grandparents require the purchase of a book.

Good quality black and white or color photos are acceptable. Not acceptable are pictures from newspapers, copies made on copy machines

On the back of each photo should be the name or names of those pictured and the name and addresses of the person submitting the picture. Pictures will be returned if at all

Additional pictures may be submitted at a cost of \$20 each. A couple having only individual pictures may submit two pictures if they are the same size, have been trimmed of border and excess background, and taped together to form one picture.

Books may be purchased for \$49.95 each plus \$3.62 tax or a total of \$53.57. For books to be mailed there is an additional charge of \$3.95 for postage and handling. The number of books pre-sold will determine the number printed. No additional books will be printed. The books will be 8 1/2 x 11 size, beautifully bound in hardback leatherette material with embossed art on the cover. In addition to the family stories it will include histories of businesses, organizations, churches, and schools as well as memorials, tributes and a chart for recording your family tree, births, deaths, marriages, etc.
