Second place silver medal winners were Jason Belew in a new contest, Current Events and Issues and Ranae Williams in ninth grade Oral Reading.



BOB BULLOCK wants to give us all a state income tax, something most Texans have violently opposed for years. To make the idea more palatable, he proposes to "phase out" the property taxes, which have continued to grow until most people with property feel they are already taxed to the limit.

Getting rid of the property tax and replacing it with another income tax sounds good, but nearly anybody who has ever paid taxes knows that if the state cuts back on one tax and creates another one, that very shortly thereafter, the original tax will be restored, and the new one kept, which just means more taxes to pay.

I read somewhere that the Roman Empire and other empires failed when taxes reached a certain percentage (I don't remember what) which already has been surpassed in this nation.

Bullock says Texas property taxes increased 29 per cent from 1980 to 1988, "the highest rate of increase in the nation."

I'm not in favor of a state income tax. And any more taxes on small businesses in the state will likely bring some more business closings, of which this community and state have had too many already. And every time a business closes in a community, the tax burden on the remaining businesses increases, making it even harder to operate.

Most of us out here in the boondocks feel that the state (and our schools) could operate on less money. The thing is, nobody wants to give up any fringe benefits or nice (but expensive) programs.

In a sort of related matter, we received this week a 14page brochure from some group called the National Taxpayers Union, which indicts Washington, D.C., and all of Congress and government bureaus for corruption, incompetence, greed and just plain skunkery. One of the main thrusts is to try to get a limit placed on how long a member of Congress can serve, to eliminate the professional career politicians whose main goal, according to the NTU, is to further their own interests, rather than those of the citizens of the country.

The pamphlet cites names and incidents and mentions proposed budget items such as \$2 million to renovate the seating area for House members in the Congressional restaurant, and \$250,000 to study the best position for TV lighting in the Senate meeting rooms.

And what does the NTU want? Like everybody else, they want some of our money.





Southwestern Bell Telephone Company has filed two separate applications with the Public Utility Commission of Texas to introduce two new optional directory services. One service is Directory Assistance Call Completion (DACC) and the other service is Multiple List Directory Assistance (MLDA).

DACC is an optional service that provides customers the option of having their Directory Assistance call completed to the requested number (when they call Directory Assistance for a number) by either the Directory Assistance operator or a mechanized audio response system.


The proposed rates' for fully-automated DACC calls are: \$.30 if the call is sent paid or billed to a calling card, \$1.00 if the call is collect or billed to a third number and \$.25 from a coin telephone.

The proposed rates * for semi-automated (operator assisted) DACC calls are: \$.85 for calls that are sent paid or billed to a calling card, \$1.20 if the call is collect or billed to a third number and \$2.60 for a person-to-person call.

Multiple List Directory Assistance (MLDA) allows the customer to request more than two listing requests per call to. Directory Assistance. Customers can either call on "demand" and receive up to 10 listings, or schedule an "appointment" and receive the assistance of a Directory Assistance operator for as long as required. The rates for "demand" MLDA are \$.30 per listing request (after applicable allowances), with a maximum of 10 listing requests per call. The rates for "appointment" MLDA are \$1.00 per minute, with a 15-minute minimum.

The optional services DACC and MLDA are intended for use by both residence and business customers. Those persons who qualify for exemption of Directory Assistance charges because of visual or physical handicaps will be able to use DACC and "demand" MLDA free of charge. If approved by the commission, DACC and MLDA will be available beginning May 13, 1991. Firstyear projected revenues for DACC are approximately \$9.6 million. First-year projected revenues for MLDA are approximately \$1.7 million.

Incidents of child abuse have lem, and one that can be prevented. Some tips on preventing child abuse include:

> · Praise and encourage the children you know;

· Be a friend to a parent;

· Promote parent groups at your church, club or work place;

· Volunteer for a community project;

· Learn more about child abuse and neglect, and become a member of the Council on Children at Risk;

The Child Abuse Prevention Network has also released tips for parents, which centers on the summer months during which children will be out of school and at home. They encourage parents to set up a safety system for children, especially if they stay home alone, and review safety procedures; schedule times for checking in with each other; make sure the home is accident-proof; identify places that children are allowed to go by themselves and places that are off limits; and make sure children are supervised by a responsible individual and there is a backup person in case of emergencies.

18 Indicted On Water Filter **Sales Scheme**

Marvin Collins, United States Attorney for the Northern District of Texas, DeWayne C. Strader, Postal Inspection Service, and James R. Flick, Deputy Divisional Inspector General, Environmental Protection Agency, announced an indictment returned by a federal grand jury in Fort Worth. The indictment charges 18 individuals with conspiracy, mail fraud, wire fraud, band fraud and money laundering in connection with a telemarketing operation which did business as National Award Center in Arlington, Texas.

Twelve of the 18 defendants are from the Fort Worth area, and were either owners, managers, or employees of the National Award Center.

"One of the indictments alleges that between Nov. 1, 1989, and July 31, 1990, the defendants conspired to perpetrate a fraud on consumers and financial institutions by making false statements and representations in the sale of water filters through a telemarketing company known as National Award Center, located in Arlington. The indictment alleges that the defendants solicited customers via postcards offering "valuable prizes", then attempted to sell water filters when the customers called the company. The company encouraged the use of credit cards by the customers to make the purchase.

The alleged false statements related to the value and quality of the water purifier offered for sale and prizes given away as incentive, the likelihood of winning any particular

prize, the delivery scheduled of the purifier and prizes, and the availability of refunds for dissatisfied customers. The indictment further alleges that certain defendants conspired to obtain the proceeds for the scheme by fraudulently and secretly depositing the credit card sales drafts generated as a result of the sales into merchant accounts of other businesses. which businesses charged a fee for this service. According to the indictment, this activity is known as "factoring".

The indictment alleges that the defendants conspired to defraud approximately 3,700 individuals throughout the United States and two financial institutions of money and property totalling approximately \$1.5 million.

County Accident Report Listed

Capt. L.A. Reinhart, District Supervisor of the Lubbock Highway Patrol District comprised of 21 counties reported that in the month of January, troopers investigated three fatal accidents,'86 personal accidents and 136 property damage accidents. There were four persons killed and 121 persons injured in these accidents.

Brownfield stated, "In Lynn county,troopers investigated no fatal accidents, four personal injury accidents and nine property damage accidents in the month of January.

For the month of February Reinhart reported four fatal accidents, 34 personal injury accidents and 37 property damage accidents. Four persons were killed and 68 persons injured in these accidents.

Recognizing environmental issues - and responsibility dealing with them — will be covered at the conference.



To help stem this loss, the Lubbock Area Foundation has provided a grant of \$2400 to help SPEMS offer continuing education programs in the rural areas. The grant provides funds for a Resource Center of education materials which can be taken out by EMTs for use in their own hometown. Materials that would be cost prohibitive for one service to buy would be cost effective when shared by the 40 EMS services in this area.
