## **Food Stamp** Theft, Wreck Investigated

Theft of food stamps, a collision in the city, and several burglaries were among incidents investigated by Tahoka Police Dept. and Lynn County Sheriff's office during the last week.

Preston Reeves of Ropesville reported burglary of a barn about 3.5 miles north of Lakeview community between Sept. 25-27, with articles totaling \$1556 in value stolen, including a Lincoln welder, an air compressor, saw and wrenches.


Two burglaries were reported near FM 211 about a mile east of FM 179 in late September. One was at the home of Jay Daniel Ussery, who lost about \$115 worth of clothing, and the other was a building nearby in which tools belonging to the Honey-Do Company of Lubbock had been stored while the firm was working on the Ussery house. Owner Everett McArthur said the tools included a power air nailer and other tools valued at a total of \$926.

Misdemeanor theft charges were expected to be filed Wednesday against a Tahoka woman in her late 20s, who was accused by a 30-yearold Tahoka man of getting his food stamps at the Post Office. Value of the stamps was \$111.

Property stolen on Sept. 23 and owned by a Tahoka youth was recovered from a store in Lubbock, and police planned to question a 21-yearold Lubbock man as a suspect, with charges anticipated. The Alpine stereo system valued at \$540 owned by Ty Stark was taken from a 1985 Ford Lariat.

On Oct. 3 at the intersection of U.S. 87 east access road and "cemetery overpass", two 1981 Oldsmobiles collided, causing minor damage and no injuries. A Royale driven by Dorothy Camille Quintero, 26, of Tahoka, and a Toronado driven by Consuelo Deleo Bernal, 50, of O'Donnell, were involved.

In jail during the week were two persons for driving while intoxicated, another for DWI plus possession of a controlled substance, one for public intoxication and one for DWI plus no drivers license.





The money must be used to pay somebody to recycle discarded tires and to pay somebody to recycle the lead and acid in batteries, which no longer may be buried out at the dumpground.

Under the new laws, which are to be enforced by the Texas Dept. of Heath, if you want to get rid of an old battery, you have to take it to a wholesale or retail battery dealer, a secondary lead smelter or a recycling center authorized to accept it. Battery retailers and wholesalers are required by law to accept these old batteries for recycling.

No doubt there will be a lot of violations by disgusted owners of old batteries who decide to just take the batteries out on a country road at midnight and set them down there. Or perhaps on the front lawn of their local legislator. But either of these options is illegal and could get you in trouble with the law, although none of the stories I've seen specifies the fine or jail term.

I can envision a scenario where a lot of otherwise good citizens are doing 10 to 20 years in the state pen for illegal disposal of batteries, while the dope peddlers, burglars and perverts are running around on probation, doing their thing without worrying about the law.

week of Oct. 6-12, and there were several good tips pertaining to fire protection and prevention offered to readers in last week's newspaper. These tips are fine and dandy, and should be taken to heart, and possibly even to the mind where they can do some good.

There are, however, several important tips which I can see right away that were left out, and being the safety-conscious consumer expert that I am, I feel duty-bound to share the following words of wisdom.

I can proclaim myself a fire safety expert because, (a) I have never burned my house to the ground, and (b) this is my column and I pretty much write whatever I feel like writing, as long as the publisher doesn't read it before it goes into print. Sometimes even I don't read it before it goes into print ... I just type blindly for about 30 minutes and see what comes out of the computer.

Okay, so here are the fire safety tips which, according to my calculations, will prevent a fire from occurring in your home or property for about 27 minutes, or until you light a match to this newspaper column, whichever comes first.

Fire Safety Tip Number One: Never use matches. They can cause fire, unless you are trying to light a charcoal fire in your grill, in which case matches don't cause anything except a buildup of little sticks in the bottom of your grill. I keep getting defective matches which lay around on the charcoal and snicker gleefully at raw hamburger meat.

Tip Number Two: Lighter fluid is a good way to asphyxiate yourself when you use a half gallon on the charcoal, which isn't going to light anyway. Don't use it.

Tip Number Three: Never ever ever ever ever EVER dump a full box of baking soda on a grease tremely, painfully hot when it boils

Tip Number Five: Make friends with the volunteer firemen. All of them. That way they know your address when the fire call comes in. Maybe you should even bring them brownies and cookies at their monthly meetings. It's true that the quickest way to a fireman's heart is through his stomach. Just don't make them too fat to get through the door.

Tip Number Six: Have your children practice fire escape routes in your home. Leave the windows open and tell them to scramble out and run to a neighbor's house and stay there for, oh, say four to six hours, until you give the allclear signal. This will give you plenty of time to check your home for fires, take a nap, cook supper and read a book. Your neighbor will be very accommodating because, after all, it is in the interest of fire safety precautions. This is also a good way to get rid of pesky neighbors you wish you didn't have to put up with in the first place.

And finally, Tip Number Seven: Marry a fireman. This will solve all your fire-related problems. If you can't marry one, move next door to one. You'll know where he lives - it's the house with all the smoke fire in your cast iron skillet. 

#### **PROCLAMATION**

#### Covernor of the State of Texas

TO ALL TO WHOM THESE PRESENTS SHALL COME

BE IT KNOWN THAT I, ANN W. RICHARDS, GOVERNOR OF THE STATE OF TEXAS, DO HEREBY ORDER, in accordance with Tex. Elec. Code Ann. § 3.003 (Vernon 1986), a CONSTITUTIONAL AMENDMENT ELECTION to be held throughout the State of Texas on THE FIRST TUESDAY AFTER THE FIRST MONDAY IN NOVEMBER, 1991, same being the FIFTH day of NOVEMBER, 1991; and,

NOTICE THEREOF IS HEREBY GIVEN to the COUNTY JUDGE of each county who is directed to cause said election to be held in the county on such date for the purpose of adopting or rejecting the constitutional amendments proposed by the 72nd Legislature, Regular Session, 1ST and 2ND Called Sessions of the State of Texas. The wording of the proposed constitutional amendments shall appear as follows:

#### Proposition 1

"The constitutional amendment allowing home-rule cities with a population of 5,000 or less to amend their charters by popular vote."




