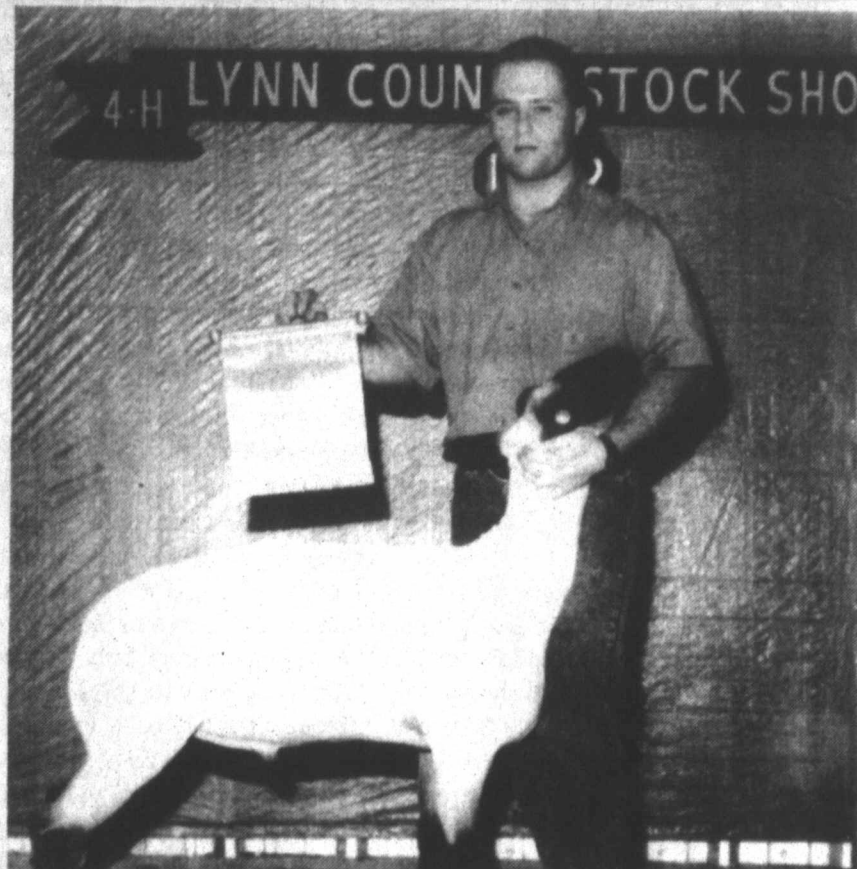

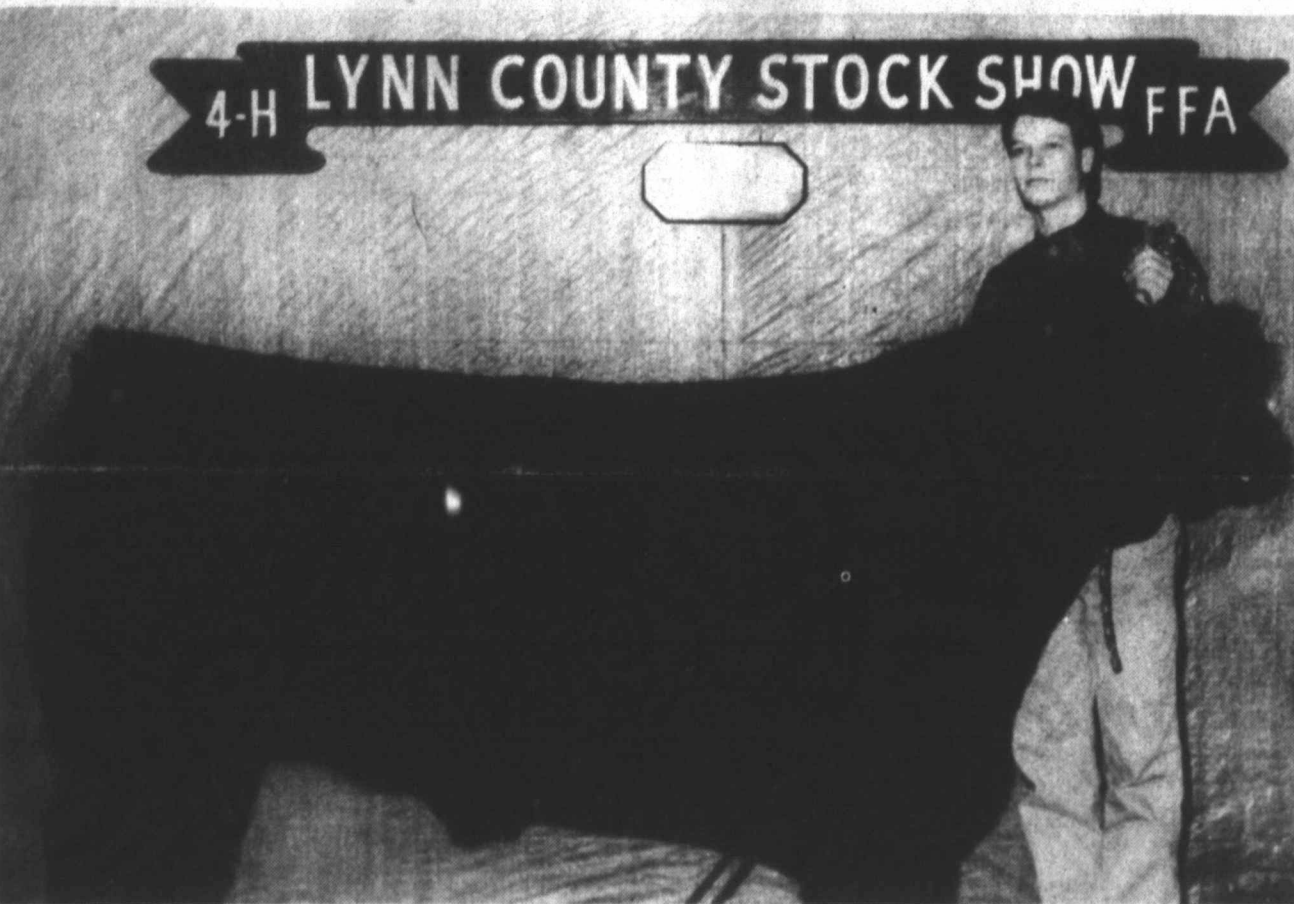

Several exhibitors from O'Donnell took most of the grand and reserve champion awards at the Lynn County Stock Show held this past weekend at the county showbarn in Tahoka, with one exhibitor from

Wilson and one from New Home finishing out the list of top winners.

Matt Hogg of O'Donnell 4-H showed the Grand Champion Steer, and his brother Jon Hogg won the Reserve Grand Champion award with his steer. Tonya Forbes of O'Donnell FFA received the top award for her Grand Champion Hog, and New Home FFA's Lisa Vineyard showed the Reserve Grand Champion Barrow.

O'Donnell FFA member Gary Stidham captured both top awards in the Lamb division, showing the Grand and Reserve Grand Champion lambs. Cody and Casey Donald of Wilson 4-H showed the Grand Champion Heifer at the show.

Judging of steers, heifers and lambs was held all day Thursday, and barrow judging was held Friday. Baked Goods winners were also named Friday. Saturday's events began with a barbecue lunch, followed by presentation of awards and the auction sale. Billy Miller was auctioneer for the event.

Lynn County Stock Show Association President David Wied presented a plaque of appreciation to the Lynn County Commissioners' Court for their help in the recent renovation of the showbarn. Commissioners T.A. Stone, Sandra Cox and J.T. Miller accepted the plaque for the group.

Wied also presented a plaque to Sandra Cox in memory of her late husband Bobby Cox in appreciation for his "untiring efforts he gave to the

Stock Show Assn. throughout the years."

The Bobby Cox Memorial Sportsmanship Award sponsored by the Cox family was presented this year to O'Donnell FFA member Mark Roy. The coveted Showmanship Awards at the County Show were presented to Tahoka's Greg Smith in the Hog division, and to Jon Hogg in the Lamb and Steer divisions.

Assisting at the show were FFA Sweethearts Katy Huffaker of Tahoka and Marla Rudd of New Home, and 4-H Princesses Lacye Payne of O'Donnell, Lynna Rash of Tahoka, and Stacey Shelton of Wilson.

Drug Prevention Workshops Offered To Parents of 4th-6th Grade Students

Last Thursday, Jan. 23, Tahoka Elementary began a series of workshops for parents of 4th-6th grade students. The workshop is entitled, "Preparing for the Drug Free Years", and will be held on Thursday nights for four more weeks. Scheduled dates for the sessions are Jan. 30, Feb. 13, Feb. 20, and Feb. 27.

Although participants are strongly encouraged to attend all five sessions, it is not absolutely necessary. Each session is designed to stand independently from the other sessions. "Each session has valuable information that you can immediately use with your children," according to Elementary Principal Molly Helmlinger.

The workshop sessions will be held in the Elementary LRC Library from 7 p.m.-8:30 p.m. There will be free baby-sitting service. "A matter of fact, those children whose parents are attending the workshop will be able to participate in a mini cheerleading clinic each of those nights. Plus, regular baby-sitting activities will be available," said Miss Helmlinger.

The workshop presenters are Mrs. Suetta Martin and Mrs. Leigh Nowlin, Tahoka Elementary staff members. "This is a workshop program designed to take early preventive action with your children. We help train parents to establish strong family bonds with their children. We help train parents to establish strong family bonds with their children," stated Mrs. Martin.

A detailed description of each session is listed below.

Session 1: How to Prevent Drug Use in Your Family (Jan. 23) When children begin experimenting with drugs, the stages of drug use, factors that put children at risk for drug abuse and what families can do to reduce these risks.

Session 2: Developing a Family Position on Drugs (Jan. 30) The importance of developing a clear

family position on drugs. How to clarify and set expectations about alcohol and drug use and communicate them to your family.

Session 3: Avoiding Trouble: How to Say "No" to Drugs (Feb. 13) Skills to help your children stay out of trouble while keeping their friends and having fun. Special techniques are taught for resisting peer pressure from individuals and groups.

Session 4: Managing Family Conflict (Feb. 20) The importance of managing family conflict constructively. Two anger management skills are taught: how to control anger and how to express anger so it doesn't drive a wedge between family members.

Session 5: Strengthening Family Bonds (Feb. 27) How to increase children's contributions to the family in four areas and recognizing each family member's special qualities.

"The title of the workshop is deceptive, but that is the name that the Texas Commission on Alcohol and Drug Abuse encouraged us to use. It really is a parents' survival course for the 1990s. It is a dynamic educational tool for all parents of children about to enter their teens. It is a program that not only helps parents realize the widespread dangers of teen drug abuse, but also empowers parents to develop an action plan to keep drug abuse out of the family," commented Miss Helmlinger.

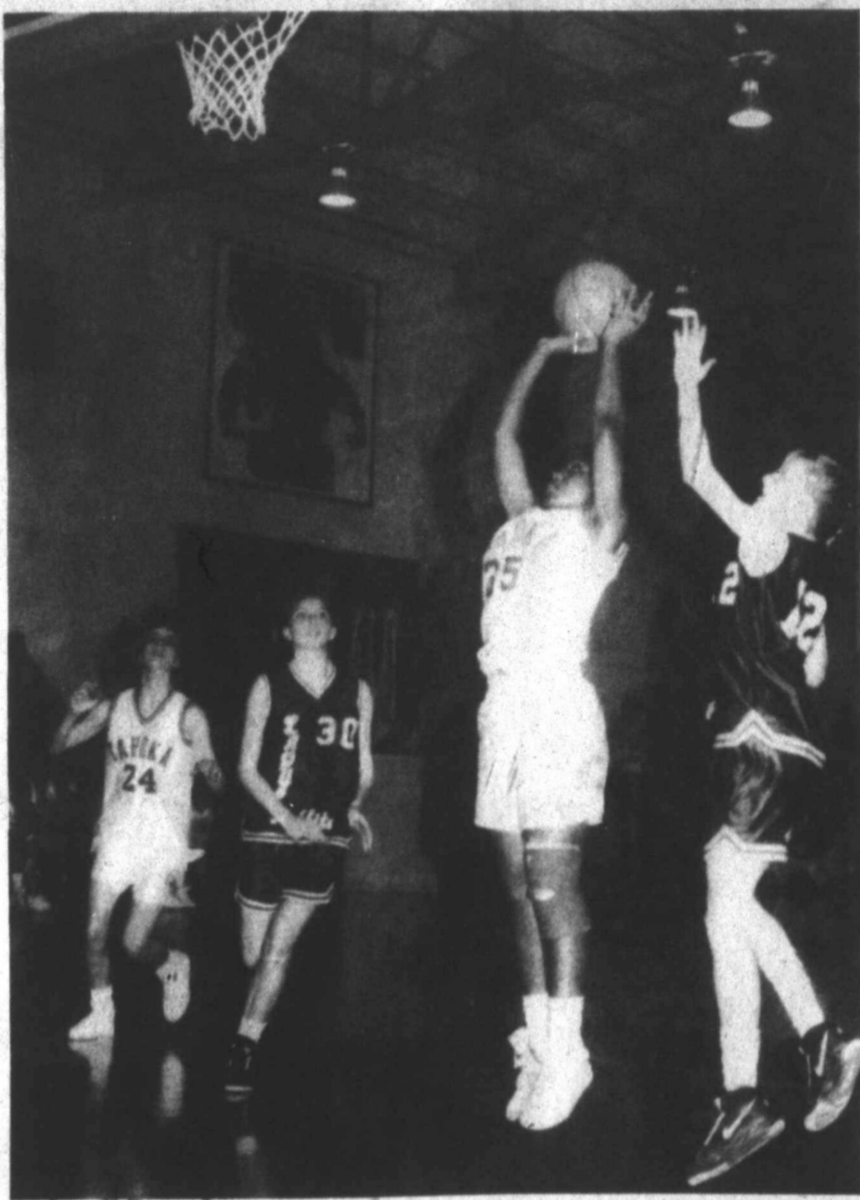
Mrs. Nowlin explained, "The program combines live presentations with video instruction. Short video segments are interjected throughout each session to present important information, model skills, and stimulate parent discussion. Parents are shown a practical demonstration of every skill that is taught. It should be very educational, and at the same time enjoyable," she added.

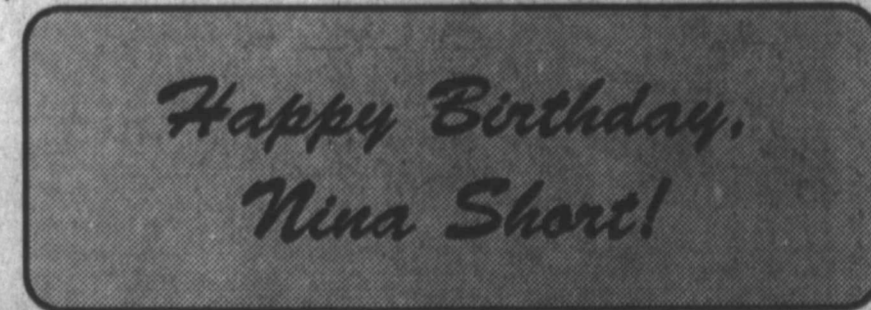
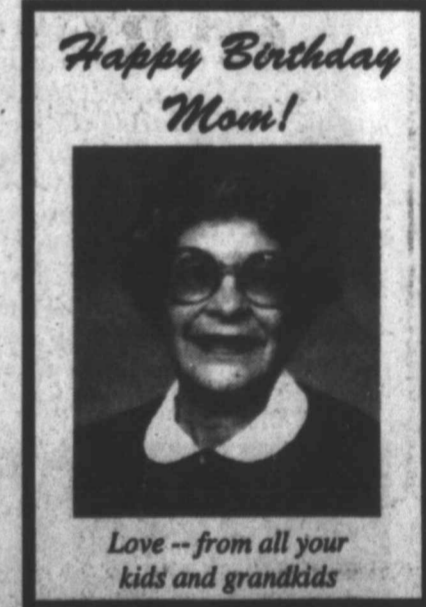
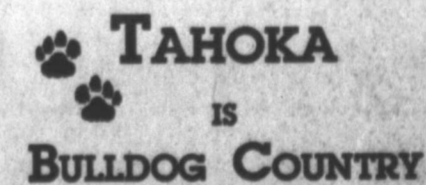
1 Fatal Traffic Accident Listed In County In 1991

Capt. L.A. Reinhart, District Supervisor of the Lubbock Highway Patrol District comprising of 21 counties said, "For the month of December our troopers investigated 2 fatal accidents, 58 person injury accidents, and 71 property damage accidents. There were 1 persons killed and 91 persons injured in these accidents."

Capt. L.A. Reinhart, District Supervisor of the Lubbock Highway Patrol District comprising of 21 counties said, "For the year of 1991 our troopers investigated 40 fatal accidents, 698 person injury accidents, and 800 property damage accidents. There were 46 persons killed and 698 persons injured in these accidents."

Sgt. Rex Akin of Brownfield stated, "In Lynn county, troopers investigated 0 fatal accidents, 3 personal injury accidents, and 1 property damage accidents in the month of December. No persons were killed and 4 persons were injured in these accidents."

Sgt. Rex Akin of Brownfield stated, "In Lynn county, troopers investigated 1 fatal accident, 31 personal injury accidents, and 26 property damage accidents in the year of 1991. One person was killed and 31 persons were injured in these accidents."

Varsity Dogs Hold Out For Two-Point Win Over Ralls

The Tahoka Bulldogs varsity boys basketball team held out to the very last seconds of the game Tuesday night to win by 2 points over the Ralls Jackrabbits. The 70-68 win brings the Dogs' season record up to 14-6 and district record to 2-4.

The Tahoka team established a lead in the first quarter of the game, scoring 17 points to the Jackrabbits' 14, and in the second quarter the Bulldogs outscored Ralls by 2, 13-11, bringing the score to 30-25 at the half.

The second half proved to be a close run for the teams, with both tossing in 16 points in the third period. The Dogs lost their 5-point lead in the fourth quarter, however, when the Jackrabbits scored three more points in that period than the Bulldogs. It wasn't enough, however, to clinch the game and the Dogs held out for the victory.

Tahoka's Brandon Cate was leading scorer for the Bulldogs with 19 points. Other scorers in double digits included Mike Burleson with 16 and Daniel Garvin with 13.

The Bulldog victory brought the Jackrabbits their first district loss, lowering their perfect district record to 5-1.

In last Friday night's game, the Bulldogs added another victory on their side 64-60 over Crosbyton. Cate was once again high pointer with a whopping 25 points, followed by Bruce Burleson with 16 and M. Burleson with 11.

They will travel to Seagraves this Friday night to play the first game of the second round of district play. The junior varsity teams and varsity girls will also play Seagraves.

Girls Lose Close One
The Tahoka Varsity Lady Bulldogs lost a heartbreaker to the Ralls Jackrabbits Tuesday night, when the Ralls team squeaked by with a 55-50 win, despite a tremendous come-from-behind effort by the Lady Bulldogs in the last period.

Tahoka established an early lead in the game, tossing in 13 points in the first period to Ralls' 9, but the Jackrabbits evened the score in the second period with 14 points to Tahoka's 6.

The Jackrabbits led 23-19 at the half, and then came out booming in the third period to score 22 points while holding down the Lady Bulldog scoring to only 11, giving the Jackrabbits a 45-30 lead over Tahoka going into the last period.

The Tahoka girls did not face defeat easily, however, and gave a tremendous last quarter effort to try to even up the score. They managed to toss in 20 points before the buzzer

sounded just a little too soon for Tahoka fans, and Ralls ended up with a 5-point margin to win the game 55-50.

Tahoka's Lana Parker led scoring with 15 points, followed by Myra Williams with 11 and Betsy Huffaker with 10.

Last Friday night, the Lady Bulldogs added another victory when they topped Crosbyton 56-47. Scoring for Tahoka was Williams with 22, Parker with 11, and Katy Huffaker with 10.

The Lady Bulldogs' season record is 15-9, and their district record is 3-5 going in to the second half of district play.

JV Boys Continue With Spotless Record

The Tahoka Junior Varsity boys team stayed undefeated as they walloped the Ralls Jackrabbits 63-28 Tuesday night, keeping their season and district records in perfect condition.

Top scorers against Ralls were JV players Robert Jackson with 15, and Timmy Stice with 14.

The previous Friday night, the JV held on to win 57-54 in a close game against Crosbyton. Scoring big the jayvee were Jackson with 17 and Stice with 14.

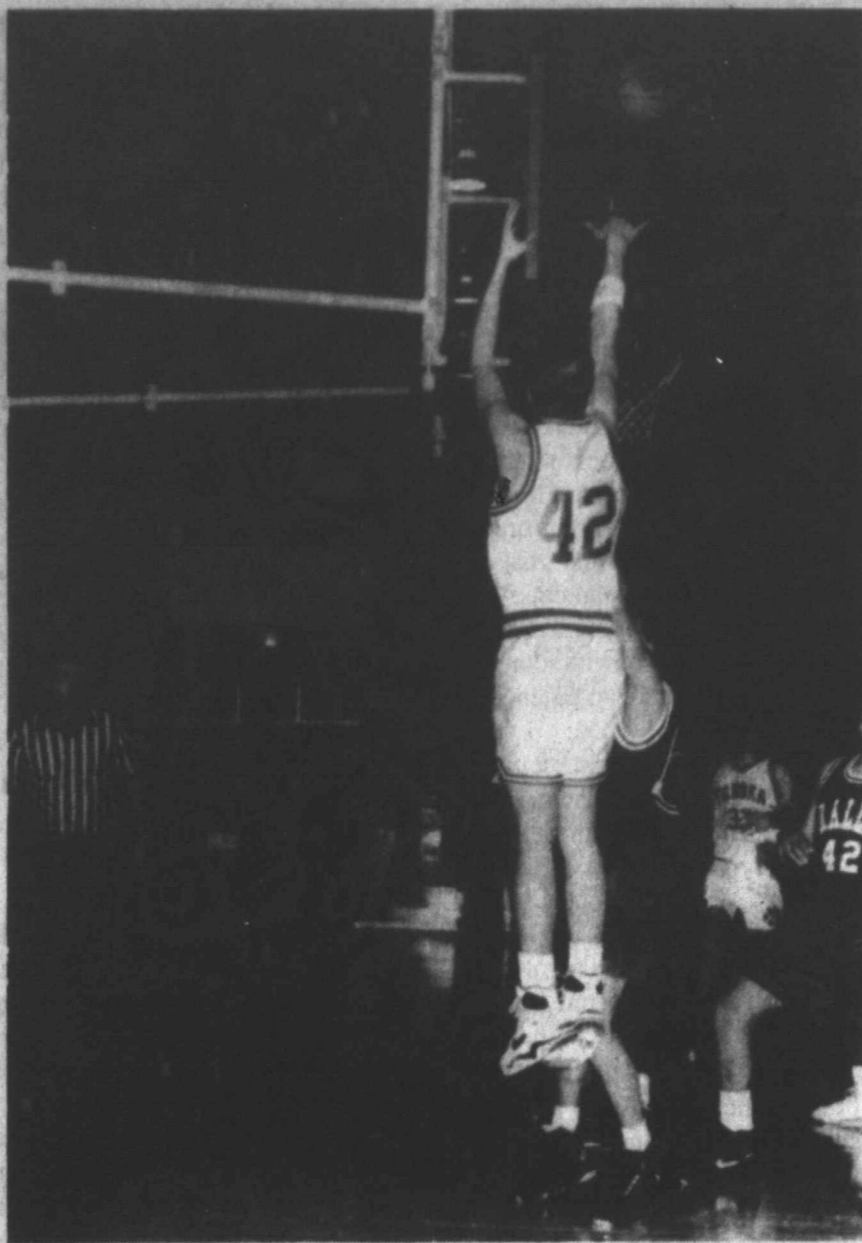
Post Takes 9th Boys

U.S. Sen. Phil Gramm has announced that farmers in seven Texas counties are eligible to apply for low-interest emergency loans to help recover from damages and losses to crops due to drought, hail and excessive rainfall which plagued much of Texas during 1991.

Due to drought between January 1 and July 19 of last year, farmers in Dawson, Andrews, Dickens and Duval counties are eligible for the loan assistance.

Due to drought, hailstorms and excessive rainfall between January 1 and July 19 of last year, farmers in Lynn and 45 other Texas counties are eligible for assistance.

For those who cannot obtain credit through normal channels, the U.S. Farmers Home Administration will make loans available at below-market interest rates to family farmers.

The FmHA, which will supervise the loan program, is charged with providing aid to the farmers and ranchers in order to assist their economic recovery from natural disasters.

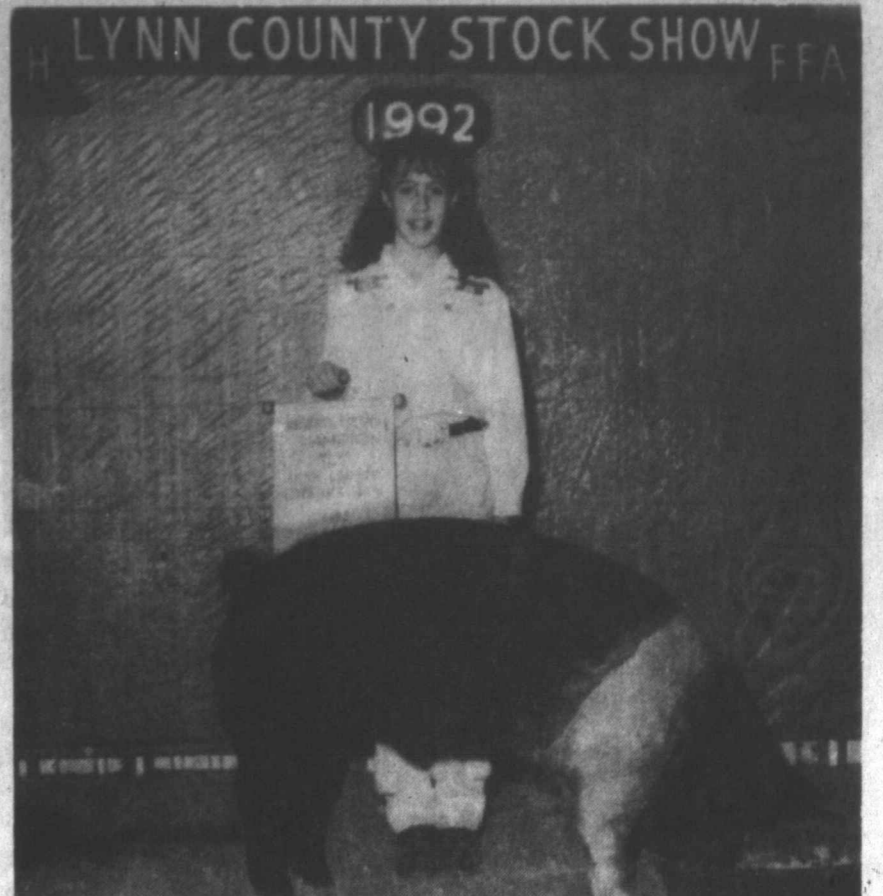

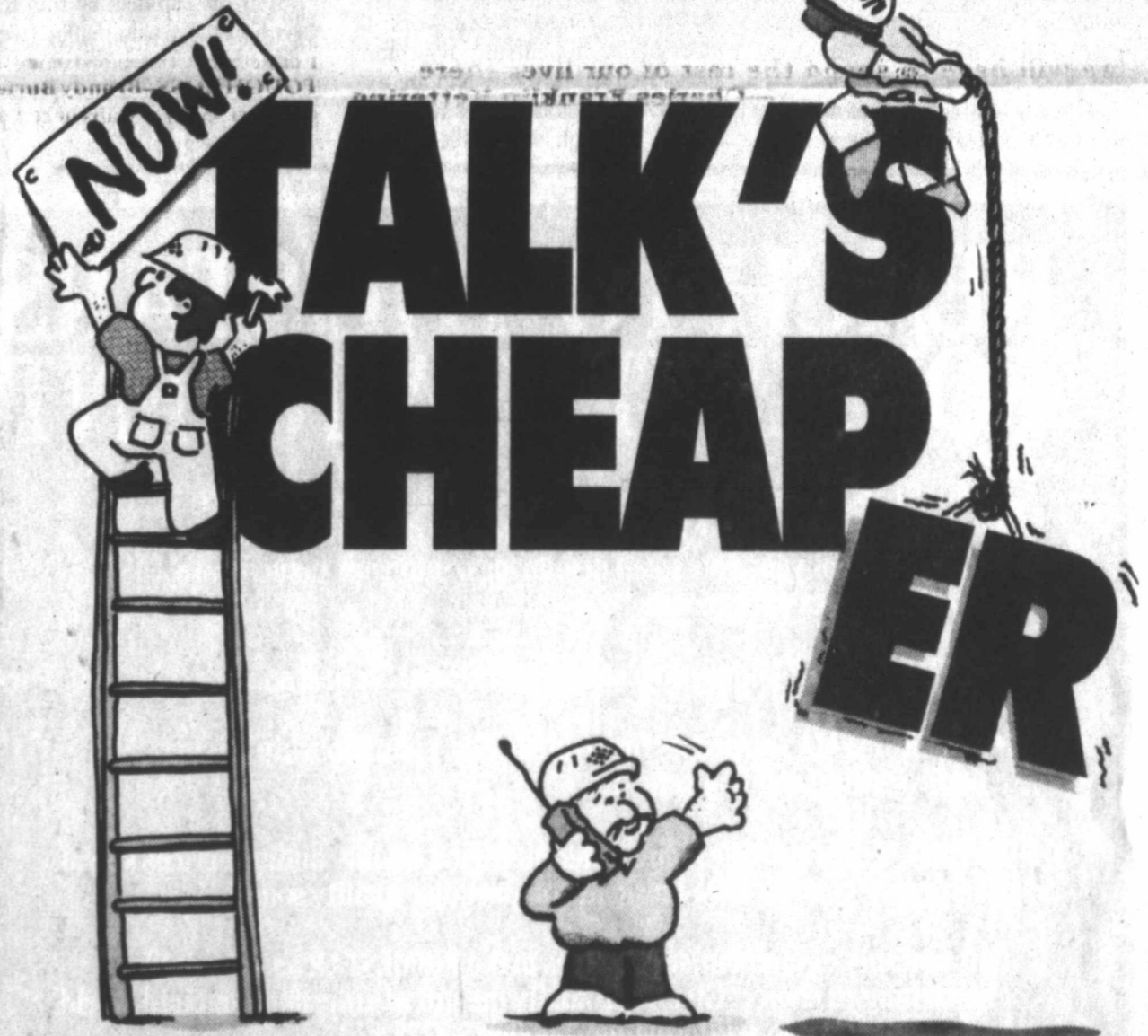

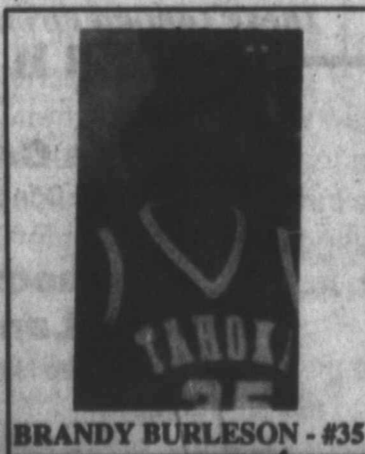

Lynn County Producers Now Eligible For Disaster Payments

The Crop Disaster Assistance Program enacted by Congress makes funds available for eligible producers having crop production losses in either 1990 or 1991 crop years. The Lynn County Agricultural Stabilization and Conservation service has eligibility information on these funds.

To be eligible, crop production losses must be greater than 35% for producers with multi-peril insurance and greater than 40% for producers without insurance. All operators should have received a packet should make a request at the local ASCS office. Eligible producers should begin to assemble their records now to be ready to apply during the short sign-up.

Signup will be from February 3 thru March 13. Appointments can be made by calling the Lynn County ASCS Office at 998-4501. Applicants should review the packet and

bring all required information with them when they come to the ASCS office for their appointment.

Operators need to report acreages that will not be harvested to the ASCS office as soon as possible. This will prevent delays when the operator signs up for the disaster program.

All interested individuals are invited to county meetings. Meetings are scheduled as follows:

Jan. 30 at the Wilson School Cafeteria at 7 p.m.

Feb. 4 at the Lyntegar Meeting Room in Tahoka at 7 p.m.

Feb. 6 at the School Cafeteria in O'Donnell at 7 p.m.

Additional meetings will be announced later. Personnel from the local ASCS and SCS offices will be presenting information about current programs. Disaster packets will be available at these meetings.

Discipline Does It

Sometimes parents say they have trouble motivating their children to take action — whether that means studying, doing their chores, participating in activities or finishing projects.

One of the life skills that we try to impart to students from elementary school through high school is self-

motivation or self-discipline. Even young children can learn the importance of time management, organization and sound study habits. In the younger grades, students are more closely supervised in their work; in older grades, students are given more and more responsibility and are expected to do some work independently. By high school, self-discipline should be in place.

Nurturing responsibility is one of the most important things we do; without it, a student will have trouble after he has graduated from school. Self-motivation is a skill that is necessary not only for success in school, but in work, relationships and life in general.

Whatever a student's level of academic achievement or skill, improving self-motivation will improve performance. With encouragement both at home and at school, a student should have many opportunities to learn self-discipline. Students need to learn how to motivate themselves in order to transform intentions and goals into action and accomplishments. There are no short-cuts for students; goals can only be achieved with some measure of hard work, persistence and enthusiasm.

Like any other skill, self-discipline is a learned behavior, which means that anyone can achieve it with the right guidance and encouragement. What does it take to foster motivation in a child or teenager? There are many factors involved, including what the student learns — and sees — at home. While self-discipline is to a certain extent a state of mind and a function of attitude, it can be helped along by following some specific steps.

Parents can help by reinforcing some concepts, many of which the child is also learning at school. Students need to focus some attention on setting priorities, construction schedules and sticking to them, and learning the difference between "I can't" and "I won't."

With so many demands and distractions around these days, it's easy for students to forget that their most important job is learning and that sometimes studying must come before other things.

If homework seems overwhelming, mapping a strategy and making a schedule will help it seem more manageable for your child. It is also important for him to understand that because he doesn't feel like completing the book report or science project, doesn't mean he can't.

Students can also be told to observe how those who manage well do it and to not put off seeking help when necessary, whether it's from a teacher, counselor, parent or friend. If a particular task seems difficult, it might help him to think back to a

problem of a similar nature that he handled in the past.

With especially large or complex projects, a great "trick" is to learn how to break it down into smaller, more manageable tasks in some order that makes sense and according to a time schedule that will allow for timely completion.

Too many students don't realize the importance of self-discipline until after they have graduated; then they are sorry they didn't take full advantage of what school has to offer. Encourage your child to become focused and disciplined now by showing him how to wisely structure his time to leave room for both recreation and schoolwork and by setting priorities. Self discipline is a skill that will carry him through life.

Stenholm Offers Advice To Disaster Stricken Farmers

Congressman Charles Stenholm (D-TX) announced that the U.S. Department of Agriculture (USDA) has released program provisions for the 1990-91 crop disaster program and that his office is available to answer questions for farmers who have experienced losses.

"A limited amount of money was recently made available for payments to farmers who can document crop losses due to natural disasters in either 1990 or 1991," Stenholm said.

Although the application period will not begin until February 3, those planning to file a loss claim are encouraged to begin assembling their records now so that the actual application process can run as smoothly as possible.

While traveling through the 17th District, Stenholm told farmers that they can receive a complete set of guidelines and a disaster program worksheet from their county Agricultural Stabilization and Conservation Service (ACSC) office. Farmers can also contact Stenholm's office with any questions regarding the program's implementation.

"Although ASCS will be administering this program in accordance with the 1990 farm bill, there is only a limited amount of money so it will have to be spread pretty thin. Consequently, we are all going to have to work together to make this thing happen," he said.

Stenholm indicated that many county ASCS offices may be extremely overburdened during the sign-up period, which runs through March 13, and producer benefits will not be paid until all the applications are processed.

According to USDA, after all applications are filed they will go to ASCS' central computer facility and producer benefits will be summarized and the "national allocation factor" for limiting total payments to the available \$995 million will be computed.

"I anticipate more loss claims than there is money to go around, so all the payments will have to be prorated to fit within the limited amount of available funds," Stenholm said. "Although I wish things could move faster, I don't expect counties to begin mailing payments to producers until mid-April."

"In the meantime, if my office can help answer questions or be of assistance, please feel free to contact my District staff at 915/773-3623 or my Washington office at 202/225-6605," Stenholm said. "It's important that the sign-up run as smoothly and efficiently as possible. Through careful preparation and cooperation we can hopefully avoid potential confusion and difficulties down the road," he added.

According to USDA, eligible producers may file claims for losses on participating and nonparticipating crops. Producers with crop insurance must have had losses greater than 35 percent and those without crop insurance must have had losses greater than 40 percent. A producer may not file on one crop on a farm for one year and different crop on the same farm for the other year. However, the producer may request benefits from 1990 on one farm and for 1991 on another farm.

Local Students Earn Executive Torch Awards

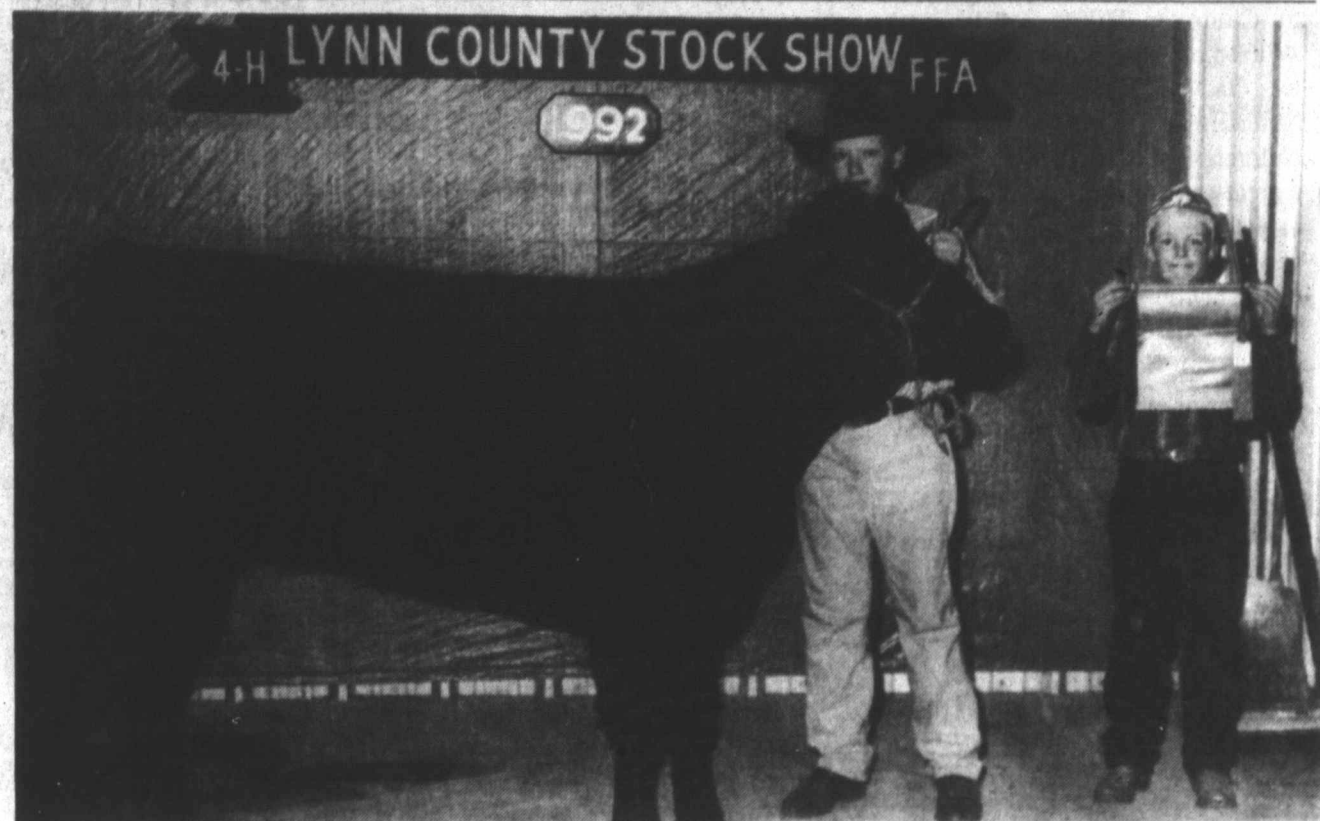

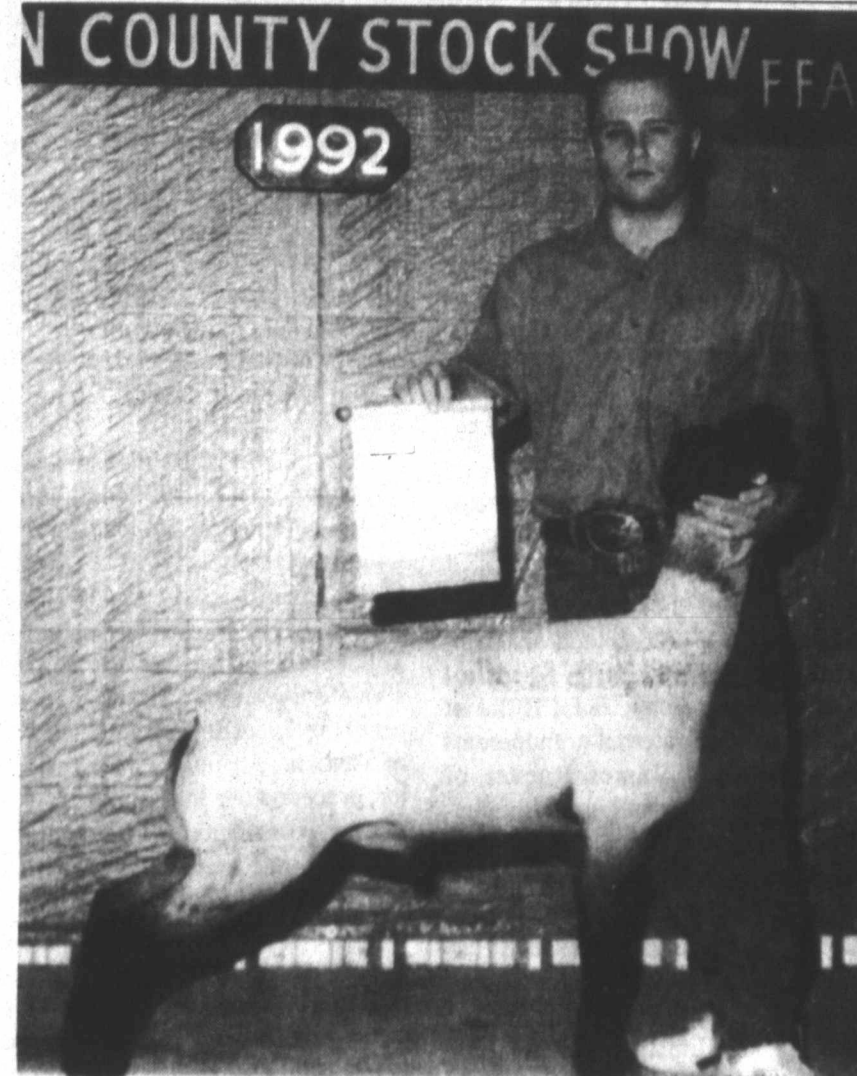

SORRY, BOB BULLOCK, but I just flat don't believe some of the statistics you claim are true regarding Texans, crime and illiteracy. Bullock, the state's lieutenant governor, last week sent out a brochure called "Issues for Texans Now" in which he cites crime as a major problem and seeks to generate support for an expensive war against crime.

All of those things I agree with. But in his brochure, he states that in 1980 one in five Texans couldn't read. And in 1990, he says, one of every three Texans can't read.

I just don't believe either figure, especially the 1990 one. Look around you, figure how many people are in the town where you live, and try to think of even a tenth of that number who can't read.

Assuming he means that a third of Texans can't read anything, I can't accept his figures. Even if he means they can only read a few things, I don't believe it.

Here's a statistic for you: Approximately 100 per cent of the current Texas lieutenant governors can't understand statistical reports.

IF YOU ARE feeling listless, irritable, nauseous, head-achy, flushed and have a runny nose, it may not be the flu, says a dietitian at Methodist Hospital, adding: "If you are a heavy coffee or cola drinker and you haven't had your usual amount, you may be suffering from caffeine withdrawal."

Cutting down on caffeine is a good idea, says the dietitian, but going cold-turkey is a poor way to do it. A headache and other symptoms related to slow withdrawal can occur up to 24 hours after your last dose of caffeine.

Chocolate, tea, cold tablets, most soft drinks and of course, coffee, contain caffeine, and it was suggested that one take about a week or longer to slowly cut down on caffeine intake.

The release suggested five points for limiting caffeine, including (1) switch to decaffeinated coffee; (2) brew your tea for one to three minutes instead of five; (3) switch from regular colas to decafs or fruit juice; (4) consider carob instead of chocolate; and (5) "always read labels carefully."

That last one is pretty weird. It reminds me of the first grader on the first day of school when the teacher told the class, "If you need to go to the bathroom, raise your hand." And a little boy asked her, "What good is that going to do?"

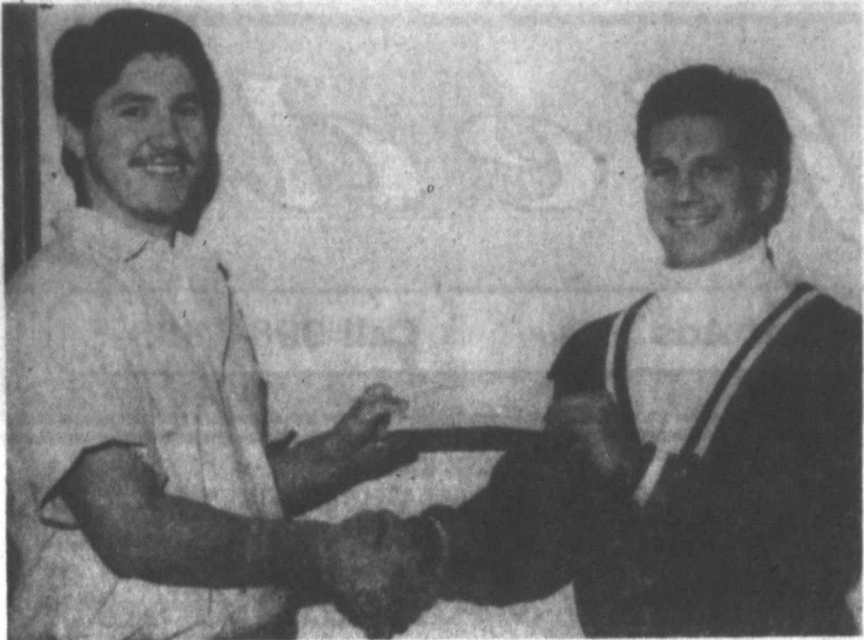

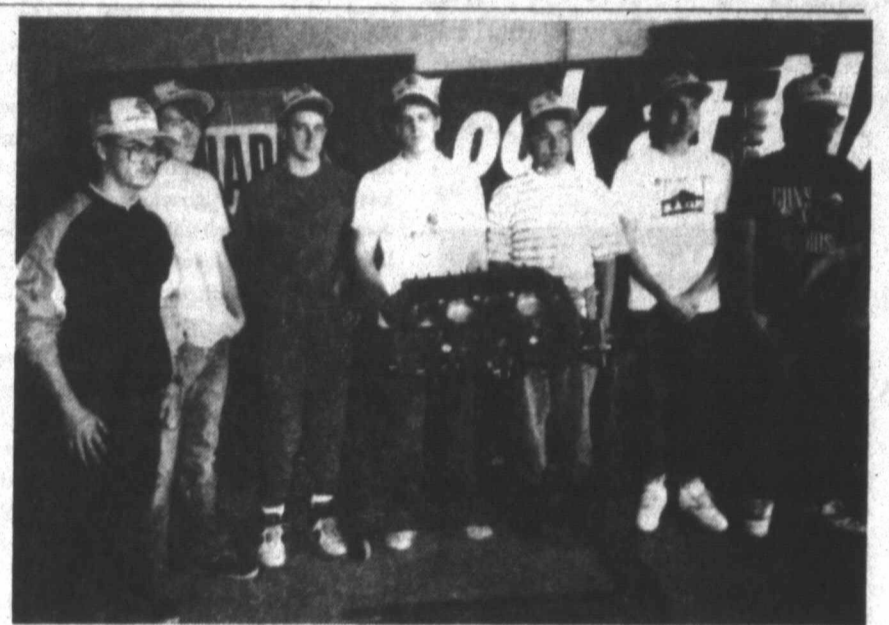
