

# **Tahoka DECA Students Win National Award In California**

Tahoka High School DECA members Albert Mendoza, Juan Hernandez, Jose Chavarria, and Jose Alvarez traveled to Anaheim, California last week with their DECA advisor, Glo Hays, to compete in DECA's National Career Development Conference.

After competing with 77 state winners from throughout the United States, they won second place with their Chapter Civic Consciousness Project. "The judges liked the school/community involvement represented when DECA students razed two dilapidated buildings in downtown Tahoka that had become unsafe and unsightly," said Mrs. Hays.

Juan Hernandez thought working on the project was fun but not near as much fun as going to California. "We got to go to Disneyland, Universal Studios, and the beach where we learned how to surf using a 'boogie board'. We were never really in danger from the rioting in Los Angeles even though we saw the smoke from the fires," he said.

Jose Alvarez and Jose Chavarria enjoyed flying in an airplane for the first time and representing Tahoka High School during competition and

as voting delegates at the convention.

Albert Mendoza said, "Everything about this trip was wonderful ... especially standing on that winner's platform holding a trophy that indicated our project was one of the best projects in the nation. A chanter project developed by a New York school beat our project ... I wonder what they did that was better than ours," he said.

Mendoza added, "One of the highlights of the trip was getting to meet the Muscular Dystrophy Association (MDA) 1992 poster family. (See DECA WINS, page 3)

#### Life Of Tahoka 9-Year-Old A tragic accident Monday Burial will be in Peaceful Gardens Memorial Cemetery in Woodrow under direction of White Funeral Home of Tahoka.

evening, May 4, claimed the life of 9year-old Jonothan Edward (J.J.) Jackson, son of Rev. and Mrs. Danny Jackson of Tahoka. J.J. was taken by EMS personnel to Lynn County Hospital about 8 p.m. after an accidental strangulation from playing with a rope in a tree, and was declared dead at 9:15 p.m. by Tahoka Justice of the Peace H.W. Edwards, who ruled the child's death accidental.

The boy reportedly was playing alone in the yard of his home and three teenage girls discovered his body.

Funeral services will be held at 3 p.m. Thursday, May 7 at Sweet Street Baptist Church of Tahoka with Rev. Ken Horn, pastor of Northern City Baptist Church of Duluth, Minnesota and Rev. Gene Hawkins, Mission Director of Lubbock Baptist Association, officiating. J.J.'s father, Rev. Danny Jackson, is the pastor of Sweet Street Baptist Church.

J.J. was born Oct. 6, 1982 in Hale Center, and moved with his family from Lubbock to Tahoka in 1990. He was a second grade student at Tahoka Elementary School, participated in Little League Baseball and Little Dribblers, and was an Honor Roll student. He was a member of Sweet Street Baptist Church.

He is survived by his parents, Rev. Danny Lee and Taryn Lynn Jackson; two brothers, Michael Lee and Robert Dale, both of Tahoka; his maternal grandparents, Mr. and Mrs. Charles A. Veal, Sr. of Lubbock and paternal grandparents, William Felton and Theda Jackson of Goree.



# **Minorities Show Voting Strength In Tahoka Elections**

The League of United Latin American Citizens (LULAC) successfully backed its Lynn County president as a candidate for the Tahoka City Council, and a Tahoka woman became the first black representative ever on the Tahoka school board after Tahoka residents and others throughout the county cast ballots Saturday in elections for the cities, school districts and county hospital

A special election ordered by a court for a two-year term on the Wilson school board wound up in a tie between Dan Cook, who had been seated on the board a year earlier, and Lowen Young, who had challenged the original election because of al-

leged discrepancies, resulting in the court order for a special election. Now that the election results came out 115 votes for each, another election will have to be held. The Wilson School Board will meet at 7 p.m. Thursday to canvass the votes, and will have five days to order a new election. Such an election must be

not less than 20 days or more than 30 days after the board meeting. A spokesman for the school said the ballots were counted several times and still came out tied.

In the regular Wilson School Board election, Roy Isham with 141 votes, Woody Follis with 130 and Tony Villarreal with 113 were elected. Others in the race and their totals were John Hernandez 84. Lester Gicklhorn 81, Tony Arellano 63 and Rickie Yowell 57.

Jackie Bishop was re-elected mayor of Wilson with 89 votes to 46 for challenger Lynda Williams. Incumbent councilmen Oscar Follis with 102 and David Cook 95 were reelected, with challenger Angela Young getting 42.

In a seven-person contest for three seats on the Tahoka City Council, incumbents Dayton Parker and Wayne Tekell led the ticket with 276 and 260 votes respectively, and Joe Calvillo, president of LULAC, won the third seat with 220 votes. Trailing these were Wayne Huffaker with 216 votes, Dustie Cook with 196, Maurio Marez with 194 and Dalton Wood with 175.


With a crowded field of 10 candidates seeking three seats on the Tahoka School Board, incumbent Juanell Jones led the field with 247 votes. Also elected were Dan Lee Stone with 233 votes and Myrtle White, with 224 votes, to become the first representative of her race ever on the Tahoka School Board.

Trailing the winners were seven other candidates, in order; Rex Rash with 191 votes, Marguerite Sawyer with 185, Gary Stennett with 168, Richard White 167, Mike Rivas 154, Reyes Morales Sr. 44 and John Flynn

#### **Research Shows School Budgets Expend More For High School Campuses**

In 1990-91 school trustees budgeted 30 percent more for operating high schools than for elementary sites. Statewide an average of \$3,280 per student was budgeted for high schools, \$2,645 for the 1,073 middle schools, and \$2,543 per child for the 3.594 elementary schools in Texas. In addition, \$1,014 per student was budgeted for the central office.

For the Tahoka ISD the figures were \$4,841.42 for the junior/senior high school and \$2,363.13 for the elementary campus while \$1,258.73 per student was budgeted for the central office.

The figures come from a new report Tidemarks 1990-91 School Campus Budget in Texas.

The report also lists the amounts for direct classroom instruction. The statewide averages were \$2,366 per student for high schools, \$1,965 for middle schools, and \$2,0340 for elementary campuses. For the Tahoka

ISD the comparable figures were \$3,784.46 for junior/senior high school and \$2,082.30 for elementary

Excluding small single-campus schools, there are 1,059 high schools in Texas ranging in size from 83 schools with less than 100 students to seven campuses with more than 3,000 students. For these high schools, \$2,328 was budgeted per student for classroom instruction, or 72.3 percent of the \$3,221 per student for total operating expenses. Locally, Tahoka High School had \$3,784 for classroom instruction and \$4,841 for total current operating

Tahoka High School had \$407.88 per student for school administration, \$414.66 for cocurricular activities including extra curricular, \$19.14 for guidance and counseling, and \$29.74 per pupil for plant main-



Sheffield was serving a 10-year sentence for unauthorized use of a motor vehicle. Miller was serving time for a burglary conviction. McGowen was serving five years for unauthorized use of a motor vehicle,



I wonder if H. Ross Perot's spending plans affected the prediction for Texas.

RECENTLY I went on a 5-day trip to places like Bracketville, Langtry, Castellon, Lajitas, Marfa, Pecos and Lamesa, and all the Dairy Queens between here and those places. I was part of a tribe with names like Leland Skyblazer, Sam Redtail, Stone Ear, Joe Smokesignal, Dummy-Who-Leads-Way, Chewbaccy and Lost Roadhunter.

A couple of impressions from the trip: the road from Big Bend National Park to Presidio is one of the worst I have ever seen. And I saw a sign at a place called Camp Wood which from a block away appeared to read "Used Barbecue." I didn't go any closer.



## SCS Says Plan On Using CRP On Highly Erodible Land

The USDA Soil Conservation Service (SCS) reminds farmers facing conservation compliance deadlines that the Conservation Reserve Program (CRP) could be their ticket to staying in compliance, saving soil, and making a profit.

The twelfth CRP sign up will be June 15-26 at local Agricultural Stabilization and Conservation Service (ASCS) offices.

The first eleven sign ups resulted in the acceptance of approximately 4.1 million Texas acres into the program. Under the CRP, farmers receive annual rental payments in exchange for agreeing to put highly erodible land into permanent vegetative cover for 10 to 15 years.

### **High-Potential Tomatoes Available To Area Growers**

Wind-tolerant, "fireproof" tomato varieties are what West Texas tomato gardeners pray for, and this year those prayers have been partially answered, says a vegetable specialist with the Texas Agricultural Extension Service. Three superior new tomato varieties - Spitfire, Surefire and Santiago - which proved their merits in Extension Service tests the last two years, are commercially available this season.

The new varieties were tested in Lubbock County Extension demonstrations in 1990 and 1991 as FMX-157, GS-12 and NVH 4465. "Now that these new introductions have names, and seed is available to plant growers at nurseries and greenhouses, gardeners can be encouraged to plant them," said Dr. Roland Roberts, Extension Service vegetable specialist.

"Concentrated fruit set, early maturity, heat-tolerant ability to set fruit, thick-walled small juicy fruit, good leaf cover to prevent fruit sunburn, and disease resistance are traits you will see in Surefire and Spitfire,"

says Roberts. Surefire fruit weight about three ounces and ripen a few days earlier than Spitfire, which weighs four to six ounces. Spitfire is a replacement for the old favorite, Spring Giant, which is hard to obtain anymore, Roberts said. Spitfire makes dark red, flat-round fruit with thick walls, ample juice and flavor judged by local tasters to be truly superior. It also has good crack resistance.

Santiago produced the largest yield and fruit size, averaging nearly half a pound, of any variety in the field tests. It is later maturing than Spitfire and has a strong plant to support the large fruit off the ground. Santiago combines large, deep-round fruit and excellent internal quality. It is resistant to Verticillium and Fusarium wilt, nematodes and tobacco mosaic virus.

"Ask your nursery, garden center or greenhouse for Surefire, Spitfire and Santiago and conduct your own trial of these high quality performers," Roberts suggested.
