Four County Schools Set Graduation Dates

The four schools in Lynn County will be graduating 92 seniors during a three-week period beginning with O'Donnell's commencement ceremony on May 21 and ending with Wilson's graduation exercises on June 5.

O'Donnell High School is graduating 33 seniors this year, which is the highest number of graduates in any school in Lynn County. Tahoka High School will graduate 29 seniors, Wilson has 17 graduates, and New Home has 13 graduates this year.

O'Donnell commencement exercises will be held Thursday, May 21, with May 22 designated the last day of school. O'Donnell I.S.D. does not

have baccalaureate services.

Baccalaureate services for Tahoka High School are scheduled Sunday, May 24, with commencement exercises set Friday, May 29. The last day of school for Tahoka students is May 28, with May 29 slated as a teacher workday.

New Home baccalaureate services will be held Sunday, May 31, with graduation exercises on Tuesday, June 2, which is also the last day of school for NHISD.

Wilson baccalaureate services are also slated Sunday, May 31, with the last day of school on June 3. Commencement exercises for their 17 graduating seniors, however, will not be held until Friday, June 5.

Burglars Target Barn, Gin Office, Golf Cart House

Lynn County Sheriff's Dept. officers this week are investigating several reports of burglaries, including stolen golf equipment, fax and copier equipment from a gin, and an air compressor and other equipment from a barn belonging to an O'Donnell man.

Don Tyler of O'Donnell reported to officers that persons unknown entered an unlocked box car barn located 7 miles south of West Point, one mile west, and a half mile south, during the early morning hours of May 7. Listed missing was a 5hp Sanborn Air Compressor, a 60 gallon vertical tank, a Sony portable radio, a case of all-weather antifreeze, an Audovok stereo cassette radio and speakers from a 1570 Case tractor, an Audovok stereo cassette radio from a 2240 John Deere tractor, and wrenches, for a total value of approximately \$800.

At West Point Gin, 16 miles west of Tahoka, persons unknown gained entry to the gin office Wednesday night, May 6 or during the early morning hours of May 7. A window on the south side of the building was broken, and there was no sign of forced entry to the doors, according to investigating officers. The perpetrator allegedly ransacked the drawers of the file cabinet and desk, taking \$23 cash from a desk drawer and the coke machine keys. The keys were found in the coke machine, and \$40 cash was reported missing from the coke box. Also listed missing was a fax phone and copier machine, valued at approximately \$700.

Joe Brooks of Tahoka reported a burglary of his golf cart house at T-Bar Country Club, but no investigation was made due to the period of time elapsing in the case. Brooks reported items valued at a total of \$1600 missing from his cart house, sometime between March 1 and April 18. Missing items included a brown golf bag valued at \$200, Wilson club set valued at \$700, Wilson club driver set valued at \$600, and golf shoes valued at \$100.

A report of illegal cable television hookup at a residence was investigated in O'Donnell by deputies, with one person filing a voluntary statement stating that another person at that residence had hooked up the cable.

In jail during the week were nine persons on the following counts: one for disorderly conduct; one for driving while license suspended; three for DWI first offense; one for application to revoke probation/robbery; one for DWI first offense and driving while license suspended; one for public intoxication; and one for unlawfully carrying a weapon, possession of narcotic paraphernalia and possession of marijuana under two ounces.

EMS Volunteers Recognized During Texas EMS Week

To help Texas citizens to know what to do in a medical emergency and to recognize the lifesaving efforts of emergency medical services personnel, Governor Ann Richards has proclaimed May 10-16 as Texas Emergency Medical Services Week.

City of Tahoka Mayor Jim Solomon issued a proclamation this week also, designating this week as EMS Week. It said, in essence, that the members of emergency medical services teams devote their lives to saving the lives of others and that the people of Tahoka benefit daily from the knowledge and skill of these trained individuals. "It is appropriate to recognize the value and the accomplishments of emergency medical services teams by designating EMS Week," concluded the proclamation.

"Almost everyone has witnessed an emergency at some time," says Lynn County EMS Coordinator Billy Tomlinson, "but not everyone knows what to do." Everyone needs to know that if they witness an automobile crash, the injured victims should be left in the vehicle until EMS arrives unless the danger of fire or an explosion exists.

"We are trained to remove victims from car crashes without further injury to an injured neck or spine," said Tomlinson. "Also, if you stop at a motor vehicle crash, do not park your vehicle directly behind the wrecked vehicles, but pull in front of the crash site and park approximately 50 yards ahead," he added.

Besides responding to calls for prehospital emergency medical care, the EMTs and ECAs of Lynn County EMS and O'Donnell EMS play an important role in educating the community about preventing injuries.

"National Safety Council statistics show that nearly 50,000 people die in motor vehicle crashes every year," said Gene Weatherall, chief of Texas Department of Health Bureau of Emergency Management, "and at the health department we know that more than 3,000 of those traffic deaths happen in Texas."

Some 11,000 die nationwide of falls and another 5,600 drown. Fires and burns account for 4,800 deaths annually in the U.S., and poisoning accounts for 4,000 deaths.

During EMS Week, Lynn County EMS and O'Donnell EMS is joining with Texas Department of Health to urge people to prevent accidents on roads, in homes, at play, and at work. "If one family learns to take precautions to prevent, for instance, accidental poisoning, because of what we say during EMS Week, then we will have done our job," said Tomlinson.

Lynn County EMS responds to a

number of calls monthly in various towns in the county, as well as out in the county, and various types of transfers. The following is a breakdown of ambulance runs in 1992, January through April.

January: In Tahoka, there were 11 runs inside the city, 3 runs to Tahoka Care Center, 3 runs to New Home, 6 to Wilson, 0 to O'Donnell, 5 in the county, and 10 transfer runs, for a total of 38 runs.

February: 13 in Tahoka, 1 to Tahoka Care Center, 0 to New Home, 4 to Wilson, 0 to O'Donnell, 3 in the county and 10 transfers for a total of 31 runs.

March: 16 in Tahoka, 3 to Tahoka Care Center, 0 to New Home, 4 to Wilson, 1 to O'Donnell, 2 in the county, 7 transfers, for a total of 33 runs.

April: 12 in Tahoka, 3 to Tahoka Care Center, 1 to New Home, 2 to Wilson, 0 to O'Donnell, 1 in the county, and 7 transfers, for a total of 26 runs.

"Lynn County EMS also appreciates the O'Donnell EMS who covers the city of O'Donnell along with part of the southern portion of Lynn County," said Shannon Percell of the Lynn County EMS. "Both services can also act as a backup for one another when necessary," he added.

Currently, Lynn County EMS is staffed by 17 volunteers, 24 hours a day, seven days a week. O'Donnell EMS is staffed by nine volunteers on a 24-hour basis as well.

Landfill Closes Monday; Collection Station To Open

Lynn County will be opening the Lynn County Sanitation Collection Station Monday, May 18 for the purpose of receiving solid waste of Lynn County residents. The collection station will be opened on Monday, Wednesday, and Saturday of each week, between the hours of 8 a.m. and 5 p.m. The collection station is located at the present landfill site.

There are no restrictions on household type garbage that is brought to the station. Tree trimmings and brush will not be accepted at this time. Herbicide and pesticide cans must be triple rinsed and crushed before brought to the station.

Batteries and oil filters are not accepted in landfills, so they cannot be accepted at the station. Contact the dealer you purchased them from about disposing of them. Tires will not be accepted from generating sources such as dealers. There will be a charge for disposing of tires for residents.

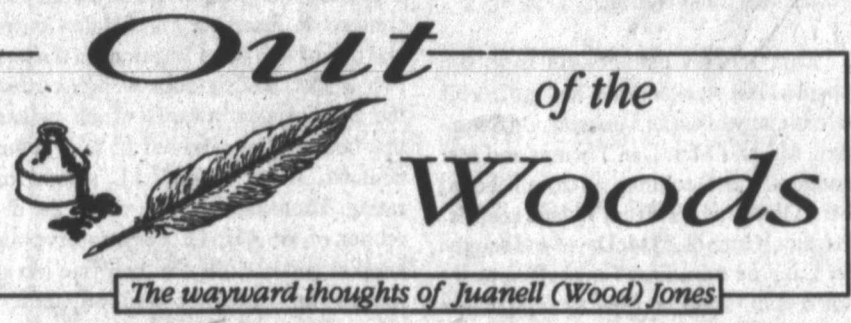
tions concerning the citizen Sanitation Collection Station contact Judge J.F. Brandon.

The Texas Water Commission prohibits any organized collection system to use a citizen collection station such as the Lynn County Sanitation Collection Station. Therefore, the City of Tahoka will no longer be able to pick-up brush or other junk in the alleys as once done from time to time.

The condition of your alley is your responsibility as ordained in the code of ordinance, Article II; cleanliness and sanitation of property; littering. For answers to any question concerning garbage collection in Tahoka call city administrator Barry Pittman.

The landfill will be closed to the public at the time the Lynn County Sanitation Collection Station is opened. Any dumping on the site of the landfill will be considered unauthorized and charges will be filed.

The wayward thoughts of Juanell (Wood) Jones

I am so very proud of this community, and all the towns in this county. When the term "good people" is used, I can't think of a better definition than the people of Lynn County.

Let me tell you a little bit about pride ... and trust ... and compassion ... and old-fashioned neighborliness. Let me tell you what "good people" do when faced with a challenge, or a tragedy.

"Good people" will drop whatever they are doing, be it work or play, when they hear that a young boy has died, and they rally around his family with love and support. Activities that were important suddenly pale when compared with a tragedy of this magnitude, and all across the county people stopped what they were doing, shocked and grieving for a family that, possibly, they hadn't even met.

"Good people" come in all sizes, and all ages. "Good people" are little elementary children who want to tell the mother and father of the little boy how much they will miss their friend. They, as well, will have to learn how life goes on without the friend they enjoyed at school and at play.

"Good people" are the teachers and other staff who rally to support the students in their classes who are grieving for the loss of their friend. They spend the day hugging the children, and sharing in the loss, showing the children that they understand and that it is okay to talk about the confusion of grief. Instead of being their teachers that day, they become their mothers and fathers away from home, understanding that "learning" is more than academics and that sometimes children are forced to learn the hard facts of life and death.

"Good people" are the high school students and faculty who are friends of the high-school age brothers of the little boy, who with only a look and a touch convey how they, too, are grieving for the family.

"Good people" are concerned pastors of other churches throughout the county who give their love and support to "one of their own", the pastor father of the little boy. Some of these other pastors and youth ministers came to the school to help the teachers and staff deal with the grieving students.

"Good people" are those people throughout the county who donated to a memorial fund for the family, giving what they could, to help the family with the expenses incurred by the tragedy. Many of these "good people" had never even met the family, but through compassion and neighborliness felt the need to give. In a sense, the memorial fund is an outlet for those who wanted to "do something" for the family, but as in all

deaths, are frustrated by the inability to find a worthwhile outlet for their compassion.

"Good people" show pride in their county by digging deep into their pocketbooks and giving generously to their county hospital ... a hospital filled with people who have learned to trust the good instincts of their neighbors when it comes to relying heavily upon donations for needed equipment.

"Good people" are those who are willing to donate to a fund so that a family may bring home from the hospital a terminally ill woman who told her family she wanted to die at home. Compassionate people in the area raised thousands of dollars in just a few days to help pay for an incredibly expensive medical flight from a Houston hospital to bring her home.

"Good people" are those who volunteer for emergency ambulance service, sacrificing time for training and to be "on call" for a service which, by its very nature, can only bring stress to the EMS volunteers. In the middle of their work day, or dark hours of the night, these people are called to witness pain, agony and fear and to deal professionally with intense situations. "Good people" hardly seems an adequate term for such selflessness.

"Good people" are those who, during the middle of harvesting season, pulled their equipment from their own farms and gathered at the site of a man who had eye surgery which prevented him from harvesting his cotton. Generous friends and neighbors manned 30 cotton strippers and four module builders to make short work of the harvest, without a thought for recognition for their good deeds. "Neighborliness" takes on a new meaning when hard labor is so generously given.

"Good people" are those who work diligently throughout the years in various volunteer groups, with a quiet but determined pride in their community and county, with little or no thanks for a job well done.

"Good people" are those who, out of a sense of duty and pride, volunteer to be leaders of the community through various county, city and school boards, for no pay and no other reason than that they care deeply about their community.

"Good people" are the people of Lynn County. I am honored and grateful to be accepted as a relative newcomer (in the last 10 years) in this community. You welcomed my family with an eagerness and friendliness which is hard to find these days. I have seen other newcomers welcomed in the same manner.

Good people ... decent people ... caring people - these are the people of Lynn County.

Commissioners Discuss Library Computer Printer

Lynn County Commissioners Court met in regular session Monday morning, May 11 for a routine business meeting with a short agenda. Mrs. Nell Cotter presented the City/County Library's request for increased funding for expenses on a computer printer and software, and commissioners agreed to sign a letter of intent to participate in this project.

Mrs. Cotter told the group that the West Texas Library System (WTLS) will furnish new computers to every library in their system, of which the City/County Library is a member, within the next year or two, and that local funds will be needed to pay for the accompanying printer and software. She said the new computer will allow tie-in access to Lubbock libraries (including Texas Tech) and, eventually, with every library in the WTLS.

Library Board members anticipate a cost of approximately \$1,000 for the printer and software, and other necessary expenses, and are asking the City and County to share in the expense. City Council members have not yet been approached concerning this matter, but Mrs. Cotter said she expects to meet with them in the near future.

Instead of a lump sum figure of \$1,000, the library is asking for \$50 per month increase in funding from the county, so that when the new computer is installed in about a year, the library fund will have the additional money saved and accessible. Currently, the library receives \$200 per month from the county, and is seeking \$250 per month in the county's 1993 budget.

In other business, commissioners approved the minutes from previous meetings, examined accounts and approved county officials reports. The group agreed to move the next regularly scheduled meeting (which would fall on Memorial Day) to Friday, May 22.

Bill A. Dodgin, a representative from Colonial Insurance, spoke to the group about a cafeteria plan health insurance, but commissioners took no action on the information.

Commissioners Sandy Cox, J.T. Miller and T.A. Stone were present at the meeting, as well as Judge J.F. Brandon, County Treasurer Janet Porterfield, County Clerk Ima Robinson, Commissioner-Elect Jacky Henry, and guests Mrs. Cotter, Dodgin, and Juanell Jones.

New Council Members Sworn In At City Meeting Here Monday

New Tahoka City Council members Joe Calvillo and incumbents Dayton Parker and Wayne Tekell took the oath of office at the votes were canvassed at Monday night's meeting at City Hall. Mayor Jim Solomon administered the oath before the council began its business meeting, with few items on the agenda.

City Manager Barry Pittman reported to the group that all public buildings owned by the City of Tahoka were surveyed, as federally mandated, for compliance with the American Disability Act. Survey reports on City Hall, the Museum and Community Center indicated a few changes should be made to make the buildings more accessible for handicapped persons. Most of the changes were entranceway ramps and restroom facilities, including larger doorways and stalls.

Pittman said the City had three years to comply with the mandate, and Solomon told the Council that the City would prioritize the changes, and make cost estimates, and then make a three-year schedule to that effect.

Chief of Police Jerry Webster gave a police report for the month of April, noting that the department responded to 208 calls and made 9 arrests. Police officers issued 21 tickets (including one for littering), and issued 27 warning tickets. Three accidents, a burglary and three thefts were investigated during the month.

The Council reviewed the budget, which showed a 94% collection on ad valorem taxes for the year.

All Council members were present including Calvillo, Parker, Tekell, Carl Reynolds, and Mike Mensch.

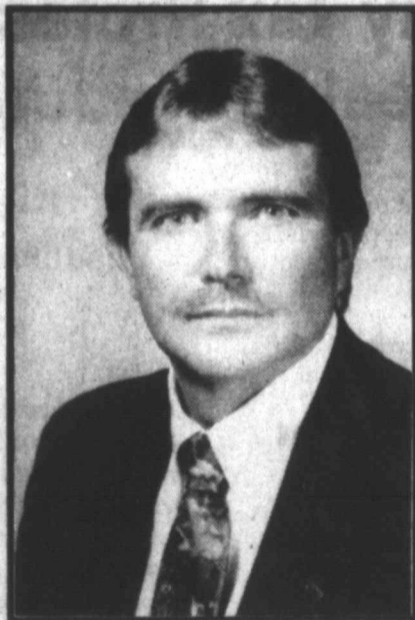

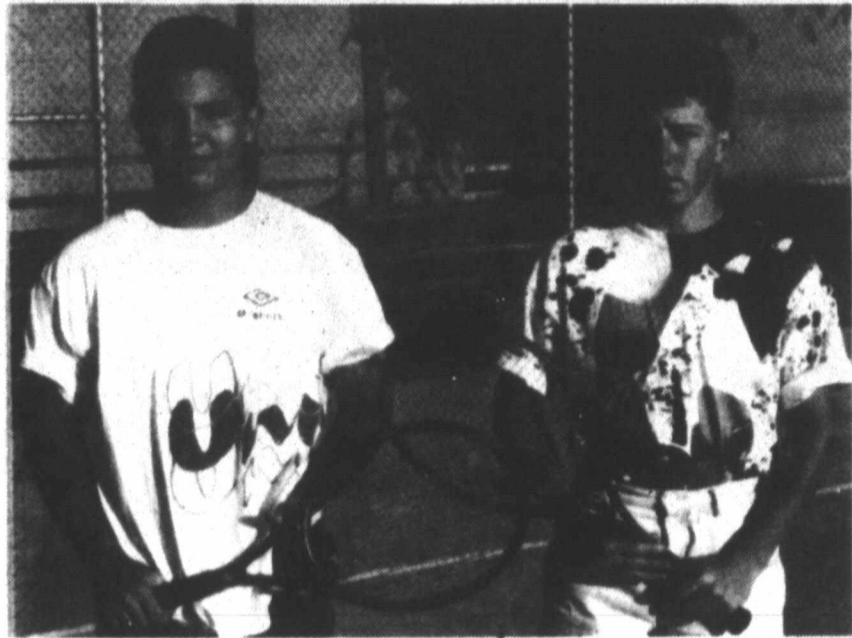

Property Tax Protest and Appeal Procedures

The law gives property owners the right to protest actions concerning their property tax appraisals. You may follow these appeal procedures if you have a concern about:

- the value placed on your property
- any exemptions that may apply to you
- the cancellation of an agricultural appraisal
- the taxable status of your property
- the local governments which should be taxing your property
- any action taken by the appraisal district that adversely affected you.

Informal Review
Contact Dovie Miller, Lynn County Appraisal District, 998-5477.

Review by the Appraisal Review Board
If you can't resolve your problem informally with the appraisal district staff, you may have your case heard by the appraisal review board (ARB).

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the appraisal district to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You'll receive written notice of the time, date and place of the hearing. The hearing will be informal. You and the appraisal district representative will be asked to present evidence about your case. The ARB will make its decision based on the evidence presented. You can get a copy of a protest form from the appraisal district office at 1636 Ave. J, Tahoka, Texas.

Note: You shouldn't try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavit saying that they haven't talked about your case before the ARB hears it.

Review by the District Court
After it decides your case, the ARB must send you a copy of its order by certified mail. If you're not satisfied with the decision, you have the right to appeal to district court. If you choose to go to court, you must start the process by filing a petition within 45 days of the date you receive the ARB's order. If the appraisal district has appraised your property at \$1,000,000 or more, you must file a notice of appeal with the chief appraiser within 15 days of the date you receive the ARB's order.

Deadline for Filing Protests with the ARB*

Usual Deadline
On or before May 31 (or 30 days after a notice of appraised value was mailed to you, whichever is later).

Late protests are allowed if you miss the usual deadline for good cause. Good cause is some reason beyond your control, like a medical emergency. The ARB decides whether you have good cause.

Late protests are due the day before the appraisal review board approves records for the year. Contact your appraisal district for more information.

Special Deadlines
For change of use (the appraisal district informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is before the 30th day after the notice of the determination was mailed to you.

For ARB changes (the ARB has informed you of a change that increases your tax liability and the change didn't result from a protest you filed), the deadline is before the 30th day after the notice of the determination was mailed to you.

The deadline for protests concerning omitted property is May 31.

If you believe the appraisal district or ARB should have sent you a notice and did not, you may file a protest until the day before taxes become delinquent (usually February 1). The ARB decides whether it will hear your case based on evidence about whether a required notice was mailed to you.

* The deadline is postponed to the next business day if it falls on a weekend or holiday.

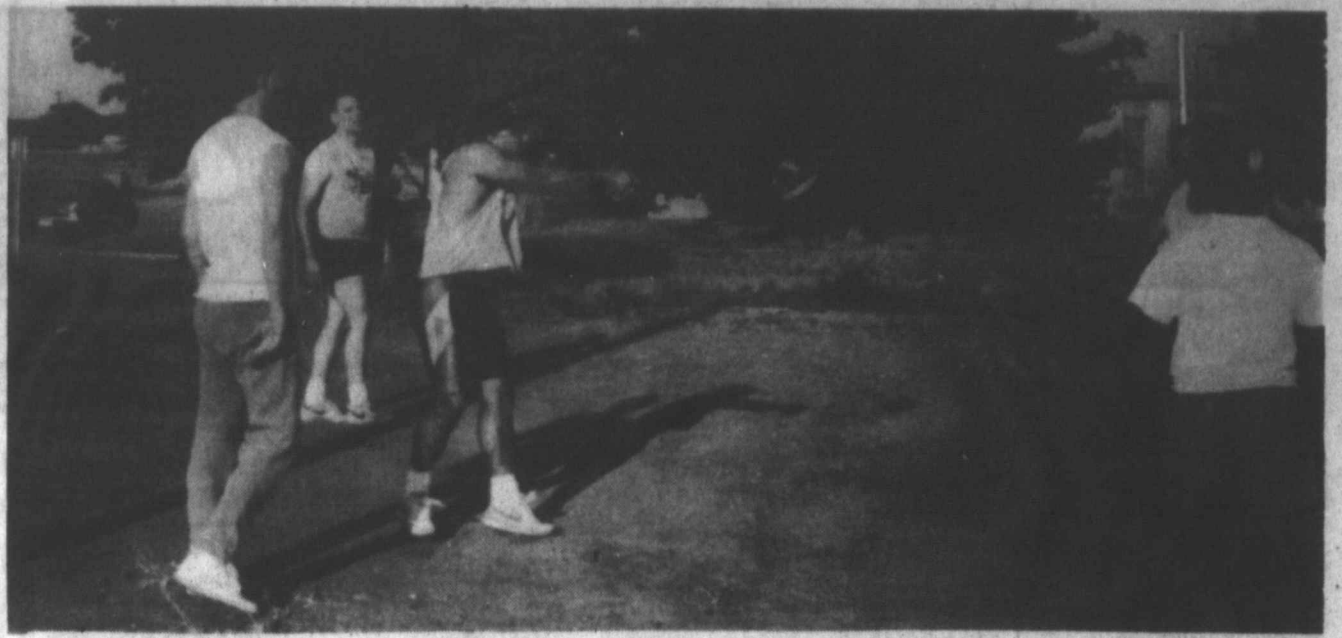
