## New Home Woman Killed In Two-Car Collision

Grace Solorzano of New Home was killed late Saturday in a two-car collision at FM 1585 and University Avenue in Lubbock. Her husband, Ernesto Solorzano, and Lubbock resident Paul J. Young were in University Medical Center Sunday with severe injuries, according to the Department of Public Safety.

Mrs. Solorzano, 24, a passenger in a 1988 Pontiac two-door driven by her husband, was pronounced dead at the scene by Justice of the peace Grady Brook after the 9:35 p.m. accident.

Ernesto Solorzano, 29, suffered head, neck and rib injuries and was listed in critical condition at UMC, a hospital spokeswoman said.

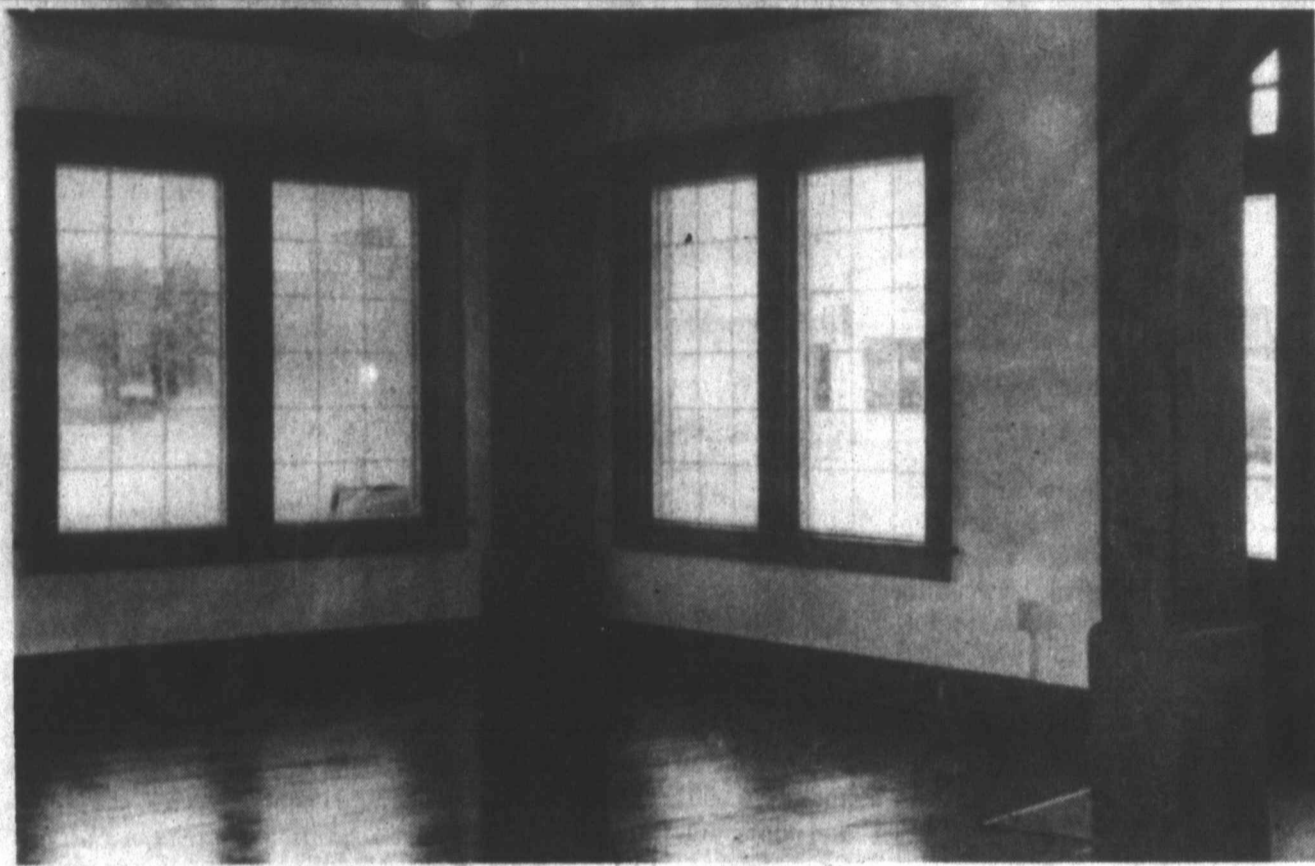
Young, 29, who was driving a

1982 Chevrolet pickup, was in critical condition with head and neck injuries at UMC, the spokeswoman said.

The pickup was northbound on University Avenue, and the Pontiac was eastbound on FM 1585, according to a report filed by Trooper Ivan Adame. The vehicles collided in the intersection, Adame said.

The intersection is controlled by stop signs facing traffic on University Avenue. Both roadways have 55 mph speed designations.

Mrs. Solorzano is survived by her husband and two children, Ernest Ray, 7, and Kimberly Ann, 4. A fund for the Solorzano children has been started at American State Bank in Lubbock.

## One Wreck Reported In Tahoka

A collision just east of the intersection of Lockwood and Main streets in Tahoka was investigated by Tahoka Police Dept. Tuesday. A 1978 Chrysler driven by Charlie Loyd Anderson, 78, and a 1987 Ford pickup driven by James Gordon Tomlinson, 31, collided. Damage to the Chrysler was heavy, but there were no injuries, according to the report. Both drivers are residents of Tahoka.

In jail during the week were four new inmates, including one for minor in possession of alcoholic beverage, one for driving while intoxicated first offense plus minor in possession of alcoholic beverage, one for DWI subsequent offense and one for public intoxication.

## Brownfield Dump Will Accept Limbs

The Brownfield dump ground will accept loads of tree limbs or shingles from Lynn County residents willing to transport them and willing to pay a fee for the service, Lynn County officials said Wednesday.

County Judge J.F. Brandon and Sheriff Jack Miller said the sheriff's office has dealt recently with several complaints that limbs and old shingles had been dumped in ditches and on private property in the county. A fine up to \$200 is specified for littering, and offenders could also be charged with trespassing, Sheriff Miller said.

Brandon said fees charged by Brownfield to individuals dumping limbs or shingles at the dump on the old Lamesa highway southeast of Brownfield are \$6.50 for a pickup load, \$11.50 for a tandem trailer load and \$21.50 for a truck load.

stored and modern heating and air have been installed.

There are 32 original rooms in the historical hotel, and the ground floor has been renovated, at a cost of approximately \$70,000, to house various offices. Renovation has not been instigated on the top floor rooms, other than the restoration of the windows and roof repair.

Future plans for the upstairs rooms are to renovate for use as classrooms in conjunction with the various programs offered. It is estimated that restoration of the upstairs rooms would cost about \$100,000.

The original woodwork in the hotel has been restored on the first floor, which has been admired by architecture students from Texas Tech University for years, according to Cubanna Daniel in an interview before her death.

The facility meets all the requirements of the Americans With Disabilities Act. Two vehicles will operate from the center, one 16-passenger van, wheelchair accessible, for long trips, and one six-passenger mini-van for in-town trips.

Bus service on SPARTAN Public Transportation is available from 8 a.m. to 5 p.m. Monday through Friday. To use this system, a resident must call at least 24 hours ahead of time to reserve a seat on the bus, by calling 998-5094.

Other officials on hand for the ribbon cutting ceremony will be Tahoka Mayor Jim Solomon, County Judge J.F. Brandon, representatives of the Commissioners Court, Tahoka Historical Society, Chamber of Commerce, and Tahoka Chamberettes.

The new SPARTAN public transportation center will serve as a bus depot and multipurpose center for programs including Head Start, Commodity Distribution, JTPA, WIC, Weatherization, Community Care for Aged and Disabled Persons, and ECP and ENTERP which are energy conservation programs.

The historical Keltner Hotel was built in 1916 by C.B. Keltner, a resident of Lubbock for 46 years until he died in 1969. His daughter, Cubanna Keltner Daniel, lived at the hotel until her death on May 26, 1992.

Owned by the Tahoka Historical Society, the building was leased several years ago to SPCAA for a 20-year period. All structural renovations to the hotel must be approved by the Tahoka Historical Society.

The hotel was restored by Donnie Webb, Gerald Fulton and Keith Atchinson of Webb Construction, officed in Levelland. The hardwood floors were re-

## Commissioners To Back RC&D County Project

In regular session Monday morning, Lynn County Commissioners told representatives of the Lynn County RC&D (Resource Conservation and Development) committee that the county would cooperate in the project involving adapting irrigation wells for use by rural fire departments to have access to water.

Jon Weddle and H.G. Franklin told the commissioners that the initial project called for adapting four irrigation wells in the county, and asked for the county to fund the initial project and then be reimbursed by the Texas Forest Service when the proposed project is granted funding through the RC&D.

Commissioners voted unanimously to fund the project at an approximate cost of \$1500, to be reimbursed to the county when the grant is approved.

Commissioners also agreed to provide road maintenance for access to the irrigation wells, which have not yet been officially designated. The RC&D county committee is working with area fire departments and land owners in designating these wells.

In other business, commissioners discussed the payroll policy, and instructed treasurer Janet Porterfield to issue payroll checks only on the designated dates. There was some discussion with problems of issuing payroll checks earlier than the checks were dated, and the court voted unanimously not to distribute any payroll checks early.

The court approved a list of election precinct judges and alternates for the November general election, and then spent some time discussing the proposed budget for next year. It was noted by the county treasurer that the tax base is lower this year than in previous years, and that if the county left the tax rate at its current .3990 per \$100 valuation then revenue would be down by \$131,345 from last year's revenue at the same rate.

Commissioners will continue to discuss the proposed budget in August.

Three commissioners were present at the meeting, as well as several county officials and guests H.G. Franklin, Jon Weddle and Juanell Jones. Commissioner T.A. Stone was absent.

### Reeves - Fillingim To Marry August 1

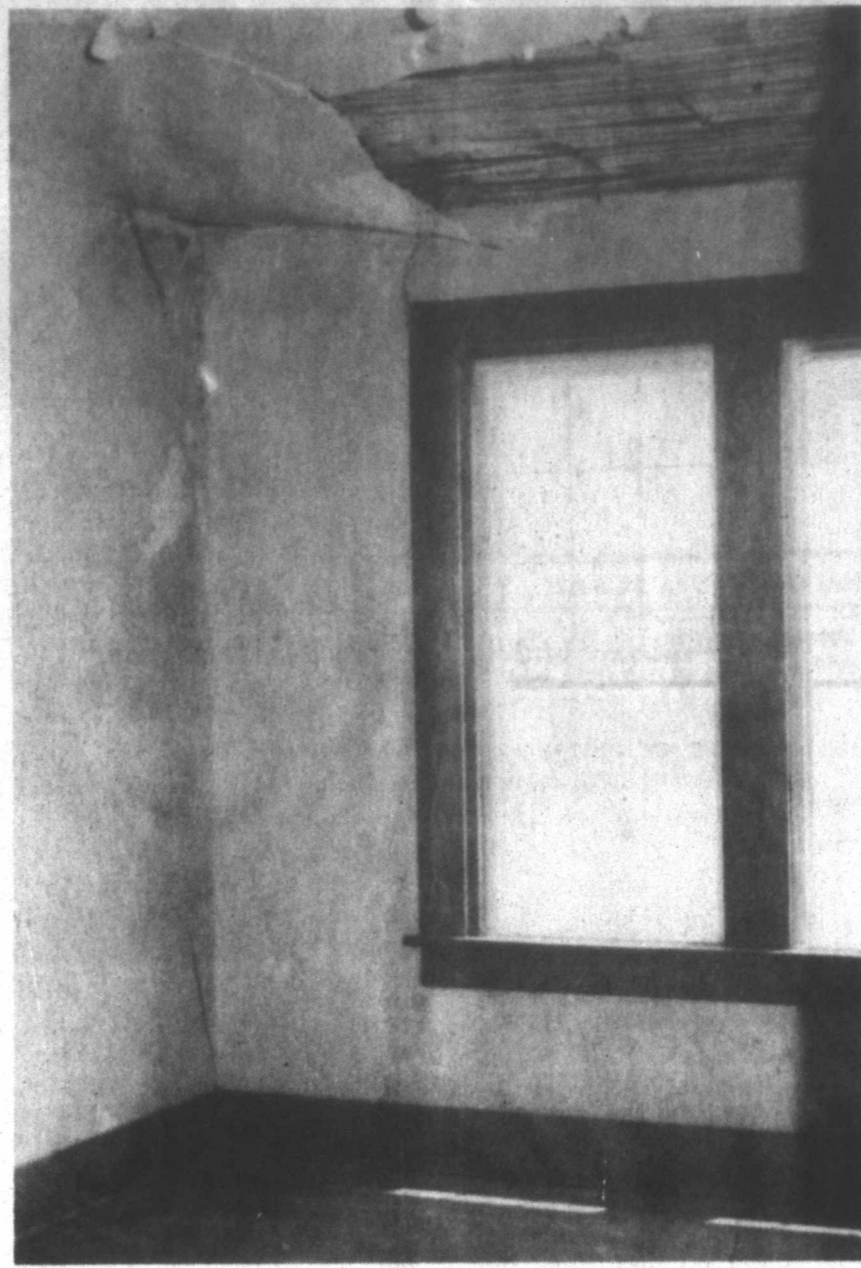

**District Water Information Helps Improve Bond Ratings**

The interest rate that cities, towns, counties and schools have to pay on bonds sold in the open market depends on the bond-rating given by firms such as Standard & Poor's of New York.

These bond-rating firms take into consideration all kinds of information on the applicants seeking a bond rating. In recent years, water availability for irrigation and municipal use has become a topic of great interest with the major bond-rating firms in considering rates for public entities in the Texas High Plains.

The High Plains Underground Water Conservation District No. 1 responds to the bond-rating companies for public entities in its service area by providing water availability data, historic changes in water availability, water quality information, and information on the conservation practices being utilized by irrigators in the service area of the entity being considered. The District also provides studies and projections on the water availability for future growth and development.

Officials of numerous public entities in the Water District service area have requested a "water pack-

age" to include with their bond-rating application. Also, many entities have followed bond council advice and requested data from the Water District for re-evaluation of a previously secured bond-rating which they considered to be too low.

### Public Notice

### Sales Tax Rebates Mailed

State Comptroller John Sharp sent a total of \$104.2 million in July sales tax payments to 960 Texas cities and 106 counties, a 5.5 percent increase over the rebates of one year ago.

Texas cities received \$93.1 million, up 5.9 percent over the \$87.8 million they received last July. Counties received a total of \$11 million in July rebates, a 5.5 percent increase over July 1991 rebates totaling \$10.5 million.

Lynn County's net payment this period was \$3,195.51, down 39.79 percent from last year's comparable payment of \$5,307.17. Payments to date are down 4.35 percent, at \$45,027.45 compared to last year's \$47,077.66 payments to date.

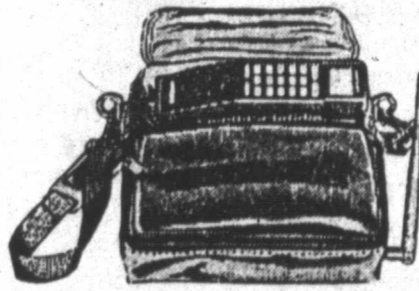

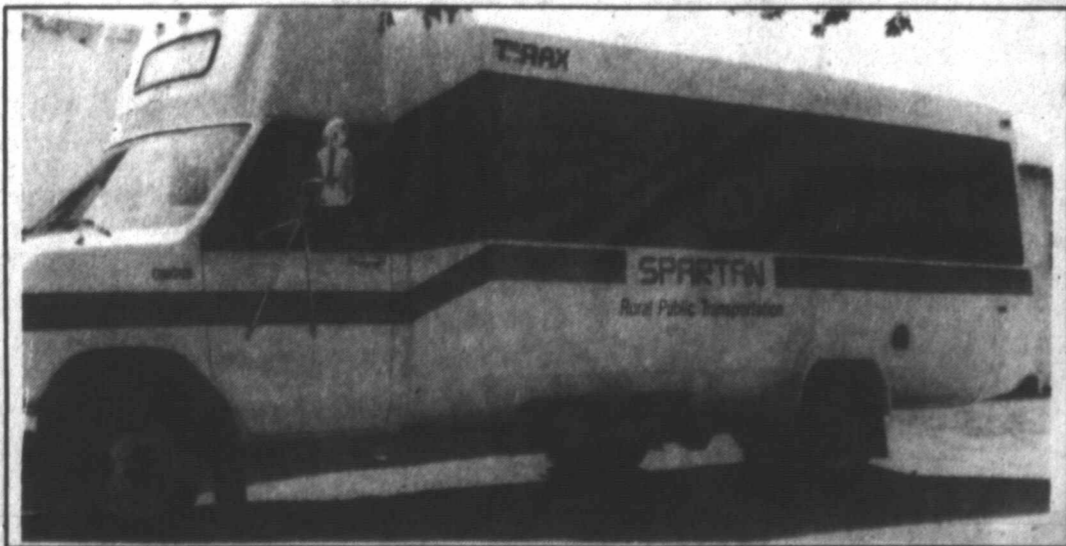

## Cows Devour Cotton Trash Like It's Candy

The cows in West Texas are devouring cotton gin trash as if it were cotton candy.

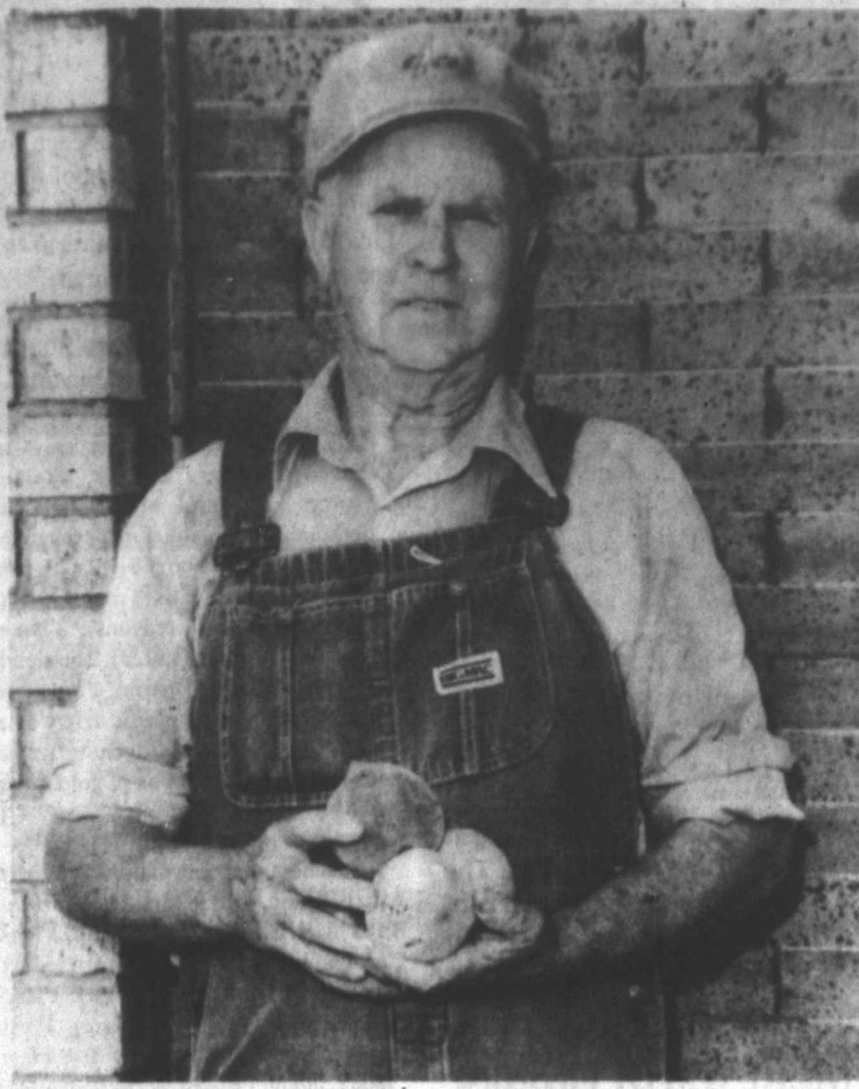
And that's made some Texas Tech University researchers happy.

"This is potentially a big step forward for the Panhandle region, for the cotton and cattle industries, as well as for helping solve the ecological problem of gin trash," said Tech researcher C. Reed Richardson, who invented a process that creates nutritious cattle feed of cotton burrs, stems and other leftovers of production.

The waste has posed an environmental problem since the federal government outlawed burning it in 1974.

Richardson's ideas are especially welcome in Lubbock and surrounding counties, which are famous for growing cotton, raising cattle and having an otherwise barren landscape.

In Richardson's process, called SP-2000, cotton gin trash is made digestible by being ground and

## Proper Management Practices Reduce Soil Erosion, Says SCS

"Erosion can carry away soil resources and produce large quantities of sediment that degrade the water," said Rodney Duus, soil conservationist for the United States Department of Agriculture's Soil Conservation Service in Tahoka. "Soil can be both a pollutant and a carrier of other pollutants."

Erosion and sediment can be reduced for much less than the cost of repairing the damage. Proper management practices hold soil and nutrients in place and keep sediment, nutrients and pesticides out of water supplies. Some of these practices are:

**Conservation tillage:** A tillage system used for managing crop residues suited to specific soils, climate and farming operations.

**Terraces:** Earthen embankments built across a slope to control runoff.

**Contour farming:** Sloping and

terraced land farmed nearly level across the slope to reduce erosion.

**Crop rotation:** Different crops planted in successive seasons in the same field.

**Grassed waterway:** Sod cover maintained in natural runoff watercourses in fields and in constructed outlets for diversions and terraces.

**Planned grazing systems:** A system in which two or more grazing units are alternately grazed and rested in a planned sequence to improve and maintain forage production, reduce erosion and protect water from animal waste.

SCS has a new publication of the subject entitled "Keeping Sediment Under Control, a water quality checklist for farmers." Single free copies are available from the SCS office.

For more information and help in planning water quality improvement measures, contact the Soil Conservation Service or the Texas Agricultural Extension Service in Tahoka. Financial assistance may be available from USDA's Soil Conservation Service and Agricultural Stabilization and Conservation Service.

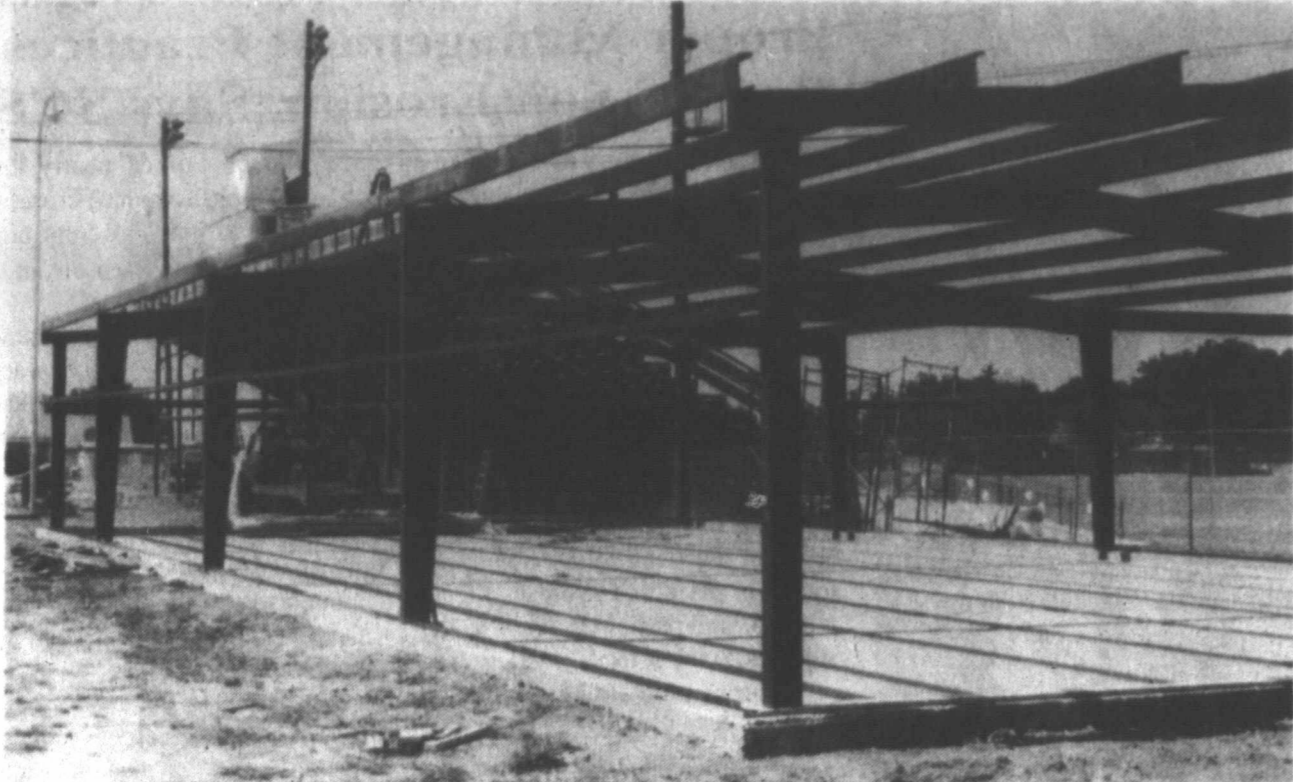

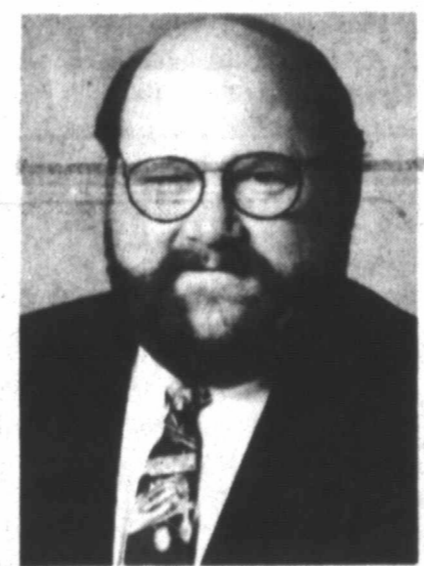

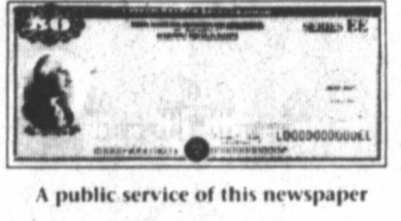

## SBA Offers Economic Injury Disaster Loans

Walter Fronstin, district director of the U.S. Small Business Administration in Lubbock has announced that SBA is accepting applications for Economic Injury Disaster Loans (EIDLs) from eligible small business concerns and small agricultural cooperatives without credit available elsewhere. Applicants must have sustained substantial economic injury because of their dependence upon farmers and ranchers who suffered the agricultural damages. "Farmers and ranchers are not eligible to apply for these SBA loans," Fronstin said. "However, nurseries that are victims of drought can apply."

Fronstin said that businesses seeking loan information and loan applications may call SBA's Area 3 Disaster Office in Fort Worth since all disaster loans are processed through that office. The toll-free number is 1-800-473-0477 or TDD 817-267-4688 for the hearing impaired.

Businesses located in Lynn, Lubbock, Garza, Dawson, Terry, and other counties serviced by the Lubbock District Office of the SBA and which were affected by drought, insects and freeze which occurred between May 1, 1991 and December 31, 1991, have until March 1, 1993 to file an EIDL application. The EIDL loan program is in-

tended to assist agriculture-dependent businesses and small agricultural cooperatives who sustained a substantial decrease in sales (or other forms of economic injury) directly due to losses incurred by the farmers and ranchers to whom the business usually sells. In some cases, this may include non-agriculture-related businesses which sustain a substantial economic loss directly due to the inability of the farmers affected by the disaster to purchase goods and services at their normal levels. Small businesses claiming to have been physically injured by the specified adverse weather are not eligible for the EIDL loans.

Fronstin said the program is available only to those businesses that are considered small by SBA's size standards and do not have credit available from other sources.

The interest rate for loans processed under this designation is 4 percent. The loans are limited to the financial needs of the applicant based on the actual economic injury and may be made for up to \$500,000. A loan may extend to 30 years, depending on repayment ability.
