Youth Get Big Wins In County Stock Show

Seven Lynn County youngsters showed grand champions and reserve grand champion animals in the annual Lynn County Stock Show last weekend, rated by officials as one of the most successful 4-H-FFA shows in years.

Total amount of the annual sale and other financial support for the show had not been determined this week, but the auction of animals brought in \$43,775 not including additions and baked goods sales, according to stock show officials.

Courtney Stidham of O'Donnell showed the grand champion lamb, and Jon Hogg, also of O'Donnell, exhibited the grand champion steer. Katy Huffaker of Tahoka had the grand champion hog, and Casey and Cody Donald of Wilson 4-H showed the grand champion heifer.

Reserve grand champion steer was shown by April Braddock of Tahoka 4-H and Anna Henry of Tahoka 4-H had the reserve grand champion hog. Jason Belew, Tahoka FFA, showed the reserve grand champion lamb. Klyssa Kelln of Tahoka 4-H had the reserve grand champion heifer.

City Officials Target 21 Dilapidated Buildings

City of Tahoka officials approved a list of 21 buildings in the city to target on the dilapidated building list, and spoke to one of the owners who attended the City Council meeting Monday night.

A tough new city ordinance on dilapidated buildings has given city officials some much-needed clout with which to enforce owners to comply with city directives, including public hearings, levying of fines and court proceedings if necessary. At last month's meeting, three build-

ings were targeted and owners notified by mail of the opportunity to speak at a public hearing during Monday night's meeting. Those three buildings are located at 1921 Ave. J, 1511 S. 2nd, and the former Lankford Variety building on Main Street.

Mrs. Elsa Day of Andrews, owner of the building on South 2nd, was present at the meeting to speak with city officials, and offered to donate the property to the city. Mayor Jim Solomon said, however, that the city

Overpass Too Low For Vehicle Transport

Three wrecks occurred in the city limits of Tahoka during the last week, but there were no injuries. The sheriff's department investigated a new report of a burglary east of Tahoka, and two Tahoka young men pleaded guilty of charges before District Judge George Hansard Tuesday and were assessed prison terms.

On Wednesday, Jan. 27, a trailer-tractor driven by Jaime Sierra, 41, of El Paso, was transporting several vehicles, including a 1984 van which failed to clear the U.S. 380 overpass across U.S. 87, smashing in the top of the van and totaling it, according to investigating Tahoka Police Dept. officers. There was no damage to the overpass, officers said.

On Tuesday in the 1600-block of Ave. J, a 1988 Ford Aerostar van driven by Danny Jackson, 42, of Tahoka and a 1991 Chevrolet pickup driven by Danny Preston, 37, also of Tahoka, collided.

Last Friday, a 1989 Toyota driven by Maria Juana Riojas, 33, and a 1974 Buick driven by Antonia Aguirre, 38, were involved in a collision at S. 2nd and Ave. K. Both drivers are residents of Tahoka.

Between Sunday afternoon and midnight that day, the home of Kent Kahl, about four miles east of Tahoka, was burglarized. Missing were a Remington .22 pump rifle, a Sony 17-inch television set and a videocassette recorder, and some men's clothing items. Investigation is continuing, according to the sheriff's department.

Judge Hansard assessed prison terms for two Tahoka men, Clifford

Sims, 29, was given eight years after pleading guilty of forgery involving an attempt to pass a check for \$201.60 at Thriftway last week. Raydell Martin, 23, was given a 12-year term after admitting a recent burglary at Bartley Grain and Fertilizer.

In jail during the week were one person each for failure to appear and driving while intoxicated, DWI second offense, DWI second plus driving while license suspended plus possession of marijuana under two ounces, public intoxication and burglary.

could not afford to set a precedent of accepting dilapidated buildings as that would place a burden on city coffers to demolish the buildings.

Mrs. Day was agreeable to compliance with the ordinance, but said she was financially unable to demolish the building at this time. After some discussion, city officials agreed to hold off on any action concerning her property to see if they could come up with a solution to the problem.

Owners of the other two buildings who were notified last month did not attend the public hearing, and city officials voted unanimously to continue with "due process" in enforcing compliance with the dilapidated building ordinance.

A new list of 18 residential dilapidated buildings was approved Monday night by council members to target, with owners to be notified by mail and given the opportunity to appear at a public hearing at the next regularly scheduled city council meeting, on March 1.

In other business, the council approved leasing the W.O.W. hall to the Pythian Sisters, and will draw up a 10-year lease with the group. Also, officials approved a motion to solicit bids for another phase of seal coating city streets, discussed costs involved in purchasing new street signs to replace those which are worn out, and options available to the city in obtaining a chipper. City Manager Barry Pittman will provide more information on the street sign project, and chipper options, at the next council meeting.

Pittman also reported that fire department donations during the month of January totaled \$3,343.40, with \$2,284.40 coming from the \$3 donation on city water bills, and \$1,059 from county residents in response to a letter asking for donations.

Lynn County Extension Agent Wade Shackelford presented a short video on a conservation program which he asked the city to endorse. The "Don't Bag It" program is a

Judge J.F. Brandon Proclaims February As Heart Month

Lynn County Judge J.F. Brandon this week, in conjunction with the Lynn County Chapter of the American Heart Association, issued a proclamation naming February as American Heart Month. The proclamation read:

"Whereas, cardiovascular diseases and stroke this year will kill more than 940,000 Americans, which nearly equals the total number of deaths from all other causes combined, and

"Whereas, the American Heart Association is funding a nationwide research program, as well as improving health care in the community through professional and public education and community service programs,

"Now, therefore, I, Judge Brandon, proclaim the month of February as American Heart Month. I urge all citizens to support the lifesaving mission carried out by Lynn County American Heart Association volunteers during February. mowing, watering, fertilizing program for lawn care which would prevent bagging grass clippings which end up in area landfills, creating space problems. Council members unanimously approved endorsing the program, and brochures explaining the program will be available at City Hall and the County Agents office.

Mayor Solomon reported to the council of a meeting with representatives of General Telephone, explaining that the city has pursued discussion with GTE for many years to upgrade the phone system in Tahoka. "At one time, we (Tahoka) were near the top of the list for renovating the phone system, but GTE did some internal reorganizing and we got shuffled to the bottom," said the mayor.

He reported that the meeting with GTE representatives did not result in any formal promises from GTE, but that he would continue to pursue this issue.

Solomon also informed the council of a letter sent from the city to Telemedia Cable Co. listing the city's preferred requirements for a cable television company, including maintaining an office in Tahoka, more new cable stations, and shorter leasing period. "That's not to say we'll get all we asked for," said Solomon. "This is just a beginning point from which they will respond," he added.

In other discussion, it was noted that the New Home Fire Department was non-functioning at this time, and that the Tahoka Volunteer Fire Dept. would respond to any calls in that area. Also, some discussion was held on initiating a recycling effort in the city, but no plans were formalized.

Chief of Police Jerry Webster reported on the department's activities for the month of January, noting that the department answered 186 calls and made 10 arrests. Officers issued 22 tickets and 20 warning citations, and investigated three accidents. Two burglaries and four thefts were investigated and cleared, and 16 junk vehicle citations were issued.

Several visitors were present at the meeting which lasted just over two hours. City officials present were Mayor Solomon, City Manager Pittman, and council members Carl Reynolds, Mike Mensch, Joe Calvillo, and Wayne Tekell. City councilman Dayton Parker was absent.

RC&D Receives Information On Grant Searches

The Lynn County Committee of the Wes-Tex Resource Conservation and Development (RC&D) council met last week to discuss grant research information received on several proposed projects in the county.

Through the RC&D, several sources for grant searches were listed for projects involving the museum expansion/renovation project in O'Donnell; a new fire truck for the Tahoka Volunteer Fire Dept.; new fire department/community center facilities for Tahoka; and communications equipment for Lynn County EMS.

Southern Arkansas University's Grant Research Information Center provided the RC&D with listings of at

least five potential grant sources for each project, from which the county committee will begin a grant search.

Five individuals in the county committee have completed a three-day Grant Writing I Seminar, and plan to do the groundwork for these grant searches before attending Grant Writing II Seminars where they are expected to complete the paperwork on the grant searches. These five individuals are Amy Preston, Theresa Robertson, Thalia Burks, Carolyn Klaus, and Frances Stephens.

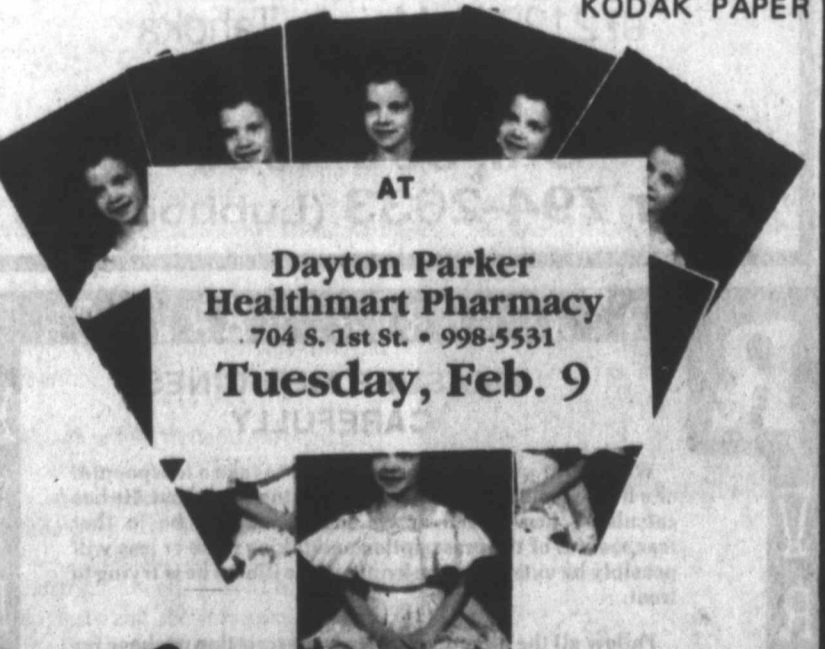

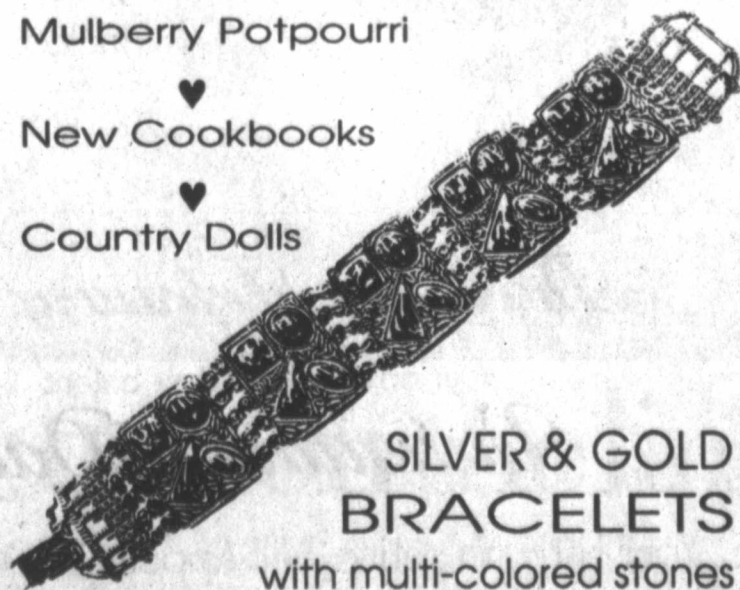

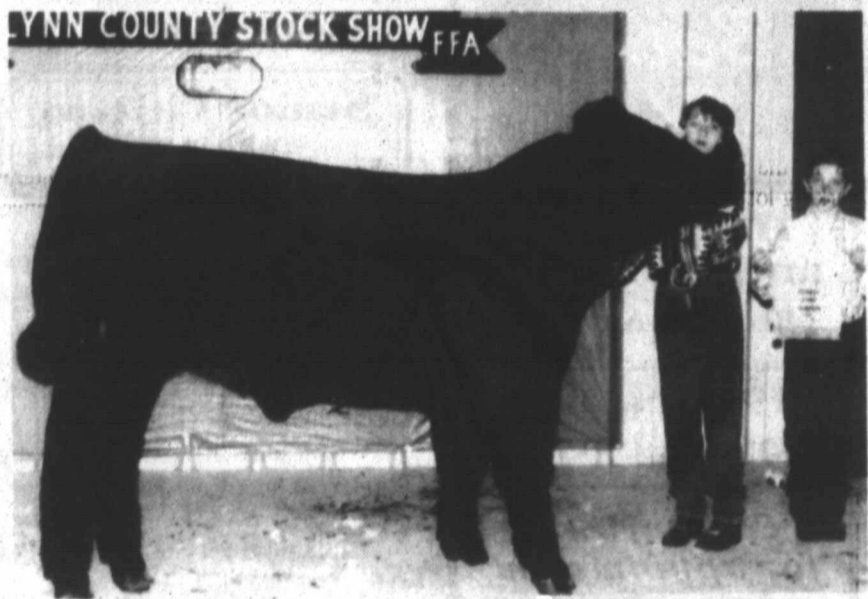

VA 1993 Insurance Dividends Announced

The Department of Veterans Affairs (VA) has announced that more than \$960 million in dividends will be paid in 1993 to veterans holding active veterans' life insurance policies.

The payout will be credited automatically to 2.5 million policyholders on the 1993 anniversary date of their policies. Policyholders may choose to receive a dividend check or select one of nine alternate payment options. VA is cautioning veterans that only those policies that have been kept in force receive annual dividend distributions.

Government life insurance policies were issued to veterans of World Wars I and II and the Korean Conflict who served between 1917 and 1956. The largest group receiving dividend payments will be the 2.1 million veterans of World War II with National Service Life Insurance ("V") policies who will receive an average payment of \$386. Total payments to these policyholders are expected to reach \$818.1 million.

Dividends totaling \$8 million will be paid to the 30,377 World War I veterans holding U.S. Government Life Insurance ("K") policies for an average payment of \$263.

Some 263,914 veterans who have maintained Veterans Special Life Insurance ("RS" and "W") can expect to receive dividends averaging \$399 for a total of \$105.2 million.

Veterans who hold Veterans Reopened Insurance policies ("J", "JR" and "JS"), currently numbering 98,960, will share a \$32.5 million dividend. Average payments to "J" policyholders are \$297; for "JR," \$534; and "JS," \$545.

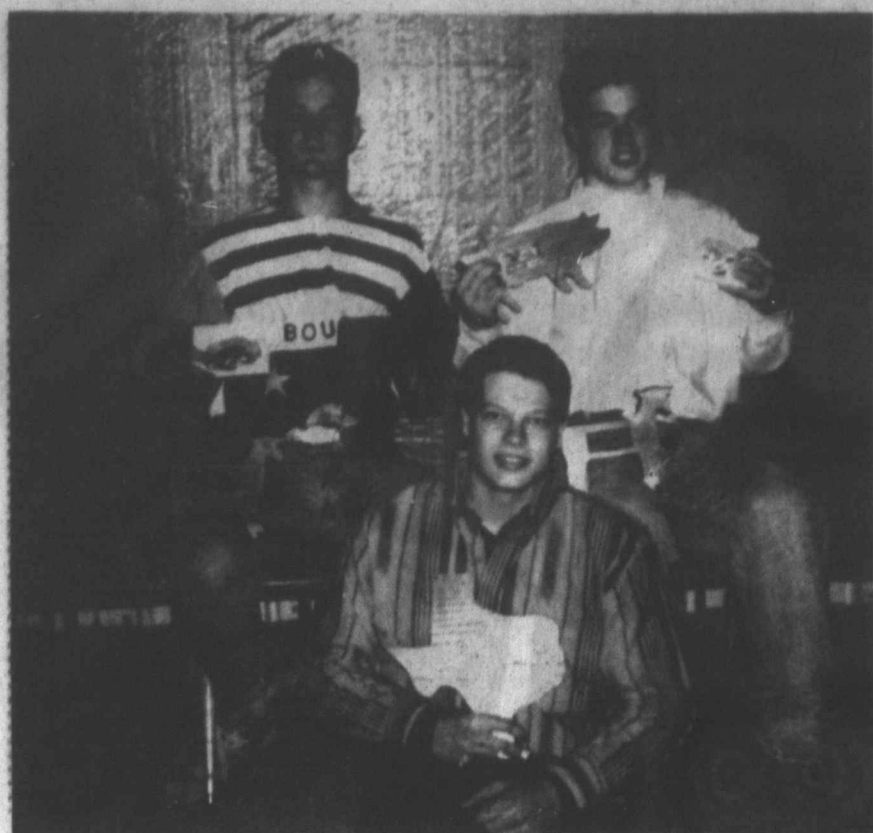

Representing 862 Texas 4-H clubs and FFA chapters, the junior show is expected to exceed 11,000 entries this year. A variety of animals are shown in the junior show division: market steers, market swine, market sheep, market poultry, beef and dairy heifers, breeding sheep, goats, commercial steers and breeding rabbits.

Lynn County Farmers Urged To Take Advantage Of Crop Residue

In 1992, Lynn County had the largest grain sorghum crop in years, due to early season cotton losses. "Lynn County farmers can take advantage of their sorghum residue to stay in compliance with their FSA conservation plans on highly erodible land," stated Soil Conservationist Jonama C. Allen of the Tahoka Field Office. "Producers can maintain crop residue on, or near, the surface to help control wind erosion," she added.

Many local farmers are scheduled to carry out crop rotations of a high residue crop alternating with cotton. High residue crops include grain sorghum and small grains crops. Producers are required to maintain their crop residue throughout the critical erosion season. Farmers must maintain these crop residues on the surface until April 1 for compliance with their conservation plans.

Producers with grain sorghum stubble can shred the stubble, then chisel or lightly disk it, leaving ample amounts of residue on the surface. Some producers are even planning to list their rows with the residue on the surface. Producers are encouraged to visit with SCS personnel about how much residue is required.

If a farmer has an entire farm in

sorghum, and properly manages the residue, he or she could be in compliance for 3 or 4 years, according to their individual plans. According to local SCS staff members, producers with highly erodible land need to come by the office each year to review their plan and to certify the conservation work that was carried out that year.

"Whether you plant windstrips or high residue crops, we need to document your files each year," said Mrs. Allen. All producers are reminded that they have until the end of 1994 to fully implement their plans. This includes any structures, such as terraces or waterways that must be constructed.

Every year approximately 5% of the compliance plans in each county must be spot-checked to confirm compliance. The plans are randomly selected by computer. This year, according to federal guidelines, farms will be spot-checked in late March, to ensure that producers are maintaining their residue until April 1.

"Our office staff will be glad to meet with anyone who has questions about their plan or the amount of residue needed," said Jon Weddle, District Conservationist in Tahoka.

USDA To Permit Planting of 1993-Crop Soybeans On Optional Flexible Acres

Secretary of Agriculture Edward Madigan this week announced that soybeans may be planted on optional flexible acreage as allowed by the 1993 price support and production adjustment programs.

Producers may plant designated crops on acreage, known as "flexible" acreage, that does not exceed 25 percent of each crop acreage base enrolled in these programs, and the crops planted can be credited as "considered planted" to the program crop. The first 15 percent is called "normal flexible acreage" and the other 10 percent is called "optional flexible acreage".

Deficiency payments will not be made to optional flexible acreage planted to a crop other than the crop

for which acreage base has been established. However, producers who plant program crops or oilseeds on optional flexible acres may receive price support.

The secretary is required to prohibit the planting of soybeans on optional flexible acres if on Jan. 1 the estimated price of 1993-crop soybeans will be below 105 percent of the 1993 loan rate.

On Nov. 16 the national average price support loan level of \$5.02 per bushel was announced for the 1993-crop of soybeans. Since the price of soybeans is projected to be greater than \$5.27 a bushel (105-percent of the price support loan rate), soybeans may be planted on optional flexible acres, Madigan said.

Farm News From Lynn County ASC Committee

Sign Up For The Disaster Program Continues: Sign up for Phase II and Phase III continues through Feb. 12, 1993. Phase III allows producers to choose between 1990, 1991, or 1992 when requesting disaster payments. Producers that are waiting for insurance information before setting an appointment should call for an appointment now. This will allow the ASCS office to begin work before the final date.

Signatures and required documentation must be in the ASCS office before the deadline or the farm will be ineligible for the disaster program. If farmers intend to participate in this program, they should make an appointment as soon as possible.

Farm Changes Needed Immediately: Now is the time to report all changes concerning farms owned or operated for 1993. Sign up of a farm involved in a reconstitution and other changes will be delayed if the work is not completed prior to your appointment for sign up. A delay in notifying the ASCS office will mean a second trip to enroll the farm that has changed.

Remember that all ownership changes will require a copy of the documentation such as warranty deed that shows the legal change. It is very important that the ASCS office records show the correct ownership of land receiving payments.

Please keep the ASCS informed of your correct address. This will prevent delays in delivering payments and other

information.
ACP Program: Applications continue to be accepted for cost shares to install conservation practices such as: terraces, irrigation pipe systems, brush control, deep breaking (20" and greater that brings the required percent of clay to the surface), livestock water pipeline and livestock water reservoirs. The second approval date will include all applications filed by Feb. 12, 1993. Applications received after this date will not be reviewed for approval until a later date.

Conservation Compliance Required For 1993: Remember to check plans for carrying out conservation compliance. Failure to follow the plan will make applicants ineligible for all benefits for ASCS, SCS, FCIC, FmHA, and Multi-Peril Insurance. If you have any questions or wish to make changes, contact the local SCS personnel as soon as possible.

Spotchecks are required and are normally made by April 1 of each year.

SCS Comments: Due to the exceptionally high acreage of grain sorghum planted in the county this year, many farmers can meet the requirements of their conservation plans for the next 3 or 4 years by simply maintaining the residue on the soil surface until April 1.

Producers are reminded that 5% of the conservation plans in every county must be spotchecked. According to new federal regulations, these farms will be checked in late March to ensure that residue is being maintained.

Oatmeal and your Heart

Researchers have been debating the value of oats in diet since a 1963 study found that oatmeal bread (vs. white) cut the cholesterol of 21 men by 11%. The U of Minnesota found that oat bran cuts cholesterol because of its water-soluble fiber. Though it took three packets of instant oatmeal per day, the study found that this could lower high cholesterol by 6% to 7%. They estimated that 1% drop could reduce heart disease mortality in the US by 2%.

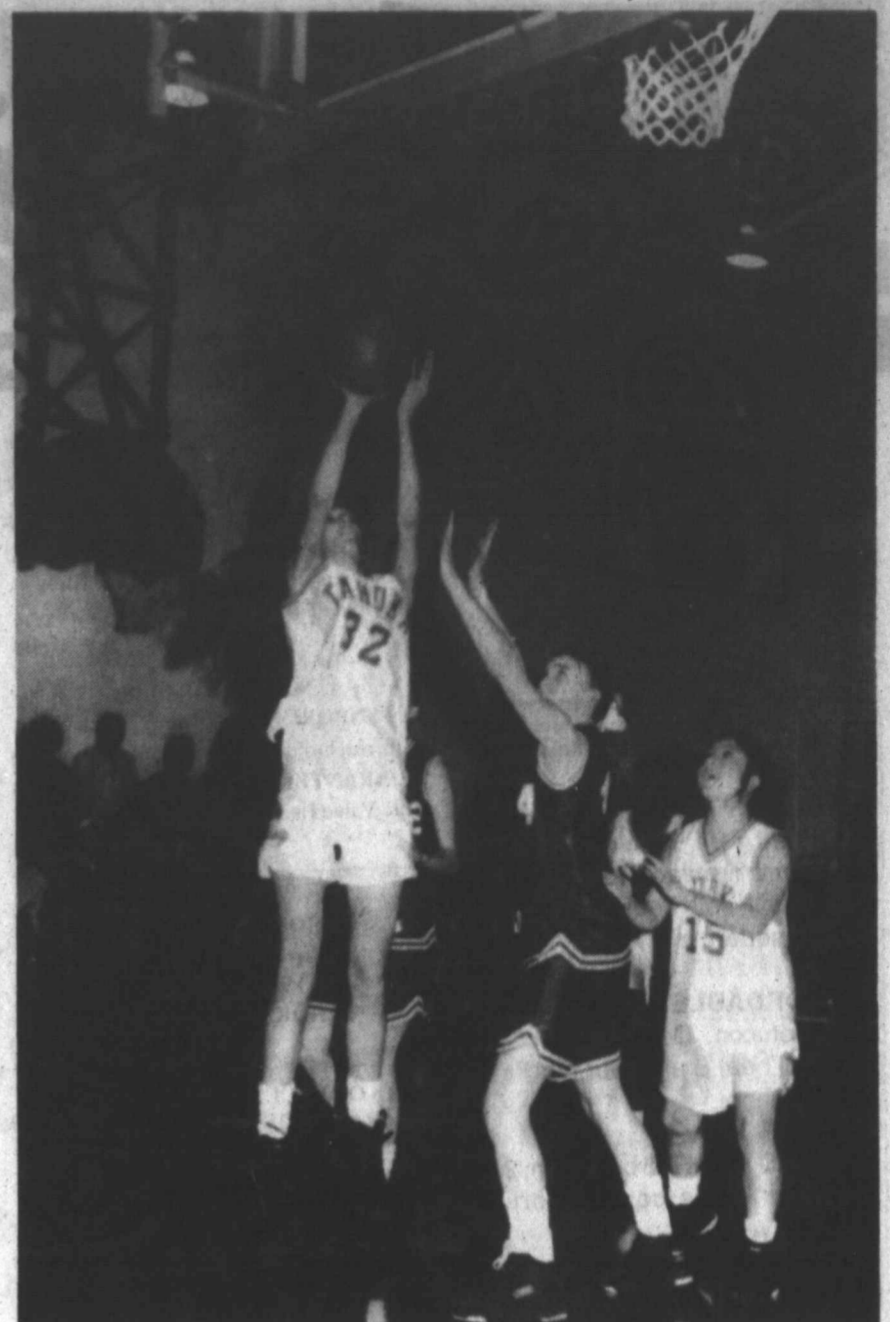
