City Sets Public **Hearing For Monday**

A public hearing will be held at Tahoka City Hall on Monday, Aug. 30 at 7 p.m., for a budget discussion. Following the hearing, city council members will approve a 1993-94 operating budget and consider Ordinance 8-93A, setting the tax rate for 1993.

Any interested persons may attend the meeting.

TISD Sets Hearing For Proposed Budget

A public hearing for the 1993-94 proposed budget for Tahoka Independent School District will be held Monday, Aug. 30 at 6 p.m. in the Tahoka Elementary Resource Cen-

The proposed Maintenance and Operating (M&O) budget for 1993-94 is \$3,689,917, which compares to \$3,590,521 for the previous year's budget. In order to fund the budget, trustees are discussing raising the tax rate from the current rate of \$1.01 to \$1.15, in order to recoup funds lost through Senate Bill 7 and reductions in state funding. A new tax rate, however, will not be set until October when so-called "property rich" school districts must make decisions on how to "share the wealth."

The victim, in her 20s, told police she had gone to sleep on a couch in her living room about 9 p.m. Sunday and was awakened around 2 a.m. by a man on top of her. She said the man placed one hand over her mouth and held a knife in the other, threatening to kill her if she screamed. She said he also said he would kill her children, who were sleeping in another

She said he then raped her, told her not to call the police, and left by the front door. She then dressed and called a neighbor, who called police. The woman, not injured physically, was treated at Lynn County Hospital, then examined at University Medical Center in Lubbock, where she was met by a counselor from the Rape Crisis Center.

Officers said the attacker apparently entered the house through an unlocked back door or open window. No vehicle used by the man was heard or seen by the victim or any neighbors questioned.






