Lynn County EMS Receives \$3,000 For New Equipment

Lynn County EMS received a \$3,000 check recently from the CH Foundation in Lubbock, to be put toward the \$8200 cost of new radio repeater communications equipment for EMS personnel. The funds were available through a grant search conducted by the Lynn County Committee of the Wes-Tex RC&D (Resource Conservation and Development). Lynn County Hospital will fund the remaining \$5200 expense, according to Hospital Administrator Louise Landers.

The equipment will be installed some time in the near future on an existing tower owned by the City of Tahoka and Lynn County, who have approved the venture. The new communications equipment will allow for better communication between EMS personnel and the hospital, and O'Donnell EMS may also have access to the hospital through the repeater station.

Currently, Lynn County EMS radio communications are through repeater tower locations in Post or Brownfield, making for "spotty" communications at best. "We're right between, but just a little too far away, from those two towers for our radio communications," said Billy

2,909 Calls **Made To Police** Dept. In 1993

Tahoka Police Dept. received 2,909 phone calls during 1993, about 150 more than in the previous year, Chief Jerry Webster said last week, after compiling figures on the last year's activities by the Police Dept.

Most categories of activities by the officers increased from the previous year. There were 99 arrests, compared to 86 in 1992; 202 tickets and 259 warning tickets were issued, compared to 164 and 248. The 12 burglaries investigated in 1993, six of which were cleared, was two less than in 1992. But the biggest increase was the number of thefts reported, 33 during the last year compared to 15 the previous year. Twenty-two of the thefts were cleared.

Tomlinson with Lynn County EMS. "This new equipment is really going to simplify our radio communications, and is something which we really needed. People need to be able to depend on emergency medical service, and we're grateful to the hospital and the RC&D, and to the CH Foundation, for bringing this about,"

he added. The need for the equipment was brought to the attention of the Lynn County RC&D group, and volunteer RC&D member Thalia Burks wrote the grant request which was then submitted through RC&D channels for a grant search. That search brought Mrs. Burks in contact with the CH Foundation in Lubbock, who approved a \$3000 grant for the commu-

nications equipment. "We're proud of Mrs. Burks for volunteering her time and efforts in writing this grant request," said H.G. Franklin, Chairman of the Lynn County Committee of the Wes-Tex RC&D. "We're all volunteers in this group, but our grant writers have taken the time to attend grant-writing seminars, and then they volunteer even more valuable time in getting the information together which is needed in writing each grant request. It's not an easy thing to do," he ex-

plained. The CH Foundation in Lubbock is a general purpose foundation, usually limiting grants to organizations whose services benefit the South Plains area of Texas. The Foundation was set up by the Mallet Ranch, located in Cochran and Bailey Counties, for the purpose of funding agricultural and ranching programs, community and neighborhood improvement and development, cultural needs, education, health and social services, research, and youth

Dan Henson of Morton, the Wes-Tex RC&D Coordinator, extended his congratulations to the Lynn County RC&D group in the venture, noting that Lynn County was one of the most active members of the 16county Wes-Tex RC&D. The group has several projects in mind for which grant searches may be conducted, and meets once a month.

Commissioners approved dues for several county associations, and selected Love Hays & Co., CPA, to serve as auditors for the 1993 county records. Some discussion was held about a copy machine for county use in the sheriff's office, but no action was taken.

A motion was passed in December by commissioners allowing Sheriff Jake Diggs to contract with the Regional Organized Crime Information Center which was supposedly to help with long-distance telephone costs and other areas, but County Judge J.F. Brandon notified commissioners that Sheriff Diggs opted not to pursue that contract.

Mike Braddock met with commissioners to discuss the Lynn County Livestock Show Barn about some livestock scales which needed to be disposed of, and the court approved a bid notice for such sale. Also, Braddock discussed guidelines for the stock barn, and after some discussion commissioners voted that the Lynn County Livestock Board of

Directors be the governing body of the showbarn.

The Lynn County Livestock Board of Directors will be responsible for care of the barn, scheduling use of the barn, setting rates for use of facilities and collection of fees, deposits and maintenance of funds. General rules include: no alcoholic beverages; no gambling; no private parties, such as weddings or family reunions; organizations and groups using facilities will be responsible for upkeep; facilities are limited to residents or organizations of Lynn County; public dances will be required to have off-duty law officers present, with fees paid by sponsoring organization; and four sponsors must be present at all times for a public dance if sponsored by high school age organizations.

Measurements To Determine Change In Water Levels

Conservation District No. 1 Technical Division staff are making annual depth-to-water measurements to determine the effect of 1993 pumpage on ground water levels of the Ogallala Aquifer within the 15-county Water District service area.

Measurements are taken in more than 1,100 privately-owned wells in the District's observation well network. These wells are spaced at a density of about one well per nine square miles throughout the District.

"We have established observation well sites for the newly-annexed portions of Cochran and Lynn Counties," says Don McReynolds, Technical Division Director. "In the portion of Hale County added to the Water District in August, we plan to measure depths-to-water in wells currently included in the State of Texas ground water monitoring pro-

After the depth-to-water level measurement is taken, the data is 1994) will also be printed.

High Plains Underground Water recorded and a vinyl sticker showing the well number, the depth-to-water measurement, and the date the well was measured is affixed to equipment at the well site.

Water District staff will begin making water level measurements in the northern portion of the District and will work their way south. Blue and white District vehicles are easily identified, and personnel will be glad to discuss the water level measurement with landowners and/or opera-

Maps showing the location and well number of observation wells in each county or portion of a county served by the District are traditionally published in the April issue of the Water District's monthly newsletter, The Cross Section. Along with the maps, tables listing the observation wells in each county and the depth-to-water measurements for one year (1993-1994), five year (1989-1994) and ten year intervals (1984-



Direct Broadcast TV Satellite Launched

The nation's first high powered direct broadcast satellite (DBS-1) was successfully rocketed into space recently from the South American nation of French Guiana.

"The successful launch of this satellite will put rural America on the cutting edge of the information age," said Ronny Puckett, Manager-Digital Satellite Television. According to Puckett, "The signal is a compressed digital format, so customers will enjoy CD quality sound and a picture that is 30% sharper than standard television signals."

The new satellite, DBS-1, will begin delivering approximately 70 channels of digital television service, called DirecTv, to viewers across the country in the spring of 1994 using an innovative 18-inch satellite dish receiving system. The Digital Satellite System (DSS) equipment is being manufactured by Thomson Consumer Electronics, makers, of RCA-brand products. The DSS includes the 18inch satellite dish, a digital receiver box and a remote control.

The service will expand to approximately 150 channels when the DBS-1 satellite is joined by a sister satellite in the summer of 1994.

DirecTv, a unit of GM Hughes Electronics, will offer the new service to viewers, throughout the United States and Canada. Distribution in many rural areas is being handled for DirecTv through an agreement with the rural electric, rural telephone and affiliate members of the National Rural Telecommunications Cooperative (NRTC).

Locally, the service will be provided by Digital Satellite Television in Lynn County and in Andrews, Bailey, Borden, Cochran, Crosby, Dawson, Dickens, Floyd, Gaines, Garza, Hale, Hall, Hockley, Howard, Kent, Lamb, Lubbock, Martin, Motley, Terry and Yoakum counties. Digital Satellite Television is being managed by Poka-Lambro Telecommunications, Inc. System owners are Poka-Lambro, South Plains Tele-

phone Cooperative, Inc., Lubbock; South Plains Electric Cooperative, Inc., Lubbock; Lyntegar Electric Cooperative, Inc., Tahoka; and Lamb County Electric Cooperative, Inc., Littlefield.

The programming signed to the system so far includes many of the most popular cable networks, including CNN, The Disney Channel, The Discovery Channel, The Sci-Fi Channel, The Learning Channel, The Discovery Channel, Country Music Television and many more. In addition, DirecTv will offer more than 50 channels of pay-per-view programming including hit movies, sporting events and specials from companies such as Sony Pictures, Paramount Pictures, Universal Pictures and the Turner/ MGM Library - all at the touch of a



be able to take advantage of two new programs in which they can possibly earn college credit. These new programs are the College Board's Advanced Placement Program and Tech-Prep Microcomputer Applications.

The Advanced Placement Program is nationally recognized by colleges and universities as one in which high school students may enroll in courses that are the equivalent in content and academic rigor to college courses. The Texas Education Agency automatically designates AP courses as having "honor" status, while all other courses must be approved individually by the Commissioner of Education.

The first AP esurse to be-effered at Wilson will be AP Macroeconomics which will be taught by Bob Williams, high school principal. Students in grades 10-12 that have completed two years of math credits may enroll. Plans for additional AP courses for next year are currently being developed.

Tech-Prep Microcomputer Applications is one set of business occupations courses where students learn business computer applications including the use of popular software programs such as WordPerfect, Lotus 1-2-3, and dBase IV. Students will utilize a laboratory with new computers equipped with the latest versions of the previously mentioned software, Microsoft Windows, CD-ROM, modems, and inkjet printers.
