

#### Wilma Hogan Is Candidate For State Rep.

Wilma Hogan, small business owner from Munday, Texas announces her candidacy for State Representative of District 70, which includes Lynn County. This seat is currently held by David Counts of Knox City. The 54 year-old Hogan has been married to Wendell "Bud" Hogan for 31 years and has two grown daughters and five grandchildren.

"I have been involved in politics since I cast my first vote for John F. Kennedy in 1960," says Mrs. Hogan. Although once a Democrat, she stated that in her opinion the Democratic party's liberal platform had deserted the mainstream conservatives in her area. "District 70 deserves a truly conservative representative and I want the opportunity to be that representative." Mrs. Hogan added that Counts was given a 34% rating last year by the Free Market PAC, a conservative group that tracks legislation. "To us that means that 66% of the time, he is voting liberal," she

Mrs. Hogan has been involved in the political realm for years and has campaigned for many candidates and causes but this is her first attempt at candidacy. She stressed that citizens should become actively involved in the political process by voting, staying informed on the issues, and communicating with those who represent them in state and national govern-

It was in her job with the Plainview school district that Mrs. Hogan said she first discovered the government waste of tax dollars. During the seven years she worked with Federal programs assisting in writing applications for Federal funds she realized how much money could be saved. Then after becoming a small business and property owner, Mrs. Hogan said she saw her taxes begin to rapidly escalate. She said she felt it was time that the average American tax payer had a say in how the government was spending their money.

Mrs. Hogan believes in less govemment, not more. "The state budget has grown from \$46 billion to \$70 billion in only three years. Texas is going to end up in the same mess as-Washington if we do not begin to control spending," said Mrs. Hogan. She said that local control of schools, cities, and counties is what Texans need.

Incumbent Greg Henley has signed for re-election to the Tahoka I.S.D. Board of Trustees, and Gary McCord has filed for a spot on the board. Two places, both three-year terms, are up for election this year.



#### **Interest Rate Falls For Rural Loans**

Federal Land Bank Associations (FLBAs) in Alabama, Louisiana, Mississippi and Texas announced their seventh interest rate reduction on variable loans in two years. Effective March 1, the new rate is 7.25 percent, down from 7.50 percent.

The FLBA variable rate has fallen nearly 1.75% since February 1992, and is the lowest rate in almost 16 years, according to Farm Credit Bank of Texas Chief Executive Officer Arnold R. Henson.

FLBAs are agricultural lending companies, owned by their memberborrowers, which provide long-term financing for rural land, homes and improvements. Of the 42,000 members who do business with the 48 FLBAs in the four states, approximately 30,000 currently have variable rate loans and will benefit from this latest rate reduction. The new rate also applies to new loans.





"Corn and sorghum producers with 1993 disaster losses are reminded they must request disaster assistance by March 4 to be eligible for possible forgiveness of advance deficiency overpayment," said Grant Buntrock.

Administrator of the U.S. Department of Agriculture's Agricultural Stabilization and Conservation Ser-

"Even if the disaster loss was not large enough to qualify for disaster payment, it may mean eligibility for some advance deficiency overpayment forgiveness." Buntrock said.

"Final deficiency payments will

not be calculated until early March. but it is almost certain, given current prices, that the final will be less than the advance. To be eligible for forgiveness of any overpayment, the producer must request disaster aid at the local ASCS office." Buntrock



#### **South Plains** Weather Is Drier, Warmer

The weather across the Texas South Plains during the month of January turned out to be drier than normal with slightly above normal temperatures, according to figures released by the National Weather Service office in Lubbock.

Temperatures averaged 0.4 degree above normal and ranged from 1.9 degrees above normal at Littlefield to 1.8 degrees below normal at Plainview.

Maximum temperatures averaged 0.9 degree above normal and ranged from 6.3 degrees above normal at Littlefield to 1.6 degrees below normal at Big Spring. The highest temperature of the month was 81 at Matador and Paducah on Jan. 6.

Minimum temperatures averaged exactly normal and ranged from 2.5 degrees above normal at Snyder to 2.6 degrees below normal at Littlefield. The lowest temperature of the month was 3 above zero at Dimmitt and Hereford on Jan. 31.

Precipitation averaged 0.20 inch below normal and ranged from 0.70 inch above normal at Big Spring to 0.60 inch below normal at Littlefield. Snow occurred at almost every station and ranged up to 16 inches at Silverton while the area averaged 2.4
