

Barbara Cook Stricken With Cancer ...

EMS Group Leads Fund-Raising Event To Aid One Of Their Own

 She's touched literally hundreds of lives, and volunteered thousands of hours, during her 10-year stint with the Lynn County EMS - and the volunteering is not over yet for Barbara Cook of Tahoka, even though life has taken a frightening, unexpected twist for her and her family. In late March, she was told by doctors following a biopsy procedure that she had ovarian cancer. She began chemotherapy treatment last Wednesday, April 13, on her 55th birthday.
 She will take the three-hour treatments every 21 days for six months, and is optimistic that the procedure will "take care of it, 100 percent."
 "Barb," as she is known by her friends, plans to resume her duties as an Emergency Medical Technician (EMT) on May 2 - she knows this, because she scheduled herself in for that day. She is the Lynn County EMS Coordinator, which means she makes out the schedule

of who is on call, fills out reams of paperwork, checks the ambulance stock, and, according to her EMS peers, "knows where everybody is and keeps us in line."
 With a husband, three children, and two grandchildren, Barb works part time at Lynn County Hospital as the EMS Coordinator, and gives countless hours as a volunteer EMT. Just in the last two and one half years, according to daughter Cathy, Barb has made 596 ambulance runs. That's a good bit of time, effort and stress for one person to give on a volunteer basis.
 "Barb has donated the last ten years of her life to this community," said Dee Dee Pridmore, one member of the EMS group. "She has given so much, and consoled so many people who were scared or needed a hand to hold on to. She has such a calming effect on patients and their families - some of them call her at home and ask her to come check their blood pressure. This is a small community, and people know Barb - she'll do what-

ever it takes. She's their friend," she said.
 Now, however, it's she who needs a friend, and her close-knit EMS group is taking the lead in speaking out for Barb. Her catastrophic illness has come with astronomical hospital bills, and Barb has no medical insurance. An account has been opened at the First National Bank of Tahoka for donations, and the EMS is sponsoring a co-ed volleyball tournament and silent auction this weekend at the high school gym, with all proceeds to benefit their friend.
 "No one has turned us down when we asked for auction items," said Rhonda McNeely, expressing gratitude to area businesses and individuals. "I've had people call me from Lubbock who said they went to school with Barb, and wondering what they could do to help. People just keep giving," she added, noting that small town communities are notable for pulling together in times of trouble.
 The tournament begins Thursday

night, and continues on Friday night and all day Saturday, with the silent auction to be conducted from 10 a.m. until 5 p.m. on Saturday. In a silent auction, all items are displayed with bid sheets next to them, and anyone wishing to bid writes down their name and bid amount. At the closing time of 5 p.m., the item goes to the highest bidder on each list.
 The EMS group invites everyone to come to the tournament to play or to watch, and to visit with Barb, who is, incidentally, an avid volleyball player. "Barb has already asked her doctor if she could play in the tournament," said Jonama Allen, another EMS member, rolling her eyes. "He said he strongly recommended her not to - we all just told her 'no way'," she added with a grin.
 Concession items will be offered at the tournament, with sandwiches, snacks and drinks on Thursday and Friday, and charbroiled "on the grill" hamburgers and homemade ice cream available on Saturday. "It's (See Barb Cook, page 3)

David Hutton Named TISD Superintendent

In a unanimous decision Thursday night, Tahoka Independent School District Board of Trustees named David Loren Hutton as new superintendent here, to begin his duties on June 1, 1994. Hutton, 49, was offered a three year contract and a base salary of \$58,000.

Hutton is currently Assistant Superintendent at Clyde Consolidated Independent School District, a 3-A school with approximately 1500 students. He was principal at Clyde High School for three years, and has been an assistant principal, teacher and coach during his career.

Hutton's wife, Glenna, is a Registered Nurse, and the couple has six children and two grandchildren. Their youngest child, Bethany, is 5 years old and will be starting kindergarten next year; Timothy, 9, is a third grader; Rebekah, 16, is a sophomore in high school; Jonathan, 20, is a sophomore at Hardin-Simmons University; Angela McCormick, 24, is an R.N., married with two children; and David Jr., 26, is a teacher.

A reception for Hutton and his family will be hosted at Tahoka I.S.D. next Monday, April 25, from 3:30 until 5 p.m. in the elementary Learning Resource Center. Area residents are invited to come meet the new superintendent and visit with his family.

Hutton graduated from Turkey High School in 1963, and received his A.A. in 1965 from Lubbock Christian University, B.A. in 1969 from West Texas State University, M.A. in 1974 from Southern Oregon College, and M.Ed. in 1988 from Abilene Christian University.

He was honored as Citizen of the Year for 1991-92 by the Clyde City Council and the Clyde Police Department, and was honored as Educator of the Year 1989-90 by the Texas 81st Air Force Junior ROTC program.

"We're very excited about David Hutton coming to Tahoka," said trustee Juanell Jones. "He seems to be exactly what the people in our community requested in our superintendent profile sessions - he's a family man with high morals and Christian values, an understanding of small town life, friendly with good lines of communication, and a dynamic leader with high expectations," she added.

The decision followed months of discussion with E.C. Leslie, of Texas Association of School Boards Superintendent Search Services, Inc., whom the board contracted with to

assist in their search for a new superintendent. Dr. Leslie conducted profile sessions with school staff and students, community and business people, and assisted the board prior to the interviewing process, as well as serving as liaison between the board and the candidates.

"We want to thank Dr. Leslie for bringing us some outstanding candidates for the superintendent position," said Board President Greg Henley. "We had a hard decision to make, and we appreciate all that he did. Every candidate we interviewed had a lot of very positive things to say about Tahoka, and that was very encouraging to us. We had a good array of candidates, and learned some interesting things in the process," he added.

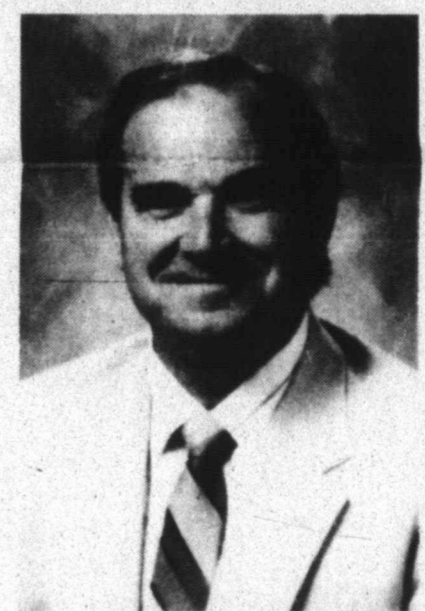
Dr. Leslie, who was present at Thursday night's meeting, said, "I want to say how much I appreciate this board, and Dr. [Duane] Carter, and his secretary, Freda [Jeffcoat]. They all took a very serious approach to the search process, and I want to commend them for that - I enjoyed working with them," he said. He also reminded the board that he and his firm were available for one full year following the placement process if the board should have any questions.

Dr. Leslie indicated that he felt the board's choice of Hutton as superintendent represents the type of individual needed to direct the district, based on the input of the profile sessions with various community and school personnel. "Hutton is excited about coming to Tahoka and really sees some exciting opportunities and possibilities for Tahoka ISD," he added.

Superintendent Dr. Duane Carter is resigning on July 1, 1994, following seven years as superintendent here.

In other business Thursday night, trustees offered contracts for four teaching positions for next year. One-year probationary contracts were offered to Alta Harvick, for a high school English teaching position; and teacher/coach contracts to Troy Hinds, a third-year coach currently at LaJoya ISD; Jimmy Burleson, a seventh year coach currently at Floydada; and to Cory Scott Barnes of Lubbock, a recent Texas Tech graduate.

Trustees accepted a low bid of \$95,565 from Webb Construction of Levelland for building two additional classrooms on the elementary campus, due for completion in mid-August. Eight bids were submitted

for the construction project, ranging from \$95,565 to \$138,000.

A tentative school calendar for 1994-95 school year was approved, with students beginning on August 15 and graduation on May 26. Book-keeper Loretta Tekell gave a financial report, noting that the district had an account balance in all funds of \$1,470,670.11 at the end of March.

Trustees approved monthly bills, with the exception of one for coaching clinic fees for Hulon Kirkland, which trustees refused to pay, citing the fact that Kirkland had resigned from his coaching duties.

The board amended the budget to accept additional federal vocational funds in the amount of \$4,594, and designated \$102,733 from general funds for the new classroom construction project, which includes architects' fees and construction costs.

Supt. Carter discussed possible improvement projects concerning the typing and journalism classrooms, but trustees took no action.

Several people were present for the meeting, including school staff and administration, and several FHA students who reported during open forum on their recent regional competition. All trustees were present for the meeting, which adjourned at 1:10 a.m.

Eagle Gets Permanent Perch At O'Donnell

 A Lubbock artist has completed a bigger-than-life eagle made of plate steel and with more than 6,000 individually welded pieces which now is perched on a pedestal outside O'Donnell High School.
 High school students and guests assembled outside the school Tuesday afternoon for ceremonies honoring the sculptor-welder, Rick Cunningham, and his employer, Jerry Stanford, a 1976 OHS graduate who helped influence the artist to do the work. Cunningham is plant manager for Consolidated Gin Co. of Lubbock, and he and his employer virtually donated the remarkable sculpture, with the school paying only for the materials.

High School Principal Glenn Hopkins said he noticed a smaller eagle atop a flagpole by the gin company as he was driving to Lubbock last fall and had, through another O'Donnell man who works at the company, asked Cunningham if he would consider doing one for the school, since the sports teams are the O'Donnell Eagles.
 Cunningham first said he would not undertake the project, but later changed his mind and started working on the eagle, which is larger than the one on the flagpole.
 Cunningham said he spent about 200 hours working on the eagle, cutting out about 6,000 individual feathers and welding them in place. He reportedly did not work from a draw-

ing or photograph; in fact, he said he glanced at a picture of an eagle in an encyclopedia, and then worked from memory.
 He did much of the work on company time with the blessing of Stanford. Both men were presented plaques of appreciation from the school Tuesday by Gabriel Rodriguez, president of the student council. Supt. Dale Read and Hopkins also were on hand for the ceremony, with Hopkins master of ceremonies.
 The eagle has a wingspan of about 5 feet, and stands 4 and a half feet tall.
 "It's a fantastic piece of art; the man is incredibly talented," said Hopkins. And all those present at Tuesday's program agreed.

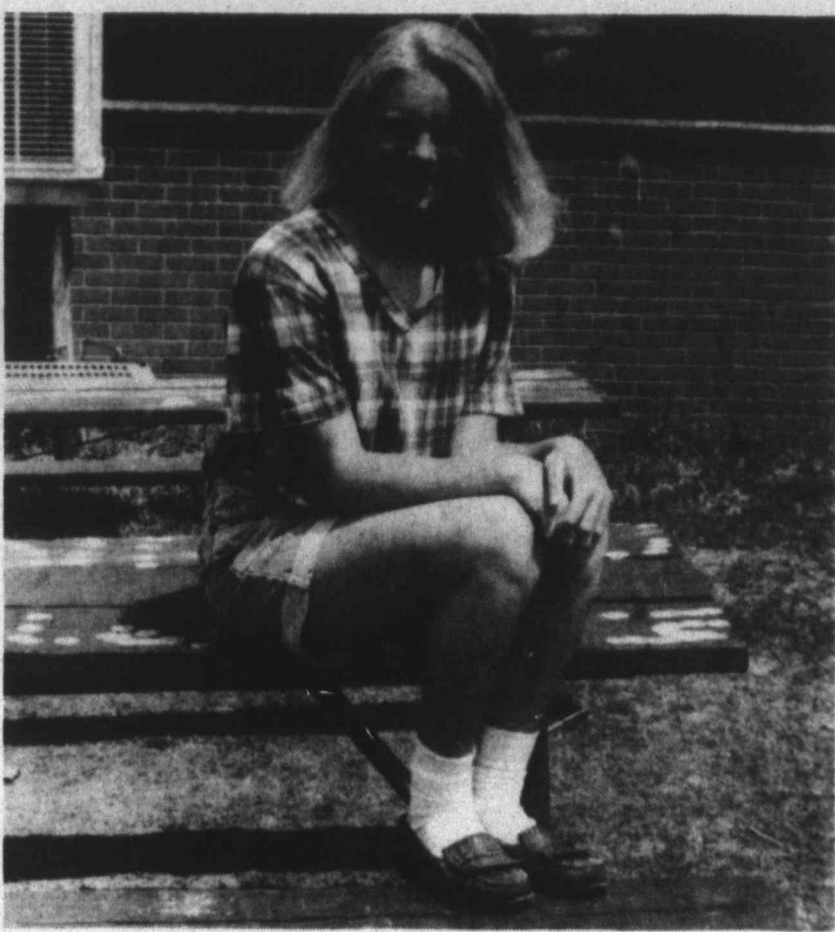

Public Notice

On February 22, 1994, Southwestern Bell Telephone Company ("Southwestern Bell" or "Company") filed an application with the Public Utility Commission of Texas ("Commission") to restructure the Company's Local Transport and Directory Transport categories of its Switched Access Service. This matter has been assigned to Docket No. 12784. The tariff sheets in Southwestern Bell's application, if approved, will bring the Company's intrastate Access Service Tariff into structural parity with the Company's interstate Tariff No. 73 for Local Transport. Southwestern Bell's companion interstate tariff became effective on January 1, 1994.

The transport rate elements provide for the transmission facilities between the customer's premises and the end office switch(es) where the customer's traffic is switched to originate or terminate the customer's communications.

Southwestern Bell proposes to implement the revised tariffs on a revenue neutral basis. Although the proposed tariff changes will affect all customers subscribing to Switched Access Service, the Local Transport and Directory Transport categories of Southwestern Bell's Switched Access Service is primarily for interexchange carriers. If approved, this application will result in an increase in Southwestern Bell's revenues of approximately \$1682.00 during the first year. Southwestern Bell proposes that the changes be effective on December 1, 1994.

Persons who wish to intervene in or comment upon these proceedings should notify the commission as soon as possible, as an intervention deadline will be imposed. A request to intervene or for further information should be mailed to the Public Utility Commission of Texas, 7800 Shoal Creek Boulevard, Suite 400N, Austin, Texas 78757. The deadline for intervention in the proceeding is May 6, 1994.

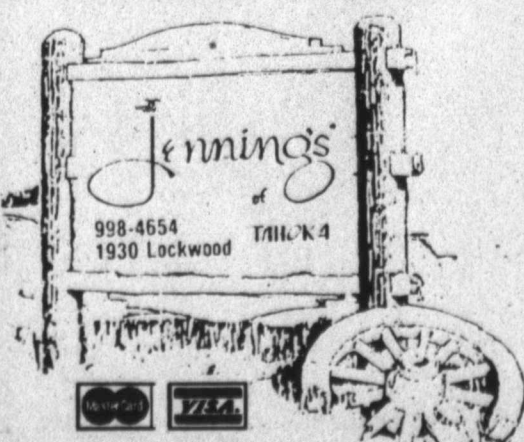

Bad Checks Put Nine In County Jail

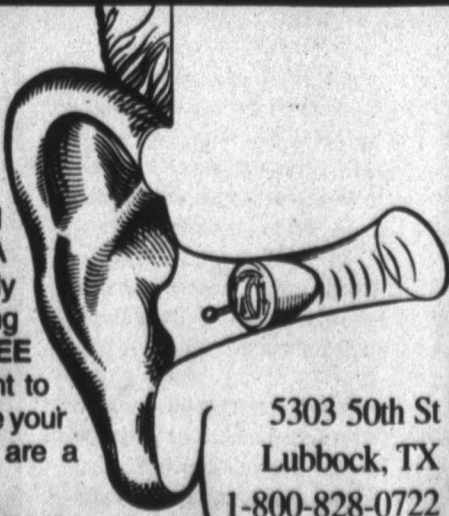

going to be a fun time, and it's all for a good cause," said Mrs. Allen.

And what does Barb think about all this attention? According to Jolene Tomlinson, Barb's EMT partner on the day ambulance crew for the last six years, she's extremely grateful but embarrassed too. "She says she feels funny - that there are lots of people who need money worse than she does," said Mrs. Tomlinson. Her EMS friends are quick to respond, however, citing the fact that she has touched the lives of so many people, and probably, literally, saved the lives of many of them. She shrugs and says that's just her job.

"Barb never loses her cool. She can handle anything on an ambulance run," said Mrs. Allen. "If she's not on call, many of us call her when we get through with a run. She's a great friend. We go to her stressed out and with problems, and we know it will all stay right there. She helps us deal with it," she added.

"Barb has been known, however, to 'lose it' on other occasions," said EMT Billy Tomlinson, with a mischievous look. "She has this problem with 'critters,'" he said, explaining that someone had placed a rubber mouse on the front seat in the ambulance which Barb was driving (after the patient had been delivered to the hospital). "She got in the cab, and you should have heard her holler. She made three circles around the inside of that cab and never touched the floor," he said with a grin.

"Another time, on April Fool's Day, somebody placed a rubber spider on her keyboard in her tiny little office. She flipped the lid off her typewriter, and nearly made a new door in the wall trying to get out of

there," said Mrs. Allen.

The entire group agreed, however, that the time when a live skunk was in the hospital was the best story on Barb. "Somehow, when the emergency room doors must have been left open following a patient delivery to the hospital, a skunk wandered into the x-ray lab room (a very small room just inside the emergency entrance). Barb went in there, saw the skunk, and climbed all over Austin, the x-ray technician, trying to get over him or through him to get out of that room," said Tomlinson, as the rest of the EMS group snickered at the re-telling of the story.

The stories prove that Barbara Cook is, after all, just a regular person. But, how many other 'regular people' are there who have made 596 ambulance runs in just a little over two years, on a volunteer basis? Her daughter says that before she decided to join the EMS, she was a real 'homebody', staying at home and sewing and tending to her family's needs. For the past 10 years, however, "she lives and breathes for the EMS - it's her life," adds her daughter.

This weekend, perhaps, the people whom she provided medical care for, will attempt to return the favor by attending the volleyball tournament, visiting with Barb, giving donations and bidding at the auction. It's only money that the fund-raising event is seeking... Barb gave the gift of caring, and sometimes, the gift of life.

It doesn't seem a fair exchange, does it?

Letter To The Editor

Dear Editor,
At the national and state level, failure to immunize preschool children for childhood diseases such as diphtheria, pertussis, tetanus, measles, mumps, rubella, and Haemophilus influenza type b, has been identified as a problem with long term health and cost of care implications. Immunization rates for preschool children are low, sometimes as low as 10 percent. The Clinton Administration's goal is to fully immunize 90% of all two-year-old children by 1996. Governor Ann Richards has adopted this goal for Texas, and we feel that Lynn County can achieve this goal with the efforts we will be making.

A collaboration of local individuals from several organizations and agencies has been formed to make up the "Shots Across Texas" Coalition, a name specified for all Texas immunization efforts. Action is under way for a Shots Across Texas immunization event scheduled during the week of April 23-30, 1994. Educational materials will be disseminated and free childhood vaccines will be given at this event. Several public locations, including local business sites and selected schools will be used.

The Texas Department of Health (TDH) is providing the childhood vaccines at no cost. Donations will cover additional medical supplies. Many volunteers are working with us to publicize the event and make it a reality.

Primary goals for this effort are not only to raise immunization rates, but to educate our community about the importance of immunizations and create a greater awareness of the importance of health. After completion of this event, our coalition will work toward other health goals in the community and continue immunization efforts in the years to come.

We ask that you encourage your employees or constituents to have their children immunized. In addition, you or your organization may be called upon to participate by contributing supplies, donating funds, or serving as volunteers. We would appreciate any support you could offer. The local Shots Across Texas coalition is chaired by TDH. Feel free to contact them at 806-998-4604 for additional information about this important community effort.

The ARP decision must be announced by June 1, he said.

CCC has provided an analysis that includes estimated planted acreage, production, domestic and export use, ending stocks, season average producer price, program participation rate and cost to the Federal government. Details appeared in the April 6 Federal Register.

Crime Line To Offer Rewards On Gang Activities

Lynn County Crime Line, Inc., in an effort to help prevent gang activities in the area, will offer rewards on solving criminal activities which are believed to be the work of gangs.

In a meeting of the Crime Line Board of Directors this week, discussion centered on the probability of gang activity becoming a problem in Lynn County, and ways to help prevent such action. The board unanimously approved a motion to expand Crime Line reward coverage to include misdemeanors specifically including, but not limited to, drug and gang-related activities.

Sheriff Jake Diggs, an advisory member of the council, told the group

that gang activity was becoming an unfortunate fact of life with the near proximity to Lubbock, and that Lubbock gangs were recruiting area youth to start their own gangs.

"We need our youth to know that we, as adults, won't stand for such activity, and one way is to provide opportunities for those who know about such activity to remain anonymous while helping curb such problems," said one director.

Lynn County Crime Line, Inc. offers rewards when anonymous calls lead to the arrest and conviction of persons responsible for crimes. The phone number is 998-5145. The Board of Directors work directly with law enforcement agencies in the county in determining reward offers. Callers to Crime Line are not required, at any time, to reveal their names.

freshman Matt Garcia went to catcher after a game with seven strikeouts.

In the 7th inning, with the score 8-5 in favor of Midland, the Bulldogs came back and scored three runs with the help of an error by the second baseman.

The game went into extra innings with Tahoka sitting down Midland's first three batters. Quake Shock Is Felt In Tahoka

Tahoka received her first thrill from earthquake shocks early Sunday morning when a number of her inhabitants were aroused from their slumbers by the tremors that evidently had their origin somewhere in the mountainous region of southwest Texas. The tremors were distinctly felt here, while windows rattled and walls quivered. NO damage was done here, however. Some felt the tremors who did not know what it was and thought that they might have been mistaken until news began to pour in during the day from other places concerning the tremor.

Valentine in southwest Texas suffered the severest damage, practically every building in town having been destroyed or seriously damaged. Walls of buildings were cracked in many other towns in that section of the state. The shocks were quite severe at San Angelo and Big Spring, though little damage was done to any of these cities. The shocks were felt as far north as Amarillo and Memphis, Texas and as far east as Dallas, Temple and Tyler.

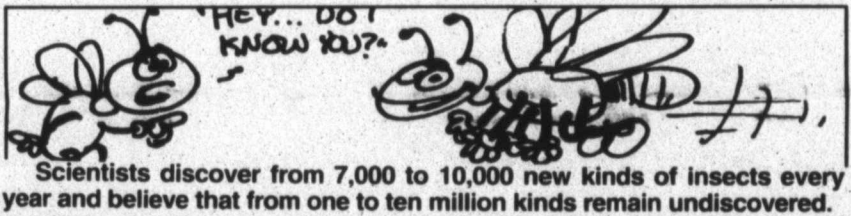
All Of County Schools Close
