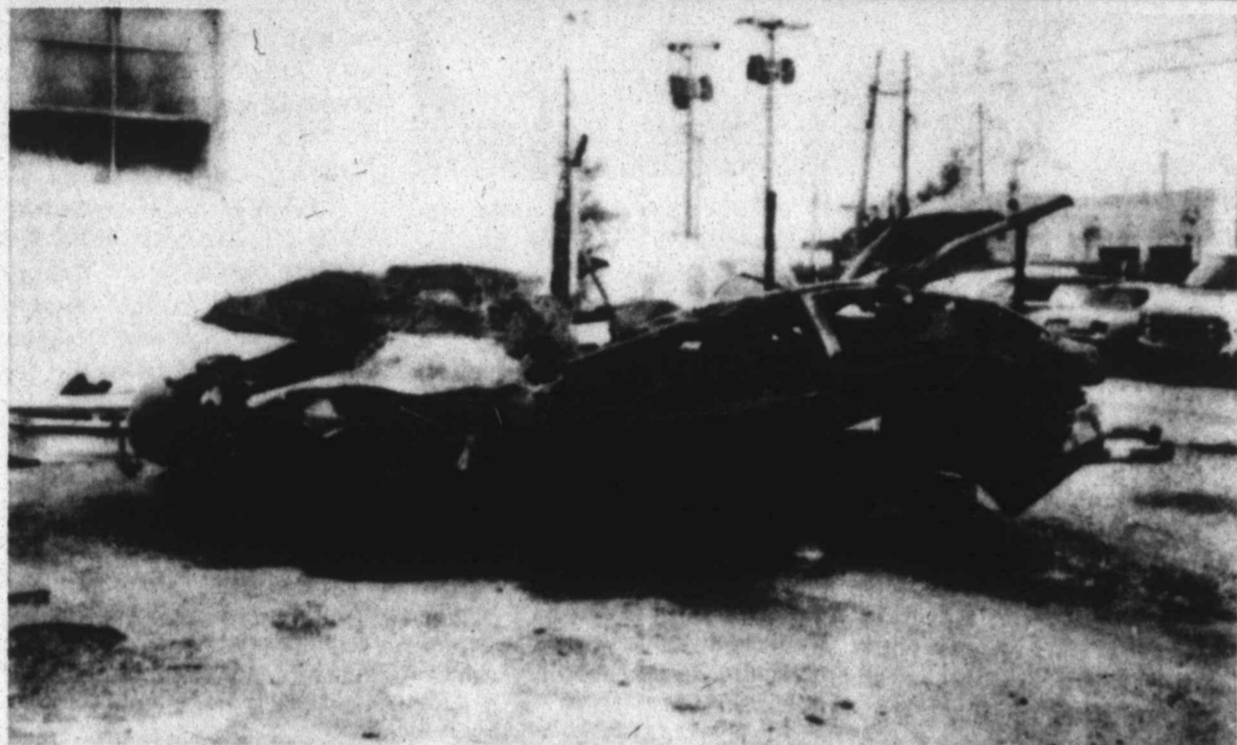
Of course, I understand that she's the one doing all the work, while I'm the one getting in the way. But it does make me wonder if any other husbands or wives ever have this problem.

## Traffic Accidents Hurt Five

Four traffic accidents, including one in the city of Tahoka, were reported during the last week, with five persons injured. All were released after treatment and none of the injuries appeared to be serious.

At 3:30 a.m. Thursday on FM 1730 northwest of New Home, a 1989 Ford Probe driven by Scott Clark Downs, 18, of Pottsboro, rolled over two and a half times. An investigating Dept. of Public Safety officer said Downs was wearing a seat belt. The car was crushed and Downs had to be removed by the jaws of life and then was taken by Aero Care helicopter to University Medical Center in Lubbock. He was admitted for treatment of head and other injuries and then released from the hospital early this week.

On U.S. 87 Friday 12 miles north of Tahoka, a 1990 Chevrolet driven by Erlinda Vacca Calvillo, 69, of Rt. 4 ran over a piece of metal in the roadway, damaging the car's undercarriage.

On a county dirt road 2.5 miles south of Draw Friday a 1982 Ford Escort overturned. The driver, Richard Lee Montez, 21, of Rt. 5,

Tahoka, and a female passenger were taken to Lynn County Hospital for treatment of injuries and then released.

A 1987 Ford Bronco driven by Victoria DeLeon, 13, of Tahoka, overturned in the 1700-block of Ave. E in Tahoka Sunday afternoon. She was taken to Lynn County Hospital for treatment, and later released. A 14-year-old passenger also reportedly suffered minor injuries.

A woman reportedly residing in the south part of Lynn County was listed as a suspect in the apparent abuse of two young children. No charges had been filed pending further investigation.

Johnny Armes of Rt. 1, Wilson, reported to the sheriff's department Thursday that his 1989 Ford Probe had been stolen from his residence. The car was found wrecked northwest of New Home later, and an 18-year-old Texas Tech student from Pottsboro was taken from the wreck-

age and transported to Lubbock for treatment of injuries. A Dept. of Public Safety officer said charges of driving while intoxicated and unauthorized use of a motor vehicle would be filed on the suspect.

106th District Judge George Hansard last week ordered probation for two persons previously convicted on felonies. They are Jerry Wayne Meeks, 38, of Tahoka and George Munoz, 25, of Wilson.

Judge Hansard also heard a plea of guilty from John Austin, 31, of Tahoka, on charges of misappropriation of trust funds. He was assessed a 10-year term, probated, with deferred adjudication.

In jail during the week were two persons for driving while intoxicated, second offense, two for application to revoke probation on DWI charges, and one person each for terroristic threat, public intoxication, and DWI first offense plus driving while license suspended.

## County's School, City, Hospital Elections Provide Some Surprises

Voters in Lynn County elections for the hospital board, city councils and school boards put some new people in office and ousted several incumbents, although current officeholders usually are re-elected.

The Tahoka City Council has three new members. Elected from a field of four candidates were Ray Don Box with 304 votes, Jay Dee House with 300 and Todd Henry with 265 votes. Incumbent councilman Joe Calvillo was defeated with 163 votes. The other two incumbents, Dayton Parker and Wayne Tekell, did not seek re-election.

Incumbent Tahoka school board member Greg Henley was re-elected with 225 votes, and newcomer Rex Rash led the ticket with 245 votes, with two seats available. Others on the ballot were Patty Saldana DeLeon with 125, Ginger Henry with 101 and Gary McCord with 98.

## Awards Days Set At School

Award ceremonies for Tahoka school students have been scheduled on three days for the different campuses.

Tahoka Elementary Awards program will be held Monday, May 23 in the elementary gym, beginning at 8:30 a.m.

Billy Tomlinson (373) were elected as directors of Lynn County Hospital District, where seven were on the ballot. Mike Rivas had 361 votes, John Henderson 308, incumbent Bettye Green 280 and Ann Wyatt 182.

In O'Donnell Tommy Woolam was elected mayor by 239 votes to 20 for Dean Smith. Two councilmen were elected. Allen Eaker with 158 and Oscar Calzada with 144. Incumbent member Bill Clopton lost by just four votes, getting 140.

O'Donnell school board elected incumbent Renn Dorman with 244 votes and Gonzalo Amaro with 187. Others were Danny Willis with 170 and Manuel Gutierrez Jr. with 127.

New Home school board elected Stacy Gill, incumbent with 62 votes, and incumbent David Foerster with 55. Candidate David Gandy had 39 votes.

Three persons were elected to the New Home City Council, including incumbent Louis Rodriguez with 29 votes, Dale Clem with 38 and Don Sharp with 24. Loyd Bell had 20 votes and incumbent Stoney Gill had 18.

Wilson school board re-elected two board members, Dan Cook with 63 votes and Keith Wied with 60. Candidate Janie Zavala had 49 votes.

There were no contests in the Wilson city election. Mayor Jackie Bishop was re-elected with 46 votes. Council members elected were incumbent Oscar Follis with 52 votes and Linda Williams with 35.

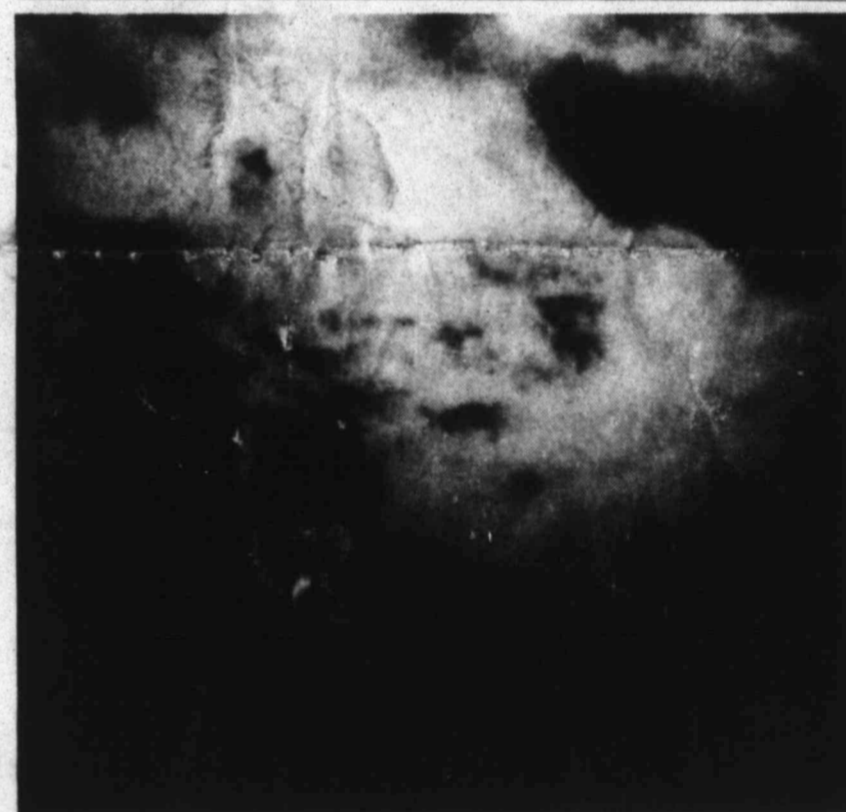
In addition to the two competitors, six THS students received the prestigious Ambassador Torch Award at a special reception while in San Francisco, representing an accu-

## County Agent Shackelford Relieved Of Duties Here

Lynn County Agricultural Extension Agent Wade Shackelford was asked by County Commissioners this week to relinquish his duties involved in his position as county agent, effective Tuesday, May 10.

In a 5-0 unanimous vote, including a vote from County Judge J.F. Brandon, the court noted in the motion that Shackelford was released from active duty in that position and that the county will not be responsible for any expenses incurred by him after May 10.

Shackelford had resigned the county agent position in December 1993, but the resignation is not effective until June 1, 1994. The court noted that he will receive his regular salary until that time.

Since January 1994, the agent has spent \$3900 of a \$4500 annual travel expense account, and it was noted that only approximately \$600 remained in the account to date for the remainder of the calendar year.

In other business, commissioners met with Probation Officer Jeri Akard and Wilbur Ray, a state probation office representative, to discuss larger office space for the probation department.

Ray told the court that when the

department was audited by the state three years ago, the Lynn County probation office was written up for "lack of office space," and that another audit was due this year. "I don't want to be written up again," he told the court, noting that the office, which is on the second floor of the courthouse, "simply does not have enough room according to state standards, and the county must comply."

After some discussion with Mrs. Akard and Justice of the Peace H.W. (Sam) Edwards, whose office is housed in the courthouse basement, commissioners agreed to begin the process this month of trading office space of Mrs. Akard and Edwards, noting that more space was available in the basement office.

Commissioners examined accounts, approved county officials reports, and noted that each commissioner needed to meet with a contact person at South Plains Association of Government (SPAG) to name rural roads in the county for 9-1-1 road signs.

Commissioners Jacky Henry, T.A. Stone, Sandy Cox and J.T. Miller were all present for the meeting, as well as Judge Brandon and several county employees.

## TISD Board Meets To Canvass Votes

The Tahoka Independent School District Board of Trustees met at noon Monday to canvass the May 7 election results, approving the results with a 5-0 vote and Board President Greg Henley abstaining, who was re-elected in the election. One trustee of the seven-member board was absent at the meeting.

Henley and Rex Rash received the most votes in the election, and were named to the two at-large seats on the board, both three-year terms. Rash led the count with 245 votes, followed by incumbent Henley with 225, Patsy Saldana DeLeon with 125, Ginger Henry with 101 and Gary McCord with 98. A total of 403 votes were recorded in the election. Outgoing trustee Mike Huffaker did not seek re-election to the board.

Rash and Henley took a pre-oath statement, and will be sworn in at the next regular board meeting on Tuesday, May 17.

## Newly Elected City Officials Take Oath

Two of the three newly-elected councilmen for the City of Tahoka were sworn in during the council's regular meeting held Monday night. Ray Don Box and Todd Henry took the oath of office after the council canvassed the votes from Saturday's election. Box, Henry and Jay Dee House received the most votes for the three seats on the council. House was absent from the meeting and will be sworn in at the next council meeting.

Councilmen Dayton Parker, Wayne Tekell and Joe Calvillo's terms of office expired in this year's election. The new Tahoka City Council is composed of Box, Henry, House, Mike Mensch and Wayne Huffaker.

In other action Monday night, Municipal Judge Melvin Burks was appointed to another two-year term in that office, and Ray Box, Mike Mensch, Juan Alvarado, Dayton Parker and Mike Huffaker were appointed to the city's Zoning Board of Adjustments. Mayor Jim Solomon appointed councilman Mensch as mayor pro-tem.

City officials targeted three dilapidated buildings for action, with those owners to be notified of a public hearing set for the June 6 regular council meeting.

Police Chief Jerry Webster reported to the council on the police department's activities for the month of April, noting that 235 calls were reported, seven arrests made, 14 tickets issued, 33 warnings issued, and three burglaries and three thefts reported. Two burglaries and two thefts were reported cleared.

Present at the meeting were councilmen Mensch and Parker, Mayor Solomon, City Manager Barry Pittman, and newly elected councilmen Henry and Box. Councilman Wayne Huffaker was absent due to illness.

## Pages From The Past...

## Sand Storms Still Coming Terrific Winds Bring Dust And Sand; Storms Worst In History Of West

Sandstorms which have filled the air with dust and sand almost without cessation for the past seven or eight weeks, continue unabated. For four days in succession now these storms have raged here, practically for six days. Saturday brought one of the worst storms of the season. On Sunday there was only a moderate breeze but the atmosphere was filled with dust. Monday, Tuesday and Wednesday brought storms of the severest type, and another is raging today. For twenty-five years, no doubt, people will talk about the spring of 1935 as possibly the worst on record.

Yet, according to newspaper reports, we people here on the South Plains are fortunate. In the Northern Panhandle, Western Oklahoma, Western Kansas and in parts of Colorado, the severity and destructiveness of the storms have been much greater than here. In some of those sections, schools and many business houses were compelled to close, visibility reduced to only a few yards at times, the lands have been denuded of the top soil for a depth of many inches in places, and in one locality gravel picked up by the winds broke out window lights.

Speaking of the near freezing temperature here on the third and fourth days of May, Dave Childress said Wednesday that about twenty-five head of cows and calves died from exposure to the cold rain and wind that came at that time.

This is the first time in many years that cows have died from exposure to cold weather in May.



## Former Tahokan Richard Havens Publishes Book About His Brother

Former Tahoka resident Richard Havens, whose family moved from Roaring Springs to a farm southeast of Tahoka in 1945, has compiled and published a book about his oldest brother, Weldon William (Billy) Havens, who volunteered for the Marine Corps during the height of World War II, and gave his life for his country on the battlefield of Okinawa.

Even though this is Havens' first book, he is no stranger to writing and editing. A 1953 graduate of Tahoka High School, Havens is the former editor and publisher of two West Texas weekly newspapers, The Abernathy Weekly Review and The Ralls Banner. He is now employed by Chaparral Graphics Group, Inc., of Lubbock.

His brother, who went by Weldon at school and "Billy" to his family, spent his childhood years in Dickens County, Texas, with early schooling at the Midway and Patton Springs schools. When the Japanese bombed Pearl Harbor on Dec. 7, 1941, he was a sophomore student at Roaring Springs High School in Motley County. Two years later he dropped out of school and for a few months worked at the Pantex Defense Plant at Amarillo, then in the spring of 1944 he volunteered for the Marine Corps and entered the service in July of that year.

Entitled, *Remembering Billy* with the subtitle, *The Story of a West Texas Marine, His Friends, His Family and His Sacrifice*, the book is a compilation of letters and interviews, with the younger Havens writing explanations and comments of clarification. Captured in the pages of the book are many of the events of Billy's life and the people who shared them with him -- his immediate family, close relatives, former schoolmates and friends, and former fellow-Marines. In gathering information over a three-year period of time, Havens came in contact with a number of former Marines with whom

Billy served, a few who knew him well, and others who were there in the thick of battle, but did not know him personally.

The first part of the book is devoted to Billy's early years, primarily with family background. It progresses to his teen years and events prior to his volunteering to serve his country, then follows him through basic training at Parris Island, South Carolina; onto advanced infantry training at Camp Lejeune, North Carolina; then to amphibious training in the Russell Islands; and finally to the battlefield of caves, tunnels and ridges of Okinawa.

Prior to leaving the States, Billy was assigned to the 32nd Replacement Draft which became a part of the First Marine Division, Fleet Marine Force. Following their initial landing on Okinawa, he was later assigned to Company G, 2nd Battalion, 5th Regiment of the First Marine Division. The First Marine Division was part of the US Tenth Army, the assault force in the last ground offensive of World War II, the invasion of Okinawa. This assault, known as Operation Iceberg, began on Easter Sunday, April 1, 1945.

Through May and early June, Billy and his fellow-Marines were involved in some of the most intense combat of the war in the southern end of Okinawa. On June 8, Billy's unit was pulled off the front lines for some badly needed rest. Because of heavy casualties, volunteers were requested to return to the front. According to his commanding officer, Billy was one of those who volunteered. On June 16, 1945, only five days before the island was declared secured, he was killed by a gunshot wound to the head.

According to the younger Havens, this is not a book written by any one individual. Rather, it is a compilation of letters and explanations of events gathered from many sources. It includes the letters that Billy wrote to

his parents and siblings, aunts and uncles. Also included are recent letters from relatives and former Marines, along with excerpts from interviews and telephone conversations.

Remembrances of Billy are also recorded by his older sister, Elda Whiteside of Lubbock, and three of his younger brothers, Jay and Richard of Lubbock, and Orville of Tahoka.

Abernathy High School English teacher, Marlina Gough, who assisted with proof reading and grammatical suggestions, commented, "The book's contents delve into history, but more importantly tell the story of a young Marine's sacrifice and reflect a long-ago time when our nation revered the solid values of the love of a family and a commitment to the perpetuation of liberty and freedom for all, no matter what the cost."

The book, which contains over 400 pages and has a deluxe hard-bound cover by Universal Bookbinding of San Antonio, is being offered on a pre-distribution mail order basis for \$14.95, plus applicable sales tax and \$2.90 per book for shipping and handling. 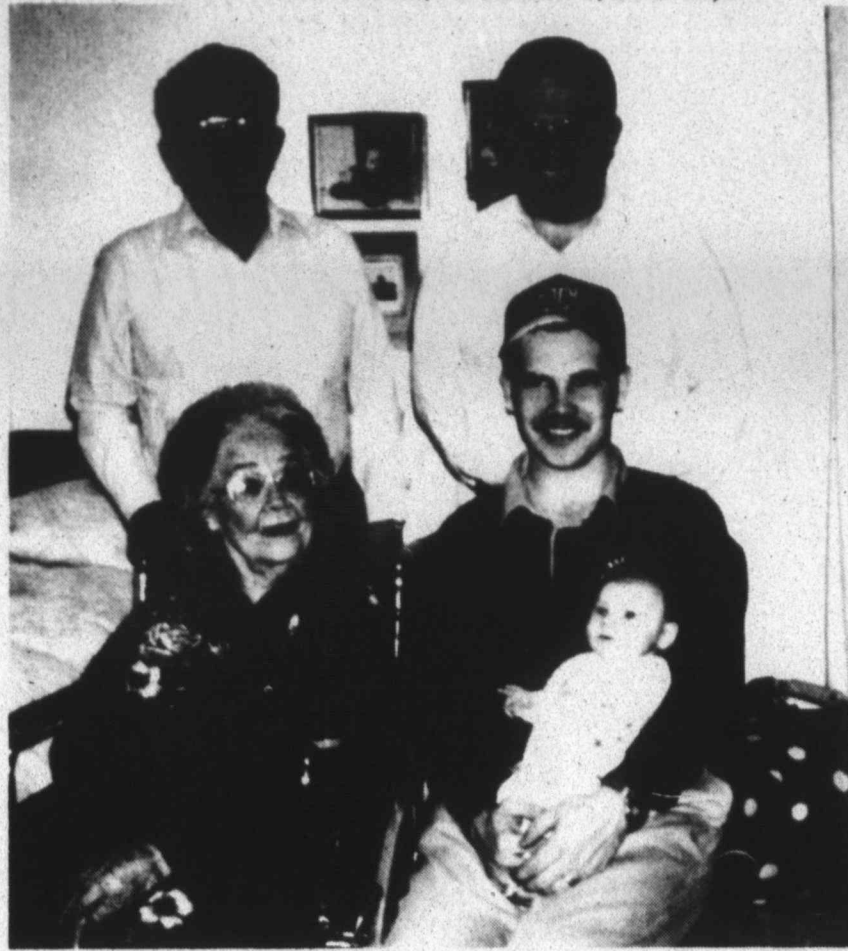

## Knowing Stroke Signs Could Help Save Lives, AHA Says

Lynn County residents should listen when their body talks — they could be having a stroke, the American Heart Association warns.

"There is no such thing as a stroke of luck," says Rebecca Dimak, Board Member with the American Heart Association, Lynn County Division. "Strokes don't always occur suddenly. And even when they do, sometimes your body has tried to warn you," she adds.

The AHA, which is the world's largest non-governmental supporter of heart and blood vessel research, says the signs of stroke are:

- Sudden weakness or numbness of the face, arm or leg on one side of the body.
  - Sudden dimness or loss of vision, particularly in one eye.
  - Loss of speech, or trouble talking or understanding speech.
  - Sudden, severe headaches with no apparent cause.
  - Unexplained dizziness, unsteadiness or sudden falls, especially along with any of the other four symptoms.
- "If any of these signs occur, don't wait," Mrs. Dimak says. "Call 9-1-1 or your emergency medical service immediately. If you can get to a hospital coronary care unit faster by car, have someone drive you," she adds.
- There are four major kinds of stroke, which is the nation's third

leading killer behind heart attack and cancer. The two most common are caused by clots or other materials that plug an artery supplying blood to a part of the brain. Ruptured blood vessels cause the other two.

How quickly a person responds to any of these types of strokes could determine whether it takes a few weeks to recover or takes a life, the AHA says. Drugs can successfully slow or prevent blood clots from forming. Meanwhile, a surgical treatment can relieve severe blockage in the neck arteries and restore blood supply to the brain. And new rehabilitation procedures can help a person adjust to any lost skills.

A non-profit health organization funded mainly by private donations, the AHA spent more than \$232 million during fiscal year 1991-92 on scientific research, public and professional education and community programs. With more than 3.6 million volunteers nationwide, it is the largest voluntary health organization dedicated to reducing disability and death from heart and blood vessel diseases, which annually kill more than 930,000 Americans.

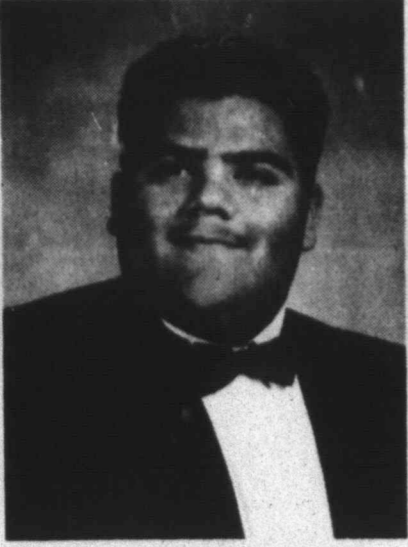

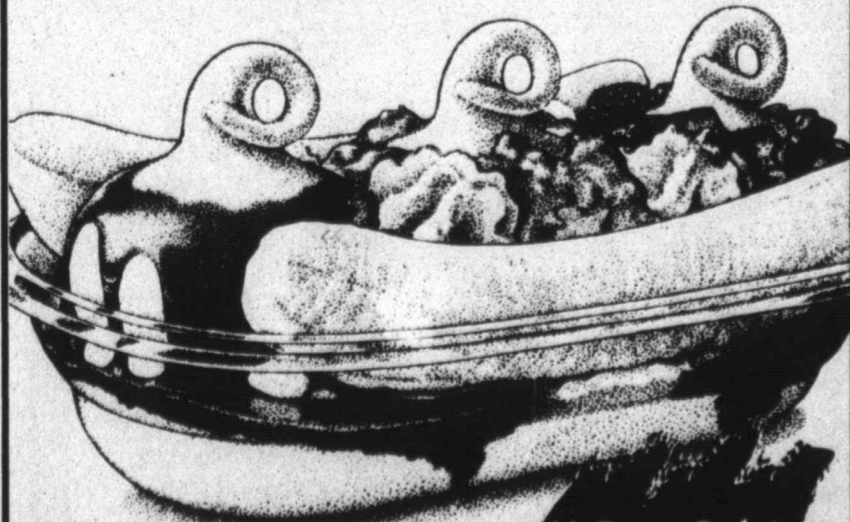

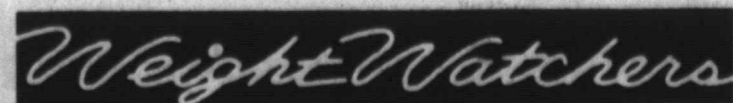
