Donations To Fund Project:

Historical Murals Enhance Downtown Park Project

Tahoka residents driving down Main Street in the downtown section during the past week have watched the progress of artist Bob McClellan as he paints historical murals on the walls surrounding the Downtown Park, an area where the former Lankford Variety store was razed. The project is spearheaded by the Downtown Park Committee, chaired by Amy Preston, a member of the Tahoka Rotary Club and chairman of the Community Service committee in that organization.

McClellan, from Morton, began last week painting a historical mural of Tahoka Lake as it was in the early 1900's on the west and south walls facing the park, and this week is painting the north wall with a scene depicting the downtown square in 1907. Another wall, on the north side of the Lynn County News, will depict another historical scene as well as a "Welcome to Tahoka" message and billboards of area businesses and organizations who are helping sponsor the mural project.

An account was opened at First National Bank of Tahoka this week to fund the project, with generous donations amounting to \$4,629.50 from First National Bank of Tahoka, Tahoka Rotary Club, Jaycees, Chamberettes, Al Griggs Autocenter, Lynn County News,

Poka-Lambro Telephone Cooperative, and J.T. Miller, as well as \$79.50 from collections from donation cans placed throughout the area by local resident Charles Isham several months ago.

More donations are needed to fund the project, and area businesses, organizations and individuals are encouraged to purchase 8'x2' billboards on the top portion of the News Office wall at a cost of \$150, with all proceeds to benefit the Downtown Park Project. The billboards not only promote local businesses, but also help pay for the painting of the murals as well as for renovating the park area with trees, benches, planter boxes, flowers, and lights.

"We plan to place lights on the walls with murals so that the murals may be seen at night," said Mrs. Preston. "We're very excited about this project, and believe that this is the beginning of a downtown beautification effort which area residents may enjoy for many years," she added.

McClellan has painted mural projects in many area towns, including Seagraves, Muleshoe, Morton, and the Economy Mills building in Lubbock. The artist, who lives in Morton with his wife and children, says he has been involved in this type of project for more than 14 years, beginning with a mural project in

Morton after he moved there from California, where he got his start in the art world by painting scenes on custom vans and motorcycles for several years in Los Angeles.

Much of the painting is done with an airbrush before McClellan gets down to detailing with a brush. He completed the Tahoka Lake scene on the west and south walls within a week, and expects to finish the early-1900 downtown square scene on the north wall this week before beginning work on the Lynn County News wall.

"McClellan also paints scenes on windows, and several of the empty buildings downtown could be enhanced with artwork on windows," said Mrs. Preston, noting that anyone interested in such a project should contact her or a committee member.

The Downtown Park Committee is composed of Mrs. Preston, Barry Pittman, Cal Huffaker, Ray Box, Juanell Jones, Charles Isham and Tahoka High School students Susan Draper and Wes Solomon. "Both of our high school students on the committee are excited about getting their peers involved in the park project," said Mrs. Preston, noting that the THS Student Council and National Honor Society members were planning to assist in the project.

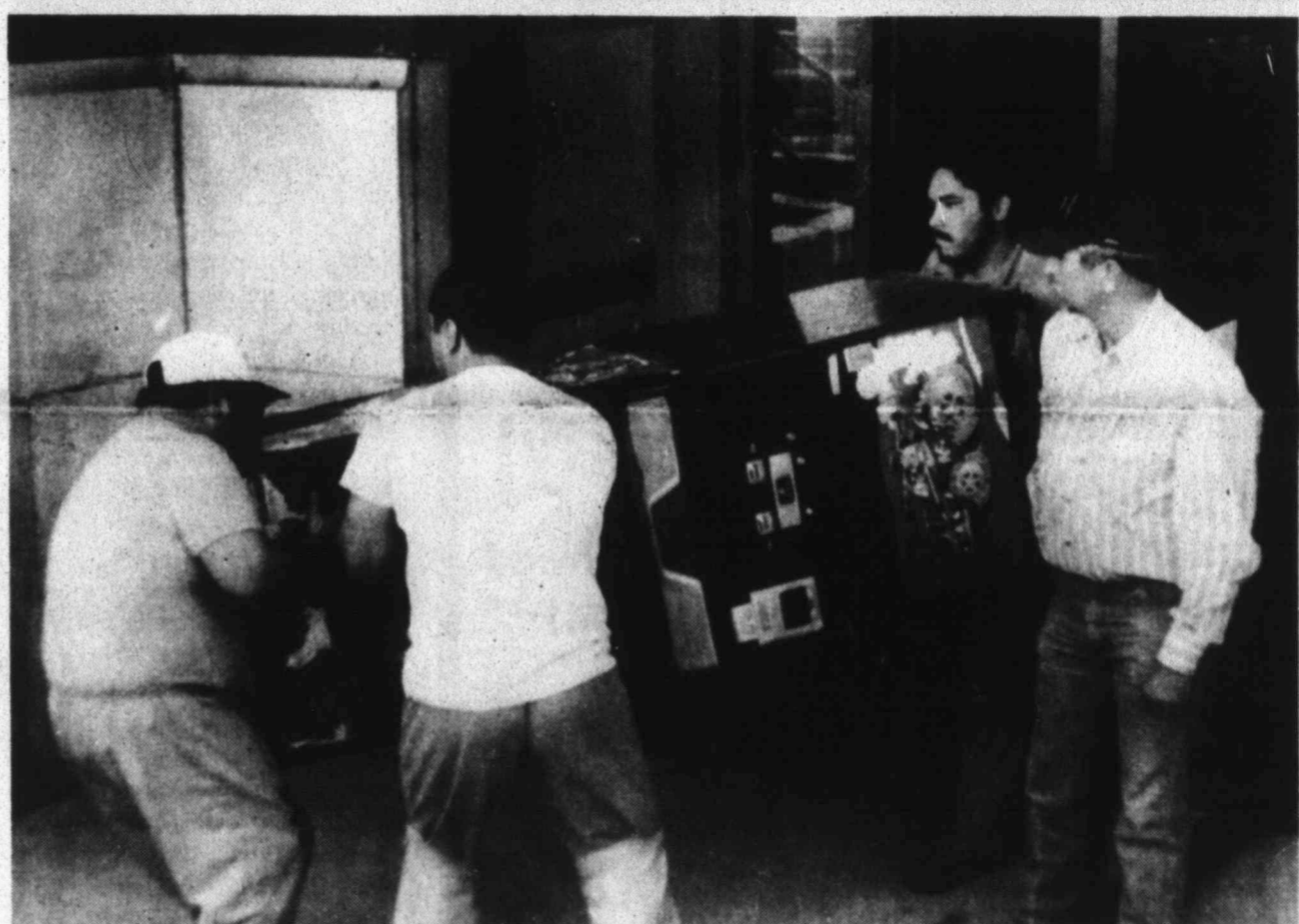
"We want this to be something our community is proud of, and we want to involve anyone who wants to contribute, either by monetary donations or contributions of labor and skill in renovating the park area," said one member of the committee.

A list of contributors to the Downtown Park Project fund at the First National Bank will be printed weekly in *The News*, as well as the total amount of the fund. Contributions may be made at the bank, or by contacting any committee member.

676 Containers Of Beer Confiscated In Raid Here

Law enforcement officers confiscated 676 cans and bottles of beer and a few partial bottles of liquor along with some other items in a raid Friday evening at a location just southeast of Tahoka city limits, referred to locally as 'the Chicken Ranch.'

Also hauled in were a video slot machine, Black Jack video, \$500 cash and a small quantity of cocaine, according to Lynn County Sheriff Jake Diggs. He said officers from the Lynn and Dawson County sheriff's departments, South Plains Task Force, Tahoka Police Dept., Dept. of Public Safety, Texas Rangers and state narcotics officers took part in the raid.

Felony charges of possession of a controlled substance, cocaine, and possession of a gambling device were filed against Margarito Serna Deleon, 50, of Tahoka. Also charged with selling alcoholic beverages without a license and possession of alcoholic beverages in a dry area with intent to sell without a permit, both misdemeanors, Deleon posted bonds totaling \$104,000 on the four charges.

Also charged in a related case during the last week was Victor Charo, 31, of Tahoka, charged with delivery of marijuana, and whose parole on an earlier conviction for delivery of cocaine, was revoked.

Bobby Crossland of Lamesa reported that tools had been stolen Friday from the cab of his tractor located 8 miles west of O'Donnell on FM 2053.

On Sunday a 1985 Chevrolet pickup driven by Elizabeth Solorzano, 15, of Tahoka, struck a parked 1984 Oldsmobile on S. 3rd St. The parked car is owned by Ruben Jesse Arouza of Tahoka. There were no injuries.

A minor collision on Thriftway parking lot last Thursday involved a parked 1993 Cadillac owned by Aleta Wood and a 1981 Chevrolet Suburban driven by Rosa Longoria.

Helen Payne, who lives on Ave. L., reported that someone last Wednesday had stolen a small swimming pool valued at \$10.

In jail during the week were five persons for public intoxication, two for driving while intoxicated, first offense, two for DWI second offense, with one also charged with driving while license suspended, and another person for driving while license suspended.

Crop Certification Deadline Nears

The Lynn County Agricultural Stabilization and Conservation Service (ASCS) reminds all farmers to certify their 1994 crop plantings, land uses, acreage conservation reserve and other program acreage as soon as possible.

Final certification date for all crops planted in Lynn County is July 15, 1994.

Larry Moore, Chairman of Lynn County ASCS Committee, explained certification as the procedure by which farmers report their program acreage to establish their eligibility to receive the benefits of price support, deficiency payments and other farm program benefits. Acreage reports are required for all participating farms. All farmers are reminded to report any failed crop before destroying evidence of the crop.

He said growers not participating in the 1994 programs should report

their acreage to establish planting history, ensure future benefits and protect crop acreage bases.

After certification, ASCS will use their computer to select farms at random to verify that acreage reports are accurate. Aerial photographs are available for farmers to help identify their fields.

Moore said crop certification is particularly important to producers of quota crops such as peanuts. "In addition to these crops, however, all other crop acreage must be accurately reported," he said.

Certification of crops is being done by appointment. Notice of appointments are being mailed to participating operators. Operators of farms that are not participating can request an appointment by calling the local ASCS office at 998-4501 any time between 8 a.m. and 5 p.m. Monday through Friday.

Stenholm Urges Flexibility On EPA's Ground-Water Regulations

During a public meeting on Ground-water Monitoring Requirements for Small, Dry, and Remote Landfills, Congressman Charles Stenholm urged EPA to give states flexibility in complying with the land-fill regulations mandated by the Resource Conservation and Recovery Act (RCRA).

"As a farmer and a native west Texan, I understand the importance of safeguarding the nation's ground-water," said Stenholm. "By the same token, we must balance such protection with the ability of rural America to remain economically viable."

In 1991, Stenholm was instrumental in establishing an arid exemption for small towns facing stringent ground-water monitoring requirements. "In arid parts of the west, the potential for ground-water contamination is quite low," stated Stenholm. "I felt it was neither practical nor fair for one set of regulations to be implemented nationwide, without taking into consideration variations in precipitation, topography, ground-water percolation, population density, and other factors."

On May 7, 1993, the U.S. Court of Appeals for the District of Columbia Circuit issued a ruling that set aside the arid exemption from underground water monitoring. EPA is holding public meetings to determine how they can modify the existing ground-water monitoring regulations to provide greater implementation flexibility.

"Many of us who have been carefully following this issue over the years do not believe the Court had all the information necessary to render a fair or reasonable ruling," Stenholm told EPA. "Nor do I believe the Court understood the significant fiscal impact this decision would have on small rural communities."

Stenholm urged EPA to review and adopt the alternative ground-water monitoring methods for small landfills in arid areas developed by the Texas Natural Resource Conservation Commission.

"States must be given the authority to make decisions which are site-specific, and which will not be financially devastating to rural America," Stenholm said.

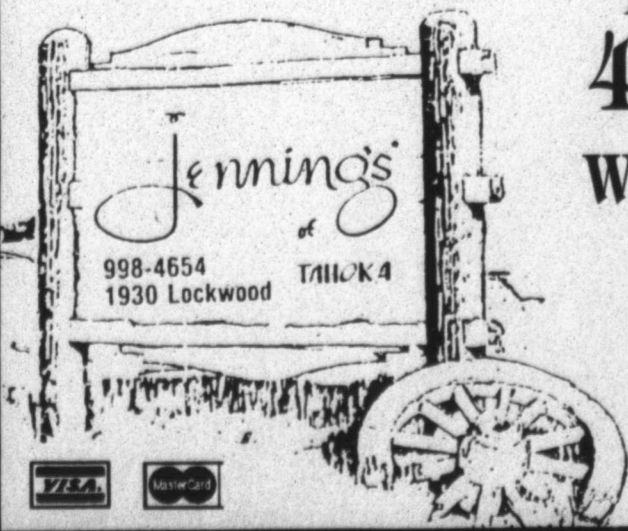

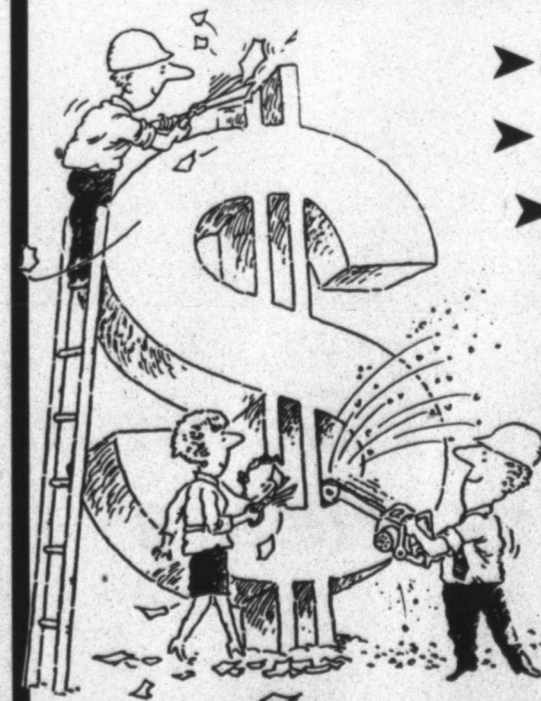

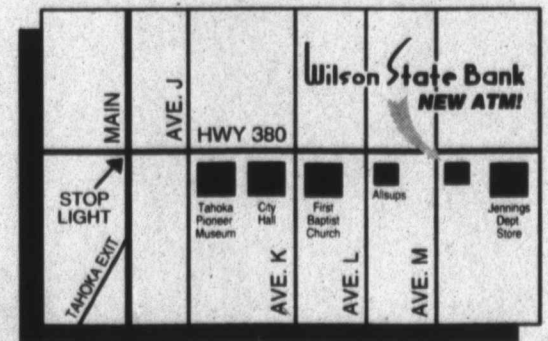

YOU NEED TO KNOW...

Managed Competition
Rural residents across the country are concerned about federal health care reform but according to some in Washington, rural Americans don't count. Just 2 percent of Americans feed the rest of the nation. With this fact in mind, farmers and ranchers do count to millions of Americans and our voices must be heard by those who represent. Unfortunately, most of the proposals being considered overlook the needs of farmers and ranchers across America. Due of the new health term is called "managed competition." "Managed competition" in short means restricting of the medical market so doctors and hospitals compete for patients. It is an empty promise for rural areas. In our unique environment where we struggle to keep hospitals and clinics open and to recruit and retain health care professionals there simply isn't any competition to manage. In our area we need to find ways for our doctors to cooperate - not compete.

Under this proposed Clinton plan of managed competition, we in the rural areas would have limited access to or be excluded altogether from adequate medical services. It makes no more sense than having a National Auto Board to determine what car for every farmer because the "experts" think the engine is too complicated for the ordinary American to understand. Suppose a National Board were set up to choose or specify a certain tractor for every farmer to use because the farmer was thought to not be "smart" enough to select his own to fit his needs. And, all were required to buy a tractor. Would the price of tractors be on the decrease or increase? So, it will be under managed competition.

This promise to make the system better will ultimately make it worse or more costly than today. It is a vicious spiral downward. We must expand programs to encourage health care professionals to come to rural areas, and we must reward them for the same care, the same pay. Each individual area has unique needs. Just because you've seen one rural community doesn't mean the same reform will fit the next one. "If you've seen one rural community, you've seen just that - one rural community." And that's exactly why we, as rural Americans, must be cautious of any reform proposal that emphasizes a "one size fits all" approach.

Before it's too late, let's take a minute to inform ourselves, examine the rhetoric and look at some crucial realities. As you read this column from week to week, I hope you will begin to understand the urgency of this issue. You may become angry. I hope instead that you become motivated to join with other farmers, ranchers, and self-employed rural Americans in the campaign to get real reform that solves the real problems in our health care system. If we are to reform and changes should be made, we should insist on a plan that will work equally well in all parts of the country. After all, all of us are very involved and our future days are at stake.

Technical Assistance Program Available To County Farmers

Farmers in Lynn County are advised of the opportunity to receive technical assistance through the Lynn County Soil and Water Conservation District to develop a site specific water quality management plan to prevent or minimize the potential of their operation contributing to further percolation of arsenic into the groundwater.

Arsenic acid is one of several chemicals identified in recent years suspected of polluting groundwater in the county.

"The advantage of participating in this program is that if a farmer voluntarily develops and maintains a site specific water quality management plan (WQMP) through our district and has that plan certified by the Texas State Soil and Water Conservation Board (TSSWCB), the farmer will be compliant with state water quality law and exempt from other state regulatory processes regarding nonpoint source discharge of pollutants," said W.R. Steen, chairman of the Lynn County SWCD.

"Of course the farmer will have to maintain his or her plan to retain their certification," added Steen.

In explaining a water quality man-

agement plan Steen said that a WQMP includes appropriate land treatment practices, production practices, management measures, technologies or any combination to achieve a level of pollution prevention or abatement.

S.B. 503, which was passed in the last regular session of the Texas Legislature names the TSSWCB as the lead agency in Texas for activities relating to abating agricultural and silvicultural nonpoint source pollution.

The TSSWCB is responsible for assuring that individual water quality management plans comply with state water quality standards established by the Texas Natural Resource Conservation Commission.

"As a result each WQMP developed, maintained and implemented by a landowner or operator through a SWCD must meet rules and criteria adopted by the TSSWCB," said Steen.

"With a little fine tuning and certification of an existing soil and water conservation plan for a farm, a producer might find that his or her operation will adequately meet state water quality goals," said Steen.

Best management practice standards will be based on criteria in the current USDA Soil Conservation Service field office technical guide for this district. Steen said.

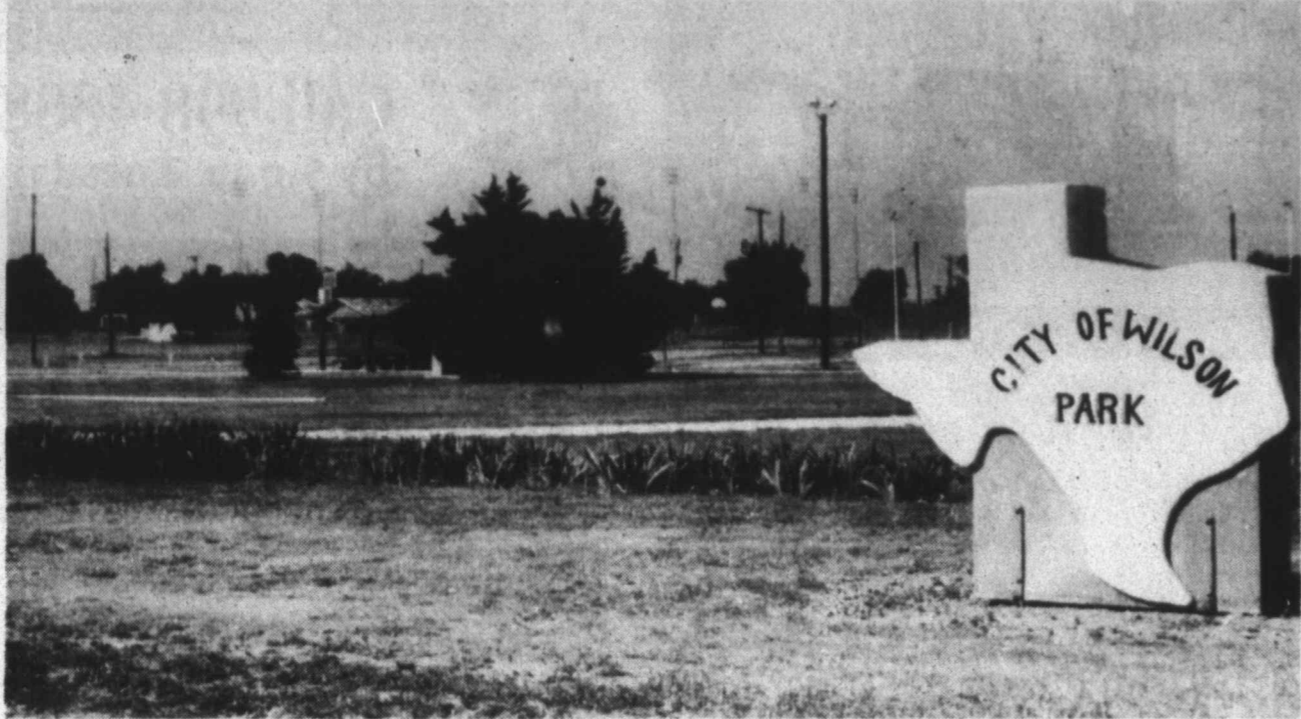

WHAT IS THE DIFFERENCE HEAT EXHAUSTION OR SUN-STROKE?

Heat exhaustion and sun-stroke are both caused by the same thing — over-exposure to extreme heat. But, they are very different and you should know how to tell them apart.

With sun-stroke, the skin is very hot and very dry. It is more serious than heat exhaustion and a doctor should be called at once. A cold water bath or sponging, ice on the head, moving to a shaded area and undressing can help until the doctor arrives. With heat exhaustion, the skin is cold and clammy. Move the person to a shady place, keep head lower than the body and loosen tight clothing while waiting for the doctor.
