Dogs Chew Up Rabbits, Take This Week Off

Tahoka freshman running back Steve Wiseman did what might be a whole year's worth of running for most freshmen last Friday night at Ralls, as Tahoka beat the Jackrabbits 29-18 in a district 4-AA and Wiseman was most of the offense.

Wiseman hurled his 163 pounds at the Ralls defense 31 times, gaining 193 yards and scoring four touchdowns, one in each quarter, on runs of 12, 13, 15 and 25 yards.

He was playing in the place of sophomore runner Dustin Burleson, who has been averaging close to 100 yards per game for Tahoka this season, but who was injured before last Friday's game. Coach Tooter Draper said this week that Burleson should be ready to play against Sundown next week. Tahoka has an open date this week.

Tahoka took the lead in the first quarter on a damp, cool night at Ralls, taking the opening kickoff and driving 84 yards, topped off by Wiseman's 12-yard scoring run. Gerald Cantu kicked the point to make it 7-0.

In the third, Wiseman scored on a 15-yard run and a pass for extra points failed. Martinez of Ralls answered with a 50-yard run, but the point try was blocked and it was 21-18 Tahoka ending the third.


Wiseman ran 25 and then for two more points in the fourth to ice the game

Tahoka had 21 first downs to 12 for Ralls, and led in penetrations, 6-3. Tahoka's total offense was 265 yards; Ralls had 203.

In addition to Wiseman's 193 yards, Matt Garcia gained 49 on 9 carries. Wes Solomon hit 6 of 13 passes for 67 yards, with no interceptions, and Chris Rodriguez caught two of those for 40 yards.

Coach Draper commended the entire offensive line for a good job, and singled out Mike Rodriguez, Cantu, Victor Herrera and Oscar Garcia for special mention.

On defense, linebacker Jesse Perez led tackling, followed closely by defensive end Reggie Moore and lineman Bobby De La Cruz. In the secondary, Clay Taylor turned in a good game.

Wilson ISD Sets Bond Election To Build New Gymnasium

The Wilson Independent School District Board of Trustees Thursday night passed a resolution calling for a bond referendum election to be held on Tuesday, Dec. 6, 1994, in the Wilson High School Auditorium. The amount of the bond election will be for \$500,000, and if passed, would help to finance building improvements for Wilson ISD, including a new high school gym.

The proposed gymnasium would meet ADA (Americans with Disability Act) accessibility requirements for access to the gym bleachers, restrooms, dressing rooms, and concession area. The site for the gym has not been determined, but it could also serve as the dressing rooms for football games. The concession area could serve for football games as well if the gym is located near the present concession area at the football stadium. Wilson's present football concession stand does not meet health department standards nor ADA accessibility standards for the restrooms, according to Superintendent Nancy Templeton.

Other building improvements would include renovating the elementary gym into additional learning centers for the elementary school. "At the present time, all classroom space in the elementary is in use. If the district continues to experience growth, there will be no room for any additional classes,"

said Supt. Templeton, noting that the extra space would allow for classes for students with disabilities.

The building program would allow the district to complete the adaptations necessary for ADA accessibility for persons with disabilities and would provide a positive environment for enhanced learning for all students in the Wilson schools, according to the superintendent. Improvements in the library and cafeteria are also being considered.

The Board will be conducting voter information meetings in the upcoming month. Questions and additional information may be addressed to board members, campus principals, or Supt. Templeton.

In other business, trustees approved a request by the FFA to attend the National Convention in Kansas City in November.

The Board voted to leave the board position created by the resignation of Tony Villarreal vacant. The position will be filled at the next regular election of school board members in May 1995.

Citizens Urged To Adopt Low-Fat Eating Plan

Lynn County citizens will get the chance to learn how to help prevent heart disease by adopting a low-fat eating plan at Heart Fest, an educational event held at Thriftway and this year at the Senior Citizens Club, Oct. 22-29. The Lynn County 4-H group will help with this event.

Heart disease is the number one killer of Hispanics. African-Americans have almost twice as many strokes, 10-18 times more kidney failure and three to five times more heart failure. "Learn how you can help reduce your risk," said a spokesperson.

Lynn County Receives More In Tax Rebates

John Sharp, State Comptroller, delivered \$134.4 million in sales tax rebates to Texas cities and counties, a 9.7 percent increase from a year ago.

Texas cities received \$120.9 million, up 10.3 percent from the \$109.6 million they received last October. Counties received a total of \$13.4 million, a 4.6 percent increase over their October 1993 rebates of \$12.8 million.

Lynn County received \$6,159.21 in rebates for October. This is a 25.93 percent increase over last year's payment of \$4,890.60.

O'Donnell received \$924.48 for October 1994 but did not receive any for October 1993.

Tahoka received \$4,683.27, down 4.23 percent from last year's payment of \$4,809.60.

Wilson received \$551.46 in rebates but did not receive any for October 1993.

Burglary, Forgery Reported

A barn burglary in which an O'Donnell area resident reported \$1,343 worth of tools and equipment stolen led the list of offenses investigated by law enforcement officers in Lynn County during the last week.

Ken Dyer of Rt. 2, O'Donnell, told officers that sometime between Oct. 8 and Oct. 12 the tools were taken from his barn near the vicinity of FM 2053 and FM 3112. Most expensive item stolen was a Miller welder and leads.

Tahoka Police officers said charges will be filed against a 32-year-old Tahoka woman accused of substituting her name as payee on two checks which she then cashed at astore in Tahoka Tuesday. The checks were for \$41.50 and \$46.50, drawn on accounts at Lamesa and Tahoka banks. The suspect said she found the checks.

Two men age 24 and 46 were jailed on charges of theft after being detained by employees at Thriftway Supermarket in Tahoka. The employes had observed the pair taking a carton of cigarettes valued at \$19 and salt and pepper shakers valued at \$2.

Mike Cranford, owner of C Bar C Barbecue, reported a cord of wood valued at \$100 stolen from his business during the last week.

In addition to the suspects in the shoplifting and forgery cases, six persons were jailed during the last week, on charges including deadly conduct, possession of marijuana under two ounces and possession of paraphernalia, failure to identify to a peace officer and speeding plus failure to appear (for Reagan County), driving while intoxicated and possession of marijuana.

City Accepts Bid For Fire Dept. Building

day night approved the lower of two bids for material to build a new fire hall and decided to borrow money from the city's own coffers to fund the construction project.

A bid from Mueller Supply Company for \$19,061.50 in building materials was unanimously approved by the council for a new fire hall to house the city's fire trucks. Partial funding for the project is coming from the \$3 per month volunteer contributions on city water bills. The remainder will be borrowed from the city's own general fund, with a stipulation to pay back the funds at the rate of interest required by law and a review every 12 months. Councilmen approved the funding process unanimously.

In other business, City Manager Barry Pittman told the council that no bids had been submitted legally for water tower improvements, and the board voted unanimously to not accept any bids. Pittman told The News that only one bid was submitted for the project and that it was faxed to the city offices, a process which is not legal for submitting bids which are to be opened at a designated time. He said that city officials would continue to look into the water tower improvement project for other options.



Hunter Education Class Set Here

A course in hunter education has been scheduled for Oct. 22-23 from 8 a.m.-4 p.m. in Tahoka Community Center. Keith Pascal will be the Hunter Education Instructor.

"According to the Texas Parks and Wildlife Department's mandatory requirements, starting Sept. 1, 1989, those persons whose date of birth is during the period Sept. 2, 1971 through Aug. 31, 1973, must have successfully completed the course in order to hunt in Texas. Effective Sept. 1, 1990, the age group affected are those whose date of birth is during the period Sept. 2, 1971 through Aug. 31, 1974 - and so on. By Sept. 1, 1993, all hunters born on or after Sept. 2, 1971, must have successfully completed the course to hunt in Texas. However, any individual may take the course on a voluntary basis and is encouraged to attend regardless of requirements,"

stated Ralph Huffaker. "The course is open to adults and youngsters and will include instructions in rifle, shotgun and bowhunting handling and safety; outdoor responsibility and ethics; laws and regulations; conservation; hunting traditions; wildlife identification; field care of game; wilderness first aid and survival," B.L. Miller said.

Students 12 years of age or older successfully completing the course will be issued a hunter education certificate from the Texas Parks and Wildlife Department. Those younger than 12 will receive a certificate of

The English Theatre will be the first theater on the South Plains to show the new feature-length Walt Disney "Snow White and the Seven Dwarfs." The picture will be here Saturday, Sunday and Monday.

"Snow White," though an animated cartoon in technicolor, is said to be one of the greatest pictures ever made, and is breaking attendance records everywhere it is shown over the nation...

Walt Disney's "Snow White and the Seven Dwarfs," which runs well over an hour, is composed of over 250,000 drawings, with a musical background provided by an orchestra of 80 musicians.

As many as 750 artists worked on the production, which has been in the making since 1934. Trustees Approve School Trips, **Audit; View New Science Lab**

Upcoming school trips for high school and elementary students were approved, the Tahoka Independent School District's annual financial audit was presented and approved, and the Board of Trustees viewed the new high school science lab, among other routine business at Monday night's regular meeting.

Trustees gave a nod of approval for several overnight trips involving Tahoka elementary and high school students, and approved monthly bills. Joe Hays of Love Hays & Reeger presented the district's audit report for the year ended Aug. 31, 1994, and told trustees the district Mason's farming and ranching was in "good shape" financially. Trustees uninanimously approved the audit as presented. ties consist of 70 acres he owns and

> All seven trustees, as well as Superintendent David Hutton, high school science teacher Cathy Box, and several other district staff, toured the newly-renovated science lab to view the new lab stations. Mrs. Box thanked trustees for providing the new lab, and said, "The district should be very proud of these new lab stations - the students are excited about doing lab experiments, and these new work stations are great." The lab renovation, approved last May, cost the district approximately \$25,000.

The board approved a textbook committee composed of several district teachers to review new textbooks up for adoption for the 1995-96 school year, including such subjects as accounting, economics, public debate, art, music, math, science and geography.


Trustee Clint Gardner was named district representative to the Regional Advisory Committee of Education Service Center-Region 17, with trustee Brad Hammonds named as alternate

The district received an additional \$9,966 in federal funds, and trustees approved a budget amendment to expend the funds in staff development, administrative supplies, nurses supplies, staff travel, and pay-

Board members received information sheets detailing each trustee's training hours, and the superintendent reported that several projects had been completed at the district, including new fences and sidewalks on the elementary campus, bus lot paving and fencing, air conditioning in the high school gym, and the renovation of the science lab. Tucking (structural repair) will be completed in November on the high school auditorium, junior high building, and the elementary gym. He noted that the district had begun teacher evaluations, and that several students would be taking their exit level TAAS tests this week.

Supt. Hutton presented a superintendent evaluation form for trustees to consider, and also provided committee minutes from the district's site-based decision making committees for informational purposes.

All seven trustees were present for the two-hour meeting. The next meeting was set for Nov. 10 at 7 p.m.





Carol Higdon, registered nurse employed by Rolling Plains Memorial Hospital in Sweetwater, and daughter of Mr. and Mrs. Archie Riddle of Tahoka, recently was bitten by a rattle nake while visiting at the home of her sister, Charlene Kilgore, near Sweetwater.

A story on the incident was published in the Sweetwater Reporter Oct. 7, pointing out that Mrs. Higdon, who has been the head emergency room nurse at the hospital for about 10 years, has seen several snakebite victims, but "now she knows what it's like to be on the table looking up at medical personnel."

"Before, I had just seen the immediate effect of a rattlesnake bite, the swelling and the bite marks. I heard patients describe the pain as 'horrible'," she said. agreeing that the word was accurate.

Remember, both the livestock producer and CRP participant must apply before grazing only. Please call the ASCS if you need additional information or to apply.

Failed Crop Acreage: Operators are reminded that any crop certified for harvest that fails and will not be harvested must be reported before plowing or destroying the evidence of the crop. This is the same rule that has applied for years. Producers are reminded to report all insured failed crops to the insurance agent before destroying evidence of the crop.






