

### Wilson School Bond Vote Planned Tuesday

Wilson School District voters will cast ballots Tuesday, Dec. 6 in a \$500,000 bond election which school officials hope will allow the school to build more elementary classrooms and a new gymnasium and to make all buildings on the campus handicapped-accessible in compliance with federal law

"The future of our young people is the main concern of the community," said a school board representative. "Passing the bond issue won't settle all our problems, but it will help us to have a better learning environment and also comply with federal mandates."

If the issue passes, the school plans to construct handicapped-accessible toilets and ramps.

Taxpayers in the district would pay an additional 11 cents per \$100 valuation if the election passes. This

### **Lynn County Commissioners Meet**

Lynn County Commissioners met Monday for a short, routine meeting, and approved paying bills including Texas Association of Counties dues of \$685. A Christmas party for county employes was also discussed. would mean a tax rate of \$1.50, compared to the current rate of \$1.39. Tax rates for persons over 65 with homestead exemptions would not be affected since their school taxes are frozen at the amount paid the year they become eligible for the exemption

A person with a home valued at \$20,000 would pay an additional \$22 per year in taxes.

### Local 'Christmas For Kids' Program Needs Supporters

With a list of 98 needy children already approved for the "Christmas For Kids" program sponsored by the Lynn County Child Welfare Board, President Janet Porterfield is seeking support from area citizens and organizations in providing Christmas gifts for a record number of needy children in this area.

Names submitted for the program are screened by the Child Welfare Board to ensure that only the truly needy receive assistance, but already the list of names has surpassed last year's all-time high number of 96 children, and there is still a two-week time period before the final deadline of Dec. 15 to submit names for the program.

Children range in ages from infant to 14, however, a sibling over the cutoff age will not be left out.

Anyone may contribute to the pro-

gram by donating money to the Child Welfare Board, who will purchase two toys and a shirt for each child, or some Sunday School classes and other organizations "adopt" a child, or a family, and purchase gifts of their own choosing for the family.

"We provide sponsoring organizations with each child's first name, age, and clothing size," says Mrs. Porterfield. "It is up to the group how many gifts the child receives."

Gifts are delivered no later than Christmas Eve. Sponsors may deliver the gifts themselves, or may bring them to Mrs. Porterfield at the Lynn County Courthouse for the Child Welfare Board to deliver.

#### Youth Reminded Of Curfew

Tahoka Police Chief Jerry Webster reminds Tahoka youth that the City Curfew for youth under 17 years of age became effective Nov. 20, and that city police are enforcing the new

Webster said his department issued nine warning tickets to youth over the Thanksgiving holiday weekend, and reiterated that parents may pick up a question-and-answer brochure about the new curfew ordinance at City Hall.

The ordinance makes it illegal for youngsters under the age of 17 to be on the streets or in public places after 11 p.m. weeknights and after mid-

night on Saturdays and Sundays, unless accompanied by a parent or guardian, or returning from a school or church-related activity, or various other exceptions which are explained in the brochure.

Violators of the curfew are issued warning citations, and repeat offenders may be issued fines of up to \$500 and be subjected to appropriate action by juvenile authorities.

### Local Pharmacist Is Also Volunteer Weather Man

For Haney Wells, a change in
Lynn County weather is not an annoyance, it's part of his job.

For the last six years, Wells, a pharmacist whose family owns Tahoka Drug, has been the co-op weather reporter for the National Weather Service. "I've always been interested in the weather," Wells said about his volunteer reporting job for the weather service.

According to Chuck McGee, program supervisor at the Lubbock Bureau of the National Weather Service, Wells is one of 13,000 people nationwide who volunteer for the coop program,

"We have a grid and try to place one (reporting) station in each box of the grid, which is about 25 miles across," McGee said. "We try to find someone in that area who is interested in weather," he explained. McGee added that most of the reporters send their data in at the end of the month, but some call their data in daily, as Wells does.

Wells said his duties consist of recording the high and low of the day from a thermometer in his yard. He also records any precipitation, snow or rain, that falls. He monitors that information from a display in his home. "I usually call in the data first thing in the morning," Wells said.


Wells said when he was younger, he filled in for Frank Hill, who reported the weather in Tahoka for 40 years, when Hill would go away for the summer. He said when the position became open in 1988, he immediately volunteered.

Although he does not intend to leave the program, Wells suggested that anyone interested in the program contact the weather service about the co-op weather program.

"We have all the reporters we need right now," McGee said about the prospect of openings. "But that may change after the program's realignment."

Under the current system, McGee is in charge of a program that covers much of West Texas and the Panhandle of Oklahoma. He said that his region will be divided into thirds with the Amarillo Bureau taking the northern third, the Lubbock Bureau taking the central third and Midland/Odessa Bureau taking the southern third.

"The station sites will stay the same," McGee said. "But the supervision will be different."

#### **Jackass Statistics**

C.S. News Service -

In the spring of 1910 the enumerators of the Federal Census Department visited every farmhouse in Lynn County and made inquiries pertaining to the various phases of our agriculture. The result of the canvases have just been published and reveal some unique, as well as interesting information. According to the reports there are 33 jackasses on the farms and ranges of this county and their total valuation is given

The jackass population of Texas is 20,408 which have a total value of \$1,720,074. Only two farms out of one hundred reported jackasses at the last census and the total number of Texas farms reporting was 8,151. The value per head is \$84.28 or \$12.47 more than that of the Texas horse. - June 6, 1913

#### Post Office Moves To Shook Building

Saturday night of last week the post office fixtures were moved from the old wooden building on the north side of the square where it has been for years to the two story brick building about 200 feet west and north on the corner of Main and Harper streets. The new location for the post office is a great improvement over the old one. It is in the lower story of the A.D. Shook new two-story brick building, facing east with a plate glass front, handsomely finished, with cement floor, steel ceiling, making it practically fireproof. The lobby is light, roomy and comfortable. In front is a wide cement sidewalk that extends around nearly three sides of the block making the post office very accessible in bad weather. Jack Alley, the post master is arranging everything so as to be able to handle the work expeditiously and accurately with a minimum amount of labor to himself and assistant. - Oct. 17, 1913

#### Founder Of News Visits Tahoka

Otis Lilly of Amarillo, who is in Tahoka today, Friday, paid The News a pleasant call this morning. Mr. Lilly is representing the Fox Typewriter now, but was the founder of The Lynn County News in 1903. Mr. Lilly, with the help of his young wife, published The News for about twelve months when his health failed and he had to sell out and move to a lower altitude. Mr. Lilly sold The News to the Boyd brothers of Snyder, who ran the paper about eight months when they mixed too much in local politics and had to quit and pick cotton for a living. The News plant was idle from October 1904 to June 1905 when the present management [H.C. Crie, editor] brought The News to life again and have managed to keep it going pretty regularly ever since. - Nov. 14, 1913


#### **Publication Outlines Options For College Scholarships**

A new academic funding publication, updated for 1994-95, is available to help step students through the process of applying for college scholarships and to outline their options and identify sources for assistance.

According to a report by the National Commission on Student Financial Aid, over \$6.6 billion of this funding goes uncollected each year simply because people do not ask it.

Yet there are over 375,000 funding sources available to assist these students. Contrary to popular belief over 80 percent of funds available to students do not depend on family need or high grades. Many are based on factors such as the student's interests, hobbies, academic focus, age, ethnic background or parent's work

This year's election for positions on the Lynn County Agricultural Stabilization and Conservation (ASC) Committee, which were to be held in December, are being rescheduled to accommodate changes brought on with last month's enactment of the law to reorganize the U.S. Department of Agriculture (USDA).

According to Larry Moore, chairperson of the Lynn county ASC Committee, the change in the election schedule is nationwide and is authorized under regulations issued by USDA. Current members of ASC committees will continue in their posts until the new election is held next fall.

The law, which reorganized USDA, created a new agency - the Farm Service Agency - which encompasses all of the commodity support and basic conservation programs of the former Agricultural Stabilization and Conservation Service (ASCS), all of the risk management programs of the Federal Crop Insurance Corporation (FCIC), and the farm lending activities of the Farmers Home Administration (FmHA).

Jimmy Woodard, CED, of the Lynn County ASCS office said the new committee system, when fully implemented, will exercise increased responsibilities in its enlarged role.

"Rescheduling the elections on a nationwide basis avoids confusion which could occur from hastily drawn rules and regulations and will create efficiencies by using funds which would have been spent on this year's election process to be used in training committees in performing their added duties," Woodard said.

portation (TxDOT) and its partners will introduce a new way of doing business to enhance the level of motor vehicle customer service they provide. Statewide implementation of the Registration and Title System (RTS) is scheduled to begin in mid-November.

"It's a total move from a manual ronment in one step," said Bob Braden, RTS Project Manager. "We're doing away with the paper forms and redundant procedures that are currently needed to process registrations and title work."

As statutory agents of TxDOT, tax assessor-collectors in the 254 Texas counties handle motor vehicle registration and title transactions and collect related fees. This work will continue at the county level. But computers will be used to enter data at the point of sale. Tax offices will be tied to a network that electronically sends

The Texas Department of Trans- the information to the Vehicle Titles and Registration Division in Austin. This method actually decreases the amount of time it takes to get current information into the system.

"It will now take two weeks to issue a title instead of ten weeks," Braden said. "RTS can also update vehicle registrations within 48 hours rather than six to eight weeks." Inenvironment to an automated envi- stant access is a powerful tool for law enforcement officers during traffic stops and other instances when they have to make an inquiry.

> The department of transportation will also provide the computer hardware and software needed for RTS. Each county tax collector has been notified about the number of workstations their offices are going to get. Distribution of this equipment was made by TxDOT, with decisions based on the number of registrations processed at each location during
