# Burglaries, Thefts, Accidents **Increase In City In 1994**

Burglaries in the city of Tahoka increased by 50 per cent in 1994 from the previous year, and accidents and thefts increased by 27 per cent, according to information released by Tahoka Police Chief Jerry Webster this week.

However, the Police Department cleared 50 per cent of (9 of 18) burglaries reported in 1994, and cleared 69 percent (29 of 42) thefts reported during the year. In 1993, 12 burglaries and 33 thefts were reported, according to Chief Webster.

Accidents in the city increased by 27 per cent, with 33 investigated in 1994, compared to 26 the previous year.

Driving While Intoxicated (DWI) arrests within the City of Tahoka decreased by 31 per cent, with 22 arrests in 1994 compared to 32 arrests in 1993.

The Police Dept. answered 2,180 calls in 1994, a 25 per cent decrease from 2,909 calls in 1993. Arrests were down by 6 per cent, with 85 in 1994 compared to 99 the previous year

Police officers issued 270 tickets last year, a 34 per cent increase from 202 tickets in 1993. Warnings issued were exactly the same both years, at 259.

And, in 1994, reserve hours worked by volunteer reserve officers totaled 470 hours (9 months), according to Chief Webster.





Throughout the year, the BBB receives many calls about dubious overseas job opportunities that are advertised in the newspaper classifieds. The appeals usually target high school and college graduates. Typical ads promise high paying jobs in interesting or exotic foreign cities, but claim little or no experience in necessary. Closer to home, other ads promise postal or government jobs all over the country. Unlike legitimate employment firms that have permanent addresses, unscrupulous employment firms usually run their operations from out-ofstate and offer applicants only a phone number or mail drop address. Job seekers should not be fooled by a firm's promise of a refund, if no job materializes. Check the company out through your BBB before doing business with them. And also check out foreign job offers with that country's consulate or embassy. Ask the BBB for a free pamphlet called "Tips on Overseas Job Scams" when you call 763-0459.

To protect you and your family against fire, here are some tips from the Lubbock Fire Marshall's office. Consider getting a smoke detector. Most fire deaths occur in the home and are caused by smoke inhalation/ carbon monoxide poisoning, rather than from heat. The Uniform Building code requires that detectors be installed in all new construction and to be wired into the electrical system of the house. We can't recommend the kind to buy, but look for the Underwriters Laboratory insignia. You will need to decide if you want a battery-operated or electrically wired or one that is wired and has a battery backup. Make sure you install them in close proximity to sleeping rooms. You also need to decide how many you need. You will also want to consider the kind of detector that has a halogen lightbulb that lights when it goes off. 


#### **Over Five Hundred Babies**

The News reporter got to looking through the birth records of Lynn County one day this week and discovered some figures that may be of interest to some of our readers. There has been four sets of twins born in this county since it was organized in 1903. The first twins on record were born to Mr. and Mrs. Walter Robinson in the town of Tahoka, Dr. S.H. Windham in attendance, March 16th, 1907, both being girls. The second pair to be recorded were born to Mr. and Mrs. Henry Fletcher of about 10 miles north of Tahoka, Dr. M.E. Miles in attendance, June 6th, 1908, being a boy and a girl. The third pair were born to Mr. and Mrs. Ira Doak in Tahoka, May 20th, 1910, both girls. The fourth pair were born to Mr. and Mrs. H.J. Henderson of 10 miles southeast of Tahoka, Dr. E.H. Inmon in attendance, Dec. 18th, 1915, both boys, one of whom weighed 5 and a 1/4 pounds and the other 6 and 3/4pounds, mother and boys doing nicely. Two-hundred-fifty babies were born between the summer of 1903 and Nov. 7, 1909; somewhere between 60 and 70 babies have been born in Lynn County during this year and the total number recorded in the Lynn County records up to date are 508. -Dec. 24, 1915





## **December Weather** Warmer Than Normal

The weather across the Texas South Plains during the month of December was significantly warner than normal.

Tahoka had an average temperature of 45.1 degrees with an average maximum temperature of 58.1 and an average minimum temperature of 32. Total precipitation for Tahoka was .37.

Temperatures averaged 3.4 deest. grees above normal and ranged from ,5.2 degrees above normal at Abernathy to 1.2 degrees above normal at Plainview.

Maximum temperatures averaged 3.1 degrees above normal and ranged from 6.3 degrees above normal at Abernathy to 0.6 degrees above normal at Lamesa. The highest temperature reported during the month was 79 degrees at Paducah on Dec. 5.

Minimum temperatures averaged 3.6 degrees above normal and ranged from 6.1 degrees above normal at Seminole to 0.6 degrees above normal at Plainview. The lowest temperature reported was 15 degrees at Muleshoe on Dec. 10.

Precipitation averaged 0.41 inch below normal and ranged from 0.77 inch below normal at Post to 0.03 inch below normal at Snyder.



## Widows May Get **Higher Benefits At 65** Anyone receiving Social Secu-.

rity benefits because they are a gwidow or widower, they may be eligible for a higher benefit when they reach age 65. This could be possible if they have been employed and, therefore, are entitled to benefits based on their own work record.

Ordinarily, one cannot change from a reduced benefit to a full benefit, but that does not apply to widows or widowers.

As a widow or widower who is entitled to retirement benefits of their own earnings, one can take reduced benefits at age 62 and receive a full widow's or widower's benefit at 65. Or, can take widow's or widower's benefit at 62 and get full retirement payment at 65.

Anyone faced with making a ecision on which benefit to take can alk to a Social Security representaive about the options available.

NOTICE The Texas Natural Resource Conservation Commission (TNRCC) is requiring the City to publish a warning concerning the nitrate level in the City's well water.

The Environmental Protection Agency's Lifetime Health Advisory level for nitrate is 10 milligrams per liter. Tahoka's well water has been testing from 11 to 13 milligrams per liter. The water received from the Canadian River Municipal Water Authority, at Lake Meredith, tests well below 10 milligrams per liter in nitrate levels.

The City's wells are only pumped during peak usage times, such as the summer months. So, in order to provide water that is within EPA level requirements, the City blends Canadian River Water with well water, which dilutes the nitrate level.

Regardless of the actions the City takes to provide water that is below the EPA Advisory Level, we are required to have the following information published.

MANDATORY HEALTH EFFECTS LANGUAGE FOR NITRATE

The Texas Natural Resource Conservation Commission (TNRCC) sets drinking water standards and has determined that nitrate poses an acute health concern at certain levels of exposure. Nitrate is used in fertilizer and is found in sewage and wastes from human and/or farm animals and generally gets into drinking water from those activities. Excessive levels of nitrate in drinking water have caused serious illness and sometimes death in infants under six months of age. The serious illness in infants is caused because nitrate is converted to nitrite in the body. Nitrite interferes with the oxygen carrying capacity of the child's blood. This is an acute disease in that symptoms can develop rapidly in infants. In most cases, health deteriorates over a period of days. Symptoms include shortness of breath and blueness of the skin. Clearly, expert medical advice should be sought immediately if these symptoms occur. The purpose of this notice is to encourage parents and other responsible parties to provide infants with an alternate source of drinking water. Local and State health authorities are the best source for information concerning alternate sources of drinking water for infants. TNRCC has set the drinking water standard at 10 parts per million (ppm) for nitrate to protect against the risk of these adverse effects. TNRCC has also set a drinking water standard for nitrite at 1 ppm. To allow for the fact that the toxicity of nitrate and nitrite are additive, TNRCC has also established a standard for the sum of nitrate and nitrite at 10 ppm. Drinking water that meets the TNRCC standard is associated with little to none of this risk and is considered safe with respect to nitrate. 2-ltc



# "The Teeth" Escapades

#### by ABBIE WHORTON THOMAS

(Editor's note: The writer is a former resident of Tahoka who, in 1944, had local dentist Dr. Kenneth Durham make her some false "freak teeth." This series is an account of her experiences.)

No Tickets For Sale On May 8, 1945, World War II was officially over, the boys were home. To celebrate the old bunch of friends decided to go to the Fat Stock Show held in Ft. Worth in February of 1946. We reserved the 4th floor of the Worth Hotel.

I went into the next room and put on a hat backwards, and a jacket belonging to Wanell Tubbs. I put in the freak teeth and then knocked loudly on the door where the bunch had gathered. Lillian McCord opened the door and I asked to see Fenner Tubbs. She said, "Come in, I'll get him." Fenner came to the door and looked absolutely speechless when he saw me. I said, "Mr. Tubbs, a man at the front desk told me you had just told him you had some extra tickets to the Fat Stock Show Matinee." Fenner said, "That was a mistake; he had two tickets and they were for him and his wife."

I said, "The man told me you had extra tickets. Why won't you let me have them? I'll pay you for them. I'm not asking you to give them to me.'

Fenner said, "Now lady, I said I didn't have any extra tickets. Will you please leave, you are interfering with our party."

I said, "You get smart with me and I'll get my husband to handle you."





The Wilson Jr. High basketball teams will play in the O'Donnell tournament Saturday, Jan. 14 and will host Southland Monday, Jan. 16.




