A talented cast of 12 Tahoka High School students gave an outstanding performance of a lighthearted French comedy, "The Imaginary Invalid" at Post last Saturday at UIL District One Act Play Contest, earning first place honors and gaining an invitation to compete in Area competition on April 8.

In addition, Tahoka captured the Best Actress award as well as boasting an All-Star cast member and an Honorable Mention to the All-Star cast. THS sophomore Abby Wells portrayed a vivacious "Toinette" in the play for which she was named Best Actress at the District contest, and sophomore Robin Martin was named to the All-Star cast for her portrayal of "Angelique." Jeremy Brandon was awarded Honorable Mention for his performance as "Monsieur Ardin."

French 17th century period costumes enhanced the casts' portrayal of characters, and the set design gave particular attention to detail, including a chaise lounge in the parlor upon which Brandon gave an amusing "fake" death scene.

Tahoka and Post were the top two winners at the District contest, with Sundown placing as alternate. Seagraves, Ralls, Idalou and Crosbyton also competed in the district meet.

Both Tahoka and Post will present their plays in Tahoka this Monday night for the public, free of charge, in the Tahoka High School Auditorium. "The Imaginary Invalid" will begin at 7:30 p.m., and Post's one-act play, "What I Did Last Summer" by A.R. Gurney, will begin at approximately 8:15 p.m.

## Fun/Food Festival Is This Saturday

The 15th annual Lynn County Hospital Auxiliary Fun/Food Festival will be held this Saturday, April 1 from 4:30 to 8:30 p.m. at the Lynn County Showbarn, offering county residents the opportunity to support the local hospital while visiting with friends and neighbors, partaking of good food, and bidding for a wide variety of auction items.

All proceeds raised from the annual fund-raiser will be used by the Hospital Auxiliary to purchase much-needed hospital and ambulance equipment.

Donated items, varying in price, will be auctioned throughout the festival, ranging from baked goods to hand crafted items to art from local artists. The Auxiliary is still accepting donations for the auction, and the showbarn will be open from 10 a.m. until 2 p.m. Saturday to accept auction items. Artists donating prints or paintings for the auction may contact the Handi Hobby who donates frames for such items.

Auctioneers will be Billy Miller and Melvin Edwards, and emcees will be Cal Huffaker, Glo Hays and Rebecca Dimak. Spotters for the auction will be Math Bartley, Denny Belew, Rex Rashi, Wesley Boone, Greg Henley, Stanley Young and Bryan Reynolds.

Food, prepared by various organizations and clubs, will also be available for purchase. The 4-H'ers will offer desserts and drinks, Phebe K. Warner Club will have homemade ice cream, Lynn County EMS will offer Hawaiian Shaved Ice, and St. Jude's Catholic Church ladies will have nachos supreme, along with the Tahoka Volunteer Firemen and Lynn County Hospital Board's all-you-can-eat fish fry for \$4.50 per plate. Carryout plates will also be available.

A silent auction will also be held, with items displayed on a table where bids may be written beside each item.

The American Heart Association will have an information booth, and

The top winners of essay contests in grades K-6 at Tahoka Elementary will have their work displayed at the festival.

A 50-cent admission at the door will give participants a chance to win door prizes during the festival.

## Wide Range Of Offenses Keep Peace Officers Busy

Thefts, burglaries, traffic accidents, aggravated assault, delivery of drugs, criminal mischief and distribution of pornographic literature were among a wide range of incidents reported to law enforcement officers in Lynn County during the last week.

A collision Monday at the intersection of two county roads 5.1 miles north of Wilson sent a 69-year-old Slaton man, Andrew Kitten, to St. Mary of the Plains Hospital in Lubbock for treatment of apparent serious injuries. Kitten was driving a 1989 Ford pickup which was involved in a collision with a 1981 Chevrolet pickup driven by Arturo Valdez, 18, of Wilson. Valdez and a passenger, Sophie Valdez, 42, declined treatment of apparent minor injuries.

A 1990 Chevrolet Corsica driven by Errin Dee Etheredge, 18, of Lubbock, struck a Lynn County line sign 6.2 miles south of Slaton Saturday afternoon. The driver and a passenger, Greg Steger, 21, of Lubbock, declined treatment of possible injuries.

In another accident 4.3 miles northeast of Wilson on FM 400, a 1979 Chevrolet pickup driven by Ysidro Rodriguez, 20, of Wilson overturned. The driver and two passengers refused treatment of apparent minor injuries.

Gene Munoz of Tahoka reported to police that someone took about \$195 in cash which he had left lying on a clothes dryer during a party at a residence on N. 7th St. Friday.

Jackie Gutierrez of Tahoka reported that someone had scratched paint on both sides of her Pontiac LeMans while it was in the driveway (See **POLICE REPORT**, page 3)

Incumbents Leland White and Harold Barrett have filed for re-election, and Mike Rivas filed as a candidate for the Board.

Four places will be filled at this year's election, two of which are three-year terms, and two are one-year terms.

Candidates may obtain filing forms at the Lynn County Hospital Business Office. The election will be held May 6.

**Severe Weather Spotter Training To Be Offered**

A free class for training people as volunteer storm spotters will be offered at O'Donnell school cafeteria next Thursday starting at 7 p.m., it was announced this week by Robbie Roberson of Tahoka, Emergency Management Coordinator for Lynn County.

Any interested persons are invited to attend the session, which will feature a new tornado video—different from the one shown in previous years' classes in Wilson and Tahoka—and new spotter training slides.

Next Thursday's session is sponsored by the National Weather Service and the O'Donnell Volunteer

Fire Dept. "We're already into the severe weather season," said Roberson, "and all of our communities need volunteers trained to help spot the storms. The weather service says it really appreciates the time and dedication of all the firemen, law enforcement officers, amateur radio operators and citizens who help spot the severe storms."

Persons who attend the training and are willing to help spot storms will be part of the "Skywarn" system.

Larry Vannozi, Warning Coordination Meteorologist for the NWS, will conduct the training session.

**Last-Minute Signups Add Candidates To Elections**

Several candidates filed for places on city and school elections throughout Lynn County last Wednesday afternoon before the 5 p.m. deadline, after the *Lynn County News* went to press at noon, although one city election did not draw enough candidates to fill the positions open for the May 6 election.

Only two candidates filed for three places on the Wilson City Council, both being incumbents. Victor Steinhauser filed last Wednesday, joining Donald Klaus in his bid for re-election. Write-in candidates may apply for a position on the ballot by filing a declaration of write-in candidacy at Wilson City Hall no later than April 5. According to election code rules, a write-in vote may not be counted unless the name written on the ballot appears on the list of write-in candidates.

In Tahoka, the City Election will not be a contested race, with incumbent Mike Mensch and John Chapa, Jr. filing for two places on the City Council and Mayor James A. Solomon filing for re-election as mayor. Mensch filed for Precinct 3 and Chapa filed for Precinct 1. Only those registered voters residing within the newly-drawn precincts 1 and 3 may vote for the council positions, but all registered voters within the city of Tahoka may vote in the election for mayor.

Two more candidates filed in the O'Donnell City election, bringing a total of four candidates for three places on the City Council. Brian Snellgrove and incumbent Billy Edwards filed last Wednesday, joining incumbent Joylene Roye and Max Mendieta for the race for the council positions.

No new information was available on the New Home City Election, where incumbents LeRoy Nettles and Jimmie Kieth are both seeking re-election on the City Council, and Mayor J.A. Evans is also seeking re-election to that position.

Several more candidates filed in school elections last Wednesday, and one candidate withdrew his name from New Home's election.

Larry Durham withdrew his candidacy for trustee on the New Home ISD Board, but Andy Maeker filed for candidacy, joining incumbent Mark Clem and candidates Mike White and Rick Clem in the race for three places on the board.

In Tahoka, two more candidates filed last Wednesday, making contested races in all three precincts up for the school election this year. David Chapa added his name to the list of candidates in Precinct 1, joining Pam Dunlap, Eddie Joe Hancock and incumbent Juanell Jones in a race for one seat on the board. In Precinct 2, Freda Jeffcoat added her name as a

candidate, joining Joe Calvillo and incumbent Myrtle White in that race for one seat on the board. And in Precinct 5, Gary Stennett and Carmen Chapa are vying for one position on the board. Only registered voters residing within the newly-drawn precincts 1, 2 and 5 may vote in this year's school trustee election. A map showing precinct lines may be viewed at The Lynn County News or the TISD Superintendent's Office and the School Business Office.

Eight candidates have filed for three places on the Wilson ISD Board of Trustees, with two adding their names to the list last Wednesday. Rickie Yowell and Lester Gicklhorn filed for candidacy Wednesday, joining incumbent Roy Isham, Carla Gicklhorn, Janie Zavala, Douglas Bolyard, Gates Compton and Ron Burton. Cumulative voting will be used in this year's trustee election, with voters allowed three votes which may all be cast for one candidate if they so choose.

The O'Donnell School Trustee election remains the same as reported last week, with five candidates vying for three places on the board. Glenn Morton, Danny Willis, Manuel Gutierrez and incumbents Travis Mires and Kenneth Dan Vestal have filed in that election, which will also use the cumulative voting process.

Early voting for these elections will be conducted April 17 through May 3, with election day slated May 6.



### Cotton Marketing Workshop Set April 6

The Texas A&M Agricultural Extension Service will present an intermediate cotton marketing workshop April 6. This workshop is designed to help farmers evaluate alternative pricing strategies for their 1995 crop, and it is designed for those with some experience with futures and options.

The workshop will begin at 9 a.m. and end at 4 p.m. with sandwiches provided for lunch. The registration fee is \$20 per person, and participants can pay at the door. Couples may attend and pay only one registration fee if they share a computer. The workshop will be held at the Texas A&M University Agricultural Research and Extension Center in Lubbock.

Dr. Carl Anderson, Extension Economist and professor of agricultural economics at Texas A&M University, will provide an in-depth analysis of the 1994-95 crop as well as how the 1995-96 crop situation could develop.

Dr. Jackie Smith, Extension

Economist and Marketing Specialist at the Texas Agricultural Extension Service here, will present a review of options including a simple computer program to estimate theoretical premiums. The stand-alone program will run on any IBM compatible computer and will be provided to all participants.

### Boll Weevil Traps Available

Area cotton producers will be able to obtain boll weevil traps from Plains Cotton Growers to track weevil activity on their farms.

The best fields to select for trapping would include those that were infested last year, those near overwintering habitat and especially in early planted fields. Traps would need to be placed in fields around the time of planting and remain in service for ten weeks.

Each trap set will cost \$12 and will include four traps, four poles, 20 pheromone and eight kill strips. It is recommended that at least four traps be placed per field.

All information from weekly trap catches will be recorded on forms provided by the PCG. This information would then be forwarded to the county extension agent. This will allow a cooperative effort to track the cotton boll weevil across the South Plains.

Any person interested in ordering traps should obtain an order form before April 11 at the Lynn County Extension Office at 1600 Ave. J in Tahoka.

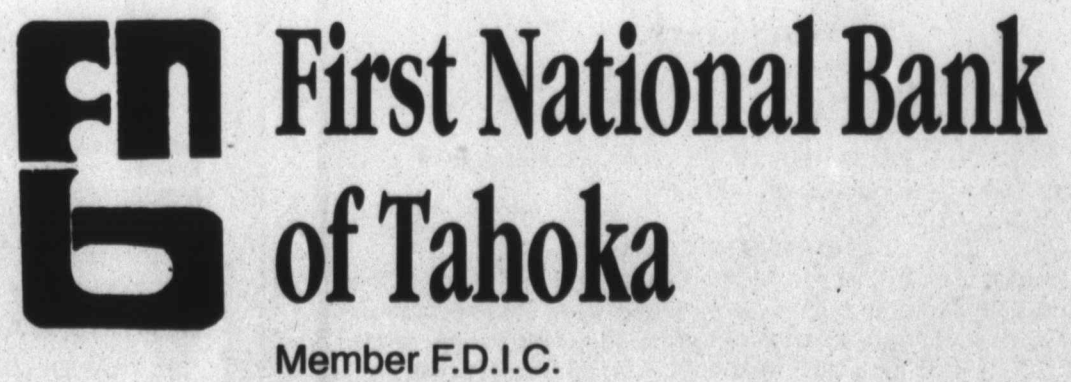
