Sundown Outlasts Bulldogs 34-21

Sundown eclipsed any bright hopes Tahoka had for a winning season last Friday, as the Roughnecks came back with two touchdowns in the last half to beat the Bulldogs 34-21 in a really good football game.

"We played really well," said Coach Darrell (Tooter) Draper. "But they just kept pounding at the middle and held us off in the last half."

Tahoka scored three touchdowns in the first quarter, but couldn't score after that. The game was tied 21-all at halftime.

Tahoka drove inside the Sundown 10 just before halftime, but a field goal try was unsuccessful.

Steve Wiseman, Bulldog tailback, ran 8 yards for the game's first score. Sundown answered with touchdowns by Jesus Martinez and

José Bocanegra. Still in the first period, Wiseman ran 15 yards across the goal line and Mike Rodriguez kicked the second of his three extra points. Tahoka went up 21-14 as Monty Hale ran 47 yards to score.

In the second quarter Sundown tied the game as Jason Holdman ran 17 yards for a TD and Bocanegra kicked the point. Bocanegra scored on runs of 5 and 7 yards in the third quarter to put Sundown ahead for good. There was no scoring in the fourth period.

This week the Bulldogs, now 3-5-1 for the year, will try to get one more win as Crosbyton comes to Tahoka for the final game for both teams. Sundown and Seagraves will represent the district in the playoffs if Seagraves beats Post Friday.

Thefts, Wrecks, Death Of Child Investigated By Officers Here

Two traffic accidents in Tahoka, thefts, vandalism and assault incidents and the death of an 18-month-old child were among reports keeping law enforcement officers in the county busy during the last week.

Pedro Jeremiah Fuentes, son of Rachel Rodriguez Fuentes of Tahoka, was pronounced dead at 2:21 p.m. last Wednesday, Nov. 1, at Lynn County Hospital. His mother had called 911 at 1:55 p.m. to report that the child was having trouble breathing.

An autopsy was ordered to determine the cause of death, and investigation of the incident is continuing, according to Tahoka Police Dept.

Police investigated two traffic accidents, one on Sunday afternoon at the intersection of Lockwood and Ave. L in which a 1982 Pontiac driven by Elizabeth Lopez, 18, was in a collision with a 1991 Volkswagen driven by Welch Flippin, 76. Both drivers are residents of Tahoka.

At S. 2nd and Ave. L last Thursday a 1977 Ford station wagon driven by Maria Autry, 29, of

Tahoka, and a 1986 GMC Jimmy driven by Jesus Ramirez, 26, of Littlefield, collided. There were no injuries.

David Fell of Tahoka reported that someone scratched the paint on his car while it was parked in the 1600-block of Ave. K Tuesday.

A 90-year-old O'Donnell woman reported that \$150 had been stolen from her purse at her home. She said she had let two boys into her home on Sunday, Oct. 29, and missed the money later. She said one of the boys returned the next day and gave her \$4 and said he was sorry for taking her money. He also said that he took only \$4. A sheriff's deputy talked with the parents of two 13-year-old boys and the case has been referred to the juvenile probation office.

Four barricade flashing lights valued at \$80 were reported stolen last Tuesday or Wednesday about a mile south of the Lubbock County line on FM 1730 in Lynn County and from a location on a county road north of FM 211.

"For My Country, I Would Do It All Again"

Local Vet Recalls Difficulties Of Life After Vietnam

When Rudy Fuentes and his fellow soldiers heard the announcement that the plane was about to land in Vietnam, everyone became completely silent.

He assumed they were all thinking the same thing he was: "How will I get home?" Fuentes had no way of knowing if it would be on his own two feet, or in a body bag.

Over twenty years later, Fuentes feels he owes it to those who did not survive to speak about his experiences, as Veteran's Day approaches this Saturday.

From 1971 to 1972 Fuentes served with the F Troop, 9th Cavalry 12th Combat Aviation Group in Da Nang and Bien Hoa.

Fuentes knew he was going to be drafted to serve in Vietnam, so he joined the army straight out of high school. He hoped by volunteering he would be able to choose what job he

did. Also, Fuentes could not afford to pay for college, so he hoped that the military could assist him in that pursuit.

Fuentes always wanted to be an accountant, but in the army he was trained to repair helicopters. His duty in Vietnam was to keep the choppers flying, and he said he still loves to hear the sound of a helicopter, and the sight of military helicopters flying in formation.

Fuentes took his physical in Amarillo and left immediately for basic training at Ft. Ord in California, without ever getting the opportunity to say goodbye to family and friends. He joined the army right after the incident at Kent State University, and said he briefly wondered if he was doing the right thing. But as a young soldier told he was helping stop communist aggression, these thoughts quickly evaporated from his mind.

After basic training, Fuentes was

given 30 days leave and remembers he did not want to go to Vietnam, but knew it was his duty to do so. The minute he stepped on to Vietnam soil, his life had changed forever.

Fuentes would spend the next 369 days in Vietnam. Looking back, he said the year seemed to go by quickly, although much of the time was spent in routine monotony.

"I lived one day at a time, never knowing if I'd make it to the next day," Fuentes said.

One of his few fond memories was receiving a Christmas package from the Tahoka Chamber of Commerce, which he said lifted his spirits immensely.

Fuentes was promoted to E-5 before his tour of duty ended. He served his country honorably and was awarded the bronze star and the army commendation medal, among others. He spent his last few days in Vietnam celebrating the fact that he was returning home alive. Unfortunately, he would leave Vietnam in the same manner that he left Tahoka, without ever getting the opportunity to say goodbye to friends left behind.

Fuentes was afraid to return to the United States when his tour of duty ended. After spending over a year in a war zone, he did not know how easily he would readjust to civilian life. He served the remainder of his enlistment at Ft. Riley, Kansas.

When Fuentes returned to Tahoka he worked for over two years at Reese Air Force Base, and then became the water and waste water superintendent for the City of Tahoka. Fuentes held this position for about 15 years, but was unable to continue due to an injured shoulder.

When he returned to Tahoka, Fuentes did not immediately feel like he was home. "I was not the same shy, timid kid who left. I was completely different," he said.

For a while he questioned why he survived, and thought that the soldiers who were killed in Vietnam were the lucky ones. He did not like to talk about his experiences in Vietnam, and wanted to leave it in the past. Fuentes says he turned to drinking as a way to cope with his feelings.

Later, he began to believe that God's will was leading his life, and God had a plan for him. He also said that the Veteran's Administration helped him cope with life after the Vietnam War, and assisted him to quit drinking. But sometimes, even

now, lightning, thunder, and fireworks can trigger flashbacks, he said.

One of the reasons that Fuentes believes many Vietnam veterans had a difficult time readjusting to civilian life is because units did not go in to Vietnam and leave Vietnam together. Instead, people were rotated on an individual basis, and soldiers did not know if their friends made it out.

Fuentes said he still looks back at the Vietnam War with some bitterness. He believes that the United States should have taken over North Vietnam, and believes that the military was being held back from winning the war. However, he said he was impressed with how well the American military performed in the Gulf War, and said that was an example of how this nation should fight wars.

"War should always be avoided," he said. But he believes if a nation is going to commit its soldiers' lives to war, then the war should be conducted as quickly as possible, and there should be no restrictions there like

were in Vietnam.

As far as the Vietnam war protesters are concerned, Fuentes said that wars will always generate protesters. It must be remembered, he stressed, that the military exists to fight and win wars, not for other services such as providing a free education. People will always lose their lives in war, he said.

Fuentes said that over the years the image of the Vietnam veteran has changed, as people have begun to study it in a historical context and learned more about what really happened. There is no longer really a negative stereotype associated with the Vietnam veteran, he said.

Fuentes is now studying accounting at South Plains College, once again working toward his original goal. Fuentes was the original president of the now defunct local VFW chapter, and says he would like to start it up again. He said it is difficult to get Vietnam veterans to go, but he hopes they can continue the VFW tradition that World War II veterans have established.

Looking back at his military service, Fuentes said that the army taught him how to follow orders and how to work as a member of a team. His old unit has never had any reunions, but he says he would attend if there was

one. When Fuentes is with other Vietnam veterans, he feels a sense of belonging, even if war experiences are not discussed.

Fuentes said that, in a sense, he celebrates Veterans Day every day by flying the American flag in honor of Americans killed in all wars. He is proud to have served in the honorable tradition of the United States military.

"I just know we did the right thing, I have to believe that, all veterans should. Looking back, I feel like I did my part," he said.

Fuentes said that Veteran's Day should always be commemorated. He sums up his feelings about the subject by stating, "I'm proud to be an American. For my country, I would do it all again."

Missionary Abductions Reported In Letter From Africa

(Editors Note: This is the last of three articles from information taken from a letter written from Terry and Twylia Bell to his parents, Mr. and Mrs. Lindell Bell of Tahoka. Terry and his wife and children, Amanda (6) and Lance (3) are in Africa to study the culture and learn the Swahili language, along with several other missionary families. The Bells are preparing for missionary work in Tanzania, East Africa. Terry, 36, is a graduate of Tahoka High School.)

Finally came our day of travel to mission meeting. Twylia and the others had to leave so much earlier because of scheduling with the plane, but they stayed occupied during those days and did not seem to get bored in Iringa. Terry knew what kind of day was ahead in terms of driving, so we left around 6:30 a.m. Monday morning. We were in for 12 hard hours of driving the roughest road I have ever seen. We (Terry, Timothy, Scotty, Andrew and I) only traveled 552 kilometers (342 miles) during that time span, which did not include the time for lunch. If you figure that up, you will see that we averaged 30 mph.

Mission meeting began Tuesday night with a time of worship and prayer. This continued throughout Wednesday. Thursday through Saturday were business meeting days, but we had a devotional each morn-

ing and worship each night. A pastor from Louisiana was the guest speaker for the worship times and he was very good. It was nice to worship in English that week. Sunday morning was Sunday School and worship and then that night was a banquet. The theme was "Christmas in July." The meal was chicken and dressing with all the trimmings. Missionaries from each station in each section of the country did a Christmas song or variation there of. We closed that night as well as the meeting by collecting the mission offering, which was a combination of the Lottie Moon Christmas Offering, Annie Armstrong Offering, and an offering for national home missionaries in Tanzania.

I know this had gotten long, but I thought it might be interesting. I do want to add this next event that I believe you all should know about. From what we understood, we thought you would have heard about it on some type of news report and may have by the time you get this letter. It is about the abduction of five of our missionaries in Tanzania. This occurred the following weekend after mission meeting (Aug. 5&6). David and Millie Mooreland, the pilot; Bill and Sandy Harrington, the doctor at Kigoma, and their daughter Christine; and Joanna Giddens, daughter of Ed and Nancy Giddens, were traveling from Dar es Salaam, on the

coast, to Iringa. The had pulled over for a rest stop when three men pulled up and forced all but Bill back into the Patrol. Bill had walked further out into the bush, so they did not see him. They drove off and headed back toward Morogoro. Bill was able to flag a car down to help pursue them, but they were unable to find them. They gave them a sedative so they would go to sleep and then drove off with the Patrol. The abductors did threaten their lives verbally, but actually did very little physically (David was hit across the face with something). This all occurred between 1:30 and 4:30 Saturday afternoon.

In the meantime, Bill contacted the Morogoro police and began a search for them. Contact was made quickly throughout the country via shortwave radio, which every station has, and several of the men in the mission who were reasonably close to Morogoro came there to help in the search. The search continued through the night. The Patrol was found later that night, wrecked with one of the abductors, who was driving it, dead.

There is another pilot stationed in Iringa, Mike Cannata, who realized that he could use the plane the next day to search for them if they had not been found by then. Only one problem had to be overcome. The area where they believed the five were in is a restricted zone for flying, therefore he would have to get permission from the government to fly there. He called the U.S. Embassy in Dar es Salaam that night around 8 p.m. to see what they could do and by 11 p.m. permission had been granted. Mike left at daybreak Sunday morning to begin searching. The others were also still searching on the ground. When Mike arrived, he realized very quickly the immense size of the area and the difficulty of trying to spot someone on the ground in the bush. He asked the Lord to show him where to look and within 10 minutes he spotted them. This was at 8:20 a.m. Sunday morning. He eventually led someone to them and they were safely taken home. Unfortunately, some of the men continued searching until the middle of Sunday afternoon because no one knew where to find them or did not have any way to communicate to them that the five had been found.

I left out a lot of details, but I did not want to type several more pages. Many of these details are about how God worked through this whole situation. He was constantly protecting and guiding everyone involved. Some

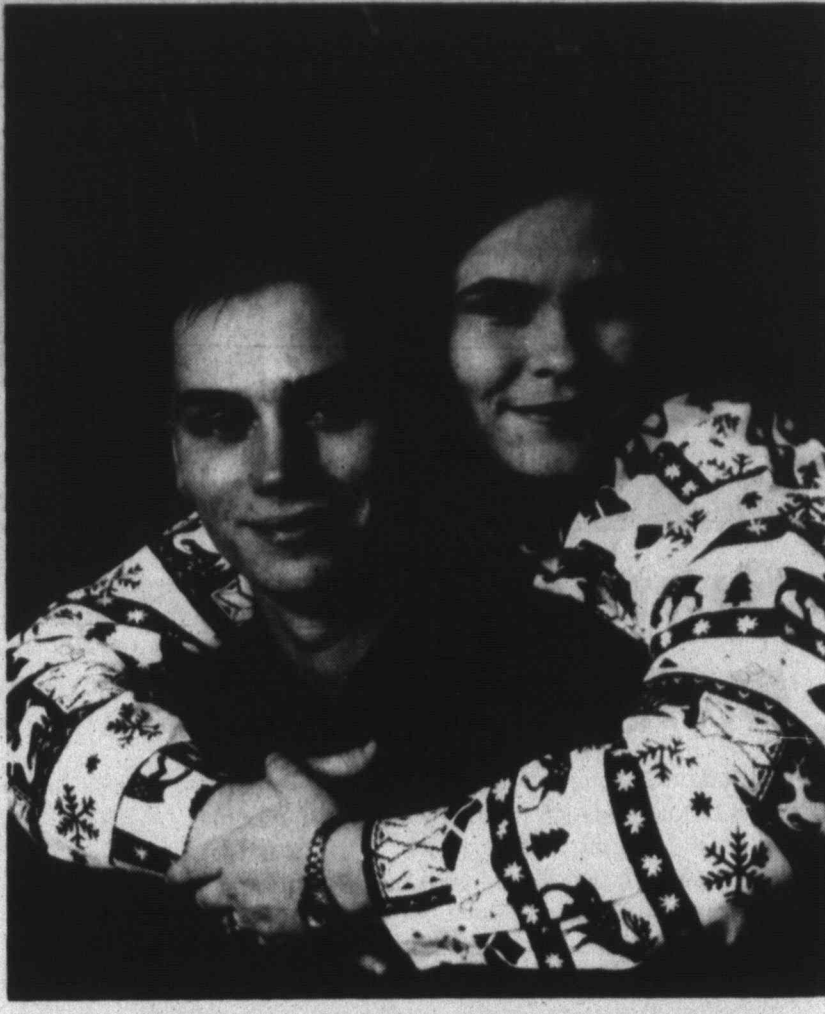
unusual methods and timing in communication occurred within the country, across the border to Kenya, and throughout the U.S. A major prayer network was quickly setup in the States during those hours. We can wonder why this event happened, but the more important result is that God accomplished a purpose in His plan for these people's lives that will grow their relationship with Him. Now, I do not want you to begin worrying about what might happen to us just because of this incident. As evidenced in Oklahoma, anything can happen anytime and anywhere. Please keep trusting in Him.

We did return to Tanzania on the following Tuesday afternoon via Kenya Airways. The mission wanted everyone to come to Dar es Salaam for a time to recover from the incident. The six people involved plus everyone else who helped in search and rescue related their experiences in the incident, therefore an accurate and complete story was put together for all of us. A lot of time was spent in prayer and encouraging the six. We were also challenged to be aware of how God wanted to use this incident in each of our lives, because we were all involved in some way. A person from the U.S. Embassy (which was involved from the beginning) made us aware of things to do in the future to make ourselves less vulnerable. It was a very good 2 1/2 days of being involved with the mission in an environment completely different from the mission meeting of the week before.

Dar es Salaam is currently capital of Tanzania, but the capital is suppose to be moved to Dodoma. This is a coastal city with all of the ingredients of a tropical climate and vegetation. Of all the places we have been in Africa thus far, it was the warmest. They held the meeting at a nice hotel right on the beach, so we could view the sun rising over the Indian Ocean each morning from our room. The beachfront was relatively small, but it was white sand and clean (aside from some seaweed, but still better than Padre Island). The water was shallow enough so that at low tide, we were able to walk about 200 yds further out before actually being in the water.

Well, I think I better bring this short letter to a close. I have enjoyed relating all of this to you.

Gel Ice Packs
Gel freezable ice packs are effective and easy to use. They remain flexible when frozen and provide more cooling since they conform to the body. Store the gel packs in the freezer until needed, they will be ready to use immediately. In an emergency even a bag of frozen peas can be used. Since packs may be colder than regular ice, be sure to wrap the pack in a thick cloth to avoid harming the skin. Apply the pack for no longer than 20 minutes at a time, longer than that may damage skin and nerves. Beware of punctures in the pack, since the chemicals in some can burn the skin.

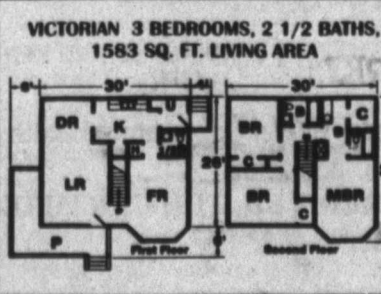

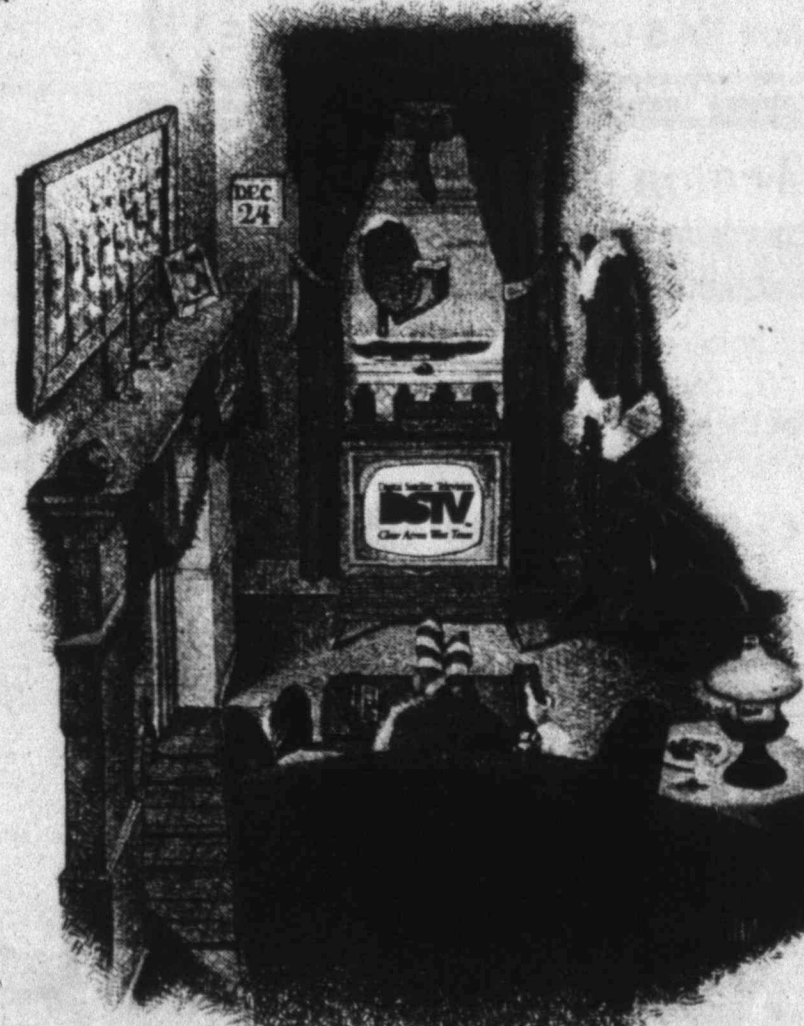

City Sets New Fee Schedules

Tahoka City Council members Monday night unanimously approved a new fee schedule for city fees regarding water meter hookups and deposits, sewer taps and gas inspection fees, increasing all but one of the fees in an effort to be more in line with what other cities are charging, according to City Administrator Jerry Webster.

"We're trying to recover our costs on all of these fees," said Webster, noting that except for a \$10 increase in water deposit fees in the last 15 years, none of the fees had increased in at least that many years. "These fees have never included labor costs, but now with increased costs in supplies and labor, we have to at least try to recover our expenses in providing these services," he explained.

Water deposit fees were raised from \$25 to \$75, and a sewer tap fee was raised from \$40 to \$125. The fee for putting in a residential water meter increased from \$50 to \$125, and for commercial water meters from \$125 to \$200. Gas inspection fees, which was a mere \$2 charge, will now be \$25.

The only fee which remained the same was a \$40 fee for street cuts.

"We have been extremely low on these fees for years, and this new fee schedule is much more in line with what other cities are charging, and in fact still lower than many other cities," said Webster.

The Council also adopted the Uniform Building Code for the State of Texas for determining fees for building permits, which will be based on property valuations as set forth in that schedule.

City Attorney Cal Huffaker gave an update to council members on the Extended Local Calling ballot which will be placed before Tahoka GTE customers within the next two weeks. A sample ballot is printed in this week's, and the next several issues, of The Lynn County News. City authorities are encouraging citizens to vote "yes" for the proposal which would allow toll-free calling to and from Lubbock, Brownfield, Lamesa, O'Donnell and Post at a cost of \$3.50 per line per month for resi-

dential customers, and \$7 per line per month for businesses. Ballots will be sent to local GTE customers through the mail, and if 70 percent of those returning their ballots vote in favor of the option, the service will be established for all customers.

In other business, the council approved a joint resolution and Ordinance 11-95A establishing a Lynn County Emergency Management Organization, and approved monthly bills. Police Chief Randy Smith gave a report on the police department's activities during the past month.

Present at the monthly meeting were council members Mike Mensch, Jay Dee House, Ray Box, and John Chapa, Jr., as well as Webster, Mayor Jim Solomon, Huffaker, and Smith. Councilman Todd Henry was absent.

The JV team ended their season 8-6.

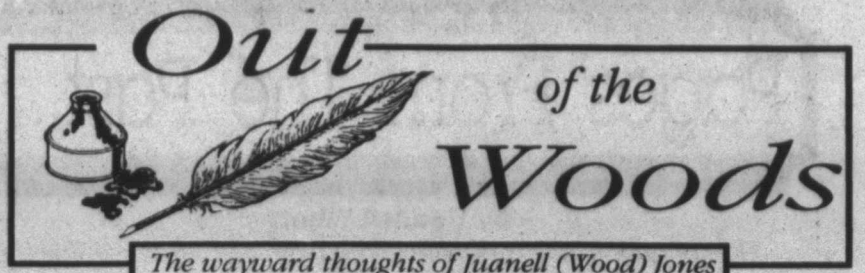

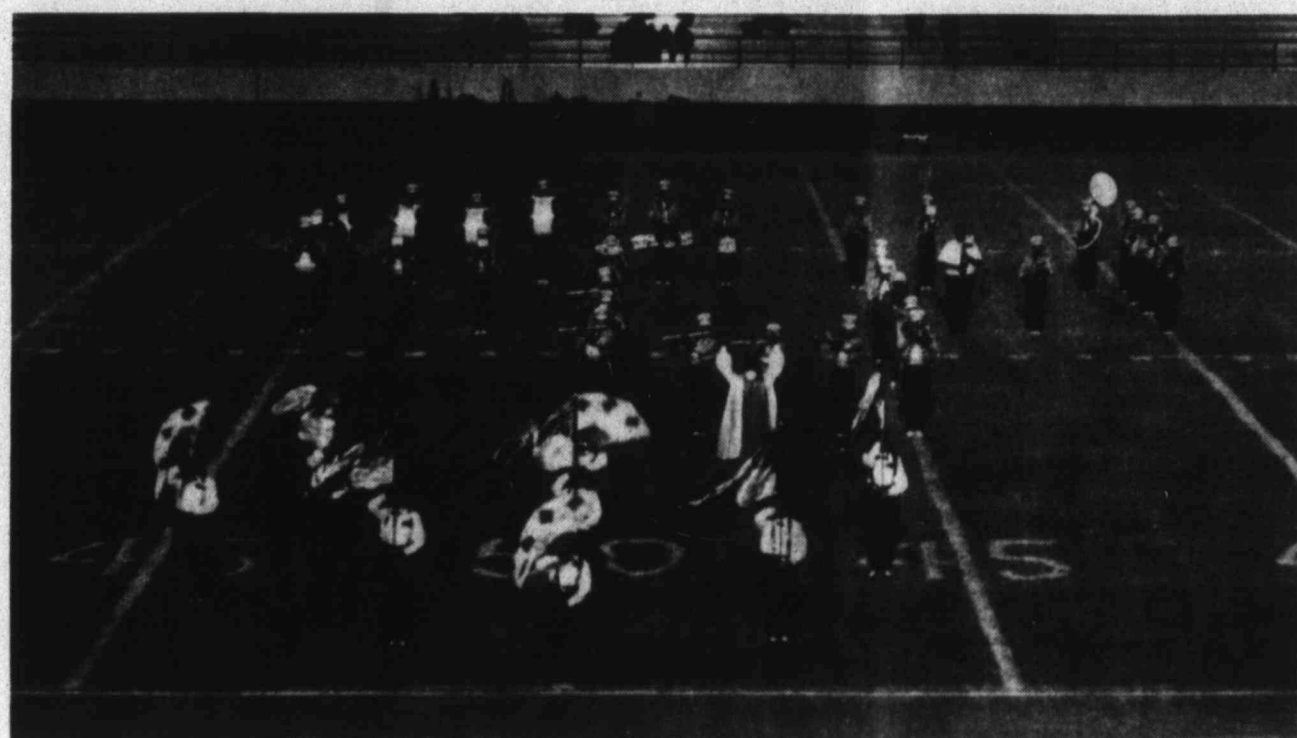

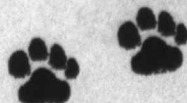
