# **Ballots On Toll-Free Calls Fouled Up; New Ballots To Be Mailed**

Tahoka telephone subscribers received ballots on proposed expanded local calling, toll-free to several area exchanges, last week, and many phone users in the 998 exchange probably have already mailed their ballots back. If so, they'll be asked to do it again.

In an error attributed to the telephone company, the ballots included names of six exchanges for expanded calling, instead of five as they were supposed to. Telephone users in Tahoka are supposed to vote on service allowing toll-free calls to Lubbock, O'Donnell, Brownfield, Lamesa and Post, and if 70 per cent or more of the ballots returned favor direct calls to those cities, a fee of no more than \$3.50 per month will be added to residential phone bills, and no more than \$7 per month for business phones.

The ballots mailed out last week included the name of Southland, making six exchanges for possible expanded calling. However, six additions of exchanges would cost an extra \$1.50 per month on the phone bills, while adding one, two, three, four or five would cost only the \$3.50 per month for residential users. And besides, said Cal Huffaker,

attorney for the City of Tahoka. which had requested the ballot, Southland was not supposed to be on the ballot anyway, since Southland has not been approved by the Public Utilities Commission (PUC) to

Ballots already mailed will not be counted, and those who have the ballots including Southland who have not mailed them back are asked to disregard them. Huffaker said Tuesday that the phone company indicated that the new ballots should be mailed on Dec. 13, 14 or 15. The deadline for returning the ballots will be 15 days from the postmarked date, he said. The new ballot should be just like the first one, except Southland's name is not on it.

The ballot, headed "Tahoka Project No. 14636", should be completed by marking "yes" or "no" next to the five exchanges listed, as well as a signature and phone number of the person completing the ballot. Ballots must be returned by mail.

If 70 percent of those who return ballots vote "yes" for Expanded Toll-Free Local Calling (ELC), then the toll-free service will be provided to all Tahoka customers at a maximum charge of \$3.50 per line per month for residences, and \$7 per line per month for business lines.

Although the ballot provides a space next to each of the five cities listed, enabling customers to choose which exchanges they want in the service, the monthly cost is the same whether one or five exchanges are marked.

Tahoka city officials, as well as many local business owners, are urging Tahoka GTE customers to vote "yes" for all five exchanges listed on the ballot. "We want to make it clear that we can get toll-free calling to and from all five exchanges - Lubbock. Brownfield, Lamesa, O'Donnell and Post - for one low monthly fee of \$3.50 for residents. Why vote for just one city, when you can get all five for the same price?" said Tahoka Mayor Jim Solomon.

After completing the ballot, Tahoka GTE customers may either return the ballot by mail in the envelope which will be provided with the ballot (no postage necessary), or may take their completed ballot to Tahoka City Hall, 1612 Lockwood.

Once approved by voters, it should be noted that ELC service will not be a per-line option for customers to choose, but will be provided for all Tahoka customers across the board, at the monthly fee stated.

THANKSGIVING is over, Christmas is approaching too rapidly, and what many of us will get for Christmas is a nasty cough and head-splitting cold. Quite a few around us already have theirs.

Each year I write a column on colds, usually when I have one, but thankfully at this writing, I don't have a cold. Granted, I have been stopped up by cotton dust at times, but no cold yet, although two or three members of my family have had colds.

Science has made some great strides in medicine and other areas, but still there is no way to cure a cold. There are things you can do to help prevent a cold, like moving to the moon for the winter, washing your hands, and some other things of doubtful but possible value, such as massive doses of vitamin C.

You should not touch anyone who has a cold, nor should you use the phone they have just used or anything else they have touched in the last few hours. And if they sneeze in your face, you should kill them, which won't help you any, but might protect future generations. And if you do touch things they have used, go wash your hands with soap before you touch your hands to your own mouth or eyes.

I washed my hands so often during the last couple of weeks that I felt like Pontius Pilate. However, my actions may have done more good than his.

Once you have a cold, there is no cure. You just have to live in misery for at least a week, usually longer. In my own case, a cold lasts about six weeks, and my colds hurt more than anybody else's (hurt me more, anyway). Doctors no longer give shots for colds, except at the insistence of the patient. Chicken soup and aspirin are about as good as anything they can give to relieve the suffering.

Dr. Lonnie Vickers told me several years ago when I had one of my colds: "I can give you some things to take and you'll get over this cold in about two weeks. Or I can not give you anything and you'll still get over it in about two weeks."

I wish somebody smart like Dr. Red Duke or Bill Gates would come up with a pill you can take after you get a cold and you'll be completely well in 12 hours. Anybody who could do that would do a great service to mankind and also make about 90 zillion dollars.

I'm a great fan of columnist Dave Barry, and here's what he has to say about colds:

Some people think the way to avoid colds is to eat a lot of vitamin C, something on the order of nine billion pentagrams a day. My wife believes in this approach. She's always choking down vitamin C pills about the size of toaster ovens. She gets colds anyway. My approach is to drink large quantities of beer. It seems to work. Since I started drinking large quantities of beer, I have not had one cold that I remember clearly.



## **Tahoka Citizens Must Now Dial Seven Digits Locally**

Beginning November 30, GTE customers in Tahoka will need to dial all seven digits when making local telephone calls within the Tahoka serving area.

The implementation of seven digit dialing may require modification or re-programming of some telecommunications equipment such as fax machines, speed calling, PABXs, key systems, automatic dialers and other equipment that may restrict or automatically dial long-distance numbers.

As of 12:01 a.m. Thursday, November 30, GTE is implementing new electronic equipment in the Tahoka area. "Because of this, several new calling features will become available and seven-digit dialing of local numbers becomes a necessity," stated Larry King, Area Manager -Customer Operations for GTE's

Plains District. New calling features that will be available include Calling Number ID (CNID) in which the incoming caller's number is shown on a CNID unit (a phone or phone attachment with a display window) if the call originated in the local calling area. The CNID units are available at stores specializing in communications equipment or from GTE. Other services that will be available are automatic busy redial, automatic call return, call block, special call acceptance, special call forwarding, VIP alert, call tracing service, call waiting, cancel call waiting, call forwarding, speed calling-8, and three-way calling.





At the time when much is being written and said about individual property rights, producers are reminded that CRP owners have property rights also. Producers are encouraged to talk to their neighbors about the boll weevil problem, before going out and burning their grass. If a producer has the CRP owner's permission to burn their grass, they should consider the following points:

1) Many acres planted to grass are on very fragile soils and burning in February is too early. The grass can be burned in March, before the grass greens up, and still kill the weevil without causing any damage to the grass or creating a blowing problem.

2) CRP owners and producers are reminded that if the grass was burned this past spring, it is not necessary to burn the grass again this spring. The grass needs more than one year to produce enough litter for the boll weevil to overwinter in.

3) CRP owners should get a statement from their neighbor releasing them (CRP owner) from liability, if

damage to houses, barns, fences, utility poles, etc.

4) Producers who have permission to burn CRP grass must be aware of wind direction and speed. Burning grass in a high wind is unsafe and also the grass burns too fast to kill the weevil. If the wind is out of the wrong direction, the producer could put smoke on a road and cause an unnecessary tragedy

5) CRP owners who wish to burn their grass should contact the Farm Service Agency first. CRP contracts must be modified prior to a prescribed burn, but the Farm Service Agency must request the modification from the Natural Resources Conservation Service.

6) CRP owners should take appropriate action to protect their property from loss. A fireguard may need to be established and maintained around buildings. If the grass is shredded around buildings, it will give the fire fighters a better chance at protecting the endangered property from a wildfire.

7) Think safety - fire is very volatile and unpredictable even under planned and controlled conditions.



NOTICE OF INTENTION TO CONDUCT WEATHER MODIFICATION OPERATIONS IN THE STATE OF TEXAS Date of the first of three weekly publications of this notice: Nov. 16, 1995.

1. Notice is hereby given that the Colorado River Municipal Water District, P.O. Box 869. Big Spring, Texas 79721-0869, has filed an application with the Texas Natural Resource Conservation Commission for a State permit to conduct weather modification operations to change, or attempt to change, the natural development of clouds for the purpose, objective, period, and by the method summarized herein below.

2. The Colorado River Municipal Water District has a valid Texas weather modification license that was originally issued in 1975, and has been renewed annually. The most recent license renewal was granted by the Commission on Nov. 30, 1994. An application by the District for renewal of it license for 1996 is now being considered by the Commission.

3. The purpose of the weather modification operation is to increase rainfall to affect the inflow of fresh water into reservoirs J.B. Thomas and E.V. Spence. The period of the permit is to be Jan. 1, 1996 through Dec. 31, 1999.

4. The proposed weather modification operation is to be conducted for and on behalf of the Colorado River Municipal Water District, P.O. Box 869, Big Spring, Texas 79721-0869.

5. The proposed weather modification operation is to be carried out in both an "operational area" and a "target area" to cause the intended effects to occur only in the target area. The operational area is that area described by being between an outer boundary, defined by a line that encompasses the block of counties of Lynn, Garza, Kent, Fisher, Nolan, Coke, Sterling, Glasscock, Martin, and Dawson, and an inner boundary which is that of the target area.

6. The area to be affected by the proposed weather modification operation is the target area. The target area is that area described as bounded by a line beginning at a point of origin at Big Spring, in Howard County, and running along Highway 87 in a northwesterly direction to Lamesa; thence, north-northeast on Highway 87 to the north border of Dawson County; thence, east along the northern boundary lines of Dawson, Borden, and Scurry Counties to Highway 84; thence, southeast along Highway 84 to Roscoe, in Nolan County; thence, south-southeast to Maryneal; thence, southwesterly to Silver, in Coke County; thence, west-southwesterly to Highway 87 at a point approximately thirteen miles northwest of Sterling City, in Sterling County; and thence, north/westerly along Highway 87 to the point of origin in Big Spring, Texas.

7. The methods and materials to be used in conducting this operation are summarized herein: A licensed meteorologist will select cumuliform clouds for seeding, using a weather-radar display, standard meteorological analyses, forecast techniques, surface weather observations, and pilot reports. With this information, he will direct an aircraft, equipped to dispense either glaciogenic or hygroscopic seeding material, into the updraft portions of selected clouds at cloud-base level to perform seeding operations.

 Persons interested in knowing more about the technical aspects of the proposed operation should contact the applicant or the Water Planning and Assessment Division of the TNRCC (512-239-0770).

9. A public hearing on this application may be called by mailing a petition that requests a hearing to the Executive Director, Texas Natural Resource Conservation Commission, P.O. Box 13087, Austin, Texas 7871,1. The petition must contain (1) the signature, full name, address, and phone number of each person requesting the hearing; (2) a statement that each person is at least 18 years of age and resides or owns property in the operational area; and, (3) a description of each person's interest and how that interest would be adversely affected. Requests for hearing must be received by the Commission within 30 days of the date of the first publication of this notice. If at least 25 eligible persons make written request, the Commission shall hold a public hearing on an application prior to issuance of a permit. More information on calling a hearing can be obtained through the Legal Services Division of the Commission (512-239-0660).


