Tahoka All-Star Girls Give Good Effort At Nationals

For the first time in history, Tahoka was represented at the National All-Stars Little Dribblers Tournament, held last week in Georgetown. The Tahoka Junior All-Stars gave a mighty effort in the tournament, placing fifth out of 11 teams from Texas, New Mexico and Louisiana.

The Tahoka team, comprised of third and fourth grade girls, were edged out in their first game by only 3 points, losing 31-28 to Brownsboro last Wednesday night.

The second game, however, was a sweet victory for Tahoka as they trampled Shallowater 27-13, a team who had knocked the Tahoka All-Stars out of the Regional Championship title several weeks ago. Tahoka had won the title of regional runners-up to qualify for national tournament competition.

That victory gave the team a much-needed boost, as they faced Central Louisiana, a team compiled from five different cities in Louisiana, in a Friday afternoon game. That game went into overtime, but Tahoka came out on the short end by 4 points, losing 32-28 and finishing their tournament play.

"This was a great experience for these girls - they were very nervous the first game, but became more re-

laxed and confident with each game," said Coach Eddie Hancock.

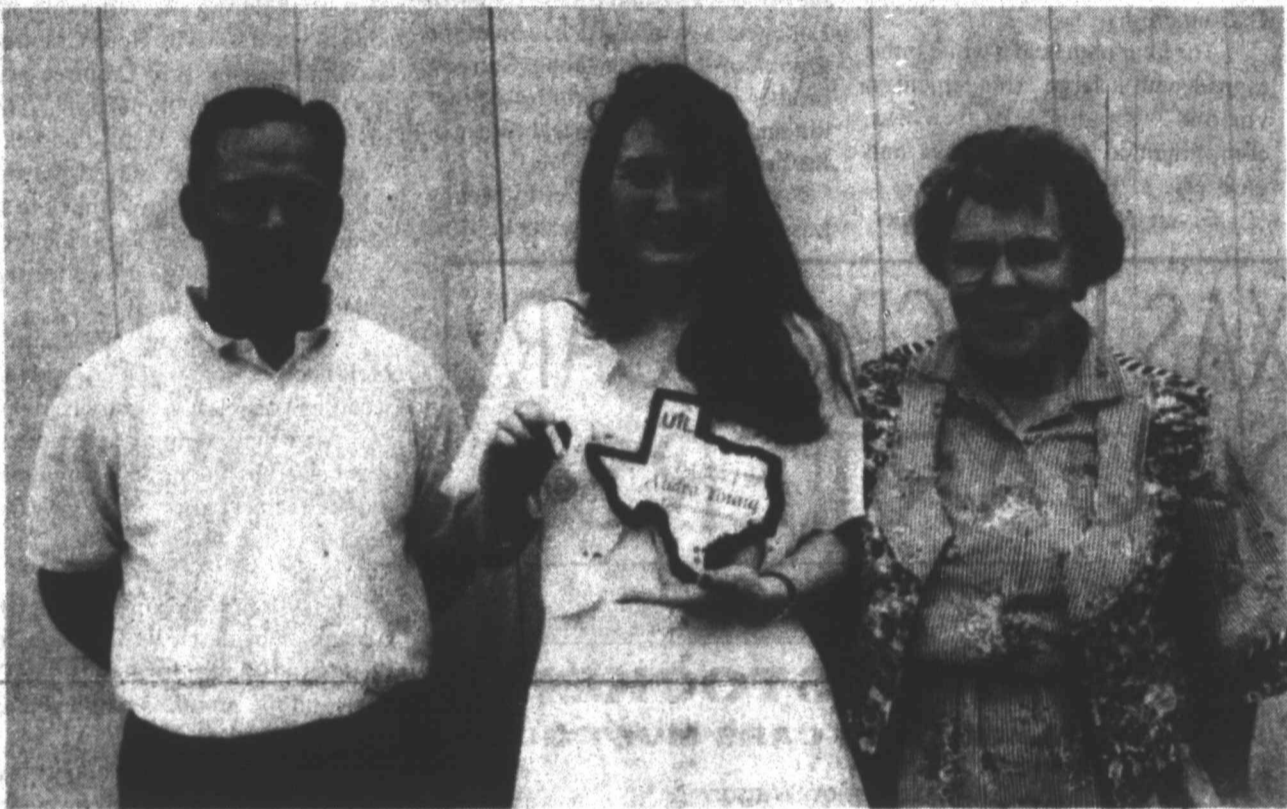
All in all, the Tahoka team scored 83 points in the National Tourney as their opponents scored 74. Scoring for Tahoka in the three games was led by Damesha Harris with 40 points, and Ashdon Hancock had 17. Others scoring were Amy Garcia, 8 points; Victoria Charo and Angela Curtis with 5 points each; Ashanti Hood had 4 points; Emily Botkin scored 3 and Kelli Engle had 1 point. Others on the team include Meredith Pittman, Lindsay Preston, Trista Wuensche, and Ashley McNeely.

During the entire All-Star season, this team was beat only five times this year, the worst being only by five points.

"I finally saw in these girl's eyes what I have been working for the past 13 years I have been involved in Little Dribblers - the desire to win it all! They will be back next year," said Coach Hancock.

"The girls played very well, with great determination and they hustled tremendously! We are very proud of them," added Coach Tina Wuensche.

The team and their families also expressed appreciation to area individuals and businesses for their support and donations in sending the team to the event.

Going from one store to another last Friday, two women cashed in stolen Lottery tickets from Allsup's at the Ince Fina in Tahoka. The Lottery tickets, valued at \$40, were allegedly stolen when the Allsup's clerk was in the back of the convenience store. After scratching the tickets, the two women went to the Fina convenience store to collect the \$19.00 they had "won". No arrests have been made at this time.

David Hutton, Tahoka I.S.D. Superintendent, reported to Tahoka Police that sometime between May 24 and June 6, someone damaged the school field house. School officials are offering a \$250 reward along with another \$250 reward from Lynn County Crime Line for information leading to the arrest and conviction of suspects in this crime. Anyone having information on this crime or any other crime may contact Crime Line at 998-5145.

In county news, Russell Heinrich of Slaton reported on June 5 that his barn in East Lynn County was broken into and two large wrenches and a high pressure sprayer were taken without his permission.

On the same day, Cindy Mendez of Wilson reported a burglary in her residence. The back door of her home had been pried open and a television, telephone, answering machine and \$100 were taken from her living room area. Estimated value of the theft was listed at \$430. Suspects are being sought as the investigation continues.

Ten people remain in Lynn County jail with four serving time for DWI, two for issuance of bad checks in Lubbock county, one for theft, one for public intoxication, one driving intoxicated without a driver's license, and one for ride not secured by safety belt from Dawson County.

Toll-Free Phone Service To Four Area Towns Now Operational

Extended local calling to four area towns for all customers in the Tahoka telephone service area is operational this week, with the service to have been initiated on Wednesday, June 12. Under the plan, all calls from Tahoka to O'Donnell, Lubbock, Brownfield, and Lamesa will be local calls. Calls from these communities to Tahoka will also be local calls.

Also beginning June 26th, all calls to and from Post to Tahoka will be local calls.

"Prior to the start of Extended Local Calling, each call between these areas was billed separately as a long-distance call, and customers would see a long-distance charge per call on their monthly bills," said Larry King, Area Manager-Customer Operations, Plains district.

"Now, these calls are equivalent to local calls, and all customers in the towns having the new Expanded Local Calling (ELC) must now dial all seven digits, both for local calls and ELC calls," explained King.

The implementation of this seven-digit service may require modification to some telecommunications equipment such as fax machines, speed calling, PABXs, key systems, automatic dialers and other equipment that may restrict or automatically dial long-distance numbers.

Customers are not required to take any action to take advantage of the new service offering. Once extended calling is operational, it will no longer be necessary for customers to dial "1+" before the number when placing calls between these communities, but all seven digits must be dialed for local and ELC calls.

This service is a result of balloting which took place several months ago in the Tahoka telephone service area under the rules of Senate Bill 632 and the Public Utility Commission Rule 23.49 (c). Under those guidelines, certain communities were allowed to petition for extended toll-free calling to nearby communities.

A per-line increase in the total monthly bill of \$3.50 for residential customers and \$7.00 for business customers will be assessed to customers in Tahoka for the added service. The charges will be listed as "Expanded Local Calling" in the tax portion of the telephone bill. More information will be provided to affected customers in their monthly telephone bill as the service becomes operational.

Residential customers with questions about the ELC service should call toll-free 1-800-438-4400, and business customers should call 1-800-438-5400.

ONCE A MONTH I get this letter from the bank containing my statement, and I get to sit down for an hour or two and try to figure out where all the money went and how come the bottom line for how much is left is nowhere near what the bank thinks it is.

In almost all cases, the bank is correct, because I have written down a wrong number, messed up on my addition and subtraction, or failed to enter something or other.

I don't mind when the bank shows more money in my account than I thought I had, but when it's the other way around, I get upset. Either way, I usually try to find out how the difference came about, and usually I don't find out.

Once I caught the bank in an error, which they corrected. But 99 per cent of the time, the error is mine.

This is why my wife and I have separate checking accounts. She balances her checkbook to the penny every month, and my kind of bookkeeping drives her up the wall. Mine usually varies, because I like to keep an extra amount in there which I have not entered, to take care of the mistakes I know I'm going to make. Actually this is an improvement on the way I used to keep my checkbook totals. For years, I would just round off my checks to the next dollar, knowing that I couldn't balance with the bank anyway. If I wrote a check for \$5.63, I'd just stub it as \$6. Eventually you get enough extra in there to take care of the \$45 check you forgot to enter at all. My wife thought that was a dumb system, so I changed to my present clever one.

On the outside of the bank statement envelope, I write down the difference between what the bank says I have and what my checkbook says. For several months in a row, the note said something like "Bank shows 42.18 more than checkbook." Then it will be \$22.18, and the next month 23.58. And I never can find out what happened to change things in that one month.

Looking at financial numbers always has confused me. Just a couple of weeks ago I was a delegate to a church conference and I voted along with about 700 others on a lot of budget figures which I didn't understand at all. I happily raised my hand each time to approve these budgets, so they would move on to something I might comprehend.

No accountant has ever been able to explain to me why, on a financial statement, assets and liabilities have to total the same. Any dummy ought to know that if your assets aren't worth more than your liabilities, you're not making any money. Accountants may be the reason I've never made any money in business.

Russian Mission Trip Involved Helping Hands, New Friends For Tahoka's Terri Solomon

Two weeks in Russia, scraping and stripping paint off concrete walls, doesn't sound like most people's version of a dream vacation. But for ten college youth, including Terri Solomon of Tahoka, the mission trip to a Russian children's home was time well spent and an experience she will never forget.

Terri, 22, daughter of Jim and Andra Solomon of Tahoka, says she and nine others from the Texas Tech Wesley Foundation overcame the barriers of language, strange food, and cultural differences through the universal language of friendship, helping hands, and hugs. "These children loved us - and we loved them right back," she said.

The purpose of the two-week mission trip was to renovate and repair the walls of a children's home in Istra, a large facility which houses children ranging from 5-18 years of age who are hearing impaired and/or mentally challenged. Located approximately 30 miles from Moscow, the facility also serves as a boarding school and orphanage.

The Tech Wesley Foundation group was comprised of six young women and four men, all in their 20's, none of whom could speak the Russian language, or knew the hand signals of Russian sign language. They were met in Moscow by an American Peace Corps leader on May 13, following a 10-hour day of flying from Dallas, to Detroit, to Amsterdam, and finally to Moscow, where they would travel by bus to Istra. For the next two weeks, they would live at the children's home, sharing meals at the facility and working on the walls, while spending as much time as possible with the young children and teenagers who resided there.

"When we arrived, our Peace Corps leader took us to the children's home, and left us there on the first day with no tools, and a 'foreman' there who was just beginning to learn English but had a hard time understanding us," said Terri with a laugh. "We finally found buckets and rags, and one of our guys found some old tiles which we used to scrape the old

plaster off the walls with that first day. We had brought money to buy the tools we needed there, but weren't able to purchase them until the next day," she explained.

And on that first day, the children would come, by themselves or in pairs and in groups, to watch the "funny Americans," said Terri. "We were singing as we worked and they would come and watch us for a little while, and then they would go find a rag, dip it in our bucket, and come stand beside us and scrub on the walls like we were. And they all wanted their picture taken," she recalled with a smile. "It was very touching... they knew we were there to help them" she added.

She said she and her group found ways to communicate with the children, many of whom were hearing impaired, and, anyway, didn't know the English language. "We'd just use body language, and although many times we felt frustrated in trying to communicate, it worked out," she said, noting that the American interpreter would come from time to time to check on them during the stay. She said one of the girls in her group knew sign language, but that Russian sign language and American sign language was so different that it didn't correspond very well, but she was able to communicate better than the rest of the group.

The mission group was able to spend a lot of time with the children, says Terri, because they were living with them at the children's home.

"We had no privacy - we stayed with the girls on one floor, and our guys stayed with the boys on another floor. We brought two suitcases full of toys and played games with them, and showed them how to play frisbee - which they had never seen - and they showed us the lake where they went to bathe and swim... although they teased us by showing us a scum-filled pond first as the place where we could all swim!" she said with a grin.

Between spending time with the children and working on the renovation project, the Americans were able to spend some time in Moscow and see some of the attractions there. They were taken to a circus and a ballet in

the Kremlin, and when the Americans saw a McDonald's they breathed a sigh of relief and headed for burgers and fries in a hurry, says Terri, after having soup for most of their noon meals at the children's home.

They finished the project work they were scheduled to do, and primed the walls in preparation for the next group who was coming in. "There were 10 other groups scheduled to come after us to work at the children's home, so they had the work planned out for each group," explained Terri.

"In all, there were 70 mission groups in Russia through the Methodist peace group," said Terri, explaining that 11 groups were scheduled at the Istra children's home and the other groups would be in different sections of the country.

On the last day at Istra, the children had a party for the mission workers, playing American music and dancing, and as the ten young Americans drove away in the bus, the children lined up and held their hands together in the universal sign of friendship.

"We'll always remember them - we had learned to love them all, and had formed special friendships with some who just tugged at our heartstrings," said Terri. "We knew we shouldn't have formed special attachments, but it was really hard not to," she explained, adding that she had bonded especially well with a 16-year-old girl named Nadia and a 6-year-old red-haired little orphan girl named Marsha. "If my Mom could have seen Marsha, she would have brought her home... and I wanted to myself," Terri said.

"We'll always remember them... I wish we could have done more," said Terri. "I'm really glad we went and I would do it again... I think all of us would."

The Americans left behind the results of their labor of love, but the friendships and memories they made will forever connect them in a special way to a small part of Russia. And perhaps the group of Russian children will remember the young Americans who came for two weeks, offering helping hands and hugs.

Never give out a credit card or bank account number unless you initiate the transaction and are confident about the company. You should receive complete details in writing about any trip prior to payment. Be wary of calling telephone number with 900 prefixes in response to a travel solicitation. Walk away from high pressure sales presentations. Be suspicious of all offers that include "all major hotels" or "all major airlines." Call your local travel agent and check them out with the BBB.

Emergency Farm Loan Applications Being Accepted

Applications for emergency farm loans for losses caused by drought, hail, and high winds are being accepted at the Farm Service Agency (FSA) office located in Tahoka, FSA Ag Credit Manager Curtis Barlow said today.

Lynn County is one of eight in Texas recently named by Secretary of Agriculture Dan Glickman eligible for loans to cover part of actual production losses resulting from the drought, hail and high winds.

Barlow said farmers may be eligible for loans of up to 80 percent of their actual losses or the operating loan needed to continue in business, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest is 3.75 percent.

"As a general rule, a farmer must have suffered at least a 30 percent loss of production to be eligible for an FSA emergency loan," Barlow said. Farmers participating in the Federal Crop Insurance program will have to figure in proceeds from those programs in determining their loss.

"Applications for loans under this emergency designation will be accepted until January 13, 1997, but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly over into the new farming season," Barlow said.

FSA is a credit agency of the U.S. Department of Agriculture. It is authorized to provide disaster emergency loans to recognize farmers who work at and rely on farming for a substantial part of their living. Eligibility is extended to individual farmers who are U.S. citizens and to farming partnerships, corporations or co-operatives in which U.S. citizens hold a majority interest.

The FSA office in Tahoka is open from 8 a.m. to 5 p.m., Monday through Friday, at 2002 S. 2nd, phone 998-4569.

Funding Studied For Water Projects In Small Communities

A state legislative subcommittee appointed by State Representative David Counts, Chairman of the House Committee on Natural Resources, met recently to discuss methods of assisting small communities in financing water projects in emergency or crisis situations. Counts, who also serves on the subcommittee, explained that many of the smaller communities in rural parts of the state lack the financial ability to respond to such urgent situations. "If a tornado knocks down the community water tower or the water well runs dry, many of our communities do not have the tax base or customer base to respond in time to avert disaster," Counts said.

County Commissioners Meet In Closed Session

Lynn County Commissioners met Monday morning, with their attorney Mrs. Sharlot Bingham from Crenshaw, Dupree, and Milam in executive session. Mrs. Bingham, along with County Attorney Jimmy Wright, discussed the litigation against Lynn County. The session was taped in accordance with the Texas Open Meetings Act of 1976. No action was taken when the court entered into regular session.

J.T. Miller and Jacky Henry made the motion for Commissioner Sandy Cox to advertise for sealed bids to sell some used equipment; a five-yard dump truck, a truck with a 14-yard dump bed and a Mack truck with a 22-yard belly dump. The motion carried unanimously.

The bills were paid and official reports presented. Commissioners Cox, Miller, Henry, and Margaret Stone were all present along with Judge J.F. Brandon.

May Weather Hotter Than Usual

The weather across the Texas South Plains during the month of May was significantly warmer than normal, according to the National Weather Service, Lubbock office.

Temperatures averaged 7.1 degrees above normal and ranged from 5.7 degrees above normal at Matador to 8.4 degrees above normal at Lubbock.

Maximum temperatures averaged 8.4 degrees above normal and ranged from 5.7 degrees above normal at Matador to 10.2 degrees above normal at Muleshoe Refuge. The highest temperature reported during the month was 106 degrees at several stations on the South Plains.

Minimum temperatures averaged 5.8 degrees above normal and ranged from 3.9 degrees above normal at Lamesa to 7.7 degrees above normal at Morton. The lowest temperature reported during the month was 35 degrees at Lamesa on Day 1.

Precipitation averaged 1.07 inches below normal and ranged from 2.94 inches below normal at Snyder to 3.31 inches above normal at Abernathy.

There was approximately 7 hours of blowing dust at Lubbock International Airport during May which occurred on the 14th and the 26th.
