# **TISD Trustees Approve New Athletic Policy**

Tahoka Independent School District Board of Trustees approved the district's athletic policy and student codes of conduct, gave a raise to district at-will employees, and conducted other routine business at Thursday night's board meeting.

Athletic Director Troy Hinds pointed out some changes in the athletic policy from the previous year, the most notable being the time a student athlete is barred from participating in a sport after quitting another sport. For the past two years, athletes who quit any sport were not allowed to participate in school sports for a full calendar year. In the new policy, a student who quits or is dismissed from a sport may not participate in another sport for the first four weeks. They must practice each day but may not compete in games for the first four weeks.

Another policy which is not new but has not been enforced, is a ruling that all middle school players will play in all games the equivalent of at

least one period per game. When questioned about the policy, Hinds assured trustees that this policy would be enforced in the upcoming school year, as he believed young players who attend practice and show enthusiasm for a sport should be allowed to play to gain experience.

The new athletic policy was approved unanimously by the six trustees present.

The campus student codes of conduct were also approved, and trustees authorized Superintendent David Hutton to purchase yearly renewable commercial and fleet insurance policies from vendors who had requested to submit proposals. Two local insurance companies, Fenton Insurance and Walker-Solomon Insurance Agency, submitted requests to be considered for insurance proposals.

District at-will employees, including cafeteria staff, maintenance staff, secretarial staff and teaching assistants, will receive a 3.5 percent pay raise, as recommended by Supt. Hutton and approved by trustees.

In jail during the week were two persons for public intoxication, two for driving while intoxicated, first offense, and one each for no drivers license and evading arrest.


#### **Sharp Delivers July Tax Rebates**





## **Guaranteed Savings For Customers Is Part Of Proposed SPS Settlement**

Guaranteed savings of \$3 million a year to be credited to Texas customers' bills is part of a proposed settlement announced recently by Southwestern Public Service Company and virtually all parties who had intervened in its merger case now before the Public Utility Commission of Texas.

SPS has stated that its proposed merger with Public Service Company of Colorado will result in significant savings and help hold down future electric rates. The settlement with the commission staff and with five other interveners was announced this morning to the administrative law judge hearing the case in Austin. The judge suspended the hearing, which began June 24, to allow the parties to finalize details. The only intervener not joining in the announcement of the hear-unanimous settlement is the Office of Public Utility Counsel (OPUC). SPS is still discussing settlement with OPUC and believes that many of OPUC's concerns have been addressed in the settlement with the other five parties.

The minimum \$3 million a year In credits would apply to SPS's residential, commercial, industrial and other retail customers in Texas for the first five years of the merger. The tentative agreement calls for a 50/50 sharing between shareholders and customers of non-fuel operation and maintenance savings during the first five years, but with customers guaranteed at least \$3 million in credits regardless of the amounts of actual savings. Customers could receive larger credits. After five years, all such savings would go to the custom-

In total, SPS is estimating that during the first 10 years of the merger its Texas retail customers will receive about \$100 million in savings through lower fuel costs and other factors that will help hold down electric bills.

"We're very pleased with this progress, and very pleased with this settlement," said SPS Chairman and Chief Executive Officer Bill D. Helton. "We're confident that the merger will benefit our customers and our company. This guarantee reflects that confidence."

For an SPS residential customer who averages 1,000 kilowatt-hours a month (representing a monthly bill of



\$62.62) the minimum annual credit would be about \$4.00.

In the settlement, SPS also would guarantee that it would operate its lowest-cost power plants to benefit SPS customers before providing power from those plants to customers in the service area of Public Service Company of Colorado. To assure access by customers to competitive power, SPS also would study options and costs to expand import and export transmission capability between SPS's system and nearby regions.

Among the interveners is Golden Spread Electric Cooperative of Amarillo, SPS's largest wholesale customer. In an agreement with Golden Spread, SPS would provide costbased backup services to Golden Spread and would provide economic dispatch for Golden Spread's future generation resources

approved by state regulators in Wyoming and Kansas. A proposed settlement agreement with the staff of the Colorado Public Utilities Commission and several other parties has been announced in Colorado. New Mexico hearings are scheduled to begin July 22. The Federal Energy Regulatory Commission in Washington, D.C., is among other agencies that must approve the merger before it can be completed. The federal commission earlier announced a deadline of Jan. 31, 1997, for an initial decision from one of its administrative law judges. This schedule would mean completion of the merger probably would be in spring 1997. However, settlement of the case before it goes to hearing could result in an earlier completion. 





Members of the Plains Cotton Growers, Inc. (PCG) Board of Directors unanimously approved a new operating budget for the 25 county producer organization.

The PCG Board approved a budget totaling \$304,700 for fiscal year 1996-1997, which began July 1. PCG Finance Committee Chairman Ronnie Hopper noted during his presentation of the budget recommendation that the PCG staff continues to do an outstanding job of argeting organizational

expenditures. In addition to the approval of a new operating budget the PCG Board also worked through a lengthy agenda which included reports on the Enhanced Diapause Control Program, Federal Crop Insurance, and the Plains Cotton Improvement

Program. In other business the PCG Board approved PCG President Jackie Burris as the organization's resentative at the upcoming National Cotton Council, Cotton Incorporated and Cotton Board caucus in August.

PCG Board members also approved members to 1996-1997 Nominating and Executive Committees. The Nominating Committee is composed of the organization's three most recent past Presidents plus members elected from the Board. Current PCG officers are not eligible to serve on the Nominating Committee. The PCG Executive Committee is made up of the current PCG officer corps, the two most recent past presidents and an elected member from each of PCG's six districts.

Late word from the United States Department of Agriculture indicates that a late filing provision has been approved for producers who were not able to sign-up for the new seven-year farm program by the July 12 cut-off date. The late filing period will end August 1, 1996.

USDA Farm Service Agency personnel have indicated that correspondence will be sent to those producers who die not come in during the initial sign-up period. This will be the last opportunity for producers and landlords to enroll in the program.

So far it appears that well over 95 percent of the cotton producers in the High Plains region have already enrolled in the seven-year program.





#### Motorola To Supply Poka Lambro With CDMA Equipment

Motorola's Pan American Wireess Infrastructure Division (PWID) has been selected to supply approximately \$40 million in digital CDMA (Code Division Multiple Access) equipment to PCS (Personal Comtions Services) operator Poka Lambro. The operator recently won C-Block licenses to provide PCS service to nearly 1,4 million subscribers in eight markets in west Texas and eastern New Mexico.

Anyway, I didn't watch the movie.

I ALSO AM irritated by the policies of laboratories who do blood tests. (Actually | am irritated by a lot of things these days, which I am sure is a sign of maturity, like getting fat and detesting ponytails and earrings on males).

Anyway, I recently had a blood test and "health profile" done by some people associated with Methodist Hospital. They gave me some numbers on about 20 elements, including cholesterol (pretty high), glucose (way high) and triglycerides (out of sight), and also told me my blood pressure was too high.

You should be able to go to the lab, tell them what you want to check, and get it done. I don't know if their refusal to cooperate is policy or law. If it's just policy, then maybe somebody needs to generate a class action suit against the labs.
