11 File This Week For City, School Elections

Eleven more candidates filed for places in area school and city ballots since last week, and filing opens this week for two seats on the Lynn County Hospital Board of Directors. Deadline to file in the hospital election is March 31.

Interest in the New Home I.S.D. election is high, with three more candidates this week joining the lone early filer to make that a contested race for two seats on the board. Three candidates also filed this week for the Wilson I.S.D. election, which has two full terms and one unexpired term up for grabs. One more candidate filed in the Wilson city election, and two filed for the O'Donnell city election. One more candidate filed for Place 4 in the Tahoka I.S.D. election, making that a contested race, and one filed for District 1 in the Tahoka city election. In New Home, no candidates have filed for the position of mayor or two council seats.

Deadline to file for a place on city or school ballots is March 17, and elections will be held May 1. For information on filing, contact city or school administrative offices.

20 Illegal Aliens In Van Stopped North Of City

There were so many illegal aliens in a van stopped north of Tahoka Wednesday morning that officers still hadn't made an exact count at press time, but one source said there were 21 persons in the van, including the driver, a woman.

State troopers, Lynn County Sheriff's deputies, and Border Patrol officers were out at the scene about 10 miles north on U.S. 87 when the 1993 Dodge van was stopped by the DPS officers about 7 a.m. The Border Patrol, which had issued an alert for the van, took the 20 male passengers and the driver to Lubbock.

The woman driving the van also was wanted for parole violation, as well as facing charges of transporting illegal aliens.

Two traffic accidents were investigated by Tahoka Police Dept. during the last week. On Friday at the intersection of S. 2nd and Ave. F a 1993 Chevrolet pickup driven by Pedro Lopez Calvillo, 20, of Brownfield and a 1996 GMC pickup driven by Estella Alvarado Rodriguez, 54, of Rt. 4, Tahoka, collided.

According to the police report, there were no injuries and no damage in the above accident, or in another accident which occurred March 1 in the 1500-block of S. 1st St. Involved in that collision were a 1985 Chevrolet pickup driven by Amelia Vega Rosas, 35, home town not listed, and a 1982 Ford pickup driven by Cruz Hernandez Rodriguez, 61, also no address listed in the report

At the regional science fair, Kelly's project won an International Science and Engineering Silver Medal, and won first place in the 12th Grade Biological Division. She won a \$500 scholarship from the Texas Tech College of Agricultural Sciences and Natural Resources High Individual Award; The National Association of Biology Teachers award; 1st United States Navy award, and graphing calculator; and 1st United States Army environmental science award, and backpack.

According to Kelly's sponsor, THS science teacher Cathy Box, Kelly did much of her research at Texas Tech University's Health Sciences Center, working with medical school grad students and under the direction of a professor there. Her findings, which Mrs. Box says are unique, will be published in a medical magazine this summer.

Tahoka Scientists Capture Top Awards:

Kelly Flynn, Tasha Mensch Eye State, International Science Fairs

Two young women from a small high school won top awards at the regional science fair and will be competing again, one at the state level for a chance to go on to internationals, and the other young scientist already has an invitation to compete at the international event,

No, it's not from the movie "October Skies" (which follows a group of small-town boys who are 'underdogs' at the science fair, and their quest for recognition at the state level). Tahoka High School seniors Natasha Mensch and Kelly Flynn are the 'small town underdogs' in this story, and they have already won top regional awards in their quest for scientific answers in the fields of chemical/physical and biological science. Tasha will be competing at the 50th International Science and Engineering Fair in Philadelphia, May 2-8, and Kelly will compete at the Texas State Science and Engineering Fair at Austin, April 14-16, for a chance to advance to the international event.

Both won first place in their divisions and other top awards at the 43rd South Plains Regional Science and Engineering Fair held March 5-6 in Lubbock. Tasha's project is an expansion of her international award-winning project last year concerning water purification from cotton gin trash, addressing further issues in that area (including a design for a benchtop reactor to steam activate carbon); Kelly researched the role of pesticides in causing Parkinson's Disease.

Tasha, daughter of Mike and Linda Mensch of Tahoka, was awarded the International Science and Engineering Gold Medal, and first place in the 12th Grade Physical Science Division at the regional science event. The Association for Clinical Chemistry-Texas Association, awarded her \$100 and an all-expense paid trip to their annual meeting in Austin to present her project. She also won other honors,

including: 1st United States Navy award, and a graphing calculator; 3rd United States Air Force; 1st United States Army physical science award, and a backpack; The American Chemical Society Award; The American Physical Society Award, and an electronic organizer; Texas Natural Resources Conservation Commission; Student Engineering Council Award, a \$300 scholarship; and award from the Texas Society of Professional Engineers, South Plains Chapter; and the Texas Tech University College of Engineering Scholarship Award, a \$500 scholarship.

Tasha was sponsored by Tahoka High School science teacher Betty Stennett.

The daughter of Mr. and Mrs. Johnny Flynn, Kelly conducted research to prove that frequent exposure of agricultural workers to pesticides containing organophosphates causes neuronal cell death which leads to Parkinson's Disease, and she


A birth certificate must be presented at registration. Cost will be \$15 for coach pitch, \$20 for minor and major league, and \$40 for senior league.

Wingate Woman Living In Old Tahoka Santa Fe Depot

(Editor's Note: The following story is excerpted (with permission) from an article in the Abilene Reporter-News, written by Ken Ellsworth's "Eye on West Texas" column. Wingate is a small town near Abilene, where Rita Stephenson makes her home in the old Tahoka Santa Fe Depot building.)

Rita Stephenson's home is a real Santa Fe train station. The poor, neglected thing used to sit beside the tracks in Tahoka. Built in 1910, it had been abandoned for 20 years when she saw it in 1985.

Mrs. Stephenson did not so much see the station for the wreck it had become, but what it could be. So, deciding to rescue it, she acted quickly. She bought the old station, put it on a truck and shipped it to the family land south of Wingate in north Runnels County. It was land that had been farmed by her grandparents and parents since 1907.

"Doug thought I was crazy," Mrs. Stephenson said. She was speaking of her husband who died in 1992. "But he really would have enjoyed

"We had just stepped into the sunken living room when I was startled by a train whistle and other train noises. I looked for the source of the sound and saw a speaker with a sensor on the floor. Walking through the door had activated it.

Mrs. Stephenson laughed at the sound and my reaction. She is a lively, small lady. She taught public school in Friona for 34 years so she knows how to talk and explain things.

The station home sits on a hill top. You cannot miss it. In the first place, right beside the house is a very red caboose. On top of that, the long driveway off of County Road 301 is flanked by railroad traffic signals and curves up to the house between big old railroad ties. On top of even that, a railroad station out in the country is hard to miss, especially with Tahoka written in large black letters

on the east and west ends.

The station home is a cream-colored, wood-framed building with a red metal roof. The eaves and windows are trimmed in brown. The most dominating external features are two large bay windows that look to the north from either end of the home. The east window was Mrs. Stephenson's idea. The west one was original to the old station, but now lights Mrs. Stephenson's wellequipped kitchen. She can sit at the kitchen table and look north, south, east and west without moving from her chair, just like railway workers used to do as they watched for trains steaming into Tahoka.

"I just love looking out of these windows. Of course, I'm in such familiar surroundings. I was born just over there," she said, pointing south-

The inside of the station home is reminiscent of a train station, but Mrs. Stephenson oversaw a lot of remodeling that changed things. The structure has three bedrooms and City Takes First Step In Loan Closure For New Wastewater Treatment Plant

City council members officially approved the first step in preparing to close a \$1,780,000 low-interest loan for construction of a new wastewater treatment plant here, authorizing the publication of a Notice of Intent to Issue Certificates of Obligation. The loan was approved last year from the Texas Water Development Board, and city officials expect to close the loan May 21. Construction of the new wastewater treatment plant will then begin, and is expected to take approximately 18 months to

City Administrator Jerry Webster said the city expects to repay the loan through a combination of tax funds and water/sewer fees. The new facility will replace the wastewater treatment plants currently in use, one built in 1929 and one in 1964, which no longer meet TNRCC requirements.

In other business, city council members approved paying off a 1988 waterworks/sewer system revenue bond. The bond, which the city has been paying on since 1988, was due for payoff in September 2002. Webster said the city has been setting aside reserve funds for the purpose of the early payoff which amounts to \$62,100, and that paying it off 3-1/2 years early will save the city approximately \$15,000 in interest.

Grant funds from the Texas Department of Housing and Community Affairs were used in paying for a water line replacement project in the south part of Tahoka which was recently completed. The council authorized final payment to the contractor after certifying the job had been completed to the engineer's specifica-

A contract with the Canadian River Water Authority was approved by the council, for continuing with the alternative water supply and de-

The rooms are furnished with antiques. Mrs. Stephenson said she had to search hard to find furniture that fit because of the unusual dimensions of the rooms. Railroad art dominates the walls - paintings of clouds of black coal smoke curling over long trains on wide expanses of prairie. Railroad knickknacks cover the table

"Oh, people give those to me," Mrs. Stephenson said.

Wherever possible, Mrs. Stephenson has preserved the original parts of the Tahoka depot. The distinctive ceiling over the living room was made of original 12-inch rustic and stained wall boards.

She regrets the accidental covering of one rough, wooden wall. It was covered with hobo graffiti drawn and etched by hobos passing through Tahoka long ago. Mrs. Stephenson wanted to preserve the hobo legacy which apparently came from a politer era. "It was so clean," she said of the graffiti. "There was not one obscenity or cuss word. Just their names and little comments and drawings. It was wonderful."

I asked Mrs. Stephenson why she had done all this. Was it because she was a lover of trains?

"No," she said. "When I saw the station, I just realized that I could do





County Approves JJAEP Program

Lynn County Commissioners unanimously agreed Monday to enter into an agreement with all Lynn County school systems willing to participate in the Juvenile Justice Alternative Education Program (JJAEP) in Terry County, with costsharing to be considered between the entities. The JJAEP program, at the old Union school, is a rigorous physical program as well as educational program for juvenile offenders.

Commissioners and Lynn County Probation Officer Bill Schoemann had met with representatives from JJAEP and from Tahoka, Wilson and New Home schools in a special session last Thursday to obtain more information about the program. O'Donnell I.S.D. had already agreed to participate in the program, according to county sources.

Cost-sharing for the JJAEP will be shared by the county and school districts, depending on whether the juvenile is counted in the school district's average daily attendance or is an expelled student, and on whether the juvenile is ordered to the JJAEP by the school or by legal authorities.

In other business Monday, commissioners approved a \$1 filing fee increase which would be dedicated to a security fee for the courthouse, to take effect April 1. The current filing fee for all documents is now \$8 for the first page, and would increase to \$9.

Some discussion was held, but no action was taken, on an agenda item concerning dump ground fee considerations. Monthly bills were approved as presented.

All commissioners were present for the meeting.



"This money is badly needed by farmers who suffered losses due to natural disasters, the effects of which are made worse by the current slump in farm prices," said Glickman. "We want to make sure that everyone who's eligible has a chance to participate."

More than \$2 billion has been authorized by Congress to reimburse farmers hit by natural disasters and who suffered losses greater than 35 percent of their historic yields.

Farmers are eligible for compensation either for qualifying losses on 1998 crops, or losses in any three or more crop years between 1994 and 1998 where crop insurance indemnity or assistance under the non-insured crop disaster assistance program was received. Farmers can receive payments under either single-




